U.S. Marshals arrest man on domestic abuse warrants

A Princeton man is in jail after the U.S. Marshal's Service picked him up on three Webster warrants.

Justin C. Miller, 32, of the

Lane in Princeton, was arrested Tuesday, June 23, and charged with domestic abuse battery, unauthorized entry of an inhabited dwelling and misdemeanor simple criminal damage to property. Bonds totaled \$87,500.

Webster Parish Sheriff's Chief Deputy Bobby Igo Jr. says the warrants stemmed from a recent incident where Miller was told to stay away from his ex-girlfriend's residence and he did not.

Should it come down?

Minden NAACP president weighs in on Confederate soldier monument

With the first two of nine victims of the Charleston, South Carolina church shooting laid to rest and the Confederate flag coming under fire, one man weighs in on the

Kenneth Wallace, the Minden chapter president of the National Association for the Advancement of Colored People, says the Confederate soldier statue at Jacquelyn Park in Minden should have come

down a long time ago. "I've advocated for years personally against the Confederate flag," he said. "It's offensive to me because of the reasons it was founded on. It's offensive because of what my ancestors went through. It's a misrepresentation, and it's really sad to me that it takes the deaths of nine people to really start looking into that."

Nine people were gunned down in a black church in a

VOA outreach goes mobile, high tech

The goal of the Volunteers of America has always been to meet the needs of the communities in which they serve, but now it's going high tech in its rural health outreach.

With a brand new mobile rural health outreach van, veterans who have a hard time reaching their doctor's appointments can meet with a registered nurse for screenings or health information, but if need be, they can also meet with their doctor via satellite.

Volunteers of America North of Louisiana was one of five selected by the VA Office of Rural Health to receive a two year grant to create and come up with targeted driven solutions to reach veterans in rural and underserved communi-ties," Tricia Jowell, VOA director of community and media relations, said.

"Some of the barriers are transportation to VA appointments or community-based outreach clinics, waiting once they get to their appointments or not being able to see their provider at all, and parking and benefits."

The van comes equipped with a soundproof room where a patient can discuss their health issues in private with their physician, and with high definition technology, the video quality of the visit is crystal clear. It makes it easier for physicians to examine their patients for things such as dermatology issues where the physician can clearly see the problem area.

Through this mobile unit, veterans who may not have had easy access to the Overton Brooks VA hospital may be able to use the services offered without having to go to the hospi-

Bible study in Charleston, and Dylann Roof reportedly confessed to the mur-

He called the shooting in Charleston senseless and says the behavior that led to these deaths is learned.

"(Dylann) Roof's behavior is learned," he said. "That type of stuff is learned, and I remember

reading when John F. Kennedy was assassinated and (Dr.) Martin Luther King Jr. says a culture of hate created this, and this is similar. It's a climate of hate."

He says Roof admitted that reading about the ideology and it's the same ideology based on the Confederate Flag.

"It's like a swastika," he said. "You'd never have that on a license plate or a flag. This individual had taken on that ideology of white supremacy, and it's

really sad."

He talked about Alexander Stephen's Cornerstone Speech, an impromptu speech delivered in Savannah, Georgia, in 1861. Stephens was elected the vice-president of the Confederacy during the time President Abraham Lincoln refused to recognize South's secession. Stephens argued in the speech that the cornerstone of southern greatness lay in slavery and white supremacy.

"You have this Confed-

erate memorial and you have this World War II veteran, and it's a misrepresentation to me when you can't honor this man," he said.

He spoke of John C. Jones, a black World War II veteran, an Army corporal and veteran of the Battle of the Bulge. Jones and Albert Harris, were victims of a lynching in the 1940s in Minden.

The statue was erected in January 1933 in memory of the Confederate States Army from 1861-1865.

"The statue was commissioned by the United Daughters of the Confederacy of Minden and was dedicated on Lee-Jackson Day in January 1933," according to the United Daughters of the Confederacy. "It was to honor the Confederate soldiers and

was unveiled by Alberta Glass, Minden's last surviving Confederate veter-

As for the Confederate flag? Wallace says he understands it's a part of history, but like others, he believes it belongs in a museum.





CAMP MINDEN CLEANUP

M6 destruction meeting set for Tuesday

The community will now learn about the process of the destruction of the M6 propellant stored at Camp Minden in a meeting set for June 30 at 6:30 p.m.

The meeting will take place at Camp Minden in Building A120 where representatives from Explosives Service International and El Dorado will discuss the destruction process from beginning to end. Representatives from the Environmental Protection Agency will be on hand as

The Louisiana Military Department is asking those entering Camp Min-

den to have their identification and allow extra time

The contract was signed last week after some discussions over additional requirements by the EPA, which increased the price tag for clean up from \$19 million to roughly \$35 mil-

ESI will use the contained burn method of disposal, which will have a pollution abatement system to stop noxious gases from entering the air. The alternate method

came about following an outcry from the community and surrounding areas when they learned the open tray burn method of disposal would be used to dispose of nearly 16 million pounds of M6 propellant discovered improperly stored at Camp Minden in 2012. A dialogue committee was formed that offered six alternate technologies to use other than the open tray burn.

A community advisory group, or CAG, has since been formed to help oversee the cleanup process and have an active role in communicating the community's concerns to the EPA as the cleanup takes

The next CAG meeting will be at 6 p.m., Monday, July 13, at First Baptist Church in Doyline.

Jindal announcement light on Louisiana's elected officials

seemed like a no-miss event in Louisiana politics, sitting governor announcing his bid for the White House. But the crowd at Gov. Bobby Jindal's presidential campaign kickoff rally noticeably lacked for political star power.

None of Louisiana's six statewide Republican elected officials showed up. Only a handful of state lawmakers were there, none of whom live in Jefferson Parish, where the rally was held. And no one vying to take Jindal's place in the governor's mansion attended.

The missing officials highlighted just how

unpopular governor has become in his own state, and suggested that few of Louisiana's GOP leaders may be willing to back up him up when he touts his achievements to voters in other

"If I'm going to be in a competitive election (in Louisiana), I do not want my opponent circulating a campaign photo right now of me and Gov. Jindal together, either shaking hands or standing on a stage," said Joshua Stockley, a political science professor at the University of Louisiana at Monroe.

Both Republicans and Democrats in Louisiana have long criticized Jindal

for financial policies they blame for creating repeated budget crises in the state, as well as crafting state policy based on his national political ambitions. His approval ratings have dipped into the low

The governor's campaign aides dismiss the low approval ratings at home as a byproduct of Jindal's tough decision-making and willingness to "bruise egos" to reform government. If Jindal was disappointed in the turnout, his spokeswoman Shannon Dirmann didn't let on.

'We invited a lot of people, and we're glad so many came out to support his run," she said.

Jindal launched his campaign for the Republican presidential nomination Wednesday in the New Orleans suburb of Kenner, with hundreds of people in attendance. Many of the governor's cabinet secretaries were there, along with the chairman of the state Republican Party, pastors and other Jindal supporters.

Attorney General Buddy Caldwell's spokesman said he had meetings tied to an undercover operation investigating child predators. Agriculture Commissioner Mike Strain's spokeswoman said he was giving a speech in north Louisiana.

As for the major GOP

governor in this fall's election, Lt. Gov. Jay Dardenne was in Shreveport speaking to a local bar association and U.S. Sen. David Vitter was in Washington for

Republican candidate Scott Angelle, a state utility regulator who was once Jindal's natural resources secretary, was at a Public Service Commission meeting, then had a newspaper interview and staff meetings, his campaign said.

All three men have sought to distance themselves from Jindal in their campaigns.

About a half-dozen of Louisiana's 144 state lawmakers showed up for Jin-

dal's rally. Among them was Sen. Mike Walsworth, a Republican from West Monroe and a long-time ally of the governor.

"I've never been to a presidential announcement, never. I said, 'This is a once-in-a-lifetime thing. Those don't happen every day,'" Walsworth said. "He's been a good friend and a good friend to my district.'

While he acknowledged he expected to see more elected officials there, he said he didn't take their absence as an affront to Jindal: "A lot of us are pretty busy. I don't necessarily think that was a negative slap at the governor.'

My boys and I enjoyed an overnight father/son basketball camp, visited our favorite greasy spoon for breakfast Sunday before church services, and shared some good quality time in different ways throughout the weekend. Overall, it was a great reminder why I am so fortunate to have a loving family who enjoys one another's

However, it was also a reminder of a more important lesson: It is absolutely critical for each and every father to do their job.

As a business trade association, we spend countless hours and energy debating different things the government should or should not do with taxpayer dollars. 

The Natchitoches area has ıong been a popular destina tion for tourists and sportsmen. One visitor from France was especially intrigued at how the local people used trotlines to catch catfish.

The trotlines were, he wrote, "no more than fishing lines about [36 feet] long. All along these lines, numerous other lines are tied about a foot apart. At the end of each line is a fish hook on which they put a bit of . . . dough or a small piece of meat. With this method they do not fail to catch fish weighing more than fifteen or twenty

The tourist was André Pénicaut, and he visited Natchitoches three hundred

years ago. His journal reminds us that many of our "modern" fishing techniques were actually developed by **Indians** long ago. The Indi-

ans' methods of taking fish were as varied as they were ingenious and would be recognized by any fisherman

Hooks and lines were popular, with hooks being made from bone or deer antler and line from deer sinew. Archaeologists have found threethousand-year-old tearshaped polished stones with holes or grooves in the top that are believed to have been weights for nets or trot-

The Chitimacha of South Louisiana used wooden slat traps and gill and hoop nets. The latter were made from rabbit vine and were attached to round wooden frames and placed at the mouths of bayous.

The Chitimacha's favorite fishing technique was to swim underwater with small nets made from hemp. These nets were about three feet long and three feet in diameter, and had elastic green cane fixed on each side to serve as a spring.

A number of men lined abreast across a long pond and then swam underwater, keeping their net open in front of them by pulling the green cane back with both hands. The men stayed underwater until they either ran out of breath or their nets were full of fish. When the nets were full, they let go of the cane, and it sprang shut to close the opening.

One Frenchman who participated in this type of fishing wrote, "I have been engaged half a day at a time. . . and half drowned in the diversion—when any of us was so unfortunate as to catch water snakes in our sweep, and emptied them ashore, we had the ranting voice of our friendly posse comitatus, whooping against us, till another party was so unlucky as to meet with the like misfortune. During this exercise, the women are fishing ashore with coarse baskets, to catch the fish that escaped our nets."

Spearing fish with harpoons or bows and arrows was also quite effective, with Indians sometimes using torches to hunt at night. Harpoon shafts were usually made from ash, cypress or willow because they float. When a hit was made, the fish quickly tired from dragging the buoyant shaft across the surface and the fisherman could retrieve his harpoon in case of a miss. My Uncle Preston

Copeland told me stories of doing the same thing as a kid on Cornie Creek with a carbide lantern and gig. And several years ago, I accompanied Terry Crum and his Fort Necessity friends on a gar gigging expedition in the Mississippi River. Just like Indians of old, Crum and his friends hurled cypress-shafted harpoons at the gar and then retrieved them once the fish grew tired.

The Choctaw and other tribes sometimes made poison by pounding up buckeyes, green walnuts and hickory nuts and mixing it into the water. The poison affected the fish's gills and suffocated them. Once they floated to the top of the water, the Indians scooped them up by

Growing up in Winn Parish, I remember a number of people talking about using buckeyes to poison fish in Big Creek and Dugdemona River, but I never witnessed it per-

An alternate method to suffocating fish was to muddy the water by having people stomp through a shallow pool and stir up the thick bottom sediment. One Spanish explorer in Mississippi wrote that the Indians "roiled the water with the mud of the waters and the fish, as if stupefied would come to the surface, and they caught as

many as they wished. My mother recalled going to barrow pits near her Mississippi home during the Depression and using the same method to catch fish. Her father put on rubber boots and churned up the mud while she and her siblings scooped up the small bream that came to the sur-

When it comes to fishing, there's truly nothing new under the sun.

Tiger big men get drafted



BATON ROUGE - For the 14th time in LSU Basketball history, a player was chosen in the first round of the National Basketball Association draft as Jarell Martin of Baton Rouge was selected by the Memphis

It was Memphis' only pick of the two-round event.

LSU missed out on having two players taken in the first round for the first time in the history of the program. But when Jordan Mickey of Dallas was taken with the 33rd pick of the draft, the third of the second round, it marked the first time that LSU had two players taken in the draft since 2000. That year Stromile Swift was taken in the first round and Jabari Smith in the second round.

While Martin watched the draft at a local restaurant in Baton Rouge, Mickey was in the stands for the draft and did walk across the stage.

Martin, who played two years at LSU, averaged 16.9 points per game and 9.2 rebounds (both third in the Southeastern Conference) and shot 50.9 percent from the field (202-397, 4th in the league). He made a team best 140 free throws and had 15 double doubles while earning first-team All-SEC honors and was an honorable mention All-American selection.

Mickey, who also left after his sophomore season, averaged 15.4 points per game and 9.9 rebounds per game. He led the nation in block average at 3.64 blocks per game and shot 50.4 percent. He posted 16 double doubles, 25 for his career as he earned first-team All-SEC honors and was named a finalist for national Defensive Player of the Year.

"I was very nervous, my heart was pounding and for me to get my name called was a big relief for me," Martin told the media in Baton Rouge. "It was a blessing for me to have my family around me. They were the ones that were around me when I was growing up, so it was great for me to come back home and share this experience with

Martin did visit Memphis during his workout trips and liked what he saw.

"When I went up to Memphis, I loved it because it reminded me of here -- Baton Rouge," he said. "The atmosphere around there reminds me of home, so it's going to be my home away from home."

Asked what he hoped to bring to the Grizzlies, Martin commented, "A lot of hard work and effort. I'm a guy that's going to go out there and play hard the whole entire time being out there. Also my versatility, I can attack the basket and knock down shots and create plays for the players around

There were a few media reports that the Grizzlies had told Martin they would pick him at No. 25.

"They said they were going to pick me at (No.) 25, but this draft got a little crazy unexpectedly. So it was pretty nervous for me and I was scared, but they wound up picking me, Martin said.

Through it all, Martin was his normal, calm self. "I'm very excited on the inside, I'm just trying not to let it show on the outside. I don't want to get emotional and cry or anything, but I'm very excited."

Towns taken first overall

NEW YORK (AP) — Minnesota Timberwolves got their man in the middle. The Lakers got a playmaking partner for Kobe Bryant.

Knicks fans just got mad — though not for

Minnesota selected Kentucky's Karl-Anthony Towns with the first pick in the NBA draft on Thursday night, the first of three straight freshmen chosen before New York chose Latvian forward Kristaps Porzingis, triggering loud, long boos from their fans inside Barclays

They were cheering later in the first round Knicks the acquired the rights to Notre Dame guard Jerian Grant from Atlanta for Tim Hardaway Jr.

Before that, Timberwolves went for a center in their first time owning the No. 1 pick. They can add him to a young roster featuring Rookie of the Year Andrew Wiggins, who was picked first last year by Cleveland and later dealt to Minnesota in the Kevin Love trade.

Towns' selection was-

n't a surprise — though he had above 50 family he said he didn't know until it was announced.

"When Mr. Adam Silver came out, I saw him, and he said, 'With the No. 1 pick', I was racing," said Towns, who was sitting with Kentucky coach John

"I told Coach Cal before when he first came out that I was trying to drink the water and I was shaking uncontrollably, and I told him, 'Coach, don't give me the ball right now for the last-second shot. wouldn't make it."

The Los Angeles Lakers then took guard D'Angelo Russell of Ohio State, who was wearing a scarlet jacket, bowtie and shoes that matched the Buckeyes' school colors.

Red — or some shade of it — was the color of choice in the green room, though Towns wore a grey jacket and Russell's table later turned gold when his supporters donned Lakers hats.

He drew huge cheers when he was announced but his crowd was dwarfed by Towns'. The New Jersey native said

"This is home to me," he said. "Been able to come here and have all my closest friends and love ones come out here. It's the most special moments in my life."

The 6-foot-11 Towns averaged 10.3 points and 6.7 rebounds in just 21 minutes per game, as Kentucky used a platoon system in winning its first 38 games and reaching the Final Four.

It was Kentucky's third No. 1 pick in the last six years, joining Anthony Davis in 2012 and John Wall in 2010. The Wildcats were hoping to have a record seven players picked and were well on their way when Sacramento took center Willie Cauley-Stein with the sixth pick, Utah grabbed Trey Lyles at No. 12 and guard Devin Booker followed one spot later to Phoenix.

Booker, at 18 the youngest player in the draft, gave the Wildcats a record-tying four players among the top 14 selections. Duke in 1999 and North Carolina in 2005 also had four lottery picks.



Univision dropping Miss USA pageant over Trump comments

Univision is dropping the Miss USA pageant and says it will cut all business ties with Donald Trump in a spiraling controversy over comments the Republican presidential candidate made recently about Mexican immigrants.

The company said

Thursday it would pull the plug on its Spanish-language coverage of the pageant July 12 by its UniMas network. It also has severed its business relationship with the Miss Universe Organization, which produces the Miss USA pageant, due to what it called "insulting remarks about Mexican immigrants" by Trump, a part owner of Miss Universe. During his presidential

campaign kickoff speech last week, Trump accused Latino immigrants of bringing drugs, crime and rapists to the U.S. He called for building a wall along the southern border of the

interview an Thursday, Trump said his criticism was directed against U.S. policymakers, not the Mexican people or government, adding that Univision would defaulting on its contract if it doesn't air the pageant and he would take legal

"At Univision, we see firsthand the work ethic, love for family, strong religious values and the important role Mexican immigrants and MexicanYork-based Communications Inc.

Both cohosts also pulled out of the show Thursday, while Colombian singer J Balvin on Wednesday canceled a planned performance on the pageant.

NBC is scheduled to go forward with its own airing of the pageant, as it has done since 2003.

Trump said Univision is submitting to pressure from Mexican leaders to punish him for positions he voices as a candidate on the campaign trail.

"They don't want me saying that Mexico is killing the United States in trade and killing the United States at the bor-Trump der," "Univision is totally laying down for the Mexican government. ... They want to silence Donald Trump. And Donald Trump can't be silenced. ... I have great respect for Mexico and I love the Mexican people, but my loyalty is to the United States.'

Univision declined to comment on Trump's remarks.

In severing her ties with the show, Puerto Rican actress Roselyn Sanchez, one of the two cohosts, cited Trump's comments.



La. farmers brace for worst year since 2008

NEW ORLEANS —
Flooded fields and fickle
temperatures put
Louisiana farmers and
ranchers in a pensive
mood as they gathered
here Thursday for the Farm

mood as they gathered here Thursday for the Farm Bureau Federation Convention, the state's largest annual celebration of agriculture.

"I'm afraid this year is a

nail-biter and a pennypincher," said Franklin Parish row crop farmer Adam Faulk, one of as many as 2,000 producers here

Cold temperatures and wet weather decimated the winter wheat crop and delayed planting for corn and other crops in the northeastern Louisiana Delta and Acadiana.

That was followed by ferocious flooding that began when the Red River left its banks in northwestern Louisiana and created a muddy tsunami that rolled through central Louisiana.

Combine the weather with plummeting commodity prices and the lin-

gering threat of bird flu facing poultry producers and Louisiana farmers and ranchers face their most uncertain year since the hurricanes of 2008.

"It started in North Louisiana and rolled its way down," said Evangeline Parish's Richard Fonentot, who grows rice, soybeans and crawfish. "We could all be in a pickle before this year is over."

"This is one of the scariest years we've face in a long time," said Caddo Parish beef cattle rancher Marty Wooldridge, who saw the Red flood 500 acres of his grazing pasture land and 200 acres of hay meadows.

This uncertain summer follows a six-year period described by Agriculture Commissioner Mike Strain as the Golden Age of Louisiana Agriculture, where producers enjoyed bumper crops, high prices or a rare combination of both.

Agriculture's economic impact in Louisiana was \$12.7 billion last year, the

third straight record.

Strain said 2015 reminds him of 2008, his first year as the state's elected agriculture commissioner.

"We had Tropical Storm Faye and Hurricanes Gustav and Ike in 2008," he said. "Like we did then, we're going to put on a full court press to stand our farmers back up."

Strain said he is working with the state's federal delegation to secure a disaster declaration as well as a supplemental appropriation to assist Louisiana producers.

"The flooding in northwestern and central Louisiana has been very damaging to pasture land and row crops and forced some ranchers to sell their herds because they had no place to put them," Strain said.

"The cold and wet winter and spring is going to affect yields in northeastern Louisiana and Acadiana, and of course we had major losses with the wheat harvest," he said.

"And we're doing all we can to protect the poultry crop from the bird flu."

James Wagley, who grows chickens for Pilgrim's Pride in Natchitoches Parish, called the threat of bird flu "our biggest concern by far."

"If one house is infected, every bird in a six-mile circle has to be killed," Wagley said. "We have to do everything we can to ensure bio security at our houses."

And Wooldridge, who also produces hay for his herds and to sell to other ranchers, still has a wary eye cast toward the Red, which is predicted to crest above flood stage again Wednesday.

"We can't move our cattle back until we see what happens with the crest," he said.

And the heart of hurricane season is still ahead.

"Don't even mention that," Woodridge said. "Don't even mention it."

Suzie Moseley, case manager for north and central Louisiana says they deal with a lot of veterans seeking mental health services.

Many veterans come

home from overseas suffering from post-traumatic stress disorder and many times, she says, there are other issues connected to that such as substance abuse. Suicide rates are higher among veterans than any other demographic, she says. VOA, a nationwide

VOA, a nationwide organization founded in 1896 in New York City, offers an array of services for veterans regarding their health care, housing, job retention and others.

Another service offered is Veterans Treatment Court, where veterans diagnosed with substance abuse and accused of nonviolent crimes to work out their sentence through treatment, counseling and community service while being monitored by the court.

To clarify, Jowell says, all these services are available to both peacetime and

combat veterans. Moseley says as long as they have their DD214 and have separated from the armed forces with anything other than a dishonorable discharge, then they are eligible for services.

When VOA was original-

ly formed, they offered a shelter for women and children and offered adoption services until the 1990s, says Jowell. VOA reached north Louisiana in 1935.

"A lot of our services were adoption services,"

Jowell said. "We no longer do adoption services, because just as time keeps going, the needs of the community change. Today, we focus really on four primary areas: children and families, senior adults, people with disabilities,

and veterans."

Veterans' services began in 2010.
