## School bells ring tomorrow

### Superintendent expects smooth start to school year

As school begins Wednesday, there a few things parents need to be aware of and some things that will help their chil-

dren get through school more smoothly.

Webster Parish Superintendent of Schools Dr. Dan Rawls says the start to the 2015-16 school year will be relatively quiet, but he's looking forward to another great year.

With the education system in limbo right now, he says they will continue to move forward as they did last year. Students who will test this year will take a PARCC-like test, he said, but it will not be the Partnership for



## Germantown museum to open 3 days a week

The hours of operation for the Germantown Colony Museum will return to its past schedule of operations, says Lynn Dorsey, executive director for the Webster Parish Convention and Visitors Bureau.

The museum's newly constructed welcome center will be open from 10 a.m. until 3 p.m. Thursday through Saturday.

Due to budget shortages prior to

the end of the state's 2014-15 fiscal year, Secretary of State Tom Schedler was forced to restrict the hours of operations of museums under the department's management across the state to one day per week.

Now that the state's new fiscal year has begun, the museums have returned to their previous scheduled hours of operation.

The new visitor center houses

exhibits of historical artifacts, a gift shop and handicapped-accessible, public restrooms.

## Louisiana Offshore Oil Port storage center getting bigger

**PORT FOURCHON** — The Louisiana Offshore Oil Port is adding three new above-ground oil tanks and 1.1 million barrels of storage capacity to its Clovelly Hub, one of the nation's largest oil trading and distribution centers.

The Advocate reports the new tanks will increase Clovelly's above-ground storage to 10.1 million barrels. LOOP also has 60 million barrels of underground storage.

Terry Coleman,

LOOP's vice president of business development, says the project is estimated to cost more than \$25 million and is set to be finished by late next summer.

The hub receives domestic and international crude by ships and pipelines, temporarily storing the oil before sending it on to U.S. refineries. The Clovelly Hub receives oil from wells in Texas, the Gulf of Mexico and the U.S. mid-

being tweaked. That's significant, because there will be a significant amount of changes from K through 12."

For high schoolers, Minden High School principal Robin Tucker says they will be offering the same incentives they did last year before ACT testing.

"This program was a huge success last year and more and more students are taking the ACT sooner and more frequently," she said in an email to the Press-Herald. "Funding for this program has been through monthly Sonic nights, donations, Brook-

shire's, and Johnny's pizza nights. We look forward to another great year of recognizing our students for the academic achievements."

She says they will continue to offer dual enrollment courses, which will allow students to earn college credit while still in high school. Some of those courses include Algebra III, psychology, American History and World History.

Everything else will stay the same, she said.

"We're just going to try to manage the heat as best we can, and we're looking forward to another great year," she said.

The Webster Parish Library will also be offering an array of resources for students to do their home-

work, study and keep up their skills. Jennifer Heard, children's coordinator, says they are offering some new ways to help children learn.

"We've always had the computers here in the children's department where they can get on and do their homework," she said. "We've got a new iPad kiosk with learning games that's specifically for younger children. It's got three iPads and there's 25 different apps on each tablet for the little ones to learn spelling, counting and that sort of thing."

Started a few years ago, but just now picking up steam, Heard says, is the Accelerated Reader program where the library puts the AR book level and point levels on all the books in the children's department and the young adult.

"It's automatically in the AR book find website," she said. "This is what they use to determine whether they can take the test in Webster. That's making it a little bit easier on the parents and the kids too."

They still have the reference materials (encyclope-

dias, magazines, etc.) for those who still want to physically put their hands on a book, she said.

Trelana Martin, who works with the teens, says while they offer access to many of the same resource materials, they also focus on making it fun for students to read. They, like the children's department, offer a monthly book club where students will vote on a book to read. They are given a month to read it, and they return to the next book club meeting to discuss it.

"Since they're so busy

with school and extracurricular activities, they're not going to have time to read a book in a week or so," she said. "We give them a whole month to read the book, and then we come in and have a two-hour get together where we talk about it, ask questions and have a good time."

## Gun lies

My town, New York City, enforces rigid gun laws. Police refused to assign me a gun permit. The law doesn't even let me hold a fake gun on TV to demonstrate something.

But New York politicians are so eager to vilify gun ownership that they granted an exception to the anti-gun group States United to Prevent Gun Violence. New York allowed States United to set up a fake gun store, where cameras filmed potential gun customers being spoofed by an actor pretending to be a gun-seller.

"This a nine-millimeter semi-automatic. It's a very handy gun. It's easy to use," he says.

"You can carry it in a purse like that gal from Wal-Mart. Her two-year-old son reaches into her pocket-book, pulls it out, shoots her. Dead, gone, no Mom!"

States United then made that footage into an anti-gun public service announcement. "Over 60 percent of Americans think owning a gun will make them safer. In fact, owning a gun increases the risk of homicide, suicide and unintentional death," says the video.

It's a powerful message. But it's a lie, says John Lott of the Crime Prevention Research Center. He says that gun control advocates lie all the time.

Lott acknowledges the tragedies. Sometimes a gun in the home is used in a homicide or suicide, or leads to accidental death, but he

adds, "It also makes it easier for people to defend themselves — women and the elderly in particular."

Lott says, "Every place in the world that's tried to ban guns ... has seen big increases in murder rates. You'd think at least one time, some place, when they banned guns, murder rates would go down. But that hasn't been the case."

I pushed back: what about people harming themselves?

"There are lots of different ways for people to commit suicide," Lott said, and researchers have looked at how those tragedies are affected by access to guns. "We find that people commit suicide in other ways if they don't have guns."

What about accidents? Lott replies that accidental shooting deaths are relatively rare: "about 500 a year." That sounds bad, but about 400 Americans are killed by overdosing on acetaminophen each year (most of them suicides), and almost as many Americans drown in swimming pools.

"It would be nice if it was zero (but) consider that 120 million Americans own guns," Lott says.

Often those guns are used to prevent crime. The homeowner pulls out the gun and the attacker flees. No one knows how often this happens because these prevented crimes don't become news and don't get reported to the government, but an estimate from the Violence Policy Center suggests crimes may be prevented by guns tens of thousands of times per year.

Add politics to the mix and the anti-gun statistics get even more misleading. Gang members in their late teens or early adulthood killing each other get called "chil-

dren." Fights between gangs near schools get called school "mass shootings."

The number of mass shootings in America has been roughly level over the past 40 years, but the New York Times still runs headlines like, "FBI Confirms a Sharp Rise in Mass Shootings Since 2000." That headline is absolutely true, but only because they deceitfully picked the year 2000 as their start point, and that was a year with unusually few mass shootings. It's as if the paper wants to make it seem as if mass shootings are always on the rise, even as crime keeps going down.

It all helps stoke paranoia about guns. Some people respond by calling for more controls. Others, fearing the government may ban gun sales, respond by buying more weapons. The number of people holding permits to carry concealed weapons has skyrocketed to 12.8 million, up from 4.6 million just before President Obama took office. Since 40 percent of American households now own guns, anyone who wants to take them away will have a fight on his hands.

Has the increased gun ownership and carrying of guns led to more violence? Not at all. "Violent crime across the board has plummeted," says Lott. "In 1991, the murder rate was about 9.8 (people) per 100,000. (Now) it's down to about 4.2."

I can't convince my friends in New York City, but it's just a fact: More guns — less crime.

## Times-Picayune, on the new University Medical Center in New Orleans

It seemed at times that construction on the new University Medical Center to replace Charity Hospital post-Katrina would never begin. And then it seemed it would never end. But, at last, the building is done.

Twenty-eight days shy of the 10th anniversary of Hurricane Katrina and the levee breaches that flooded New Orleans in 2005, patients were transferred into the \$1.1 billion, state-of-the-art medical center.

Unlike the glitches, disagreements and delays over the past decade, move-in day went flawlessly.

The move started at 6 a.m. Saturday (Aug. 1), and the last of 131 patients had been transferred from LSU Interim Hospital into University Medical Center before 1:30 p.m.

Juara Wilson, of Baton Rouge, was the first patient to be taken to a new room. Ms. Wilson, who was diagnosed with lymphoma in October, had spent long hours at the interim hospital. "I thought I was in another continent," she said after the move. She even got a bouquet of flowers from the medical center staff.

"I was at a loss for words," she said. "I really felt like a queen."

Rachel Alcina, of Kenner, was the second patient moved into one of the medical center's high-tech beds — which are programmed with hundreds of languages.

Ms. Alcina is in remission from breast cancer and recently underwent reconstructive surgery. Everything about the new room was an improvement, she said — from the rolling cart beside her bed to the extra space for family members.

"Everything is so soft, like the textures — which doesn't have a lot to do with the medical (care). But ... it makes you feel better," she said.

That isn't how you typically hear a hospital described. But this one has the look of a boutique hotel.

"We wanted it to feel not like a hospital," Mackenzie Skene, an architect at NBBJ, said earlier this summer. "You want a hospital that doesn't assault your senses, strip your privacy."

Of course, this is a hospital — one covering 2.3 million square feet. It has 446 patient beds, 60 of those for people with mental health issues, and is the only Level One Trauma Center in the region. It is staffed by 2,000 employees, including 600 physicians, and is equipped with cutting-edge technology.

Images from operating rooms can be transmitted to classrooms throughout the complex. Interoperative imaging equipment will allow surgeons to order MRIs during surgery.

Having a 21st century teaching hospital in the heart of New Orleans is important to the city's ongoing recovery post-Katrina. In addition to training new doctors, the medical center is a key component of a biomedical corridor in Mid-City that is expected to be an economic engine for the city. The other integral piece is the Southeast Louisiana Veterans Health Care System complex, which is under construction nearby. The new VA hospital is scheduled to open in 2016.

The hope is that other health care and research facilities will fill out that part of the city and produce high-paying jobs.

The opening of the medical center — which is formally named the Rev. Avery C. Alexander Academic Research Hospital — is an important moment. But it will take a while to grow into its full role.

Initially, the hospital will use 250 of its 446 beds. Officials will work to fill the others over time. The hope is that top-notch facilities and medical care will draw patients from outside the region, as MD Anderson Cancer Center in Houston and University Hospital in Birmingham do.

That will require balance, though, because University Medical Center still has a mission to care for our community's indigent patients — as Charity Hospital did for so many years.

How successful the new hospital and the bio-medical corridor become will play out over time. But the long wait for the doors to open is over, and that is a positive sign for New Orleans' recovery.

## Healthy ways to handle stress

Stress affects people of all ages. The symptoms of stress can be extremely unpleasant, as participants in a study released earlier this year by the Statistic Brain Research Institute and the American Institute of Stress who reported experiencing physical symptoms of stress admitted to feeling fatigue, headache, upset stomach, and muscle tension, among other things.

Among those who reported feeling physical symptoms of stress, 77 percent admitted to feeling those symptoms regularly, citing job pressure and money as the primary causes of their stress. How men and women handle stress can impact both their immediate and long-term health, as stress has been linked to a host of problems and ailments, including sleep dysfunction and heart disease. Many people cope with stress in unhealthy ways, which may only exacerbate the effects of stress on the body. Certain methods of handling stress may work for some people but not others, but the following are a few healthy ways to combat stress.

- Limit alcohol and caffeine consumption. Many adults turn to alcohol at the end of a stressful day, but the Centers for Disease Control and Prevention note that relying on alcohol to cope with stress may only create more problems down the road, and those problems will only increase your stress levels. In addition, the Anxiety and Depression Association of America notes that alcohol and caffeine can aggravate anxiety and trigger panic attacks.

- Rely on a support network. Coworkers, family and friends have stressful days, too, and such confidantes can help

you handle stress in healthy ways. The ADAA recommends men and women dealing with stress let their support circle know how they can help relieve stress. Many people simply need to talk to someone after a stressful day, which can feel like a weight has been lifted off their shoulders. Let your support network know you're there for them when they experience stress as well.

- Get daily exercise. Exercise pays a host of dividends, not the least of which is relieving stress. At the end of a stressful day, get some exercise instead of pouring yourself a drink or indulging in an unhealthy meal. When the body is physically active, the brain secretes endorphins, which are neurotransmitters that make you feel good. Regular exercise also helps you get a fuller, deeper sleep, which can be disrupted by stress.

- Eat a healthy diet. Diet also can affect how your body handles stress. Certain foods can tame stress. For example, oatmeal can boost levels of a calming chemical known as serotonin in your brain. That calming effect can make it easier to cope with stress. Other foods may help strengthen the immune system. Vitamin C, for instance, may help curb levels of stress hormones such as cortisol while simultaneously strengthening the immune system. Omega-3 fatty acids, which are found in fish such as salmon and tuna, may help prevent surges in stress hormones while also protecting against heart disease and depression, two serious conditions that studies have linked to elevated stress levels.

Healthy ways to handle stress can help men and women who are stressed out ensure that stress is not compromising both their immediate and long-term health.

# Bulldogs back to work

RUSTON – The heat may have pushed the first practice starting time back a few hours but that didn't deter Louisiana Tech's players from showcasing enthusiasm for returning to the practice fields as the Bulldogs held their first fall camp practice Monday evening.

The practice was split into two sections with work taking place on the practice fields to start then the team wrapping up under the lights and on the new FieldTurf at Joe Aillet Stadium.

Originally scheduled at 3:30 p.m., the start time was pushed back to 7 p.m. due to the excessive heat North Louisiana is currently experiencing (Ruston experienced a high temperature of 105 degrees Monday). That didn't slow down any of the players.

"I think we've got a lot of talent out there that can run and that was really obvious," head coach Skip Holtz said in a press conference after Monday's practice. "When you are in shorts, it's pass skell, there's no any hitting and there's no offensive line you can get in a little false deal (security) but I thought

we had some guys that can run around and some guys that did some good things out there."

Monday's practice began fall camp practices after the Bulldogs reported to campus Sunday. The speed shown on the field impressed several members of the coaching staff that were already excited to return to the practice fields.

"In my opinion – and this isn't just blowing smoke or coach speak – I think we have one of the best strength coaches, if not the best strength staff, in America," defensive coordinator Blake Baker said. "We were just talking about it as a staff in the locker room, on both sides of the ball. If we can put this together in 27 days with the speed we play with – and not everything was perfect – but with the speed and strength of our guys, my hat is off to the strength staff. They did a phenomenal job."

While Holtz was excit-

ed about the speed many of the newer players displayed in practice, he was cautious as to how that would translate into on the field throughout camp or in a game.

"I like the way some of the receivers run," Holtz said. "Jaqwis Dancy had some great speed. But how are they going to play when they put on pads? It is still way too early to tell. I am going to hold my reservations because I have tried to make early calls in the past and it is normally the guys you don't like in shorts but you love in pads. We are not going to a seven-on-seven tournament, we are going to a football game. We are going to have to find out who is ready to put on the pads and play at this level and who's got the toughness it is going to take."

The later start time with the cooler – at least by comparison – weather may have helped the team keep an upbeat tempo throughout Monday's practice session, but it is still early in a rigorous camp that will define the 2015 Louisiana Tech Football team.

"I certainly think that helped the tempo and

mindset and the way they are working right now," Holtz said of the later start with less oppressive temperatures. "We'll learn about this football team as they go. They were out there and had a lot of energy, a lot of passion, flying around and running around. We'll find out where we are when we hit day five or six and start putting on pads. That's when you really start to find out what kind of character your football team has

and what type of team you are going to have for the course of the season. I like what I saw but it is still early on day one."

That character Holtz alluded to will be one that defines whether the Bulldogs can return this fall and take care of what Holtz has often described as "unfinished business" from a handful of games last fall, most notably against Marshall in the Conference USA Championship Game.

The drive to return to

the league's title game and claim a conference championship begins on Sept. 5 when the Bulldogs host Southern in the newly expanded Joe Aillet Stadium. Roy Stapp is an energetic businessman in the north Louisiana area. He has been successful in a variety of ventures but the one upon which he is currently embarking has him more than excited. August 1 was opening day of his Sportsman's Paradise Consignment Shop.

"I have a friend in Columbia, SC who opened a similar business there a couple of years ago and he has been stunned at the response of outdoors-minded folks in that community. He realized there were lots of sportsmen who needed a place to sell outdoor gear they no longer wanted or needed and has been overwhelmed with the response. I firmly believe that with all the hunters

and anglers in this area, the same concept would work right here in our part of the country," Stapp said.

The doors of Sportsman's Paradise Consignment opened Saturday August 1 and even with very little publicity initially, scores of people visited the store last Saturday looking for gear to buy.

"We didn't have anything for them to purchase on the day we opened but this reinforced my conviction that once we have it for sale, people will come in to make purchases that will save them money. What we need right now is for people to bring us materials that we can sell for them," Stapp added.

The outdoor gear consignment idea differs from other such outlets like thrift stores, pawn shops or on-line sales outlets such as E-Bay.

"Thrift store sell lots of supplies but they're in operation by way of citizens donating items for the purpose of raising funds for charitable organizations. At our store, "Stapp said, "someone wishing to bring us their gear to sell will be making money they can pocket rather than simply donating it."

When you think of what can be brought to the store and placed on consignment, the possi-

bilities are endless.

"A hunter or fishermen needing to upgrade his hunting or fishing gear can bring what they have here for us to sell for them and use the money they make to purchase new gear. Think of what you have in your closet of garage you no longer need; hunting clothing you outgrew, things like tents, canteens, knives, Boy Scout and Cub Scout uniforms, rods and reels – the possibilities are endless.

"We're in the process of obtaining our Federal Firearms License (FFL) and once we've been approved, we can take

guns on consignment. Also," Stapp continued, "we're looking for high-end gear. We don't want things purchased at discount outlets but are interested in brand names like Scent Loc, Mossy Oak, Under Armor, Columbia and in the fishing department, brand named reels such as Abu Garcia and Shimano. We want whoever purchases the gear you consign to us to be pleased knowing they've bought a top quality product."

Sportsman's Paradise Consignment is conveniently located at 4707 Cypress St. in W. Monroe and is located halfway between Well Road and Downing Pines exits off I-20. The building is newly renovated, is spa-

cious and air conditioned with highly visible signs out front making the building easy to locate. Phone number is 318/389-1001.

"One other thing we'll be doing is in case folks have gear they wish to consign with proceeds going to a charitable organization such as their church, we'll be able to make the check out to whomever they choose," Stapp said.

"I am convicted that people want to have a place to sell their outdoor equipment and clothing they no longer need and," said Stapp, "we feel we can offer them that."

# Trump defends comments on Fox News anchor

WASHINGTON — Donald Trump said Monday he never intended to say anything inappropriate about Fox News Channel's Megyn Kelly and said the uproar over his criticism is "all fueled by the press."

"This wasn't meant to be much of an insult," the billionaire real estate executive and Republican presidential candidate said in a telephone interview with NBC's "Today" show. In his remarks, Trump again tried to clarify what he had said about Kelly, one of the moderators of last week's presidential debate.

During the debate, Kelly asked the Republican candidate about negative statements he's made in the past about women. Trump was angered by the line of questioning and later told CNN that Kelly had "blood coming out of her eyes, blood coming out of her wherever."

Trump said in the Monday interview that he didn't get to complete his description about how he thought Kelly was being so angry toward him. But he did say, "She asked me a question that was nasty and I gave her a pretty tough answer."

Addressing comments he made last Friday in an interview on CNN, Trump said, "I said she was so angry that blood was coming out of her eyes. I said blood was coming out of her ... and I didn't even finish it."

Trump has been digging in his heels since last Thursday's nationally broadcast Fox News debate as his rivals work to navigate a GOP presidential primary campaign that has been dominated by reaction to one of his bellicose statements after the next.

He said the other candidates benefited from his presence last Thursday.

"They had 24 million people watching," Trump said. "If I wasn't on the show, they would have had 2 million." Trump gave a series of phoned-in television interviews Sunday responding to the latest controversy surrounding his campaign.

This time Trump, who has made inflammatory statements against Mexicans crossing the border illegally and Vietnam War veteran Sen. John McCain, R-Ariz., was under fire for his CNN remarks.

Kelly had questioned Trump's history of insults directed at



women and whether that kind of language would perpetuate the idea of a Republican "war on women."

Trump, who has enjoyed an early lead in the polls, refused to apologize for the remark Sunday, and said that only a "deviant" would have thought he'd intended the word "wherever" to mean anything other than her

ears or her nose.

"I apologize when I'm wrong. But I haven't been wrong. I mean, I said nothing wrong," Trump told NBC's "Meet the Press."

He also declared that he would be a wonderful president for women, despite his history of sexist remarks.

"I'm very much into the

whole thing of helping people and helping women," he said on CBS's "Face the Nation." "Women's health issues are such a big thing to me and so important."

Trump's remarks resulted in him being disinvited from a major conservative gathering and also earned criticism from several of his rivals, including


former Hewlett-Packard CEO Carly Fiorina, who said that Trump's comments were "completely inappropriate and offensive."

Trump's campaign is currently in the middle of a shakeup after having parted ways with Trump's longtime adviser Roger Stone.




