Couple gets arrested after barging in residence, stealing couch, and damaging property

Last week Webster Parish Sheriff Deputies were dispatched in response to a disturbance taking place along the 500 block of Main Street in Doyline. Upon their arrival, they made contact with the complainant, who stated that two individuals, Richard Shirey, 42, and Cindy Burham, came into his residence, stole a couch, and damaged the property in the process.

"[The complainant] stated Richard Shirey Cindy Burham (Richard's Girlfriend) came into their home without permission to get a couch that Richard's ex-wife asked him to get for her. Tina used to live in the house, but she has not lived in the house or paid rent in several months."

So essentially, the exwife of Shirey requested that he get a couch from a residence in which she no longer lived, and brought along his girlfriend to aid in the pro-

According booking report, "[The complainant] said he heard a knock at the door, when he began to open the door, Richard and Cindy barged into the residence without permission. [The complainant] stated Richard was obviously intoxicated and threatening him, all while flipping the couches over and throwing items around in the residence."

As Richard was taking the couch out of the residence, "[he] put several holes in the walls with the feet of the couch as he was trying to hurry and get them outside."

After a written statement and signed complaint affidavits were submitted, the complainant filed charges against Shirey and Burham. After being located they were placed under arrest for the charges of unauthorized entry into an inhabited dwelling, with Shirey receiving the additional charges of simple criminal damage to property and disturbing the peace through public intoxication.

This Saturday, Seafood Empire and Geaux Fresh are collaborating to bring a one of a kind event to Downtown Minden called Brunch & Brushes. The event itself will feature an array of unique dishes combining the expertise of restaurant owners Buddy Myles and Jodie Martin, as well as a community mural where anyone can pick up a brush and help contribute to brighten up the downtown area.

The event will take place this Saturday, Oct. 16, from 9 AM to 1 PM.

Speaking about the origins of the event, Martin said, "A group of us met and were talking one night about community unity, all kind of strategizing about things that bring people together." As a chef, one particular thing came to Martin's mind, food.

She went on to say that the Minden Foundation and other community members had already been planning a mural across the street of Geaux Fresh, and Martin herself was planning on having one painted on the side of her building as well. "So it kind of all fell into place like that," said Martin.

"Buddy, Coach Mike Dick, and I all worked together to come up with the recipes, to incorporate both restaurants. It was really fun to work with him and his wife when we were running on the trials," said Martin.

"What Myles stated, we've done is create collaborative dishes to bring

together some of her and my cuisine, to put out some good food together."

They went into detail about some of the unique dishes that were specially made for Brunch & Brushes.

The first being what they call a Cajun Pileup. It comes with a base of a made from scratch savory waffle, boudin and andouille sausages on it with eggs and Seafood Empire's signature crawfish cheese sauce, with

They will also be making some specialty Shrimp & Grits. "Myles has a signature blend that he uses for blackening shrimps, so it will have blackened shrimp over a two cheese grit with bacon, eggs, and green onion on top."

For those with more of a sweet tooth, there will

also be a Funfetti Stack, which will be house made funfetti stacked waffles with fresh whip cream and a white chocolate and strawberries. They will also have a Donut Shortcake Shortstack. "Donuts filled with whip cream and sugar strawberries. So a decadent way to eat a donut," said

Myles and Martin also wanted to thank Minden Foundation, Rachel and Patirck Miller, Jennifer Heard, and Coach Mike Dick for helping to make this event possible.

"I'm glad there are still people who want to be together and show togetherness," said Myles. "People who come together in these times show that we can work together and make things happen. Even though we're not in the best place as far as the city, this is a way for people in the community to show we are together, no matter what goes on. It's a way to spread positivity and spread love in the community."

"I think it's a great opportunity. Food always makes people happy, music makes people happy, so I think when you do that it creates an environment for comradery, for unity. It creates an opportunity for people to work alongside each other and be nice to each other," said Martin.

"I just think those are really good opportunities in the midst of everything that's going on, if you can focus on something positive, it helps your overall morale, and it's good for the city, good for the town to do something happy."



### Preparing for normal life in our schools again

Concerns were raised in state government circles when state Superintendent of Education Cade Brumley provided an added local option to choices on managing COVID quarantines in our schools. This opinion piece is not written to advocate for or against this option but to have us think about the major question generated by the option

question in this epidemic in our state is "When does the epidemic end and how does it

The end will not be eradication of the virus. Any strategy based on this goal is doomed to failure. Instead, the goal is to stop the epidemic by managing the disease. Safe and effective vaccines, considerable natural

immunity, and very promising therapeutics are having an impact. This virus will likely not be the dominant force in our lives too much longer.

The proposed option was to reconsider the benefits and risks of one of the mitigation strategies in our schools. Since each of these mitigation strategies brings with it significant disruption and unintended consequences, considering reversal of restrictions is just as important as the initiation of restrictions. Since the natural history of viral surges is predictable, we should be dialing masks, quarantines, and social distancing up and down depending on the viral load of the local community.

There are things we should

always do. We should always encourage vaccines in adults, especially in the older, overweight, immunocompromised, or pregnant. We should continue to invest in research in new therapeutics. We should make an effort to develop an Operation Warp Speed for therapeutics. And we should make sure we don't make the same mistake again of economic lockdowns and closure of schools for in school learning.

Dr. Brumley's option exposed for discussion the principle that solutions are usually best developed by the people closest to the concerns. In this COVID epidemic, the decision-making has predominantly gone to federal and state governments - putting global

decision-making in the hands of just a few. Whether we agree or not with Superintendent Brumley's quarantine option, there is something to say for local accountability and local decision-making beyond state emergency status.

No matter what happens with Superintendent Brumley's local option consideration, we need to be preparing to roll back quarantines, social distancing, and masking mandates in schools as the viral surge continues to abate. We need to do it in a stepwise fashion as proposed in Superintendent Brumley's option and we need to start as soon as possible and complete it also as soon as possible. If a new variant emerges, we can mask up again. But in the meantime we need to get our schools, our economy, and our communities back on track.

### Quick thoughts on the electric car mileage pilot program

Tucked within the infrastructure bill is an interesting pilot program - but one that does, ultimately, make sense.

However, stacking it within a bloated bill that is being steamrolled through congress (and also being held hostage by President Joe Biden and the debt ceiling versus budget fiasco) isn't a good look at all for democrats who have - roughly - \$5 trillion on the line between budget and infrastructure spending.

The program itself being touted as a 'new tax' on the number of miles an individual drives. Unfortunately **DAVID** most

people who'd like to torpedo the bill, that's not accurate. The pilot program is an opt-in agency which allows certain counties across the country to expirement with a cost-permile tax on electric vehicles.

The purpose? To through just how many electric cars are currently on the road, how many miles they drive, and what tax rate would be fair to make sure that infrastructure funding could remain intact.

For those who are confused

by the premise, for most states a gas tax funds infrastructure needs. Here in Louisiana, we are no strangers to the gas tax and infrastructure woes. In fact, there's some really appropriate data that would suggest Louisiana might want to participate (should the legislation be passed) because the Bayou is very, very behind in infrastructure funding - to the tune of \$2 billion (if including mega projects, not maintenance).

With vehicles being required (both legislatively and in the market) to be more fuel efficient, and gas taxes clearly not going the distance - at least in Louisiana - the program seems to remove the economic principle of 'free riders' - meaning those who drive electric vehicles are, to a certain degree, doing so freely without fair contribution to infrastructure projects.

But, as with most things political these days, the program has been mahred by controver-

sy - most of which is the democrats who proposed it own doing.

Why was something so important wedged into a controversial bill? What's in the language they don't want you to know? Why is there an 'allor-nothing' approach from the White House?

Most importantly - why does the US still deal in omnibus bills, when technology could easily allow legislation to be handled piece-by-piece?

The lack of answers to these questions have allowed the purpose of the bill to be perverted for political gain, which is unsurprising these days.

But the thrust of the bill remains true, and something the United States cannot give up on. With electric vehicles becoming more affordable (Teesla has started releasing their mid-size sedan) and major logistics companies moving trucking to all-electric, it won't be long before lawmakers

are looking around wondering 'where's all the money for

But how can we fix the problem at hand?

The biggest stride the country's legislative system could take, at the federal level, is to do away with omnibus bills - that is, legislation that has multiple proposals built in, some of which are related and, sometimes, they aren't.

If federal lawmakers could make that leap, there would be no more hiding proposals like this one deep inside a bill's wording. There would be no holding proposals hostage by the White House.

And, frankly, it would be easier to follow the legislative process. No more 2200 page bills dropped at the 11th hour that even those who work in Washington have a hard time sifting through before the deadline, much less the standard citizen.

Drop the omnibus bills they're bad for the country, and it's a good way to get perverted legislation passed without the ability to discuss, amend, and


### Vicarious Travels

I later traveled with a group of families walking or traveling by wagons, trying to escape from the Russians and Germans who were fighting battles all around us. Weeks were spent trying to avoid capture, and many were buried along the way, never making it to their goal of a land of peace.

Not all my time was spent in the European wars, there were other

> We traveled through the mountains in Kentucky, riding horses and s o m e t i m e s

mules, to deliver library books and magazines to the mountain people living in the remote areas, miles from their nearest neighbors. The mountain people were leery of outsiders and it was only after several visits they began to accept the services of the library, eventually looking forward to the visits each month.

It was not all peace and quiet in the mountains as there were family feuds, moonshiners and other dangers awaiting among the dense forests.

We traveled to the coastal towns, seeking a quiet and simple lifestyle. Instead we became involved with residents searching for a group of jewel thieves.

We walked the streets of New York, joining young career girls attempting to make their way in the big city. Some coming from small towns were met with many obstacles, but pressed onward toward success.

In the year 2021 when we were unable to travel, literally, we made our way around the world, through books.

Until the time when we once again can pack our suitcases and leave home, I'll continue my journeys through the printed page.

# Louisiana intends to scrap school letter grades this year

BATON ROUGE, La. (AP) — Louisiana's top school board Wednesday agreed to shelve letter grades for public schools this year because of the coronavirus outbreak, assuming the federal government signs off on the move as expected.

The action from the state Board of Elementary and Secondary Edu-

cation means that grades and school performance scores that are usually released in November will be set aside amid classroom upheaval and falling test scores blamed on the pandemic.

The Advocate reports that state Superintendent of Education Cade Brumley said he's confident the waiver request will win federal approval. At least 45 other states have gotten federal clearance to cancel school rating procedures, and the U.S. Department of Education encouraged states to apply for waivers because of the pandemic.

"We fully expect what we have seen from other states, that the waiver will be approved," Brumley told the state education board Tuesday.

The board initially signed off Tuesday on the suspension of the school letter grades and performance scores, with final action taken Wednesday without objection.

# seen on TikTok' is the new 'As seen on TV'

(AP) — Near the Twizzlers and Sour Patch Kids at a candy store are fruit-shaped soft jelly candies that earned a spot on the shelves because they went viral on TikTok.

A flood of videos last year showed people biting into the fruit gumplastic casing, squirting artificially-colored jelly from their mouths. Store staffers at the candy store chain It'Sugar urged it to stock up, and the gummies did so well that TikTok became part of the company's sales strategy. The chain now has signs with the app's logo in stores, and goods from TikTok make up 5% to 10% of weekly sales.

"That's an insane number," said Chris Lindstedt, the assistant vice president of merchandising at It'Sugar, which has about 100 locations.

TikTok, an app best known for dancing videos with 1 billion users worldwide, has also become a shopping phenomenon. National chains, hoping to get TikTok's mostly young users into its stores, are setting up TikTok sections, reminiscent of "As Seen On TV" stores that sold products hawked on infomercials.

At Barnes & Noble, tables display signs with #BookTok, a book recommendation hashtag on TikTok that has pushed paperbacks up the bestseller list. Amazon has a section of its site it calls "Internet Famous," with lists of products that anyone who has spent time on TikTok would recognize.

The hashtag #Tik-TokMadeMeBuyIt has gotten more than 5 billion views on TikTok, and the app has made a grab-bag of products a surprise hit: leggings, purses, cleaners, even feta cheese. Videos of a baked feta pasta recipe sent the salty white cheese flying out of supermarket refrigerators earlier this year.

It's hard to crack the code of what becomes the next TikTok sensation. How TikTok decides who gets to see what remains largely a mystery. Companies are often caught off guard and tend to swoop in after their product has taken off, showering creators with free stuff, hiring them to appear in commercials or buying up ads on TikTok.

"It is a little bit of a head scratcher at first," said Jenny Campbell, the chief marketing officer of Kate Spade, remembering when searches for "heart" spiked on Kate Spade's website earlier this year.

The culprit turned out to be a 60-second clip on TikTok posted by 22-year-old Nathalie Covarrubias. She recorded herself in a parked car gushing about a pink heart-shaped purse she'd just bought. Others copied her video, posting TikToks of themselves buying the bag or trying it on with different outfits. The \$300 heartshaped purse sold out.

"I couldn't believe it because I wasn't trying to advertise the bag,' said Covarrubias, makeup artist from Salinas, California, who wasn't paid to post the video. "I really was so excited and happy about the purse and how unique it was."

Kate Spade sent Covarrubias free items in exchange for posting another TikTok when the bag was back in stores. (That video was marked as an ad.) It turned what was supposed to be a limited Valentine's Day purse into one sold year round in different colors and fabrics, such as faux

TikTok is a powerful purchasing push for Gen Z because the creators seem authentic, as opposed to Instagram, where the goal is to post the most perfect looking selfie, said Hana Ben-Shabat, the founder of Gen Z Planet. Her advisory firm focuses on the generation born between the late 1990s and 2016, a cohort that practically lives on TikTok.

Users trust the recommendations, she said: "This is a real person, telling me a real story." Instagram, YouTube

and other platforms connected people with friends or random funny videos before marketers realized their selling potential. For TikTok, losing the veneer of authenticity as more ads and ways to shop flood the app could be a risk. If ads are "blatant or awkward, it's more of a problem," said Colin Campbell, an assistant professor of marketing at the University of San

Diego. Influencers who get paid to shill for brands are getting better at pitching goods to their followers, telling them that even though they get paid, they're recommending a product they actually like. "They feel like they are our friend, even though they aren't," he said.

Channah Myers, a 21-year-old barista from Goodyear, Arizona, bought a pair of \$50 Aerie leggings after seeing several TikTok videos of women saying the cross-banding on the waist gave them a more hourglass-like figure.

"It's funny, I shop religiously at Aerie and I had no idea they existed until I saw them on Tik-Tok," Myers said.

After those Aerie leggings went viral on Tik-Tok in 2020, the teen retailer expanded the same design to biker shorts, tennis skirts and bikini bottoms, all of which can be found by searching "TikTok" on Aerie's website. It wouldn't say how many of the leggings sold.

TikTok, along with other tech companies like Snapchat, is gearing up to challenge Facebook as a social-shopping powerhouse. Shopping on social media sites, known as social commerce, is a \$37 billion market in the U.S., according to eMarketer, mostly coming from Instagram and its parent company Facebook. By the end of 2025, that number is expected to more than double, to \$80 billion.

Last month, TikTok began testing a way for brands to set up shop within the app and send users to checkout on their sites. But TikTok has hinted that more is coming. It may eventually look more like Douyin, TikTok's sister app in China, where products can be bought and sold without leaving the app — just like you can

on Facebook and Instagram.

"Over the past year, we've witnessed a new kind of shopping experience come to life that's been driven by the Tik-Tok community," said TikTok General Manager Sandie Hawkins, who works with brands to get them to buy ads on the app and help them boost sales. "We're excited to continue listening to our community and building solutions that help them discover, engage and purchase the products they love."

That includes The Pink Stuff, a British cleaning product that wasn't available in the U.S. last year. That all changed when videos of people using it to scrub rusty pots and greasy countertops went viral on TikTok, pushing the brand to cross the Atlantic. It launched in the U.S. in January on Amazon, with 1.3 million tubs sold monthly, and is getting calls from major stores wanting to stock it, according to Sal Pesce, president and chief operating officer of

the The Pink Stuff U.S. "I've never seen anything like this," he said.

Neymar Marango, a young 15-year-old boy from Panama, has the right to feel sorry for himself. Born with a defect in his right leg that eventually required that the leg be amputated.

But Neymar wasn't feeling sorry for himself last weekend. He was hopping around on his left leg and shouting for joy in his native tongue when he stood over the fallen doe he had shot.

Neymar was hunting as a guest of the Dream Hunt Foundation with details of the hunt provided by his guide, Hunter Brown.

"Neymar and his father are here from Panama staying at Shriner's Hospital where he awaits to get fitted for a prosthesis," Brown said. "Dream Hunt Foundation has a special arrangement with Shriner's where we are introduced to kids in that facility who show an interest in the outdoors. In fact, we took Neymar fishing a few weeks ago and in the process learned he had an interest in hunting as well. That's what sealed the deal for us to put him in a deer stand with us last weekend."

The youth was settled in his stand with a group including Brown who served as camera operator, guide Micah Arbuckle, and Kenny Gallion, a native of Colombia who served as translator since Neymar speaks no En-

"The day before, we took him out to where we would be hunting in Red River Parish, taught him firearm safety and gave him the chance to shoot. He was ready for the hunt the next morning," Brown

Settling into the stand before daylight, the hunt-

ing party begin seeing several deer moving out onto the food plot. Nevmar settled the crosshairs on a big doe, hit the trigger and watched as the deer took off.

"We knew his shot was true and that he had hit the deer, which didn't run far but ran into a thick area," Brown said. "Neymar joined us on his crutches as we followed the blood trail to where the deer had fallen. It was an emotional experience to see this young boy jumping around on crutches, grinning and yelling in his own language. It's an experience I'm so thankful I was there to witness."

Dream Hunt Foundation is a Louisiana-based non-profit organization

whose mission is to help kids with special needs or the underprivileged to fulfill dreams of getting to experience a hunt of a lifetime.

Founded in 2013, the Foundation's reason for being has to do with the belief that kids between the ages of 8 and 18 whose lives have been otherwise focused on their disability, illness or limited resources, could have the opportunity to love the outdoors in an organized hunting or fishing experience.

The organization is partnered with Shriner's Hospital in Shreveport and it is that partnership that resulted in Nemar having an experience he won't soon forget.

"I am a bowhunter my-

self and it's something I dearly love," said Brown, who has already taken a 12 point buck with his bow this season. "However as much enjoyment as I get from getting to deer hunt with my bow, getting to share this experience through Dream Hunt Foundation with youngsters with special needs is more rewarding to me than when I'm settling the sight pin of my bow on a good buck."

After a bye week of rest, Louisiana Tech hits the road to return to the gridiron as the Bulldogs are set to play at Texas-El Paso starting at 8 p.m. Saturday.

"We said going into the week that we needed some guys to get a lot of team reps," Holtz said. "We did about a 40-50 minute team period every day last week and really got some of our depth guys and some of our younger guys a lot of reps as we tried to get them ready if we were to need them in the second half of the season. We felt like we needed to get some of the guys healthy. When you look at the number of reps the starting five O-linemen were getting, the defensive linemen, etc., we tried to take some of the pounding off of them.

"There were a lot of things we tried to get done during this open date. It was really productive for us. It really showed up on Sunday. When we came back and practiced on Sunday night, it was very energetic. This team is really excited to get into

Even those who deny it, try to avoid it, prolong life through the miracle drugs and vitamins, they all end up in the same location: Boot Hill.

Thanatology is the study of death and the dying process. These specialists can tell us a lot about our approach to death through their knowledge. Hospice groups are so

> the words of Jesus in John 14.

"To him who in the love of Nature holds communion with her visible forms, she speaks a various language; for his gayer hours she has a voice of gladness, and a smile and el-

oquence of beauty, and glides into his darker musings, with a mild and healing sympathy, stealing away their sharpness, ere he is aware.....

Yet a few days, the all-beholding sun shall shine no more in his course; nor yet the cold ground, where thy pale form was laid, with many tears, nor in the embrace of ocean, nowhere shall thy image exist. Earth,

For some, comfort comes in dis-

covering they are not the first to ask the question. Every griever's question deserves to be honored. Sometimes they meander their way into answers like an artist working with a lump of clay. They may revisit answers that initially satisfied them, but comfort comes in the returning....much like returning to the cemetery often, visiting the graveside of a loved one..." (Grievers Ask).

We do not need to suffer in our grief alone. Sometimes we may need some professional help. Your pastor may be able to guide you to some qualified counselor. Let's not face this important phase of life alone when assistance is available.
