# **Minden High School Selected As Amazon Future Engineer School**

Minden, La – Minden High School has been selected as an Amazon Future Engineer (AFE) School. This is a partnership between Amazon and Project STEM to improve access to computer science education in communities currently underrepresented in the technology field.

According to U.S. Bureau of Labor Statistics, there are 1.4 million available jobs related to computer science, but only about 400,000 computer science graduates with the skills to apply for those jobs. Amazon and Project STEM are collaborating to address this gap by sponsoring teachers and administrators who are committed to bringing computer science to their school.

"It provides full curriculum in STEM activities: in science, technology, engineering and said Minden math", High School Educator Laura Haley. "For me, it's going to supplement curriculum that we are already providing for Jump Start students.

The Jump Start Program allows Webster Parish students to obtain credentials before graduating high school. Haley instructs students who are obtaining credentials as Certified Internet Web Professionals. She had to apply and be accepted into the AFE program.

Haley's students will work with Amazon engineers to learn about computer coding and how computers operate. Students will learn about the coding taking place at Amazon facilities and the robotics that are being used by the company.

"I want my students to realize that every computer is only as smart as the person behind it," said Haley. "If they can put the code in, they can do anything they want with any machine.

Students are also eligible for scholarships and internships at Amazon.

# Appeal for Huffman Management delayed at City Council

Recently some controversy has arisen in the Historic District of Downtown Minden concerning Huffman Management's plan to have their recently acquired property, formerly home to Grace Estate, turned into a Bed & Breakfast/Event Center.

The controversy more so centered around the event center, with some residents of the historic district bringing up worries that the center would lead to disruptions in the neighborhood, whether that be traffic, noise, etc.

Huffman Management went to the planning commission in order to be granted the same variances that Grace Estate had prior, those being using the property as a Bed & Breakfast and an event center, with the main difference being changing the variance Grace Estate had to operate a tea room to instead be a variance to operate a ten-seat bar.

At the initial planning commission, concerns were raised regarding having a bar in the neighborhood, so that idea was scrapped and then brought back to the table with just the B&B and Event center. The variance for the B&B passed and center failed.

That brings us to morning, Wednesday where Jim Huffman presented an appeal to the City Council to be granted the event center variance. During the course of this meeting, Huffman spoke about his vision for the business and the concessions that he has made to his plans for the event center in order to address the concerns that had been raised against it.

"As a company and as a family, let me first state that we are neighbors of this home. We've been in the hospitality industry since 1979," said Huffman.

"Basically, all we're asking for is for us to continue to do what is currently being done. We're not asking for any variances that haven't already been granted, and we're willing to even not utilize some of the variances that have already been granted to that home, such as the tea room portion."

First addressing the traffic concern, Huffman started off by stating that the main road that was cause of worry due to possibly being too narrow, Sylvan Place, could indeed have two cars pass one another, and had pictures to prove the point.

the variance for the event Later he also stated that he reduced the max occupancy from 500 to 100 to address these concerns as well.

> "Some things that you may have heard in the past is that the street next to it is too narrow, and can't hold two car traffic without going into other people's yards. That's not true and I do have photos to prove that."

Another of the complaints levied against the event center was that noise would be generated from the establishment during the event. To address this, Huffman agreed that they would not allow live bands to play at the venue and that no firework shows would take place there as well.

"You may have heard that this will bring noise issues. At this point we're willing to say we want to be good neighbors. Therefore we will not book any bands or any events with bands at that event center," said Huffman.

"In spite of the fact that there's only been three fireworks shows, you may have heard that fireworks create an inordinate amount of sound. And as a company we've said ok, we want to be good neighbors, we won't have any fireworks."

Later during the discus-

sion Councilman Terika Williams-Walker of Dist. B brought up the fact that live DJs could possibly produce too much sound as well.

"My question is, I see where you say no outdoor bands, but what about a DJ? It's still noisy," said Walker.

On the spot, Huffman agreed that there would be no DJs, stating, "Ok, no DJ. No bands whatsoever, no noise whatsoever, with the exception of laughing children."

Walker Later also brought forth the possibility of reducing the max occupancy even further, having the occupancy that had already been reduced from 500 to 100 changed from 100 to 50. While the effect this would have on tackling potential concerns is debatable, it once again demonstrated a willingness on behalf of Huffman Management to make whatever concessions were deemed necessary in order to be granted the variance.

"Right here where you said the event size should not exceed 100 people. Have you thought about decreasing that number from 100 to maybe fifty?" asked Walker.

Huffman responded, "Ok, done. 50." With the main concerns being addressed, Huffman then clarified why exactly it was so important to be granted the variance for the event center in the first place, the main concern being allowing those who utilize the event center to take advantage of the outdoor spaces as well.

"The reason why we need the event center classification is because, without it, we cannot advertise for meeting space, we cannot advertise for family reunions, military reunions, we cannot host those things in our home," said Huffman.

"I was asked once, 'if you're really focused on family reunions, and you're really focused on smaller events, why don't you say you'll just only do what's inside your home?' That seems like a fair request, but, given some of the hurdles that we have faced recently, I'm afraid that will lead us down a path that would have police officers called when we have a family reunion and we have a bouncy house behind the house. I'm afraid if I allow ten people to barbeque on my back lawn, that I won't be holding up to my end of the bargain, which is to only have events inside the home." "Knowing that that is


the threat, I would request that we allow the variance to go through as an event center with the assurances, no fireworks, no live bands. We will control the noise at that home, but we do request the event center include the grounds, and again, should include the grounds because of family reunions, having barbecues, children having bouncy houses, ladies wanting to have a tea party on the front lawn," said Huffman. "It's those kinds of events that we do want to continue to be able to have."

Of course there were those in attendance that were there to voice the supposed concerns of the residents of the historic district, those being Catherine Hunt, Emily Hunt, and Leslie Rainer.

However, few to no new concerns were raised during this meeting that hadn't already been addressed. Multiple times they referenced signatures for a petition that they had acquired in late January.

"When you say a few though, we have 65 signatures that represent 45 households. How is that a few?" said Catherine Hunt.

Emily Hunt added, "We collected signatures See, APPEAL, Page 3

### Head Start teachers in 3 states suing over Biden administration's COVID vaccination mandate

(The Center Square) – Head Start teachers in Louisiana, Ohio and Virginia are suing the Biden administration over a nationwide COVID-19 vaccination mandate for the federally funded program.

Elizabeth Etherton, a preschool teacher at Fairfax County Public Schools in Virginia, has filed a lawsuit in U.S. District Court over a threatened termination Monday for failing to take a COVID-19 vaccine.

The lawsuit, which was filed last week, followed a similar case involving Head Start teachers Sandy Brick in Louisiana and Jessica Trenn in Ohio, challenging an "interim final rule" by the Office of Head Start under the Department of Health and Human Services.

The rule, issued Nov. 30, requires all staff, contractors and volunteers to receive a second dose of a COVID-19 vaccine by Jan. 31. The order also required all adults and children over 2 years old in the program to wear masks.

"I love my job and it breaks my heart to think I may lose the opportunity to work with my students over this federal mandate," Etherton said. "I did everything I could to adapt to challenges over the last two years. I taught from home. I stayed late to clean my classroom. I followed the procedures, participated in weekly testing, and submitted a medical exemption saying I could not receive this vaccine. But that wasn't enough. So many teachers are in this position and this lawsuit is my last resort to protect myself and others like me."

Etherton, Brick and Trenn are among about 280,000 Americans employed in programs that receive federal funding through Head Start. Those programs are largely nonprofits or run through local public school districts and serve children age 2-5 from low-income families. The Head Start programs offer services beyond traditional preschool by providing nutrition, social skills and other support for students. The federal vaccination mandate applies to teachers as well as volunteers, estimated at about 1 million people. The teachers are represented by the national, nonprofit law firm Liberty Justice Center. In Louisiana and Ohio, at-

Louisiana and Ohio, attorneys with the Pelican Institute for Public he Policy are assisting with the case. The Liberty Justice Center and Pelican int

Institute partnered for a similar effort to block the Biden administration's vaccine-or-test mandate for private businesses that was overturned by the U.S. Supreme Court last month.

"This mandate is yet another example of the government's federal relentless, illegal effort to control the private choices of Americans," said Daniel Suhr, managing attorney at the Liberty Justice Center. "The Biden Administration does not have the authority from Congress or the U.S. Constitution to issue blanket vaccine and mask mandates."

Attorneys representing the Louisiana and Ohio teachers are seeking to join a federal lawsuit brought by 24 states regarding the Head Start vaccination mandate. In January, U.S. District Judge Terry Doughty granted a preliminary injunction to block the mandate for the 24 states, which includes Ohio and Louisiana. A separate lawsuit in Texas also resulted in a judge blocking the mandate, Suhr said.

"The government has not appealed yet in the Texas or Louisiana cases," he said. "We have asked for our teachers to be consolidated or merged into the state case ... and that request is currently being briefed.

"Hopefully, we'll get all those cases merged so they can be resolved on the same track," Suhr said.

Once appealed, the cases would head to the U.S. Court of Appeals for the Fifth Circuit, the same court that enjoined the private employer vaccine mandate before it was ruled unconstitutional by the Supreme Court.

In Virginia, a state that is not a party to the broader state lawsuits, Etherton remains under the government vaccine ultimatum.

"I think part of the reason they have not appealed is because the rulings are only effective in the states that brought the cases," Suhr said.

All of the cases center on the same legal argument: the Head Start statute does not give the U.S. government authority to implement a vaccination mandate, while the individual teacher cases also assert violations of personal freedoms.

"Courts have consistently recognized the liberty each of us has to make medical decision affecting our lives," Suhr said. "We feel a government mandating a vaccine invades that individual liberty."



throughout the historic district and down Pennsylvania, and I can tell you these people excitedly signed our petition."

However the concerns that residents of the historic district would have had at that time, noise, traffic, etc., would have been addressed by the concessions Huffman Management has made.

The only other relevant concern brought forward was that of an overarching desire to keep the historic district entirely residential, despite the fact that Grace Estate had been granted these same variances.

"As neighbors, we feel like we're defending our neighborhood, and we're having to do it over, and over, and over, and over, again. I'm sick of having these meetings. There's a reason why the planning commission is only supposed to hear this once a year. And then there's supposed to be an appeal," said Emily Hunt. "When all we want is for our

residential area to be in fact, residential."

Nearing the end of this particular discussion, Huffman once again restated his willingness to make whatever changes necessary to make sure his business would not affect the lives of their neighbors while also pointing out the hypocrisy of some of the most vocal opponents of the variance, stating that in the past they had attended events at Grace Estate similar to the ones he plans to hold there in the future.

"Bottom line is, a lot of my opponents have asked for certain things. No fireworks. We said ok, no fireworks. They said, bands too loud. We said ok, no bands. We keep taking our dream, and what we want, and we keep shrinking that down, smaller and smaller, and smaller, to appease those very loud negative individuals, that continuously bring up the negativitieses of the place, not admitting that they attended


multiple events," said Huffman.

The longer the discussion went on, the more it became a back and forth between Huffman and Rainer, Catherine Hunt, and Emily Hunt, more so than the original goal of the discussion, which was supposed to be Huffman's appeal to the City Council.

Bringing this fact to life, Bloxom proposed the decision that was ultimately made, which was to table the discussion to allow more time for Huffman and residents of the historic district to discuss the matter further with the new concessions in mind, and hopefully come to a mutual agreement.

"Mr. Huffman, I'm sorry to do this to you, but I really believe we should just remove this from the agenda, let the historical people have a meeting, make their reference, if they have to come back to us then, let's address it in April," said Bloxom.

# White: Upskill your employees at no charge

Beginning in July 2022, a new financial assistance program that is often referred to a TOPS for adults will launch in the state of Louisiana. The M.J. Foster Promise Program, named in honor of former Louisiana Governor Mike Foster, is a state fund that will provide financial support for students to earn credentials that align to highdemand jobs in growing industry sectors in Louisiana. The fund is capped at \$10.5 million in this inaugural year, so awards will be distributed on a first-served first-come, basis. All public two-year community and technical colleges in Louisiana are eligible training providers as well as accredited proprietary schools licensed by the Board of Regents. For employers in the targeted industry sectors, including construction, healthcare, information

technology, manufacturing, and transportation and logistics, consider this an incentive to upskill your existing entry level employees who show potential for growth within

your company. Use this program as a way to show your employees you care about their professional growth, and you want to help them invest in their futures. Most community and technical colleges now offer critical training programs in nontraditional hours, as the traditional student for them is one that is over 21 and has a job, so consider offering flex time for your employees that want to pursue training under the program.

There are eligibility requirements for the program, it is not intended for every adult; the goal here is to remove the financial barrier that is often the one thing holding back adults who do want to improve their skills. The program is for Louisiana residents 21 or older and who meet the following criteria:

I. Meet a family income that does not exceed 300% of the Federal Poverty Level (see below) or be unemployed or underemployed for six months prior to receiving grant.

2. Have earned a high school diploma or equivalent or co-enroll in a qualified program of study and in a program to earn high school credential.

3. Have not previously earned an undergraduate degree at the associate level or above.

4. Be a Louisiana resident and U.S. Citizen.

5. Commit to reside in Louisiana one year after completion and to perform 20 hours of community service, an internship, or a mentorship annually to maintain the award.

Incarcerated individuals and those who have been convicted of any crime of violence are prohibited from receiving M.J. Foster Promise funds.

The program will serve as a "last dollar" award, which means all appli-


### **OTHER OPINION**

That's how America is perceived by our adversaries and that is why these dangerous, highly volatile actions are occurring across the globe. How could it be otherwise? After the Afghanistan debacle, why would our enemies think any differently? Remember how the U.S., in

an impotent and humiliating fashion for the world's only superpower, abandoned Afghanistan last year. In so doing, we gifted to the Taliban-our terrorist enemies who gave Al Qaeda the staging area to plan the September 11, attacks—\$86 billion in military hardware.

Why didn't befuddled Pres. Biden give this \$86 billion in military hardware to Ukraine's brave Presi-



barrels per day of liquid hydrocarbons from Russia. (energyintel.com). At the current rate of \$100 per barrel, the fact is our nation is currently helping to fund Putin's war machine against Ukraine at the rate of \$60 million per day.

Iran then breached the limits on its uranium stockpile, the purity of the nuclear fuel it was producing and resumed work at the underground Fordow site."

Recall that the U.S has also now abandoned the energy independence we had achieved during the Trump years, forcing us back into a situation in which we are relying on foreign oilfrom countries, many of which hate us-to sustain our national economy. By the way, oil at \$100 a barrel not only hurts American citizens, it puts billions into Russia's war effort as well as Iran's nuclear program. In fact, according to Forbes, in 2021, Russia accounted for 21% of all U.S. gasoline imports for a total of \$12.78 billion. Right now, the Biden Administration is importing roughly 600,000

through the conflict in Ukraine that energy security is also the key to global security and stability. As President Trump has noted, energy security is national security.

President Putin has for many years had designs on making Russia more than a regional power (as a KGB officer at the time, Putin would have never supported Gorbachev's dismantling of the former Soviet Union) while China has salivated over Taiwan for decades and now sees an opening with a U.S. still distracted by and reeling from the China virus and the flaccid leadership of the Biden Administration.

# WSJ: Biden missed an opportunity with State of the Union

President Biden is no Olaf Scholz. The new Chancellor upended decades of centerleft German defense and energy policy this week after Vladimir Putin invaded Ukraine, and Mr. Biden had a similar opportunity in his State of the Union address Tuesday. He missed the moment. The President remained on the same policy course of his first year, albeit dressed up in new anti-inflation packaging.

More defense spending to meet the threats from autocrats? No. A new appreciation for the contribution of fossil fuels to American and European security? Not a word. A note that government spending contributed to the highest inflation in 40

years? Nope. A word of praise for the private Pharma innovation that developed Covid therapies and vaccines? He proposed government price controls instead.

Mr. Biden did offer stirring support for Ukraine and its fight for freedom, which received bipartisan applause. His Administration deserves credit for helping to rally Europe and other nations to impose sanctions and provide more military aid. He was properly condemning of Mr. Putin.

But his self-congratulation ignored the failure to deter the Russian autocrat. "We were ready" if Mr. Putin invaded, Mr. Biden said. But if the U.S. had been ready, Mr. Putin wouldn't have invaded. The Russian invaded because he thought the West would do little. And Mr. Putin finds himself in a struggle now because of the bravery of 41 million Ukrainians, not the strength of Europe or the United States.

What we also didn't hear was a vow that Russia will not be allowed to conquer and hold Ukraine. There was no warning to Mr. Putin not to launch missiles into residential neighborhoods or surround and starve cities into submission like a medieval siege. This was not Harry Truman at the dawn of the Cold War calling the world to meet a new danger.

On his domestic agenda, Mr. Biden acknowledged inflation, as he had to given the polls. But he blamed rising prices on the pandemic and greedy businesses, and his solutions are to unleash prosecutors and antitrust cops, and to spend even more money on social welfare and entitlements. His most other-worldly line was that his program would "cut energy costs for families an average of \$500 a year by combating climate change."

The entire point of his climate agenda is to raise the price of energy for Americans by reducing the supply and increasing the cost of coal, oil and natural gas. His regulators are working to do that every day in every way. It was as if the horror of the last week, which exposed the folly of Europe's dependence

on Russian oil and gas, had never happened. The climate left still has a choke hold on this Presidency.

An anxious world is looking for American leadership in a dangerous new era. Instead Mr. Biden offered a rehash of his first-year domestic agenda that has brought him to his low political ebb. It's dispiriting that a White House facing so many daunting challenges could come up with so little. The President really does need to fire some people and get better advice.


# **Sports** Briles out at GSU less than week after hire

Art Briles' tenure as offensive coordinator at Grambling State is over less than a week after it started.

The former disgraced Baylor coach said he didn't want to be a "distraction" at the prominent HBCU with a storied football program in northern Louisiana, leaving the program just five days after he was surprisingly hired by coach Hue Jackson.

"Thank you for giving me the opportunity to be part of your coaching staff at Grambling State University," Briles said in a statement released Monday. "Unfortunately, I feel that my continued presence will be a distraction to you and your

team, which is the last thing that I want. I have the utmost respect (for) the university, and your players."

Briles has been a pariah in college football since 2016, when he was fired by Baylor after an investigation concluded he and his staff took no action against players named in sexual assault allegations.

ESPN first reported that Briles would not coach at Grambling. It wasn't immediately clear whether Grambling asked Briles to resign or the coach did so on his own.

The baggage surrounding Briles was wellknown, but that didn't stop Jackson from making the hire last week. The 66-year-old Briles coached briefly in Italy and then at a Texas high school after he was dismissed from Baylor.

Grambling's decision received renewed attention Monday when a three-day old social media statement from the Hue Jackson Foundation gained traction. It was the latest in an avalanche of criticism for the university. The foundation's statement said that Briles' hiring "will be instrumental in teaching others the importance of knowing how to prevent victimization, proper reporting procedures, provide adequate resources to individuals who have been victimized and develop strong law enforcement partnerships within the community."

Former Grambling quarterback Doug Williams — the first Black quarterback to win a Super Bowl with Washington in 1988 — was one of many who voiced his displeasure with the school's decision to hire Briles in the first place.

The NFL executive with the Washington Commanders said the foundation's statement didn't sway his opinion.

"I don't know what you get from that statement," Williams told the AP on Monday. "I don't think anything needs to be added. Everybody knows what I think about it. I'm not going to change."

In the Baylor case, the NCAA infractions panel stated that Briles "failed to meet even the most basic expectations of how a person should react to the kind of conduct at issue in this case. Furthermore, as a campus leader, the head coach is held to an even higher standard. He completely failed to meet this standard."

Baylor paid Briles more than \$15 million after firing him. He later acknowledged making mistakes and apologized for "some bad things" that happened under his watch.

This isn't the first time a coach has attempted to hire Briles since 2016. Southern Miss coach Jay Hopson attempted to hire Briles as the program's offensive coordinator in 2019, though university administration eventually vetoed it.

Briles was considered one of the top offensive coaches in the country when he led Baylor from 2008-15, leading the program to a 65-37 record. His spread offense kept the Bears regularly ranked in the AP Top 25 and the program had four 10-win seasons in a fiveyear span from 2011-15.

Jackson is the former head coach of the NFL's Oakland Raiders and Cleveland Browns.







I just finished making fried apple pies.

I've had these on my mind for several days but had not been able to get to it. Last week was a cold, rainy week and would have been an excellent time to be in the kitchen. However I was detained for a few days as we had a contractor on site to remodel my bathroom, installing a shower that was needed due to the aging of the occupants. And his port of entry was my kitchen door so there was no way I was going to interfere with his coming and going.

This job was planned two years ago, but we were unable to find a dependable contractor who would follow through. We suddenly came upon this one, by word of mouth, and

he did what he said he would. He showed up when he said he would and stayed on the job, completing it in four days.

Finally, this week, I made it to the kitchen and made my pies. Às I was

Although I made apple pies, they are not my favorite. My favorite was always the chocolate pies Mama made, using a mixture of sugar and chocolate, topped with butter encased in the flaky pas-

try crust. I have made these, especially when the kiddos were still at home, but I don't make them very often now.

When Mama made fried fruit pies, there was some long-time preparations required for them.

She often made pies with dried peaches she had prepared ahead if time. We would help "cut off" peaches to be dried and stored for later use. After all the peaches were cut off from the seed. Mama placed a sheet on a

shed or other place in the sun to begin the drying process. They were all sun-dried over a period of time and stored in a cloth flour sack. Those dried peaches were a treasure as it meant there would be some peach throughout desserts the year.

Sometimes these fried pies would be included in our school lunches. We had to carry lunches for several years, until the school finally installed lunchroom. That а lunchroom was probably a relief to a lot of mothers. I know it was to ours, as there were four of us to prepare lunches for.

She always managed to pack a treat in our lunch, a "sweet" of some kind. She was a very inventive person in the kitchen and could come up with some different treats, usually which took a lot of time to prepare.

Probably my favorite was saltine crackers put together, not with peanut butter, but with chocolate fudge icing. The salty and the sweet made an excellent treat and was often envied by our friends. We would share, but were a bit reluctant to do so.

Our parents, as well as others during those years, had to be inventive and "make do" as many items needed in a household were rationed. They were survivors of the Great Depression and then hit with the sacrifices required by World War II.

I remember that sugar was a precious

commodity and families received stamps required to purchase that along with many other items. There was a man who lived near us that had a truck and he was always willing to swap his sugar stamps for gasoline stamps. Since we didn't go very much, that was a good deal. It meant Daddy could always have sugar for his coffee and a sweet dessert. He could easily make that deal when it came time.

It's strange how the thought of fried pies can set the mind to wandering.

And it can conjure up such sweet and precious times.
