Man arrested with cocaine and kids in school zone

A Homer man was arrested last Friday on drug charges after police spotted him driving the wrong way on a one-way street.

Lemario Harris, 33, was stopped for driving northbound on Richardson Street, which only allows southbound traffic. Harris was unable to provide a driver's license when stopped. When exiting his vehicle, a baggie containing a white substance fell to the ground.

"As he stepped from the vehicle, a small plastic baggie fell to the ground and was stepped on by Harris," the arrest report stated. "He was immediately detained." A field test confirmed the suspected substance was co-

Harris was not alone at the time. Inside the vehicle were three children, ages 8, 8, and 5. The traffic stop took place within a school zone, which are all

also drug-free zones.

Upon further research, it was also found that Harris had a suspended driver's license due to past DWIs.

Harris was arrested and charged with possession of a schedule II substance (cocaine), possession of a controlled dangerous substance in the presence

of juveniles, possession of a controlled dangerous substance in a drugfree zone, driving with a suspended license, and driving the wrong way on a one-way street.

All defendants are presumed innocent until proven guilty in a court of

Minden man shoots 14-year-old

A Minden man was arrested on Monday after being identified as the person who shot a 14-year-old in the leg, just above the knee.

Minden police were contacted by Minden Medical Center in reference to a juvenile gunshot victim. They also received a separate report of gunshots on Stone Street.

Police Chief Cropper stated in the arrest report: "Detectives were dispatched to the Minden Medical Center and were allowed to interview the 14-year-old victim. The victim indicated that his juvenile friends had gotten into a verbal altercation with an unidentified Black male. The Black male had a beard and wore long dreads. He was wearing red and white shoes. The victim indicated that, after the verbal altercation, the Black male suspect left the area and then returned a short time later. Once he returned, he began shooting at him and his friend.

After interviewing witnesses on the scene and obtaining the identification of the shooter as Sean Simmons, 22, officers discovered that Sean Simmons had outstanding arrest warrants from the Webster Parish Sheriff's Office. Minden police officers then traveled to the 800 block of Clay Street, located and arrested Sean Simmons

on the Webster war-

"Sean Simmons was transported to the Minden Police Dept. advised of his Miranda Rights, and interviewed. During his interview, Sean Simmons stated that he had been confronted by a large group of males, brandishing some weapons and striking him with their fists. After he was able to get away from the large group, he went to Jackson Street, armed himself and returned to the location. Sean Simmons states that, once he returned to the scene, he observed the juveniles that had attacked him on the trail between Stone Street and Evans Street. Simmons stated that the group once again pulled out guns, so he just started shooting at them. He stated that he shot five or six rounds. After he fired the five or six shots, he ran away and went and got something to eat."

Officers investigating the location on Stone Street recovered six spent .40 caliber shell casings at the scene.

Simmons has been charged with aggravated 2nd degree battery, illegal use of a weapon during a crime of violence, and being a fugitive from Webster Parish. He is being held on a bond totalling \$110,000 and is being housed at Bayou Dorcheat Correctional Center.

All defendants are presumed innocent until proven guilty in a court of law.

Early voting begins October 25, 2022

The 2022 voting season will soon be upon us, and now is a great time to make sure you're ready to

The deadline to register to vote or to make changes to your registration will be October 11. The following week, October 18. will be the deadline to register online or make changes to your online registration.

The early voting period will be from October 25 until November 1. Anyone who chooses to may vote early. Voters who want to vote early for any election may do so in person at designated locations in their parish. Two standard locations in Webster Parish are the Webster Parish Courthouse located at 410 Main Street, Room 101 in Minden or the Springhill Civic Center at 101 Machen Drive in Springhill.

The Louisiana Secretary of State's website states: "The registrars of voters will open their offices from 8:30 a.m. to 6 p.m. for each day of early voting. When you go to cast your vote early, you will be asked to identify yourself with either a photo ID or signature on a voter affidavit. You mav use a Louisiana driver's license, a Louisiana special identification card, a United States military identification card that contains your name and picture or other generally recognized picture identification card that has your name and signature. You may wish to contact your local Registrar of Voters

Office for specific loca-

tions, dates and times."

If you prefer to use a mail-in ballot, the deadline to request one — for everyone except those in the military or overseas will be November 4, with the deadline for receiving those mail-in ballots as November 7. If you are in the military or overseas, your deadline to request a mail-in ballot will be November 7. Election day is November 8, 2022.

As election day draws nearer, people may be coming door-to-door trying to verify voter registration. Secretary of State Kyle Ardoin issued this advisory to Louisiana voters: " In advance of the upcoming November federal election, Louisiana Secretary of State Kyle Ardoin would like to inform Louisiana citizens that the Secretary of State's office, Registrar of Voters offices, nor Clerks of Court offices conduct a door-to-door canvass to update or confirm a voter's registration. Although independent third party groups conduct their own door-todoor surveys, registration or petition drives, Louisiana residents are under no obligation to speak to or answer these groups' questions. Cooperation or refusal to cooperate will have no bearing on a voter's registration status. The Secretary of State's office, in conjunction with local election officials, conducts an annual voter canvass via mail only."

'Little Demon' latest to emerge from our cesspool

U.S. Rep Mike Johnson this week correctly rebuked the FX animation "Little Demon" as being a dangerous influence on children. He stated that "this (American) culture has be-come dark and desensitized" and this so-called piece of entertainment is only the latest

Johnson went on to describe the show as an attack against the "hearts and minds of our kids" and pointed out the inevitable conclusion that "Disney and FX have decided to embrace and market what is clearly evil.

Little Demon began FX's streaming on August 25 and stars Aubrey Plaza as the mother to the anti-Christ and Danny Devito as Satan, who together bear a daughter but have different desires for that child's upbringing, according to a description on the show's official webpage.

"Thirteen years after being impregnated by Satan, a reluctant mother, Laura, and her Antichrist daughter, Chrissy, attempt to live an ordinary life in Delaware, but are constantly thwarted by monstrous forces, including Satan, who yearns for custody of his daughter's soul," the program explains.

Actress Lucy DeVito, who portrays the antichrist daughter and is Danny DeVito's actual daughter, states "I love that we are normalizing paganism," Lucy DeVito said. "Laura is a pagan. She's a witch. She's jacked."

Let's be clear about what's at issue here. We are not talking about targeting adult audiences in such a way that "Little Demon" could be characterized as satire for the purpose of entertainment.

No, the target of this programming—and its dark and recklessly cavalier portrayal of the devil—are innocent, impressionable children. That's demented.

What other similar examples there?

M y brother, attorney Christopher Alexander, of Louisiana Citizen Advocacy

Group (LA-CAG), has recently written of an ongoing episode in Livingston Parish involving a confused librarian, a concerned parent, taxpayer money, and smut in the children's section of a library paid

for by Louisiana citizens. What are the facts in the Livingston Parish matter?

Ryan Thames is a resident of Livingston Parish and the father of two girls, ages 13 and 5. Thames had the "nerve" to

publicly protest the placement of sexually explicit books located in the children's section of a public library. His offense was to request that library personnel simply move the objectionable material to another part of the library, out of the reach of children. Samples of the books at issue, which include prepubescent themes such as anal sex, butt plugs, masturba-tion, sex toys for "bonus fun," and the proper use of sex lube, complete with graphic illustra-

Again, this cannot be mis-construed as merely "entertainment." Obviously, many users of a public library—particularly the children's section of a public library—are children. In any other setting, an adult who provided such sexually explicit, ^tgrooming' material to another parent's child could potentially be arrested.

What else?

Drag Queen Story Hour at public libraries.

Cropping up in different parts of the country-including in Lafayette, Louisiana—are men dressed provocatively in drag as women who read nursery rhymes to young children, often in a public library. Some of the sponsors of Drag Queen Story Hour have stated that their purpose is to indoctrinate children about a "gender fluid" way of life. It's clearly dangerous and unhealthy for children to be exposed to gender confusion during their moral formation, at their most impressionable. And this is not harmless, victimless "fun": in Houston, a participating "queen" turned out to be a registered child sex offender convicted of abusing an 8-year-old.

This is, again, a targeted effort to create doubt in the minds of young children at the very time they should be affirmed and reassured about who they innately are, the ultimate goal being to create uncertainty, making children more likely to question their sexuality or gender at a later age.

Again, this is not some bawdy, risque form of entertainment for adults. It is a premeditated effort to specifically target innocent, vulnerable children.

I share these examples so parents know what their children are being exposed to in public schools and libraries with taxpayer dollars. There is nothing more powerful than a passionate parent or concerned citizen filled with righteous indignation raising these issues in a school board meeting or other public setting. I salute them. Their valiant efforts to protect children from this filth will ensure our 'best hope for the future' of America.

Science has shown that infants who do not get proper nutrition during those early months are at risk for lifelong impairment and intellectual disability. Nutritional deficits have a direct proven impact on IQ scores - one standard

WSJ: FDA's reluctance on ALS drug more political than prudent

Few diseases are as cruelly debilitating as amyotrophic lateral sclerosis (ALS). But a Food and Drug Administration advisory committee this week gave patients a glimmer of hope by backing a new treatment that can slow their decline and provide precious more time to live.

ALS, or Lou Gehrig's disease, is a neuro-degenerative affliction that gradually robs people of their ability to function. It afflicts about 30,000 patients in the U.S. with 5,000 new cases each year. Patients typically live only two years after a diagnosis as they lose their ability to control essential muscle movements and eventually to chew and breathe.

Scientists don't fully understand what causes the disease, and there are only two approved treatments. Neither has shown to both extend life and slow functional decline. But Amylyx Pharmaceuticals' experimental drug did both in a small Phase 2 trial. Patients treated with the drug lived on average 4.8 to 11 months longer than those who weren't and experienced 25% slower functional decline over 24 weeks.

However, an FDA advisory committee in March voted 6-4 against approving the drug. Many members wanted to wait for results from Amylyx's Phase 3 trial, which likely won't be complete until late next year or early 2024. They worried that approving the drug would give patients false hope if the Phase 3 results prove less beneficial. Our guess is that patients will take their chances on any hope.

FDA leaders appeared inclined but reluctant to approve the drug after the political lashing they took for overruling their advisory committee last year to approve Biogen's experimental Alzheimer's drug. Billy Dunn, the FDA chief of neuroscience, was pounded by the public-health left for urging regulatory flexibility amid positive but inconclusive trial results.

The FDA earlier this summer made an unusual decision to let Amylyx submit more trial data and reconvene its advisory committee for a second look. Canadian regulators in June approved the drug on condition Amylyx completes the Phase 3 trial, which prompted some patients to consider heading north to obtain the drug. What an embarrassment for the U.S.

The U.S. is the world's leading pharmaceutical innovator, and Americans typically get access to more novel treatments, and sooner, than patients in countries with government-run health systems. But the public-health left is campaigning to limit access to expensive new treatments, and Amylyx's ALS drug was nearly caught in the cross-hairs.

The good news is that advisory members appeared to have been moved at their recent meeting by wrenching testimony from ALS patients and the doctors who treat them. Patients who received the drug said it helped stabilize their conditions and live

independently. One could even go hiking.

Dr. Dunn rose in support of patients and urged members to show the broadest flexibility, notwithstanding an FDA staff report that was somewhat critical of Amylyx's results. Advisory members voted 7-2 in favor of approval. It's notable that one of the no votes, Johns Hopkins internist Caleb Alexander, was also a leading critic of Biogen's Alzheimer's drug.

The advisory committee's support should give FDA the political cover it was apparently seeking to approve the drug. But the battle over FDA drug approvals will continue, so patients will have to keep fighting to live another day.

Saints happy, humbled, about historic comeback

NEW ORLEANS (AP) New Orleans Saints coach Dennis Allen was both gratified and concerned that his first game in his new job was rescued by the largest fourth-quarter comeback in the franchise's 56-year history.

"There's a ton of stuff that needs to be corrected," Allen said Monday after reviewing video of Sunday's 27-26 victory at Atlanta. "But I'll say this: It's been my experience over the last however many years, you get into games like this, and the good teams are able to win these games when they're not playing at their best."

The Saints trailed 26-10 early in the fourth quarter before scoring the next 17 points, the last coming when Wil Lutz, who'd clanked an earlier field-goal attempt off the left upright, hit a 51-yarder with 19 seconds left.

But because of star cornerback Marshon personal Lattimore's foul for a hit after the whistle on the game's penultimate play, the victory wasn't sealed until New Orleans defensive end Payton Turner blocked Younghoe Koo's 63-yard field-



goal attempt as time ex-

Lattimore's penalty was his second in the final minutes — the other being a third-down defensive holding call that allowed Atlanta, which led 26-24 at the time, to run the clock down further before punting the ball back to the Saints with 48 seconds to go.

"We did a lot of things in that game that could have kept us from winning," Allen said.

In the locker at team headquarters Monday, Allen's sentiments were echoed by linebacker Pete Werner.

"We're fortunate for the win, but as a defense, and feeling vibe from the players and coaches, we can't have a performance like that

again or it's not going

to end with a 'W' in our minds," Werner said.

Allen, who'd been New Orleans' defensive coordinator since late in the 2015 season before his promotion to head coach following Sean Payton's retirement, was bothered by the fact that Atlanta rushed for 201 yards.
