Boil Advisory for City of Minden

A boil advisory has been issued for the entire City of Minden's water system starting on September 28, 2022. Residents are urged to disinfect their water before using it.

To disinfect water, bring water to a rolling boil in a clean pot and then boil it for at least one full minute. Allow to cool.

advise disin-They fecting water before consuming it (including fountain drinks, ice, etc.), before using it to brush your teeth, or before using it in food preparation.

The advisory was issued due to a control issue that created a low water-pressure event. The control issue has since been resolved. The advisory will be in effect until the Louisiana Department of Health and Hospitals has determined that a collected sample of water is safe.

Minden man arrested with meth, crack, and ecstasy

A Minden man was arrested last week on multiple drug charges after police stopped him for speeding and run-

ning a stop sign. Lish Antonio Island, 51, was observed driving 45 mph in a 25 mph zone and then rolling through a stop sign as he turned onto Bayou Avenue. When the officer approached and requested Island's driver's license, the officer observed a beer can and cooler in the vehicle. Island was unable to provide a driver's license.

"I observed a beer can on the floorboard in the backseat along with a cooler in the backseat," the officer stated in the arrest report. "I asked Island if he had been drinking, to which he stated he had three or four beers."

The officer performed the standardized field sobriety test on Island, and he failed all three categories of testing.

"While searching Island's person for any weapons or band," the report continued, "I located a round blue pill in his front left pocket of his shorts, later identified as Viagra." While searching the vehicle, officers found more drugs.

"[An officer] located an orange prescription pill bottle in the center

console. Inside the bottle were several small clear bags containing different substances. One bag contained a clear crystal-like substance suspected to be methamphetamine, another bag contained a square white cube suspected to be crack cocaine, and another bag contained numerous different colored pills suspected to be ecstasy. Also inside the container were two loose pills suspected to be ecstasy. All items located inside the prescription pill bottle were field tested and tested positive for methamphetamine, crack cocaine, and ecstasy. All amounts of the narcotics were in amounts suspected to be packaged for individual sales."

In the end, police confiscated 3.3 grams of methamphetamine, 1 gram of crack cocaine, 33.5 ecstasy pills, and 1 Viagra pill.

Island was arrested and charged with driving while intoxicated, driving over the speed limit, running a stop sign, driving while under suspension, possession of schedule I (ecstasy) with intent to distribute, possession of schedule II (meth) with intent to distribute, possession of schedule II (crack cocaine) with intent to distribute, and possession of a legend

drug (Viagra).

Annual Report from Assessor's Office to go out to Parish Citizens

The Webster Parish Tax Assessor's Office is proud to announce that the second Annual Report from their office will be mailed out to taxpayers in the parish over the next few weeks. The report will provide plenty of helpful information citizens can look over to become more informed on topics such as Tax Roll Overview, Tax Dollars at Work, Special Assessment Levels, Approaches to Values, and the Millage Rate Process and how it works.

Webster Parish Tax Assessor Denise Edwards stated that this year's report will focus on ways taxpayers can stay involved and be informed when their local tax districts are setting their millage throughout the year. "I'm delighted to keep the citizens of Webster Parish informed on the current operation of my office and keep the tax base knowledgeable on the kind of figures generated through property taxes that keep our local government working for the people," said Edwards.

Not only excited to send out the Annual Report, Edwards was also happy to share the news that her office has once again elected to lower the Assessment District millage rate for the second year in a row. Within her first two years as assessor, she has kept the millage lowered and saved the taxpayers of Webster Parish approximately one million dollars in property taxes. She believes that if her office can run effectively at a lower rate then she has a fiscal responsibility to

So where was taxpayer money saved? Edwards stated that it is all in how a governing entity handles their millage and if they adjust forward or opt not to. She acknowledged that it is important for taxing districts to levy the maximum millage if needed so they have the monies necessary to effectively maintain operations. If a taxing district opts not to adjust their millage forward and receive the max millage which has been the case in the Assessment District these past two years - then the savings are

passed on to the tax base. All this talk about millage rates was also a good segue for Edwards to remind Webster Parish citizens about a Constitutional Amendment that will be appearing on people's ballots this November, that being Amendment No. 5.

Currently, taxing districts are required by state law to adjust their millage forward every so often to keep their max millage. If taxing districts fail to levy their maximum millage, it could cause budgetary shortfalls affecting governmental services for the

public. Essentially, taxing districts are heavily incentivized to levy their maximum millage or else face the consequences of having reduced funding in the years to come.

If Amendment 5 were to pass, then taxing districts won't have their hand forced when it comes to the decision to not levy their maximum millage. This would allow taxing districts the flexibility to save the taxpayers money without fear of losing the max millage option.

If you would like any further information on millage, Amendment 5, or any property tax information, Edwards says her door is always open, and she and her staff are happy to assist the public with any questions, concerns, or needs. All taxpayers should receive the Annual Report by mail, but you can always stop in at the assessor's office to pick up a copy.

Webster Parish Libraries collecting stories for Veterans **History Project**

Webster Parish Libraries has joined with the Library of Congress in collecting the firsthand experiences of war veterans through oral histories, documents, and photographs. The purpose of the Veterans History Project is to preserve these accounts for

future generations. The Veterans History Project was created in 2000 by the Library of Congress. Since then, libraries across the nation have been collecting the stories of veterans who served in military actions from World War I through the present. This includes WWII, the Korean War, the Vietnam War, the Persian Gulf War, the Iraq War and many others.

Veterans are asked to submit personal narratives such as audio- or video-taped interviews or written memoirs. They can also submit correspondence as letters, postcards, or personal diaries, or visual materials like photographs, drawings, or scrapbooks. All documentation must be original, and taped interviews must be unedited.

"It's all about collecting the firsthand experiences of veterans," said Janetta Robinson, historical archivist for the Minden main branch library.

Once those experiences have been collected, they will be added to the National Archive for future generations to learn from. The local libraries and the people who submit their stories will also receive copies.

Anyone who would like to submit their stories is invited to contact the library. They can come in and have their stories recorded or the library will make arrangements to come visit the storyteller.

"I'm looking forward to hearing the stories because guys who have experienced that — have been in wars — they usually don't like to talk about it, and this gives them an opportunity to talk about some of the things they wouldn't normally talk about and that they may not mention to their families But they might be willing to do something for this type of thing because it will be historical and from their point of view," said Robinson. "And it will be included in the National Archives where other people can access it. It may be something they want to leave to their families, but without having to talk about it to them."

While the project began in 2000, it is ongoing with no determined end time. But that is no reason to put this off, and there's a very important reason to submit stories as soon as possible.

"Some people might not be willing to right now, but they may change their minds later," Robinson continued. "I don't want to put a limit on it as far as time frame, but I do want people to understand that it is time sensitive because you never know when this history might be lost because we lose someone. And we've lost

Group of state attorneys general say Senate energy bill could impose backdoor Clean **Power Plan**

(The Center Square) — Louisiana Attorney General Jeff Landry is leading a coalition of 18 states in opposition to the Energy Independence and Security Act, which they claim is a backdoor attempt to impose the failed Clean Power Plan.

"The Biden Administration and its allies in Congress are attempting to not only force unreliable renewables on hardworking Americans, but also turn those consumers into bigger pawns of the green energy industry," Landry said. "The DC elites, in a rushed process, want to restrict the electric power grid by repealing the traditional authority of the states to regulate their own resources and utility policies."

U.S. Sen. Joe Manchin, D-WV, introduced the Energy Independence and Security Act of 2022 last week, and the "comprehensive permitting reform" is included in a Continuing Resolution to avoid an Oct. 1 govern-

ment shutdown. The bill is part of a deal between Manchin, Senate transmission Leader Chuck Schumer, D-NY, House Speaker Nancy Pelosi, D-Calif., and President Joe Biden to gain Manchin's support for the Inflation Reduction Act approved by Congress in August.

Manchin contends the legislation is necessary to reduce costs for energy projects, though the legislation faces opposition from both Republicans and Democrats.

In a letter to Schumer, the attorneys general argued three interrelated provisions in the bill "eviscerate states' ability to chair their own landuse and energy policies."

"First, it would authorize private companies to use eminent domain against state land. Second, it would authorize (the Federal Energy Regulatory Commission) to command utilities to construct entirely new transmission facilities whenever and wherever FERC deems necessary. And third, it would authorize companies to spread costs of constructing new

facilities onto residents of other states, requiring citizens of one state to subsidize the agenda of citizens in other states," the letter

"These provisions eviscerate state sovereign authority, commandeer companies to carry out the will of a three-vote majority of FERC Commissioners, undermine the power of each citizens' vote to decide policies at the state level, and inevitably force the citizens of our states to subsidize the costs of expensive energy policy preferences of California and New York."

The attorneys general also took issue with the short timeline for approving the legislation, which they argued "is completely unacceptable."

"If this sounds uncannily like the Clean Power Plan, the ultra vires [a legal term that means acting beyond one's authority] 2015 EPA rule that would have effectively forced all states and regions to adopt the caprenewableand-trade,

subsidizing policies that to date only some states and regions have chosen, that's because it is in large part the same policy - but this time with no meaningful public notice, explanation, discussion, input, or legal recourse," the attorneys general wrote.

"As the Supreme Court held earlier this year, the Clean Power Plan was illegal - but at least it was openly proclaimed by President Obama, undertaken through public notice and comment and subject to full judicial review," the letter read. "To attempt changes on this order without any notice and under rushed timing is completely unaccept-

Landry was joined in the letter by attorneys generals from Alabama, Alaska, Arizona, Arkansas, Georgia, Indiana, Kansas, Kentucky, Mississippi, Missouri, Montana. Nebraska, South Carolina Tennessee, Texas, Utah, and Virginia.

Early voting begins October 25, 2022

The 2022 voting season will soon be upon us, and now is a great time to make sure you're ready to cast your votes.

The deadline to register to vote or to make changes to your registration will be October 11. The following week, October 18, will be the deadline to register online or make changes to your online registration.

The early voting period will be from October 25 until November 1. Anyone who chooses to may vote early. Voters who want to vote early for any election may do so in person at designated locations in their parish. Two standard locations in Webster Parish are the Webster Parish Courthouse located at 410 Main Street, Room 101 in Minden or the Springhill Civic Center at 101 Machen Drive in Springhill.

The Louisiana Secretary of State's website states: "The registrars of voters will open their offices from 8:30 a.m. to 6 p.m. for each day of early

voting. When you go to cast your vote early, you will be asked to identify yourself with either a photo ID or signature on a voter affidavit. You may use a Louisiana driver's license, a Louisiana special identification card, a United States military identification card that contains your name and picture or other generally recognized picture identification card that has your name and signature. You may wish to contact your local Registrar of Voters Office for specific loca-

tions, dates and times." If you prefer to use a mail-in ballot, the deadline to request one — for everyone except those in the military or overseas will be November 4, with the deadline for receiving those mail-in ballots as November 7. If you are in the military or overseas, your deadline to request a mail-in ballot will be November 7. Election day is November 8, 2022.

As election day draws nearer, people may be coming door-to-door trying to verify voter registration. Secretary of State Kyle Ardoin issued this advisory to Louisiana voters: " In advance of the upcoming November federal election. Louisiana Secretary of State Kyle Ardoin would like to inform Louisiana citizens that the Secretary of State's office, Registrar of Voters offices, nor Clerks of Court offices conduct a door-to-door canvass to update or confirm a voter's registration. Although independent third party groups conduct their own door-todoor surveys, registration or petition drives, Louisiana residents are under no obligation to speak to or answer these groups' questions. Cooperation or refusal to cooperate will have no bearing on a voter's registration status. The Secretary of State's office, in conjunction with local election officials, conducts an annual voter canvass via mail only." The election day vot-

Petroleum reserve hits low point, gas prices begin to rise again

(The Center Square) – Gas prices are on the rise again just as the Strategic Petroleum Reserve hits a low point that many say is a problem.

Gas prices hit record highs in the middle of June, surpassing a national average of \$5 per gallon before starting a steady downward trend for several consecutive weeks.

That streak ended last week, though, when gas prices began to tick back up. The current national average price for a gallon of regular gasoline is \$3.77, up from \$3.68 a week ago.

The Biden administration also touted the lower gas prices last Tuesday, but the very next day data showed they had begun to rise again.

"Folks, gas prices are now back to levels they were at in early March," Biden wrote on Twitter. "That means nearly all of the increases since the beginning of Russia's war in Ukraine have been wiped out."

At the same time, the Strategic Petroleum Reserve is at the lowest level in nearly four decades.

Last week, the Office of the Strategic Petroleum Reserve announced the sale of another 10 million barrels of oil, bringing their total to 165 of the 180 million barrels Biden authorized for release. Biden has touted the lower prices and the relief they've brought to Americans as prices have dropped.

Lawmakers, though, blasted Biden for using the petroleum reserves so extensively for short-term relief, saying he put the U.S. in a difficult position without addressing the root causes by encouraging more domestic oil production.

"The Biden Administration can't continue to tap the Strategic Petroleum Reserve and simultaneously say we don't have an energy crisis or a need to increase domestic energy production," said U.S. Rep. Garret Graves, R-La. "Their self-imposed mistakes are weakening our energy security."

Other critics pointed out an emergency could stress the already weakened reserves and put the reserves dangerously low.

"Less than two years into his term, [Biden] has released more oil from the nation's Strategic Petroleum Reserve than all previous presidents combined, causing our supply to fall to a historic low," U.S. Rep. Michael Burgess, R-Texas, said. "This is a national security threat, and it is unacceptable."

The lower reserve level also spurred questions about whether hurricane Ian, expected to potentially hit the site of several petroleum storage sites, will affect the availability of reserves especially if another emergency arises.

"I don't have any concerns at this point that we're going to have the ability to handle the fuel needs that we're going to need in Florida," FEMA Administrator Deanne Criswell said at a White House press briefing in response to those concerns. "We will continue to assess after the storm passes to see what the im-

pacts are. We'll make sure

that we're putting measures in place to support ... any gaps that we might identify."

The higher gas prices come just ahead of the midterms and could have a major impact on law-makers seeking reelection. Gas prices had become a political cudgel used against Democrats, especially alongside soaring inflation, but the drop of those prices in recent weeks largely disarmed Republicans.

If gas prices continue to rise through election day, Republicans will have another weapon in their arsenal to use against the Biden administration and Democratic candidates.

"If you're wondering why the Biden admin won't be talking about gas prices today, it's because they've now risen for the 6th day in a row after being artificially lowered by releasing our Strategic Petroleum Reserve," said Jennifer-Ruth Green, a Republican running for Congress in Indiana.



Federal case illuminates collusion between feds and Facebook

A civil case has been brought in federal court by Attorney General of Louisiana Jeff Landry and Missouri Attorney General Eric Schmitt regarding the relationship between the federal government and Big Tech—here, Facebook

The question regarding freedom of speech has always been how these enormous social media sites choose to "moderate"—in fact, censor—the content of speech and whether, either by their own doing or as a result of pressure from the federal government, or both, the tech giants are suppressing certain speech which is virtual-

ly always conservative speech.
U.S. District Judge, Terry Doughty, of the Western District of Louisiana, recently ruled that full discovery requires the disclosure of additional email and other communication between Dr. Anthony Fauci, White House press secretary Karine Jean-Pierre, and several of the public affairs staff at the Department of Health and Human Services.

What led Judge Doughty to require the additional disclo-

Well, while there are a number of email communications discovered thus far that would otherwise seem benign—if they didn't involve active coordination between the largest social media company in the world and U.S. government officials-there are several additional emails that are more concerning—and may represent only the tip of the iceberg of improper collusion. These emails involve high-ranking White House officials.

In one example, after Pres. Biden claimed that social media sites and "Covid misinformation" were resulting in "killing people," a senior staffer at Meta (a Facebook spinoff) sent

together collaboratively. A week later that same Meta official sent another email to Murthy stating that "I wanted to make sure you saw the steps we took just this past week to adjust policies on what we are removing with respect to misinformation." The email concludes "...you (Surgeon General) have identified 4 specific recommendations for improvement and we want to make sure to keep you informed of our work on each."

This is all much too cozy. This incestuous relationship

between the federal government and Facebook and Big Tech creates a toxic coordination between government and huge social media sites to suppress critical information millions of people need to know to make good, well-informed personal decisions. That's irrefutable censorship of free speech.

Facebook's presence in American society is so widespread and prevalent as to bear all the trappings of a government entity—a public utility. These emails clearly establish that Facebook is functioning as an arm of the government, a "state actor" in legal parlance, and as the functional equivalent of the Thought Police of the State. Therefore, it should be held to the same prohibitions on censorship as the Govern-

Facebook pretends that it is a neutral arbiter operating an information exchange platform. In fact, in March of 2020, Mark Zuckerberg stated that"I just believe strongly that Facebook shouldn't be the arbiter of truth of everything that people say online.... Private companies probably shouldn't be, especially these platform companies, shouldn't be in the position of doing that.'

However, when you fast forward to today, we see that Zuckerberg and Facebook have become captives of the Thought Police at Facebook and do regularly make editorial content decisions in the composition of

its news feed through its algorithms, and those decisions are often not objective and fair to all points of view.

I note that while our 1st Amendment prohibits the suppression of speech by local, state, and federal governments, government censorship is not the only kind. Private sector suppression of speech is just as threatening, chilling, and destructive. This is particularly true where Big Tech platforms become news editors and make common cause with the Deep State and the National Democrat Party.

In truth, social media has become our modern-day public forum. It's also true that the greatest virtue of free thought and free speech is that all kinds of ideas are thrust into the rough and tumble of the marketplace of ideas where the best idea prevails. It is this collision of, this testing of, speech and thought in a free and open exchange that produces the best results—and leads the nation to wise and popular policy results on challenging national

I'm looking forward to seeing what new email or other communications are recovered by turning over more rocks in this lawsuit.

It's time to head back into the kitchen

Summer is winding down. The canning and freezing processes are complete and now it's time to get back to one of my favorite activities. Baking.

I don't pretend to be an expert or professional baker, I just enjoy making the items that our family and friends enjoy eating. I like to bake and share with friends. This gives me the opportunity to do something I like to do as well as be a "good neighbor" or friend. I haven't done much of this

recently due to other activities taking up much of my time. But last week, I started what I call my fall baking; foods that remind me of the cooler temperatures. My usual first item is applesauce cake. This is a simple recipe, full of walnuts to make it crunchy. It is good eaten by itself as a snack, with coffee for break time or with iced tea or milk at meal time. I baked this last week and we feasted on it for several days.

Monday, in spite of having several tasks to do, I tried out a new recipe for bread. A friend had promised to share his recipe, but since I didn't have it yet, I used one called Amish Bread. It is just a regular yeast bread so I don't know why it is

tagged as Amish bread. It was a fairly quick recipe and I took two loaves out of the oven a short time after lunch. I can't wait when I pull the aromatic

anxious to try it with some of the new jelly I made this year.

It will soon be sweet potato time. This will be a time for baking sweet potato bread and pies. These usually appear around Thanksgiving and Christmas, but often, I can't wait and I slip in a few earlier in the fall. The all-time favorite of many is the pecan pie. I usually buy a supply of pecans in October and they serve for my baking needs all year. I've already used them all and I'm substituting walnuts in some recipes when I can. It's good that next month the new crop of pecans will be ready and I can get a supply and keep in the freezer.

(Even though coconut cream pie isn't considered a fall treat, but one that is commonly served year round, this is the one I make most often. Probably every friend who has experienced sickness or loss of a loved one, has received one of my coconut pies. I really need to get out of the rut.)

Then there's the dark, moist gingerbread. The recipe I use calls for molasses and I think that may be what causes it to be so dark. We usually top each serving with a spoonful of applesauce.

The fresh apple cake is a fall favorite and it is also one of Hubby's favorite cakes. He usually gets one for his birthday, which will be coming up in No-

In addition to all the sweet treats I enjoy baking, there are some which are not sweet and can be used for breakfast breads. An easy and delicious one is the Buttery Scones with dried cranberries. These have a hint of sugar but are not actually sweet and are good with coffee.

Irish Soda Bread is an interesting bread I discovered a few years ago. It makes a hard, crusty bread and contains raisins and nuts. Slice this and toast it slightly and it makes a tasty breakfast toast. You can spread it with butter, peanut butter or even Nutella for a finishing touch.

As fall drifts away and December comes along, we'll be thinking about baking for Christmas. This is probably my favorite baking period as this is the time I prepare Mama's Dark Fruit Cake.

The recipe is one my mother used for her many years of baking fruit cakes. Of course, she substituted many of the ingredients to use fruits she had preserved in the summer. I, too, have adapted the recipe but it makes the moistest fruit cake I have ever eaten. This cake is moist with candied fruits and is chock full of nuts. Hubby and I make it every year, usually around Thanksgiving. We wrap it and store it in refrigerator. It keeps well and is ready for the holidays.

Umm, I think it's time to head back to the kitchen.

Washington Post: Congressional stock trading unfair

It is a long-running scandal that members of Congress are allowed to trade individual stocks. They have access to privileged information. They oversee a sprawling web of federal policy. Their actions can have direct effects on the companies in which they have stakes. The potential for real or perceived conflicts of interest is enormous.

Yet House Speaker Nancy Pelosi (D-Calif.) has not always favored cracking down on lawmaker stock-trading. "It's a free-market economy," she said last year, dismissing concerns. Lately, she has changed her stance, indicating that a stock-trading bill from Rep. Zoe Lofgren (D-Calif.) will make it to the House floor this month. That's good. The question is whether the speaker will do what's necessary to get it over the finish line.

Ms. Lofgren sent a letter to colleagues last week laying out a framework for a bill that would restrict public officials from exploiting their positions for personal gain: banning them as well as their spouses and dependent children from dealing in stocks, securities, commodities, futures, cryptocurrencies and similar investments, and mandating that they either divest existing assets or put them in a qualified blind trust. Those officials would still be able to hold diversified funds as well as government bonds, on the theory that dealing in those sorts of investments doesn't present the same potential for abuse. Disclosure requirements would also become more detailed, and the penalties for noncompliance more severe.

The proposal Ms. Lofgren described is appealing. But good-government advocates are nevertheless wary. Democratic congressional leaders have not allowed votes this year on multiple bipartisan bills written along similar lines, which hardly builds confidence that they are committed to reform. Timing is now an issue: Lawmakers leave Capitol Hill on Friday and will not return until after the midterm elections, so any knotty disputes will need fast untangling if the Lofgren bill is to pass.

The proposal's prospects are made even murkier by the pressure to apply the bill's restrictions to Supreme Court justices along with members of Congress. This is a guaranteed nonstarter for Senate Republicans, at least some of whom would need to support the bill for it to advance. Otherwise, the bill might pass the lower chamber, handing Ms. Pelosi a victory and a talking point, but perish in the upper one.

The speaker shouldn't allow that to happen. If Ms. Lofgren and her allies believe their bill is better than those already introduced, they should seize the opportunity to fix their own branch and leave the others for separate legislation. Some reform is better than none.

A recent New York Times report on congressional conflicts of interest revealed that nearly one-fifth of lawmakers bought or sold assets in industries possibly affected by their work. Some of the examples appear to show impropriety; the majority likely show only the appearance of it. But both are corrosive to citizens' faith in good government. In bringing a viable bill quickly to the floor, House Democrats would help restore public faith by holding themselves to account on stock-trading, and by doing what they said they would.





New book on Bayou D'Arbonne swamp must read

I just finished reading an outstanding book, "Bayou D'Arbonne Swamp," written by retired wildlife biologist Kelby Ouchley and it got me thinking about the swamps and woods I grew up around in rural Natchitoches Parish.


The "swamp" that stands out most in my memory couldn't really qualify as a swamp; it was a little creek that coursed through the woods at the feet of beeches and oaks not far behind our country home. Molido (pronounced Molly-doe) was where I learned to swim. It was the creek where I landed my first bass, killed my first squirrel, and fell victim to my first and only snake bite.

Ouchley delves deeply into the swamp where he grew up and currently lives by "offering a kaleidoscopic view of Bayou D'Arbonne swamp that reveals its unique past and distinctive flora, fauna and people".

Five miles or so from where I grew up was a "real" swamp, one I spent untold hours on hunting, fishing and exploring. Saline swamp - it really is a swamp - is a larger stream into which my Molido empties and eventually makes its way on to the Red River which empties into the Mississippi River which eventually ends up in the Gulf of Mexico.

It was along a certain stretch of Saline that as a kid, we dunked live crawfish impaled on a hook into the waters where the bottom was a mixture of sand and gravel. It was there where we caught what we called "smallmouth" bass when in fact they were Kentucky or spotted bass.

In his book, Ouchley really triggered my memory when he wrote about catch-"smallmouth" bass along Bayou D'Arbonne.

Another favorite activity in spring along Saline was wading out in the backwaters and scooping up the making of some of the best jelly known to man, mayhaws. Ouchley writes about doing the exact same thing in his swamp with a descriptive term that makes my mouth water. He writes "Mayhaws are small trees found in forested wetlands of the Southeast that produce a fruit used to make one of the finest jellies ever to grace a buttermilk biscuit."

Let's cut to the chase right here. Kelby Ouchley's writing style, in my opinion, rivals that of any writer anywhere when it comes to his gift of painting pictures with the written word. I have copies of his other books including the popular "Bayou Diversity: Nature and People in the Louisiana Bayou Country" that validate my point of view.

Here's an example in sharing his thoughts after a beautiful indigo bunting had crashed into the window next to his office.

"For tens of thousands nights I have slept in this place on the edge of the swamp as wild geese flew south and wild geese flew north, wings rustling the pages of my calendar, and now that I have surpassed seven decades of a life that has included many migrations, individuals of all species seem more important. Maybe it's a softening of my hard science outlook, or perhaps it is because I've had a couple of near window strikes myself that I made the effort to bury the indigo bunting beneath my favorite wild azalea. Purposefully."

Kelby Ouchley knows the bayou D'Arbonne swamp so well because he lives on a hill overlooking this place he loves. His background in working with wildlife all his life when coupled with his attachment to the natural world his swamp reveals to him is a gift few enjoy.
