Facility improvements approved at school board meeting

The December meeting of the Webster Parish School board was held in Sarepta on the campus of North Webster Jr. High on December 5 but, other than the change of location, the school board business conducted at the meeting was routine.

The minutes from November's finance committee meeting, curriculum committee meeting, and board meeting were approved. Jessica Green, an 8th grade science teacher at Lakeside Jr./Sr High, was presented with the Employee of the Month award by Rodney Taylor of Taylor and Sons. A number of faculty/staff trips to conferences were approved.

A new job description was approved that will allow speech therapists to

have assistants working under their guidance. The human resources department has had a very difficult time finding speech therapists and the new job description will enable the department to have more people working one-on-one with students.

The Minden High School cheerleaders have been approved to travel to the UCA Gameday Nationals in Orlando, Florida, pending their qualification for the event. They will be competing at the UCA State Competition in December in Hammond, Louisiana. If they get 1st place (or a very close 2nd place) in the Hammond, Louisiana, competition, they will be eligible to go to Nationals.

The Minden High JROTC was approved to travel to San Antonio, Texas, for JROTC Senior

Trip.

The procedures for the Special Education Audio/Video Recording policy were approved.

The school board will be accepting sealed bids for replacing the visitor-side grandstand at the Minden High School football stadium. They also approved a change order in the amount of \$31,819.83 for changes in the electrical service and storm shelter at the new Minden High School multi-purpose building. These changes were required by the City of Minden and the Fire Marshal. A number of maintenance projects/improvements using different maintenance funds were also approved. These projects will be detailed in a future Minden Press-Herald story.

As this was the final board meeting with the current board, some

members took this opportunity to express their appreciation of the Webster Parish School Board.

In January, Malachi Ridgel will be replaced by Debbie Thomas in District 2; J.J. O'Neal will be replaced by Jonathan Guthrie in District 4; and Fred Evans will be replaced by Jana Watson in District 6. Frankie Mitchell's position does not yet have a replacement.

Ms. Mitchell of District 9 is willing to continue in her seat until her seat is filled, but that will have to be approved by the new board in January 2023. There will be a special election to fill this seat in April 2023.

The next school board meeting will be held on January, 9, 2023, at 6 p.m. The public is welcome to attend.

North Carolina woman drops her pants on Lee Street

A North Carolina woman was arrested on Friday after obstructing traffic on Lee Street at Industrial Drive and then creating an obscene scene.

Officers were dispatched after Latasha Rena Bittle, 27, was reported to be displaying bizarre behavior in and around the roadway. She continued to act irrationally even after the police arrived to investigate.

According to the complainant, Bittle pulled a speed limit sign from the ground and then threw it into the road. She then walked into the road, causing traffic to come to a full stop.

"Once in the roadway," the complainant stated in the police report, "traffic came to a stop and Bittle began to dance. She then proceeded to pull her pants down to her ankles and began to slap her buttocks."

Next, she found a 2-foot piece of pipe and started chasing cars with it. She also charged at a group of people standing outside the Valero gas station and a person watching from the Exakta Inn parking lot.

When the officers ar-

rived, Bittle was standing in the street with the pipe. "I observed Bittle standing in the north-bound lane of traffic (Lee Street) with a 2-foot metal pipe," the officer stated. "Once Bittle observed officers, she proceeded to walk into traffic and then into the parking lot of 1403 Sibley Road (the Exxon station). At this time, officers made contact with Bittle in the parking lot of Exxon. As officers approached her, she had the metal pipe in her hand. Bittle was asked to drop the pipe, and she complied. As the officer began to speak with Bittle, she began to yell obscene language as the patrons continued to enter and exit the store. Due to her erratic behavior, I advised dispatch to contact the Webster Parish coroner's office to speak with Bittle. In doing so, she was later detained and placed into handcuffs and placed in a marked patrol unit."

Bittle was not placed on OPC [order for protective custody], and she was arrested and charged with simple obstruction of a highway, obscenity, aggravated assault, disturbing the peace, and simple criminal damage to property.

Runoff election results for Webster Parish

The Congressional General Election was held on December 10, 2022. In this election there were three runoff elections in Webster Parish plus three proposed constitutional amendments.

The mayor of Springhill will be incumbent, Ray Huddleston, who received 62% of the votes (a total of 637 votes) over Ronnie Hearnberger, who received 38% of the votes (a total of 394 votes). The unofficial voter turnout was 36.8% for this election.

In Minden, District A’s new city councilman will be Carlton Buddy Myles, who received 56% of the votes (a total of 227 votes) over incumbent, Wayne Edwards, who received 44% of the votes (a total of 178 votes). The unofficial voter turnout was 26.7% in this district.

Also in Minden, District C’s new city councilman will be Latasha Anderson Mitchell, who received

53% of the votes (a total of 149 votes) over incumbent, Vincen “Cheese” Bradford, who received 47% of the votes (a total of 130 votes). The unofficial voter turnout was 20.2% in this district.

Buddy Myles had this to say about winning the race for Dist. A’s Council seat.

“I just want to thank the people of Minden, for all of their support and for sticking beside me. Also I’d like to thank Councilman Edwards for his years of service to our community. It takes sacrifice to do that. Myself and I’m sure the community appreciates him very much.

“I’m looking forward to working with the new council to grow and implement new changes in the city to help us move forward from the days of the past. We have capable people on the council and in the mayor’s seat, and everyone is ready to work with one another.

“In the short amount of time since the runoff, I’ve gotten numerous texts and calls from people who are

ready to move the city forward, and I’m ready to do that as well. I’m looking forward to a new Minden.

“Again I want to say thank you to the people of district A, and to the new council and mayor, let’s put our boots on and get to work,” said Myles.

Latasha Anderson also shared her thanks to her supporters and ensured that she would continue to keep open communication with her constituents to help bring forth the changes in Minden that will move the city forward.

“First I want to thank God, then I want to thank all the people that voted for me and supported me, through the primaries and the runoff. I had some good supporters, I really did.

“I worked hard for this position. I walked and I talked and I walked and I talked to all the people in Dist C, and it paid off. I’m going to continue talking to people in the community, and anyone with any concerns is more than welcome to call or email me,” said Mitchell.

Proposed Amendment No. 1 which asked “Do you support an amendment to provide that no person who is not a citizen of the United States shall be allowed to register and vote in this state?” passed with 73% of the votes, meaning only US citizens will be allowed to register to vote and then vote in Louisiana.

Proposed Amendment No. 2 which asked “Do you support an amendment to

make appointed members of the State Civil Service Commission subject to confirmation by the Louisiana Senate?” passed with 71% of the votes, meaning that persons appointed to this position by the governor must now also be confirmed by the State Senate.

Proposed Amendment No. 3 which asked “Do you support an amendment to make appointed members of the State Police Com-

mission subject to confirmation by the Louisiana Senate?” passed with 71% of the votes, meaning that persons appointed to this position by the governor must now also be confirmed by the State Senate.

These are the unofficial results as of the evening of December 10. The official and verified numbers should be available by the end of the week.

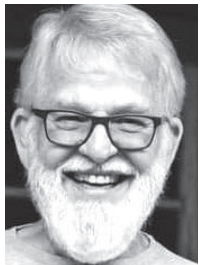


Evelyn J. Bradley

Millage for library on upcoming year ballot

Your Webster Parish Libraries will be on the ballot to have the current, critical operating millage renewed on March 25, 2023. The millage is not an increase, but a renewal of 12.39 mills for ten years. This millage makes up 97% of library revenue used to provide services to all residents throughout the parish. These funds are dedicated specifically for library operations and are separate from other departments.

The millage is renewed by vote every 10 years and the current millage will expire at the end of 2024. "The 10 year millage election results affect not only our libraries, but our entire parish. Our library system is the fourth oldest library system in the state and, in my opinion, one of the very best. This is because of the support received from Webster Parish residents year after year. It makes me proud to represent Webster Parish Libraries across the state. On March 25, 2023,

we will once again hope to receive support from the people we serve. Our libraries are a valuable resource to the parish, and I couldn't even begin to imagine what our communities would be like without them," said Savannah Jones, Director of Webster Parish Libraries. "When our parish residents go to the voting booth on March 25th, the fate of their local libraries will be in their hands. This means you will be voting on what you want to see happen with your local li-

braries! We have so much we want to continue accomplishing for all the residents of Webster Parish!" This millage renewal would provide continued funding to all seven branches of Webster Parish Libraries, which includes the Cotton Valley, Doyline, Heflin, Minden, Sarepta, Sibley, and Springhill locations. Funds from the millage are used to cover operating expenses and are vital to the continuation of current library services.

Twitter censorship files expose partisan intelligence officials in secret alliance with complicit media

He promised he would. For months before the actual consummation of the sale that gave him ownership, Elon Musk vowed to return free speech to the massive social media platform that is Twitter.

And there have been some discoveries that are as stunning as they are unnerving.

The release by Musk of internal emails highlights Twitter's 2020 censorship and suppression of the New York Post story a month before the 2020 presidential election. These revelations make undeniable the blatant conflicts of interest, influence peddling and likely crimes of Hunter Biden and the incestuous complicity of his business partner, 'The Big Guy'—then-presidential candidate Joe Biden.

But Twitter suppressed the New York Post story and shut down several prominent Twitter accounts, including that of the New York Post itself, that would have circulated the story.

What persuaded the Twitter brass of 2020—not to mention the corrupt and highly partisan national media—to suppress the story?

The Advocate: Governor's agencies - a legacy of disaster

With state agencies under historic challenges involving crime and abuse of children — toddlers dead after government and law enforcement failed to act, the juvenile justice system out of room for troubled youth — Gov. John Bel Edwards might well be accused of trying to shift the blame away from his appointees and his budget policies.

If he is, it's not going to work. But it makes no sense to look at the specific issues without dealing with the broader context, and that is going to be challenging not only to the current administration but to whomever is elected next year to replace Edwards.

"There is no denying that child welfare agencies nationwide are facing very difficult and complex challenges and Louisiana is no exception," Edwards said after particular-

ly horrific cases mishandled by the Department of Children and Family Services.

In that statement, accepting the resignation of DCFS head Marketa Garner Walters, the governor — as so often — talked about the mechanics of the challenges facing a state department trying to help abused children.

"Those issues include staff retention, high worker caseloads, increased substance and domestic abuse, and sadly the tragic deaths of innocent children," Edwards said. "While there are no quick solutions, it is urgent that we find new and effective ways of addressing the problems to make certain we provide the help our families need and deserve and to move our agency forward."

If that seems a tad bureaucratic in light of the deaths of fentanyl-poisoned toddlers, it

is: The consequences of these missteps and failures by agencies Edwards is in charge of haven't been a few missed deadlines or an aggrieved politician here or there, but truly tragic losses to our state and its communities.

Life-long losses, starting from age 2.

But to borrow from the governor's words, we can't deny that he has a point, and many of his same words could apply to the virtual collapse of the juvenile justice system.

The agency drew criticism from judges and district attorneys when it served notice that there's no room for more young offenders. Not that the agency has been doing a very good job of the difficult task of turning arrested kids away from a life of crime, despite good intentions.

What underlies the prob-

lems in both these areas of state government is a society under new stress.

That is reflected in conversations with district attorneys and judges in the courts, not to mention cops — and not just on the mean streets of big-city New Orleans, but in places where one homicide in a decade used to be the norm but where now they're looking at double-digit murders.

Talk to social workers and anti-poverty agencies, and their perspective is near that of officialdom. Although these folks are probably quicker to bring up the proliferation of guns in unstable hands, another larger reality that politicians often shy away from.

Families that were on the edge before — insert cataclysmic event of choice here, whether it be the pandemic, Hurricane Laura or whatever

— have been damaged. And once they topple over the myriad lines of bad behavior or child neglect, they make headlines like the ones from DCFS and the Office of Juvenile Justice. Or the crime reports.

The youth in today's OJJ prisons were toddlers when their families were scattered by hurricanes Katrina and Rita in 2005.

The governor is commissioning a major study of DCFS to figure out how to deal with the new reality there. But there's no denying that the problem is more than how a state agency is organized, or disorganized.

The next governor faces a new world. No denying.

G-Men grab win over Vanderbilt

NASHVILLE, Tenn. — For the first time in school history, the Grambling State University men's basketball program has picked up a pair of victories over Power 5 opponents in the same season. In November, the Tigers led from start to

finish in a home win over Colorado. On Friday, Grambling State held off a last-second shot in a 64-62 victory over Vanderbilt at Historic Memorial Gymnasium. The victory also marked the first Southwestern Athletic Conference (SWAC) school to defeat Vanderbilt.

The Commodores were 13-0 against teams from the SWAC and 34-1 all-time against Historically Black Colleges and Universities (HBCUs) before Friday's game. In addition, the win also evened the series at 1 between Grambling State and Vanderbilt. Carte'are Gordon

led Grambling State, despite fouling out, with 12 points five rebounds, two assists and one block. Shawndarius Cowart added 11 points, five assists, three boards and three steals. Virshon Cotton registered nine points, while Jourdan Smith and Jonathan Aku each finished with eight.

Bulldogs put 15 on All-CUSA football team

RUSTON — Louisiana Tech wide receiver Tre Harris, defensive tackle Keivie Rose and punt returner Smoke Harris earned first-team all-Conference USA honors, while defensive back Myles Brooks and Harris (kick returner) landed on the league's second team announced by the conference office last week. Wide receiver Cyrus Allen, offensive lineman Carson Bruno, placekicker Buck Buchanan and running back Marquis Crosby earned a spot on the Conference USA All-Freshman Team, while six more Bulldogs earned honorable mention all-league accolades.

Tre Harris earned all-conference honors for the second straight year after being named honorable mention in 2021. Harris led LA Tech with 935 receiving yards while tallying 65 receptions and 10 receiving touchdowns. Harris 10 receiving touchdowns ranked second among all C-USA players and 11th nationally. Rose was a mainstay among the Bulldogs' defensive line. The Henderson, Texas native recorded 24 total tackles, including four for loss and two sacks, in addition to three quarterback hurries and two forced fumbles. Rose tallied tackles for loss in three consecutive games during conference play (Middle Tennessee, UTSA, Charlotte). Smoke Harris was one of the top punt returners in the country, leading the conference and ranking seventh nationally with 12.4 yards per return. Harris returned 19 punts for 236 yards, includ-

ing a season-high 74 yards in punt returns during the season finale against UAB. Harris also led the conference and ranked seventh nationally in kick return average at 27.2. The St. Francisville native had 19 returns for 517 yards. Brooks made an immediate impact in his first season at Tech, recording 29 tackles, including three for loss in addition to three interceptions and eight pass breakups. Opposing quarterbacks completed just 36 percent of passes when targeting Brooks, which was the eighth-lowest completion percentage against nationally during the regular season. Allen averaged 22.73 yards per catch which was the second most nationally, while ranking sixth nationally

among all true freshmen in receiving yards with 500. Allen also led all C-USA true freshmen in receiving touchdowns with four. The New Orleans product also led all FBS freshmen in scrimmage plays over 30 yards with 10. Bruno started all 12 games on the Bulldogs' offensive line this season while paving the way foreight 100-plus yard rushing games. The Shreveport product also protected the quarterback in the Bulldog passing attack, ranking 30th nationally at 267.2 yards per game. Buchanan led all C-USA rookies in kickoff yards (4,070) and touchbacks (34). Buchanan made a 52-yard field goal, tied for the 10th longest in program history in the win over UTEP (10/8)

while connecting on field goals of above 40 yards against North Texas (46) and Rice (48). Crosby rushed for 918 yards and nine touchdowns on 183 carries, while eclipsing the century mark in rushing during four games this season, highlighted by a 197-yard rushing performance during the Dogs' 52-17 win over Stephen F. Austin on Sept. 10. Crosby ranked sixth nationally among all freshman in total rushing and fourth among C-USA backs in yards per rush. The Bulldogs saw six players earn honorable mention all-Conference USA honors, including OL Carson Bruno, RB Marquis Crosby, OL Bert Hale, OL Josh Mote, DB Willie Roberts and OL Dakota White.

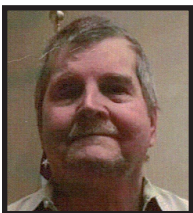

The GILGAL WATER SYSTEM, INC is currently in violation of the treatment technique requirements for minimum residual disinfectant level as set forth by the State (Part XII of the Louisiana State Sanitary Code). Although this incident is not an emergency, as our customers, you have a right to know what happened and what we are doing to correct this situation. A failure of the automatic chlorine system connecting the wells caused the minimum residual disinfectant level violation. The chlorine system has been repaired and the following Louisiana Department of Health samples should be within treatment technique requirements.

The Louisiana Department of Health (LDH) has determined that the presence of microbiological contaminants is a health concern at certain levels of exposure and requires the disinfection of drinking water to kill disease-causing organisms. Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses, and parasites which can cause symptoms such as nausea, cramps, diarrhea, and associated headaches. These symptoms, however, are not just associated with disease-causing organisms in drinking water, but also may be caused by a number of factors other than your drinking water. LDH has set enforceable requirements for treating drinking water to reduce the risk of these adverse health effects. Treatment such as filtering and disinfecting the water removes and destroys microbiological contaminants. Drinking water which is treated to meet LDH requirements is associated with little to none of this risk and should be considered safe.

We are required to monitor your water for the residual disinfectant level. This tells us whether we are effectively treating the water supply. During the compliance monitoring periods of (10-1-2022 through 10-31-2022, and (11-1-2022 through 11-30-2022), the GILGAL WATER SYSTEM, INC failed to provide the minimum residual disinfectant level in the treated water supplied to customers.
