WPSO seizes \$26k worth of meth

Mikel Stegall, 42, of the 600 block of Childs Road, was arrested for possession of a schedule II substance (methamphetamine) with intent to distribute. This arrest was carried out by the Webster Parish Sheriff's Office. As a result of the bust, WPSO obtained approximately 1.4 pounds of methamphetamine with a street value of around \$26,000.

On December 14, WPSO detectives and narcotics agents executed a search warrant after receiving information that a large quantity of illegal controlled dangerous substances was at said residence. Based on this information, detectives were able to obtain a search warrant for the



Police nab hiding man on assault charges

A Minden man was arrested on domestic abuse and aggravated assault charges after officers located him hiding in his victim's mother's home.

At the time of the initial incident, Nicholas Bryant, 31, and his girlfriend, the victim, were living together in the 400 block of North Roosevelt Street in Minden. Bryant's girlfriend was six months pregnant with his child, and they had been dating for a year and a half.

On November 30, the girlfriend confronted Bryant about text messages she had found on his phone from a prior girlfriend indicating he was considering rekindling their relationship.

"Nicholas was in the shower when confronted by [the victim]," she reported to police. "Nicholas became angry, exited the shower, and pushed [her] out of the bathroom and into a sheetrock wall across from the bathroom door. The sheetrock was damaged due to the battery. Nicholas then began striking [her] in the head and face area with open and closed hands. [She] was able to get to the living room of the residence before falling on the ground.

"While on the ground, Nicholas wrapped his arm around [her] neck, which prevented her from being able to breathe normally. Nicholas released [her], grabbed [her] by her hair, and began to drag [her] across the floor, telling her to get out of the house.

"[She] still had Nicholas' cell phone in her hand during this time. Nicholas attempted to grab the phone from [her]. [She] refused to give Nicholas the phone. Nicholas then bent down and bit [her] on her back near her right SPIRIT OF THE HOLIDAYS

WPSB funds repairs, improvements at several schools

During the December 5, 2022, board meeting, the Webster Parish School Board approved a number of expenditures to help maintain and improve campuses across Webster Parish.

The Consolidated District 3 Maintenance Fund will be used to purchase two Kwik Goal soccer goals for Lakeside Jr/Sr High School from Anthem Sports for \$7,216.80. It will also be used to pay an invoice of \$2,240 to Sexton Tree Service for the removal of a large pine tree which was struck by lightning at Central Elementary School.

The Doyline Maintenance Fund will be used to pay for HVAC work at Doyline High School. Mechanical Concepts will be paid \$6,388.96 to replace one compressor and inverter board, \$7,287.93 for repairing the HVAC system in the pre-K building, and \$8,886.62 for repairing the HVAC system in rooms 129 and 130 at the school.

The District 6 ½ Cent Sales Tax Fund will be used to pay Homeland Safety \$109,902.21 for security camera upgrades and \$3,670.50 for a remote electronic

locking system at Webster Jr High School. It will also be used to pay Mechanical Cooling Services \$1,650 for a blower wheel, housing, and motor for room 109 at Webster Jr High School.

Griffith Park will also be seeing some improvements courtesy of the District 6 ½ Cent Sales Tax Fund. Stewart Electric will be paid \$7,985 to repair or replace and re-aim the baseball field lighting, and Minden Farm and Garden will be paid \$1,080 for rye grass seed for the baseball field.

And last but not least, the Sarepta Maintenance Fund will be used to pay Mechanical Cooling for a blower motor and module form in room 104 at North Webster Jr High School.

The Webster Parish School Board continually seeks to improve and maintain our campuses across the parish to give students excellent environments to learn in. School board meetings are open to the public.

Report: Minden household expenses lower than national average

shoulder blade.

"During the physical altercation, Nicholas pulled [her] shirt off. Nicholas then 'threw' [her] off the back steps of the house with no clothing covering the top half of her body, and locked the door."

The victim stated that she knocked on the door, begging to be let back inside. When he let her back in, he hit her in the back of the head with an object as she walked past him. The abusive incident continued to escalate.

"Nicholas then walked outside of the residence to his [vehicle], retrieved a silver and black Smith and Wesson handgun and initially pointed the gun at [her]," the report continued. "Nicholas turned the gun to the ground and fired one round into the ground within approximately six feet from where [she] was standing. Nicholas then entered the vehicle and drove away from the residence."

Officers attempting to serve a warrant on Bryant located his vehicle parked at Hinton Park. One of the officers knew that the victim's mother's house was in the 1000 block of Mark Drive, which is within walking distance of Hinton Park. The officers proceeded to that address in an attempt to locate Bryant.

There were two people home at that time, including the victim. Both stated that Nicholas Bryant was not in the residence. However, the second person did contact the homeowner and gained her permission for the police to conduct a search. Bryant was located in a bedroom closet and was taken into custody without incident.

Bryant has been booked and charged with domestic abuse with strangulation, domestic abuse aggravated assault, and possession of a firearm by a felon — all three charges are felonies.

All subjects are presumed innocent until proven guilty in a court of law.

For more information you can visit their website at seedswomenscenter.com, or you can call (318) 639-0907 or text (318) 459-8579. study by doxo IN-SIGHTS found that people in Minden are paying 16.4% less than the national average on utility bills which include electric, gas, waste, and water and sewer. The study analyzed household spending for 2022 across the United States.

While many of the findings in this report could be expected, a few stand out as unusual.

Minden residents are paying about the same, on average, as the rest of the nation for auto insurance, life insurance, cable/satellite, and security alarms.

In some categories we came out better than the national average. The average cost of our auto loans is slightly lower than the national average at \$393 versus the national average of \$433. Our average utilities were \$243 compared to the national average of \$328. And both mortgage costs and rent costs were significantly lower than the national average: \$785 versus national average of \$1,368 for mortgages and \$745 versus national average of \$1,129 for rent.

However, in two categories, Minden residents are paying significantly more than the average American. While the national average for cell phone service is \$113 per month, our average is \$212 per month. And we are paying, on average, \$217 per month for health insurance while the national average is \$123.

All together, this study showed that, in Minden, we're paying about \$1,674 per month on household bills compared to the national average of \$2,003.



"They get two credentials and dual enrollment through BPCC. This is the first year that we've had 100% certification for the ServSafe Food Protection Management credential, which is the big one. It's not easy; it's a hard test. We have food handler certification and then the big one which is manager certification. That's required at every restaurant that you go into; somebody in that building has


to have one stuck on the wall. So, if they go into food service, they'll get a little bit more money and get looked at first on resumes."

Chef Carey presented the students with their certificates, and he also had a special gift for the highest scoring student, Kielyn Combs, who received a laser thermometer to use when cooking.

Kevin Washington, the supervisor of student services, also spoke, saying, "I want to showcase young people. Sometimes they're only getting press when they're not doing positive things. We have some amazing young people in Webster Parish. We have way more kids that do right than do wrong. I want to say kudos to these young people for doing an amazing job."

We must keep on keeping on and look to Him for the answers. Sometimes God places people in our paths to help us do that.



I am really looking forward to 2023. And, as most of us tend to do with the start of the each new year, I have set lots of personal goals upon which I



Glenbrook quarterback Ty Feaster was named Offensive MVP while the Apaches' linebacker Rhett Johnson shared Defensive MVP on the All-District 1-1A team..

The Apaches' David Feaster was named Coach of the Year.after guiding his team to a 6-0 record in district player and 10-0 egular season mark.

Glenbrook advanced to the quarterfinals of the select Division I playoffs before losing to eventual Division IV Select School champion Ouachita's Christian, 28-27.

Feaster, a junior, completed 157 of 231 passes for 2,436 yards and 37 touchdowns with only four interceptions.

Johnson, a senior, totaled 111 tackles, including 11 for loss, and three fumble recoveries. He shared Defensive MVP honors with Homer senior lineman Walteze Champ. Feaster was also named first-team all-

Our church has an annual food drive where bags of groceries are accumulated from donations and distributed to needy families in the community.

A few years ago, Kay and I helped bring a bit of joy to some families in our community. Seeing the faces of children and grateful parents and being able to take a bit of edge off what pain and anxiety they may be facing was worth giving up the few hours we spent.

As we handed out bags of groceries and received heartfelt thanks, my thoughts turned to memories of the season when I was growing up in the country.

Christmases Our were relatively simple, but that didn't make them any less special. When it came time to put up the tree, we didn't go to the shopping center and select an artificial one. We didn't go to a Christmas tree farm and cut our own from a neat row of cloned trees.

We walked out behind the house to the woods with the hope of finding a cedar growing away from other trees. This didn't happen often; you'd find a tree that looked just right and nicely shaped, until you checked the back side and saw that the oak next to it had robbed it of sunlight, leaving it shapely on one side and skimpy on the other. If this was the best one you could find, you cut it and put the skimpy side next to the wall.

For decoration, there was red roping, icicles and colored balls. We didn't have strings of lights during those early Christmases because there was nothing to plug them into. Electricity hadn't found its way to Goldonna yet.

My mama's kitchen was a mixture of sights, sounds and aromas as the special day neared. Dad, my brother and I made sure we saved a couple of wood ducks shot down at the Sand Flats for mama's special recipe.

I recall seeing those ducks, roasted almost black in a Dutch oven, swimming in a dark sea of the richest gravy you can imagine.

There was a pan of dressing mama made from cornbread she'd cooked the day before and set aside.

A fat hen provided the broth and zest to the dressing.

On the side, there was a bowl of ambrosia, pecan pies, chocolate pies, divinity, fudge and the traditional applesauce cake mama made from homemade fig preserves, raisins and pecans from our tree in the yard.

As we handed out bags of groceries that day, I recalled a parallel event from childhood that made me want to have a part in sharing with other folks this time of year. Before we sat down to our Christmas dinner, Mama would always prepare a big tray from the bounty of our table and our whole family would walk through the pine thicket to the home of an old couple, our neighbors, whose Christmas dinner would have been meager had it not been for mama's generosity.

Times change, and they do it in the blink of an eye. All the older participants in those early Christmases are gone; Mom and Dad, the old couple down the road.
