# Minden REC hoping to score some tournaments

Softball and baseball registration are open at the Minden REC, and Assistant Director Mike Aguilar is hoping that this will be another great season. Last year the Minden girls, known as Team Louisiana, won the Dixie World Series championship in the Angels X-Play division which was held in Alexandria.

"We're really proud of our 9- and 10-year-old World Series Champions that won it and our 11- and 12-year-old girls that were the runner ups," said Aguilar. "And our 11-year-old boys, who are now 12, finished third in the World Series in West Monroe last year. So we had a really good year last year."

In 2022, Minden hosted the 8U AA Coach Pitch District IV Tournament and the 12U O-Zone District IV Tournament. Plans are in the works to secure more tournaments for Minden this year.

"The state tournament director was here last year, and he was thor-

oughly impressed with the fields and the facilities," Aguilar said. "We did a banquet for the kids. Everybody loved it. We brought in \$41,000 in just gate money, approximately, for the city. And that doesn't even count hotels and restaurants, gas and snacks. I don't know what the full economic impact was.

"We are going to be bidding on the 9- and 10-year-old softball Angels division, the 13- and 14-year-old — which is the Belles division. We're also going to bid on the Sweeties, which is the 6-year-old division. For the boys' side, we're going to do the 12U O-Zone division. We're going to go down there and hope for the best."

Team sports have been shown to promote health not only physically, but mentally and emotionally as well. "Being on a team gives kids a sense of belonging," said Event Coordinator Zita Williams.

If you'd like your child or grandchild to participate, but they don't want to play baseball or softball, other sports are

# **Piney Woods Jamboree brings Branson-style entertainment** to Webster Parish

Mark Eubanks of the Piney Woods Jamboree is passionate about music and producing great shows for audiences. "I've been playing for 53 years -43 of those years professionally," Eubanks said. "My mom said I started at two years old, beating on Folgers coffee cans with pencils. I don't get tired of music."

The Piney Woods Jamboree Band is chock full of talented musicians. "The band are all studio and road-quality musicians," said Eubanks. "They all play three to five instruments apiece. They can swap around if they want to."

The Piney Woods Jamboree Band consists of Brett Traylor of Haughton, Louisiana, on piano; Gene Simmons of Dierks, Arkansas, on steel; Tommy Amason of Fordyce, Arkansas, on bass; Ronnie Hearnsberger of Springhill, Louisiana, on keyboards; Zane Glasscock of Magnolia, Arkansas, on lead guitar; David Mann of Warren, Arkansas, on lead guitar; Mike White of Shongaloo, Louisiana, on guitar and fiddle, and Mark Eubanks of Springhill, Louisiana, on drums. Together with the support staff, they have created an avenue to bring Bransonstyle shows to Springhill, Louisiana, on the second Saturday of each month (except in May).

This band does an impressive amount of work to prepare a new show with different headline performers each month. Eubanks described his part of the process, saying:

get the music to-"T gether, and contact all the ones who are going to be singing and say, 'give me four songs, the artist and the version that you're doing, and the key that you want to do them in.' I do that for each person and then send it out to all my musicians."

The musicians then have about two to three weeks to look over it and study it.

"Meanwhile, I'm putting the show together – how it's going to go, who's going in what order. I've got a comedian who comes out of Hot Springs each month - Mickey 'Shinbone' Shinn of Malvern, Arkansas – who used to be in Branson. When that's all put together, I send them out a copy of the set list so thev can look and be familiar with the flow of the show. They roll in on the day of the show at noon and set up, and from one o'clock

where from 24 to 27 songs together and put the show together. Then at seven o'clock we do the show. That's how good they are. To keep things fresh,

Eubanks enjoys thinking of monthly themes.

"I tend to try to theme shows. For the February show, we're looking to theme it with country love songs, because that's going to be Valentine's. It doesn't necessarily have

maybe like Rascal Flatts' song 'What Happens When You Play a Country Song Backwards' - you get your wife back, you get your dog back, you get your trailer back — it's funny. Or it could be like Willie Nelson's 'Always on My Mind.' The April show might be an Easter theme - looking more toward country gospel," he said.

The Piney Woods Jamboree is held at the Frank

tivity Center (FACA) in Springhill. Each show will start with a prayer and a rendition of the National Anthem, something that Eubanks feels strongly about.

Another thing that Eubanks strives for is the comfort of his audience. While the FACA has a seating capacity of about 900, they usually set up enough for only 600-700 people to give plenty of room to walk between rows of seats. Concessions are available and reasonably priced. And there is even a 31-unit RV park next to the FACA for people who want to stay close by. Admission is \$10. The doors open at 6 p.m., and the show starts at 7 p.m.

# **Free tax preparation through local VITA site**

With the many new changes in tax laws over the last 3 years, many people are uncertain about how to file their tax returns. The economic conditions that exist today, requirements by the IRS to receive stimulus checks and paying high fees for preparation of returns is not an option. So, what do you do? For the eight consecutive years, Greater Saint Paul Baptist Church has partnered with the Internal Revenue Service, United Way of Northwest Louisiana and Creighton Hill Community Development Corporation to offer free tax preparation and electronic filing to any person or family who earned \$58,000 or less per year.

Taxes are prepared by IRS certified tax preparers and submitted electronically to the IRS. If



you have a bank account, the IRS will deposit your return directly into your bank account. If you have no account, your refund will be mailed directly from the IRS. State tax returns will also be prepared and filed electronically. CHCDC VITA SITE has received the highest possible score, 100%, for the service provided to Webster Parish and surrounding parishes since its beginning. The Volun-

teer Site Coordinator Pastor Royal Scott, attributes the success of the site to the well trained and dedicated volunteers that love what they do and their high integrity. "This is a ministry for us and we receive great joy in helping people".

The location for these services is Greater Saint Paul Baptist Church 510 High Street in Minden. The site will be open Monday, Wednesday, Thursday and Friday from 3:00 until 7:00 p.m. Because of Covid-19 you must call for an appointment and masks are required. It is closed Tuesday and Sunday. **Two Webster Parish** educators to counsel new teachers as part of statewide initiative

WEBSTER PARISH, La. — Lakeside Jr./ Sr. High School English Teacher Josh Beavers and Minden High School English Teacher John Dillon were selected to be part of a new statewide initiative to help new teachers with issues they may face in the classroom. The New Teacher Experience is a pilot program in Louisiana that has a goal to retain teachers.

"The state saw the need that basically a lot of the support that they need ... They don't know how to handle a classroom as far as what to do in their curriculum," said Josh Beavers. "They have issues, and administrators are extraordinarily busy with all of the things they have to do. Other teachers are very, very busy. They have their grading. They have their home life, so some teachers are just left in the wilderness." "When you start off, you take everything personally. Everything the kids do or say that's disruptive, that's insulting," said John Dillon. "You start to realize all the problems the kids live with and deal with, sometimes on a dayto-day basis. Then, you realize that if you were

made to do this job, you're going to change who you are, change how you approach the kids and change how you approach everything in the classroom."

Teachers who were interested in becoming mentors had to apply with the state. They were selected to take part in this pilot program.

The inaugural group consists of about two dozen veteran teachers from all over Louisiana. Each teacher will work with a number of new teachers each month. The group will hold virtual meetings, so they can all share their experiences and solutions to cope with challenges. The first meetings will be held this month. Louisiana education leaders hope that this program will help build the confidence in new teachers and improve their students' achievements. The program is also designed to retain new teachers, so they do not leave after just a few years in the classroom. Every time we raise the debt ceiling, and an enormous gusher of new debt dollars pours into our national economy, we are increasing the level of inflation because way too many dollars are chasing way too few goods.

However, as Daniel Heninger of the Wall Street Journal notes, this time the debt ceiling debate is different. "The pandemic put the federal government inside everyone's head, and what the government did was spend, spend, spend, money, money, money. These spending rivers included a bipartisan Covid-relief bill of \$2.2 trillion; the American Rescue Plan's \$1.9 trillion, and then a bipartisan infrastructure bill of \$1 trillion. Mr. Biden's 2023 budget proposal was for \$5.7 trillion. In December he signed a \$1.7 trillion spending bill."

It's simply an ocean of federal debt spending.

But why is this time different? Because now, Henninger observes, "...Americans have one other mega-detail on their minds: an inflation spike that can't be separated from the spending spike."

Most Americans don't want to see the credit rating-as well as our international prestige-of the U.S. downgraded or weakened by the conclusion that America is going to default on its bills and obligations. However, most Americans are suffering acutely at the gas pump, grocery store and in virtually every aspect of their lives with the governmentally selfinflicted hidden tax of inflation which has dramatically shrunk the purchasing power of their dollars.

So, if, and only if, the debt ceiling increase is agreed to, it must be linked to structural reforms which actually begin the process of reducing the national debt and the annual budget deficit so that the nation's budget is placed on a trajectory such that in the not-too-distant future, tax revenues are balanced with spending outlays, as is the case with the budget of every American family. These reforms should include programmatic funding cuts as well as the very reasonable capping of discretionary spending at fiscal year 2022 levels while simultaneously implementing pro-growth policies that serve to offset the debt ceiling increase. A great place to begin would be rescinding unspent Covid funds as well as the highly partisan trillion-dollar spending on Green New Deal "projects."

What we are doing nowbrazenly defying the fiscal laws of gravity-is utterly unsustainable. On a bipartisan basis, we must quickly and permanently put our nation back on a path of fiscal responsibility by shrinking the size of the federal government and fostering an environment of economic freedom and growth.





Neither team could put the ball through the hoop in the early going, combining for 18 straight misses and the score being stuck on 5-4 for almost six minutes.

The offense slowly started to kick in for both teams. First it was UTSA (7-16, 1-11 C-USA) who built a 14-10 advantage with 5:54 to go in the first half. It was the 'Dogs turn after that, making their largest scoring run of the contest with 10 straight points, including backto-back three-pointers by Crawford and Williams.

The advantage ended up being 25-18 at halftime

and was pushed to a 32-20 lead at the 17:32 mark of the second half, but Crawford picked up his fourth foul. Then came the Roadrunners.

I enjoy a good movie now and then. I'll sometimes even go to a concert like the one I attended a week ago when Tommy Emmanuel's amazing guitar work made me want to head home and bust my guitar over a fence These events post. serve as an avenue of entertainment; we need such occasions to get us out of our rut and offer a measure of change from the daily grind.

For sheer entertainment, though, I'll take what Mother Nature has to offer any day. Sitting and observing the things that happen naturally in the Great Outdoors offers entertainment that money can't buy.
