## The Villas at Spanish Court are open for business

The Villas at Spanish Court are finally completed and ready for guests. The Villas, located on Union Street near Minden High, were built around 1931 by

F.C. McClanahan. "According to a news clipping from 1931, they were the most state-of-theart apartments in the state of Louisiana," said Sara McDaniel, owner of the Villas and Simply Southern Cottage. A former owner had stated that the villas fell into disuse in the 1980s. They had sat vacant until McDaniel breathed new life into these quaint apartments, turning them into stylish short-term rentals with designer decor.

"They all have a name," said McDaniel as she gave the grand tour. "This one is Laura. It was sponsored by Laura Ashley, so that means that there's Laura Ashley wallpaper, the art, the pillows, the rug, the

bedding, the kitchen dishes. All that is sponsored by Laura Ashley. So when a guest looks online, they can choose a villa according to what design aesthetic they want

ic they want.

"The Annie is sponsored by Annie Selke — I know the core style isn't for everybody, but it's about the experience," said McDaniel.

Some of the units are more calm and neutral like the Piper, which also contains designer rugs from McDaniel's own collection, and some are more beachy and tropical like the Cindy. All of the units have WiFi and access to a patio with a fire pit and string lights.

"I can't decide which one's my favorite," McDaniel said.

Because these buildings had been vacant for about 40 years, a huge amount of work was required to bring them back to life. "It had asbestos, lead paint, there was a lot of termite damage, so we had to rebuild the studs," said McDaniel.

"That's one reason why this is so expensive, because you have to remediate the

right way."

Much effort went into saving or replicating the historic architectural features of the buildings such as the fireplaces, cabinets, doors, and mantels. She was able to save the original bathtubs and tilework.

McDaniel is also really excited about her great staff. "We have such an amazing staff," she said. "I got so lucky. I hired a recruiter and did a nation-wide search for an inn-keeper/property manager, and I found somebody in Heflin. And she's perfect! The moral of that story is 'look in your own back-yard."

The Villas at Spanish Court have been featured projects over the past year in both Cottages & Bungalows magazine as well as American Farmhouse Style magazine. In fact, the Piper is showcased on the front cover of the February/March 2023 issue of Ameri-

can Farmhouse Style

magazine and "The Laura" is on the cover of the February/March 2023 issue of Cottages and Bungalows.

McDaniel is planning to have an open house on March 24 and 25. "Chef Jodie Martin and Chef Blake Jackson from Shreveport are teaming up for 'Smores & More' on March 24th, which will be an exclusive private event to tour the villas. There will be a progressive, charcuterie dinner through each of the eight villas capped off with a s'mores station. Landry's Vineyards will be on hand for a wine tasting. Ryan Miller, the 2021 recipient of the American Songwriter of the Year award, will provide live music. All proceeds from this event will support the 2024 Minden St. Jude Auction. The next day, 12 to 6 p.m., I will be hosting another Simply Southern Saturday, and people will be able to tour the villas. Saturday proceeds will sup-

## **Webster Sheriff announces arrest** of BDCC Deputy

Sheriff Jason Parker announced this evening the arrest of a corrections deputy for attempting to transport narcotics into the Bayou Dorcheat Correctional Center.

Corrections dep- PARKER uty Eric W. Robinson, 56, of Minden, was arrested on 1 count of introducing contraband into a correctional facility (R.S. 14:402) and malfeasance in office (14:134).

Sheriff Parker said Robinson was arrested as he attempted to enter the facility with 5 bags of synthetic

marijuana, also known as 'mojo' in his possession.

He was immediately terminated upon his arrest. Parker said the

arrest was the result of an ongoing investigation by the Webster Parish Sheriff Office Narcotics and Investigation Divisions.

"Our investigators worked diligently and

thoroughly to gather the facts and evidence to make an arrest and to stop the these drugs from entering our facility. No one is above the law, and we certainly will enforce the law equally to all, including our own employees. It is a disappointment to have to arrest one of your own because we hold ourselves to the highest standards of integrity and character. As sheriff, I will continue to uphold these standards and be accountable to the citizens of Webster Parish," said Parker.



#### Remembering Bernard Hudson

Bernard Hudson was born in Minden, Louisiana on September 28, 1946 to the late Dave Hudson and Tishie Warren Hudson. He accepted Christ at an early age at Growing Valley Baptist Church under the pastorate of the late Reverend J.H. Dixon and served as Chair of the Memorial Day/Veterans Program, Assistant Graveyard Marshal, and a Trustee Board Member.

As a child, he attended Growing Valley schools and later went to Union Elementary in Doyline. He played football and was a proud graduate of the Webster High School Class of 1966. After graduation, he enlisted in the United States Army for four years, received the National Defense Service Medal and the Armed Forces Expeditionary Medal in Korea and achieved the rank of Sergeant. Following his service, he attended Delgado Community College in New Orleans where he also worked as a security guard and received a degree in Criminal Justice. As a proud graduate of Webster High, he continued to host many of his high school class's

events.

Bernard loved his Growing Valley community and people. Regardless of where his travels took him, he was destined to return. He was always helping someone in and outside of the community, and he never met a stranger. He was "Louisiana Famous" for hosting his annual National Night Out community events at his home, and he has been described on many occasions as doing everything for so many and expecting nothing in return

Bernard was also a hard and dedicated worker at all his jobs. He worked at Atlas Refinery, the Kansas City Southern Railroad, the Louisiana Army Ammunition Plant and was the first Black person in the apprentice program at The International Paper Mill. The one place that he absolutely loved talking about the most was his time at General Motors as a maintenance millwright. Engines were started for the first time on his final line where he conducted the road tests. Because of his dedication to GM, anyone who knew him knew that he only drove AND rode in GM-made vehicles! He was a leader at UAW 2166 and remained at GM until his retirement in 2012 when the plant closed. Even the plant manager described him as someone he looked

up to himself. During his time at GM and especially with his newly found spare time, he became a member of several organizations. He was a District 7 Volunteer Fire Department Commissioner, a board member of the Carter Federal Credit Union, served as a member of The Pleasant Valley Water System and the School Board and was a Webster Parish Reserve Deputy. As an experienced and dedicated elected member of the Webster Parish Police Jury, his campaign slogan was... "I can't change the direction of the wind, but I can change the set of my sails." He faithfully served District #5 from 2016 until his untimely death. Because of his above and beyond service to the community and these organizations, he received numerous appreciation plaques and "Citizen of the Year" awards.

On Wednesday, February 1, 2023, while in his home surrounded by his loved ones, Bernard was called home to be with the Lord. There to greet him were his parents, Dave and Tishie Hudson; siblings, Clem Hudson, Etherline Hudson Kemp, Edward ("Monroe") Hudson, and Carrie Hudson Walker; and sistersin-law, Mae Hudson and Willene Hudson. He is now at peace and rests in the loving arms of his Lord and Savior, Jesus Christ.

His memory will be cherished by his children, Aileen Thomas (Skip) of Houston, TX; Rodney Ary (Tiko) of Baton Rouge, LA; Allyson Hudson of Minden; LaTori Combs (Kelly) of Dubberly, LA; Joshua Hudson of Minden; sisters, Lillie Doris Hudson of Los Angeles, CA and Peggy Hudson Morris of Minden; brothers, Dave Hudson and Lee Drue Hudson (Vernia) of Minden; brother-in-law Henry Lee Walker; grandchildren, Nicholas, Jaida, Khalia, Desirae, KJ, Jaylen and Kash; a special niece, La-Trisha ("Toot") West; special friend, Evelyn Parish of Minden and a host of nieces, nephews, cousins and friends.

Mr. Hudson was honored with a "Celebration of Life" ceremony on Saturday, February 11, 2023. Many spoke about his kind and giving heart and how he never met a stranger and Mayor Cox presented a Webster Parish resolution. As a veteran, he was also given full military honors and the flag was presented to his oldest child, Aileen Thomas, whom he actually just met only a few years ago. His oldest granddaughter, Jaida, sang a solo and his niece, LaTrisha, gave a beautiful family tribute. He will be missed by all who knew him.

## The death of academic freedom through DIE **Movement: Diversity, Inclusion, Equity**

Under the DIE creed, diversity doesn't refer to celebrating our National Creed, E Pluribus Unum, a Latin phrase meaning 'Out of Many, One' signifying that America's strength comes from the diverse cultural, religious, ethnic, racial and intellectual differences

tort and control the meaning of being melded into One Nation striving to Perfect Our Union by advancing our fundamental constitutional principles of "Life, Liberty and the Pursuit of Happiness."

On the contrary, to the Left, DIE means diversity in all things except thought, with free expression rigidly controlled by the Thought Police.

But there is more.

The Heritage Foundation undertook a study entitled "Inclusion Delusion: The Antisemitism of Diversity, Equity, and Inclusion Staff at Universities." The study first notes that the number of people devoted to DIE efforts has grown to about 45 people at the average university and then examines whether these large DIE staff are, in fact, creating a tolerant and welcoming environment on college campuses. Rather than promoting diversity and inclusion, universities may be contributing to an increase in anti-Jewish hatred by expanding DIE staff and power." (Jay Greene, Ph.D. and James Paul, Dec. 8, 2021).

Wow.

Florida Gov. Ron DeSantis' administration has pushed back hard against DIE.

To ascertain funding at its state colleges and universities, Gov. DeSantis scrutinized what funds were used for DIE. He discovered that numerous DIE staff members are on the payrolls of Florida's colleges and universities and that DIE "may be better understood as jobs programs subsidizing political activism without improving campus climate," not fostering a welcoming environment for all students.

This kind of censorship simply cannot be allowed if our Republic—and the freedoms guaranteed by our Constitution—are to endure. The greatest virtue of free thought and free speech is that all kinds of ideas are thrust into the rough and tumble of the marketplace of ideas where the best idea prevails.

DIE must be opposed and defeated, and die.

As an activist, who witnessed and experienced child abuse in an orphanage, I must take a stand for those who have no

The Bible says "It were better for him that a millstone were hanged about his neck, and he cast into the sea, than that he should offend one of these little ones" which I think applies to anyone who is helpless, such as children, the elderly or those who are mentally challenged.

According to Safe Horizon, which is the largest non-profit victim services agency in the Burroughs of New York City, one in ten children are being abused.

How would you like to be a defenseless child who has no voice? Recently I was talking to someone who thinks we shouldn't be whistle blowers, ones who take a stand on such issues as child abuse which really agitated me, causing me to respond that if we don't report child abuse we are just as guilty as if we had molested or abused the child ourselves! If not, why not?

I can't help but ask why would anyone not want child abuse exposed?

After being in a loving foster home, I could hardly believe the abusive orphanage where I landed. Rather than be a victim, I decided in October, 1962, at the age of fourteen, that I would make it my mission to expose what often goes on behind closed doors.

I was shocked when a tenyear-girl asked me to step into the bathroom with her at church. In horror I watched her unveil massive layers of blackened bruises beneath her

Without hesitation I told her "tomorrow we will go to the school nurse." I knew I'd gone against the home. I nervously

watched

the clock school, dreading my punishment. Still I felt proud of what I'd done. Just as soon as I arrived back at the home, I boldly hurried off the bus and told the superin-

tendent who was waiting for us. Instinctively I knew he was looking for the one who had reported an employee.

I was verbally slapped in the

face when he said me he'd tell my housemother because the nurse had kept my name anonymous when she visited the home.

She lectured me for hours, telling me how she had beaten her daughter with a garden hose so severely she had to be put to bed. She didn't dare lay a hand on me because she knew I would report her.

My punishment was to be one month's grounding -- and I wouldn't be able to bathe or wash my hair. I was to wear the same dirty clothes to school and church for the duration of my grounding.

I suppose she thought this would make me look stupid.

Sixty-one years later I smile because it backfired on her the following Sunday morning when she suddenly remembered that was to be the day of "Open House," when the home showcased our immaculate cottage to display our "wonderful home-like" environment to the many church members who might choose to visit the orphanage and leave a contribution to the "worthy cause" so they might be hoodwinked into feeling good about their generosity as they recalled our plastic smiles and wellgroomed appearance.

Never did my housemother fly so fast to see that the older girls helped me wash, set and dry my hair in a day before blow-dry hair styles.

Though more than half of a century has passed and the abusive housemother was finally fired the following year, and my own sadistic housemother was later fired, I'm proud of the shy, undersized, awkward fourteen year-old girl from the backwoods of Arkansas, who took justice into her own hands back then and continues to do so, being the activist that I am, as I strive to be an advocate, a voice to speak out for those who appear to have no voice!

Even though the orphanage has moved and changed their name court records show abuse still reins while they home school their children which makes it harder to report the abuse.

One house father is serving time in prison for repeatedly raping and sodomizing a young girl in 2003.(She was unable to report the abuse until she went home.)

In 2010 I compiled and published a book of true stories written by these adult children (many in their 50's and 60's) because they wanted to finally be heard to give some closure to what went on back then and perhaps to prevent future abuse.

If we don't protect children who will?

## Protecting your camp during the off-season

It was finally the weekend. Spring turkey season had arrived and all Neal Windley of Norfolk, Va., wanted to do was get to his farm, change into his camouflage and get into the woods. What he found when he arrived not only put a halt to his weekend of hunting, it also cost him thousands of dollars in repair and prevention.

"Windley's hunting camp was demolished. Windows were broken, a television and other items were missing and the once clean and comfortable house had been turned into a disaster area.

Sadly, that was not the first time this had happened. Vandals had trashed his camp two other times. Sweeping up glass and filling out police reports were not what he had in mind when he and a good friend originally bought the land in the early 1990s. The above report was


part of a news release I received from the National Wild Turkey Federation. The report from the NWTF gives sobering evidence that all too often, hunters head for camp after a long hiatus to find just what Neal Windley found.

The first thing I did after reading the NWTF press release was call a fellow club member to see if he's checked on our camp lately.

I breathed sigh of relief when he reported he was there this past weekend, and everything was as we had left it.

The second thing I did was call the Lincoln Parish Sheriff's office to talk with an agent to see if there have been incidences of hunting camp vandalism and/or theft recently.

I learned that there are several things hunting

The hunting camp is a fine gathering place during hunting seasons but can be a target for thieves during

camp owners can do during the off-season to keep criminals from trashing or stealing from your hunting

First, if your camp has a locked gate, be sure to keep the gate locked. This won't necessarily prevent theft but it makes it harder for thieves to cart off large

Another important thing is don't leave valuable items, such as 4-wheelers, guns, cookers, lanterns, etc. at the camp. Take them home for the off-season.

You or somebody in your hunting club should check on your camp regularly. Also, you might get a neighbor who lives near the camp and who you trust to keep an eye out for what may be going on when you're not there. One

of the problems is that the

Sheriff's office will get a re-

port in the fall when hunters arrive at the camp and it may have been broken into in late spring. That time lag really hampers what can be done.

Make an inventory of everything of value in your camp, just like you should be doing in your home.

Write down serial numbers, description of each item, and where practical, put some identifying mark on the item in a concealed area so thieves won't be as likely to find and remove it. Take photos of valuable items to aid in identifying them should they be stolen.

Some other suggestions, offered by the NWTF, is to give the appearance that someone is home. Leave a radio or television playing, put your lights on a timer or

leave an unused vehicle in

the driveway to discourage trespassers and thieves.

Another way to keep your hunting camp safe is to make the local authorities aware that the camp will be unoccupied for a designated period of time.

Talk to the sheriff's department, U.S. Forest Service and local law enforcement agents in the area. Each of these offices makes regular patrols and can help protect your hunt camp.

Also leave keys to your property's gates with someone in authority to help them watch your place while you are away.

Follow these suggestions and you stand a better chance of finding your hunting camp this fall just as you left it....except of course for dirt dobber nests and the occasional

## School expenditures approved in February 2023

During the February 6, 2023, board meeting, the Webster Parish School Board approved numerous expenditures to help maintain and improve campuses across Webster Parish.

Lakeside Jr/Sr High will be paying an invoice for \$3,600 to Mechanical Cooling for a new HVAC compressor motor protection and related parts. Central Elementary will accept the proposal from

Fitzgerald Plumbing of cal Concepts for replac-\$12,600 for boring under the concrete drives to install 2-inch water lines to the existing fire sprinkler system on the stage. Both of these will be paid out of the Consolidated District 3 Maintenance Fund.

Using the Doyline Maintenance Fund, Doyline High will be paying an invoice from Mechanical Concepts in the amount of \$2,525.60 for repairs to the HVAC system, and they will also be accepting a proposal of \$4,870.93 from Mechaniing the defective coil and evaporator core in the nurse's station. Doyline High will also be purchasing field conditioner, sure dry, and mound clay from Minden Farm and Garden for \$2,570. And Doyline High will be accepting a proposal of \$5,500 from Lynch's Lawn & Fence for a sidewalk and landing.

The District 6 ½ Cent Sales Tax Fund will be used to accept a proposal from Mechanical Cooling services in the amount of \$122,800 for replacing all

the HVAC front end controls on buildings A, B, C, and D at Webster Jr High.

North Webster High will be accepting a proposal from Gentry & Holder Floors in the amount of \$2,700 to screen and recoat the gym floor. North Webster Jr High will also be purchasing a 14' x 28' custom built portable building from **Christ Built Construction** for \$28,950. This building will be used as a concession stand for the football complex. And JnJ Fencing will be paid \$15,619.97 for reconstructing selected fencing at the Sarepta Sports Complex. These purchases will be paid out of the Sarepta Maintenance Fund.

North Webster Lower Elementary will be paying Southern Pipe \$5,649.96 for replacing a 100-gallon hot water heater, using the Shongaloo Building Fund.

And in Springhill, the Springhill Maintenance Fund will be used to pay Mechanical Cooling \$1,750 for replacing multiple bleeder valves on the HVAC water lines at North Webster High.

The Webster Parish School Board continually seeks to improve and maintain their campuses across the parish to give students excellent environments to learn in. School board meetings are open to the public. The next meeting will be held at the school board office on March 13, 2023, at 6 p.m.

#### **New housing development** coming to Minden

A new housing subdivision, named Millwood Landing, will be coming soon to the Minden area. The project is being developed by Micah Hanson, Senior Vice-President at b1Bank, and Chad Still, owner of TImberland Services LLC.

"Chad Still and I started a real estate holding company in 2008. We've purchased and sold several properties through the years," said Micah Hanson. "The housing supply in Minden is limited. The diverse geography, Kisatchie National Forest and Camp Minden are all unique attributes of South Webster Parish. However, this can create obstacles for new home builders."

Millwood Landing will be sited on Hwy 532, between I-20 and Hwy 80. This location was carefully selected with several factors in mind.


"The property location was chosen due to its proximity to the city of Minden and its ease of access to Interstate 20," Hanson said. "Allowing homeowners who may work either to the east or west of Webster Parish a quick commute each day.

"This is considered Minden and is outside the city limits. Electricity will be provided by Entergy via underground service. CenterPoint Energy will provide natural gas. Water will be provided by the Dixie Overland Water Sys-

The property name was chosen as a salute to the new sawmill that Hunt Forest Products is building in Bienville Parish.

"The new lumber mill currently under construction in Taylor, Louisiana, is something we feel will spur economic growth in the Minden area. We choose this name to give recognition for the positive impact this new industry will have," Hanson

Millwood Landing will



consist of 52 lots, each at least 1 acre in size, as well as green areas and a small family park. Pricing is going to start in the low \$60,000's and go to the high \$70,000's.

Once the weather allows road construction to begin, the roads should be finished in 60-90 days. After that, the lots will be surveyed and available for

"We have a list of potential buyers to contact on a first come first serve basis," Hanson said. "Anyone with interest can contact either of us directly. We are also available to give tours of the site to anyone before the work begins. This will answer any questions that potential buyers may have concerning the "buildability" or appearance of the lots.

"We are currently working with our attorney on the subdivision covenants. We'll begin preselling lots once covenants are finalized and filed."

Once you purchase a lot, you can hire your preferred construction company to build your new

"Purchasers will be able to use their own contractors," Hanson said. "Plans will have to be approved by the Architectural Control Committee before construction begins. We also have talked to several local builders considering lots for spec house construction.

"Our intentions are to develop a clean, safe, family-friendly atmosphere for homeowners of all ages," said Hanson.
