Cresson speaks about fish conservation at Lions Club

David Cresson, executive director and CEO of the Coastal Conservation Association (CCA) of Louisiana, was the guest speaker at the noon Lions

Club meeting on June 22. CCA got its start in 1977 when a group of recreational fishermen formed the association in an effort to protect the populations of redfish and speckled trout that had been decimated by commercial overfishing along the Gulf Coast. CCA has expanded and now has 30 chapters all along the Gulf Coast, the Southand MId-Atlantic regions, the California coast, and up into the Pacific Northwest. One of their largest chapters is located in Shreveport. Each chapter has regional fish that they help to manage and protect. But some species of fish are easier to protect than others.

'Many of our fish in the Gulf are managed by the federal government, and the federal government — without fail — does a pathetic job of managing fish," said Cresson. Fish such as bluefin tuna, sailfish, red snapper, and marlin are considered offshore species and are managed by the federal government. "I wish we could get more of the management of those species into state management because, at least at the state level, we have more immediate access to that level; we can go to people like [Senator] Robert Mills and [Representative] Wayne McMahen, and they can help us start making a difference. Where, at the federal level, even though we've got great congressmen and women, the wheels of government in Washington D.C. grind extremely

"We build artificial reefs all along the coasts." said Cresson. "One of the big issues we deal with in Louisiana is the loss of our reefs. There's really two ways we lose our reefs. One, our oyster reefs across Louisiana are getting demolished. There's a number of factors, but the number one factor is how we harvest them [dredging]. The other way that we're losing habitat in Louisiana is the removal of the [oil] platforms in the Gulf of Mexico. And I call them reefs, because that's what they become; the second they hit the water,

they become a reef and

a habitat for fish. They're being removed, but that's removing fish habitats along with them. So we're going behind those spots and rebuilding reefs."

CCA is using old construction materials to replace these habitats, giving the smaller fish a place to call home which, in turn, attracts the larger fish. "In the last five weeks, we have built five reefs. These are expensive projects. They cost hundreds of thousands of dollars. We work with big companies like Shell and Chevron and ConocoPhillips and others to develop the funding for these projects. The state of Louisiana works with us and matches the dollars one-to-one," Cresson said. "Once we build one of these projects, the fish show right back up."

Cresson wants people to know also, that one of the biggest threats to fish is foreign owned industry. In particular, two companies, one out of Canada and the other out of South Africa, are coming to Louisiana's shores and harvesting a very important forage species that we call pogy (menhaden) that

other fish need to live. They do this about 12,000 times a year in Louisiana.

"The important thing about menhaden is that everything in the Gulf of Mexico eats these fish," said Cresson. "So when you pull a billion pounds out of our water, clearly you're going to have an impact on the other fish that rely on that forage. Not to mention they also take about 50 million pounds or so or bi-catch things like trout and redfish and shrimp and other species that we depend on.

"We're the only state in America that allows them to do what we're allowing. There are other states that allow them to do it offshore, but they don't allow them to do it on their beaches like we do here in Louisiana." Cresson asks that you as a voter in this upcoming election year, ask candidates what they plan to do about the pogy situation.

Whistleblowers make clear that Hunter Biden received highly favorable treatment from DOJ

What a sweetheart deal. Two misdemeanors and pretrial diversion for countless crimes established by the Laptop from Hell.

It's really no surprise to learn that Pres. Biden's son, Hunter Biden, has received highly preferential treatment regarding the numerous criminal allegations against him, charges that would send most Americans and any Republican to federal prison for years.

It's still important, though, to know with clarity how Joe Biden has corrupted the DOJ and the FBI to protect Hunter and himself.

What am I referring to?

This past week news broke that the Biden Department of Justice hindered, in numerous ways, the investigation of Hunter Biden.

Of course, for months, a lazy and compliant national media has spun the narrative that the investigation really wasn't receiving any special treatment. We now know that was false. Two whistleblowers, one named and one anonymous came forward this week and gave sworn testimony.

The named individual, Gary Shapley, a 14-year IRS veteran, and the anonymous individual have told a story of "blocked search warrants, tip-offs to Mr. Biden's (defense) team, squelched avenues of investigation, downgraded charges, and interference by Joe Biden's appointees." (K. Strassel,

WSJ, 6-23-23).

Shapley testified that the DOJ, its Tax Division and the Delaware U.S. Attorney's Office provided Hunter Biden with "preferential treatment and unchecked conflicts of interest." (WSJ, 6-23-23)

Shapley, head of an elite team of tax investigators, testified that his team was almost immediately prohibited from taking normal in-

vestigatory actions.

thwarted both in doing spontaneous questioning of witnesses and in searching for evidence be-

cause somehow the Hunter Biden defense team was tipped off and able to impede it. Shapley was also not allowed to ask questions about "dad" or "the big guy". They were also prohibited from investigating campaign finance violations.

It goes on and on.

Shapley provided further evidence of influence peddling when he revealed WhatsApp message in which Hunter Biden tells a Chinese businessman: "I'm sitting here with my father" and urges the businessman to fulfill the "commitment."

Hunter Biden then warns the businessman to personally resolve the issue that

night or "I will make certain that between the man sitting next to me and every person he knows and my ability to forever hold a grudge that you will regret not following my direction." (K. Strassel, WSJ, 6-23-23).

There are also photos of Hunter Biden on his laterabandoned laptop showing him at President Joe Biden's Wilmington, Delaware home on the day he included his father's name in the WhatsApp message he sent to threaten his Chinese business associate, Henry Zhao, an official working with Chinese energy conglomerate CEFC Energy. (Newsmax, 6-23-23).

While Shapley did not provide evidence that Joe Biden was actually in close physical proximity to Hunter Biden as he threatened businessman Zhao, "if Joe Biden was sitting next to his son as he sent the message as it suggests, it would be a fatal blow to the president's repeated claims that he never discussed overseas business deals with his son, and the photographs of Hunter Biden at what appears to be a family gathering at the Delaware home is the strongest indication that he was in close proximity to his father when he threatened the Chinese businessman." (Free Beacon, 6-22-23).

In another email later that day Hunter Biden also mentioned "me and my family", confirming an agreement

for a \$10 million contract for "introductions alone," with bonuses for any successful deals that come about as a result of the Biden family's

Still further, Shapley also points out that Hunter's one-time business partner, Rob Walker, admitted to investigators that an "orchestrated" appearance of Joe Biden while out of office was made to "bolster" the odds of a "deal work (ing) out. "

For obvious reasons, Shapley recommended more serious felony charges than the minor counts to which Hunter Biden has now pled.

If this is not an example of influence peddling-and blatant corruption of our Constitutional principle of equal justice for all—then I don't know what is. 

About a month into summer offseason workouts, Minden Head Coach Spencer Heard is pleased with the progress his team is making.

In addition to regular practices three days a week, weightlifting and speed work, the Crimson Tide have been playing 7-on-7 games each Thursday against Airline and Lakeside.

The first games were June 15 at Airline. Last week, Haynesville joined the three teams at Lakeside. The next games are set for Thursday at 10 a.m. at Minden.

While the games are certainly competitive, the outcome isn't what's important. Developing skills that will help win games in the fall is the main pur-

Of course, 7-on-7 is all passing so it mainly helps develop timing between quarterbacks and receivers. Defensive backs also hone coverage techniques.

"It's been good," Heard said. "I feel like we're getting good work. I think it's really good especially for our defensive backs because they have to try to cover for such an extended period of time. There's definitely been some progress in that area."

Minden has a new starting quarterback in rising junior Hudson Brown, son of Minden head boys basketball coach Jacob Brown, himself a former Tide quarterback.

"We've got a young quarterback," Heard said. "He's getting a lot of looks, different schematic looks, but also just getting used to our scheme in terms of knowing where guys are and kind of getting comfortable with the receivers.

'It's good to get Hudson those reps. He's showing he's got the ability for sure.

Rising senior Jakobe Jackson, one of the area's best athletes, was the starting quarterback last year and will likely see some action at the position again.

But Jackson will mainly be used as a slot receiver and safety.

"He's definitely our most explosive player," Heard said.

Heard said he couldn't pinpoint just one receiver or defensive back who's stood out.

"I think they're all just working hard," he said.

The 7-on-7 games are

especially beneficial to the young players.

One of the things we try to do too with the 7-on-7 stuff is just have a lot of guys get reps," Heard said. "Young guys, just kind of throw them out there and see what they can do

"Some of the young ones get out there and they do some positive things but then they get beat and make mistakes but that's how they learn. I definitely saw a progression from the first 7-on-7 to the second one. Hopefully it just keeps getting better as the summer wears on."

Minden is playing in a 7-on-7 tournament in El Dorado, Ark., on July 12.

The official start of fall practice for teams that had spring practice is Aug. 7. The Crimson Tide opens the season Sept. 2 at Park-

New Glenbrook coach hits the ground running

New Glenbrook Head Coach Reagan Smith has been guiding his team through summer workouts for about four weeks now. He said things have gone smoothly so far.

'It's just a really good fit," he said late last week. "The kids are very coachable. They're used to winning. They're learning my way of working out. And it just seems to be going really positively.'

Smith was officially named head coach on May 11. The Apaches started summer workouts on June

This is Smith's first head coaching job after a highly successful career as an assistant with stints at North Caddo, Parkway, Logansport, Evangel Christian and West Monroe.

He spent the last four seasons helping North Caddo enjoy unprecedented

"I felt like I needed a new challenge," he said. "When I stepped back and analyzed what all had occurred in my career I felt like I needed to try it. I needed to kind of expand on what I had already done. And I didn't know what that would look like. So far I feel really good about it."

Glenbrook hasn't played 7-on-7 games against outside competition. But the Apaches have competed against each other. "We probably won't

participate in any tournaments," Smith said. "But we have done a little bit with each other and it has been really positive. It's good or better than I expected."

Besides regular workouts, weight training has been at the forefront.

A former offensive line coach, weight training is something that's especially important to Smith, who is an expert in the area.

"That's my thing," he said. "I'm a big weight room guy. But not in a traditional sense. I try to track like what is the latest and greatest in basically strength technology. And so we try to implement things that give us an edge in that respect."

Smith said about 50 players in grades 7-12 have been participating in workouts this month.

The Apaches are coming off a 12-1 season that ended with a 28-27 loss to eventual champion Ouachita Christian in the quarterfinals of the select Division IV playoffs.

Many of the key players from that team are gone.

"The good news is we return more lineman, more functional, capable linemen, than I can remember almost anywhere I've been," Smith said. "So there are tons of linemen and there are still a handful of athletes. So I think that that's really positive. I think that that's really something that was a pleasant surprise."

One player Smith is especially high on is rising senior Landry Powell, who is also an outstanding baseball player.

Smith said Powell will be playing linebacker and could line up just about anywhere on offense.

"He's a college level player," Smith said. "On offense he can play all of them, like literally he can play quarterback, running back, receiver. He has the potential to be a really good receiver."

LDWF says leave fawns alone

Kay and I were driving home after a special Father's Day lunch in town, and as I glanced toward the pasture across the road from our home, something caught my eye. It was a tiny fawn standing within a few yards of the pasture fence.

I stopped, lowered the window and snapped a few photos of the little fellow before it wandered off across the pasture. I posted a snapshot of the little deer on Facebook and within an hour, there were responses from others around the region who had also seen newborn fawns.

'We saw one about 20 minutes ago less than a few hours old"..."I saw one outside of Tullos in Winn Parish last Wednesday."... ."One was in my yard."... "My husband saw two today here in the woods.'

What does this all mean? You don't have to be a wildlife biologist to realize that this is the time of year when fawns are being born in our area.

Every year about this time, I receive a press release from the Louisiana Department of Wildlife and Fisheries (LDWF) reminding people who encounter what appear to be abandoned young deer alone in the outdoors, that those fawns should be left undisturbed.

Here's how the press release reads..."Every year the department receives calls from concerned citizens who have found what they consider to be "abandoned" fawns. Well intentioned, concerned citizens sometimes bring fawns home and then call the department to retrieve and raise them.

"LDWF is alerting the public that it is against the law to capture young deer or any other wild animal. If caught transporting or

possessing wild deer without a permit, well meaning individuals may be subject to citations and fines.

"Picking up fawns seriously diminishes their chance to live a normal and healthy life. When a fawn is born, it is weak, awkward and unable to move well enough to feed and escape predators. However, the newborn fawn has a coat of light brown hair liberally covered with white spots that provides excellent camouflage against predators. The mother doe will remain in the area to feed and nurture the fawn. When the young deer gets older and stronger it will be able to forage for food with

its mother. encountering "When fawns in the wild, simply leave them untouched and depart quietly from the area. This action will provide the young deer its best chance to survive in the wild and prevent a possible citation for a well-intentioned outdoorsman. been

'There have too many cases of kindhearted folks picking up what they believe to be an abandoned fawn and with the idea of keeping it as a cute little pet. There have been numerous reports of that sweet little creature becoming aggressive and dangerous once it reaches maturity.

"If it is confirmed that the mother has in fact died, such as seeing a fawn next to a road-killed doe, what you should do is call the LDWF and report what you

find. There are facilities that are licensed to take in such baby animals.'

If you should chance to walk up on one in the weeds or next to a log, snap a photo if you would like and back away slowly. The doe is likely peaking through the brush somewhere nearby and is probably watching you to see if you are a threat to her baby. Once things settle down and you leave, she'll return and the little one will follow her away.

t's tempting I know to have compassion on what seems to be a helpless little baby deer and rescue it from harm when in fact, this is Mother Nature's way of taking care of the situation. Mother doesn't need your help.
