GAS BUDDY Gas prices on the rise WILL PHILLIPS

Average gasoline prices in Louisiana have risen 6.4 cents per gallon in the last week, averaging \$3.09/g today, according to GasBuddy's survey of 2,436 stations in Louisiana. Prices in Louisiana are 0.3 cents per gallon higher than a month ago and stand 94.6 cents per gallon lower than a year ago. The national average price of diesel has risen 0.1 cents in the last week and stands at \$3.80 per gallon.

According to GasBuddy price reports, the cheapest station in Louisiana was priced at \$2.77/g yesterday while the most expensive was \$3.69/g, a difference of 92.0 cents per gallon.

"With oil prices rising to \$75 per barrel last week, the highest level in months, the national average price of gasoline saw similar upward pressure, with a little over half of the nation's states seeing gas prices rise last week," said Patrick De Haan, head of petroleum analysis at GasBuddy.

The national average price of gasoline has risen 3.4 cents per gallon in the last week, averaging \$3.53/g today. The national average is down 1.6 cents per gallon from a month ago and stands 97.5 cents per gallon lower than a according to GasBuddy

Ryan Barnette speaks at Lions Club

The guest speaker at the noon Lions Club meeting on July 6 was Deputy Ryan Barnette. Barnette has over 15 years of professional experience in law enforcement and is

the creator of Nine and One Tactical, a mindset and tactics based training company that offers realistic firearms and personal defense training. Barnette BARNETTE spoke specifically on the legal issues

associated with using lethal force.

Lethal force is defined as the amount of force that will cause death or great bodily harm. This covers many possibilities including shooting someone, running them down with a car, or pushing them off a building. A person does not need to die in order for lethal force to be in effect.

Barnette has boiled all

"There are three things that have to be present for lethal force to be legal and justified," said Barnette. "Those three things are ability, intent, and op-

portunity. When am I legally authorized to use lethal force? The answer to that is those three words. When the bad guy, the offender, the attacker has the ability, the opportunity, and

the intent to cause you or another innocent person death or great bodily harm. It's really that simple."

Barnette went on to share some scenarios in which one of the three factors was missing, and clarify some points. For example, an elderly man using a walker who is threatening to beat some-

Star Maker Independent Artists Association, a local organization based out of Shreveport, Louisiana, dedicates its efforts to helping independent, local musicians gain exposure and further cultivate their careers in music.

The Star Makers Independent Artists Association offers its programs and services to artists and potential artists in Minden and surrounding areas. The organization began a year and a half ago when founder and president, Melvin Ashley, wanted to help local musicians reach their goals of getting their music out and into the public sphere. Melvin Ashley, whose stage name is "The Captain," helps with the artists' sound and stage productions

of deputy chief of police, a battalion chief position for the fire department. We've come a long way in six and a half months. I'm proud of everyone we hired and appointed.

"Our council is made up of business minded people that look at the city as a whole. They all represent their district well, and they see the bigger picture, helping each other's district as well. We're blessed to have that Council."

One of the things the Mayor ws proud to mention was their decision to hire a lobbyist for the city of Minden. In short, a lobbyist serves to represent Minden in Baton Rouge, most notably when there is money to be budgeted.

Mayor Cox initially got the idea to retain a lobbyist while working on the Police Jury and getting advice from Bill Altimus.

"When I was on the Police Jury, I went to Bill Altimus in Bossier Parish. He was the administrator of the parish over there. He's since retired, but he, in my opinion, is a genius when it comes to running municipal government. In my opinion, he's a big reason Bossier Parish is as successful as it is," said Cox.

"We visited for a while and I asked, 'Bill, if I had \$50,000 extra in Webster Parish, where would you tell me to spend it. I had several ideas about what he might say, like spend \$50,000 and invest in this, or spend \$50,000 and get some software. He said hands down, without a second thought I'd hire a lobbyist. I never dreamed he would say a lobbyist.

"He said , well if you don't have a seat at the table you get nothing. And you don;t even know to ask. You'll be so unaware you don't even know you can ask for stuff. I didn't forget that.

Cox stated that the decision to get a lobbyist for the city has already returned on investment, from obtaining funding for smaller projects like road striping, christmas decorations, the animal shelter, and even bigger projects like a multi million capital outlay project for the water tank.

"The cost associated with having a lobbyist is fractional compared to the money she could potentially give us," said Cox.

"My attention gets put on what happens within our boundaries. But some of the best opportunities are outside of Minden's borders, such as federal grants, state grants, and also state capital outlay.

"This particular type of lobbyist is for the state level. She lives in Baton Rouge. She's originally from the Shreveport/ Bossier area, so she's very passionate about Northwest Louisiana municipalities. Her job on behalf of the City of Minden is to be a Minden representative in Baton Rouge.

"It gets us a seat at the table, and if we don't have a seat at the table, we're the meal. Meaning the money goes somewhere else. What we should be getting, we weren't getting, because we didn't ask for it. The Bible says if you don't ask, you ain't getting it."

Another project the Mayor was excited to mention as that of the Public Works Control Center. This would be the creation of a new building to consolidate the employees of various public works departments under one roof, helping to make manning the positions easier as well as being cheaper overall to run.

"We'll be able to consolidate employees. Right now we have 24/7 day a week employees doing shift work at the steam plant watching the electrical control system, and at the water plant watching the water control system," said Cox.

"If we combine the water and the electrical in one control room, they'll be able to help one another, be cross trained, and we'll be better manned.

"Let's take what we have spread out across the city, and combine it to make it work better. I've spent most of this year tweaking my department leadership to try and make it work more efficiently, and it's getting better. I'm happy with where we're at.'

The building itself will cost half a million dollars to build, but the Mayor believes this to be a worthwhile investment, both to update the facilities that city employees work in, as well as the cost savings in the long term from consolidating multiple separate offices throughout the city under one roof.

Mayor Cox has also been focused on the city's presentation, from projects such as new lighting along I20, overlay projects for the Minden Airport, and buckling down on condemned properties.

"If you're driving down I10, are you ever going to pull off on an exit that's not lit. You're not going to do it. First of all it's dangerous looking, and second of all it doesn't look like it's open for business," said Cox.

"We had an opportunity to get 90% of the lighting project funded for new lights. The lights that we do have are dim, so it's time for an upgrade. The

state makes the projects and they turn it over to the city, The city of Minden has to pay the light bill. If the bulbs go out, the City of Minden has to replace them. If it gets damaged, we have to fix it.

"These will help the city because they're energy efficient, we can lower the masts like a flag, bring the lights to the ground, change the lightbulb and raise it back up, whereas the other ones, you had to get a bucket truck on I20 because of electric costs."

As mentioned previously, the Mayor and Council have also been cracking down on condemned properties. It's gotten to a point where a lot of properties that they are eyeing end up getting dealt with because word is getting around about how serious this administration is on the issue.

"I think people in Minden know that we want to be proud of our city, and put our best foot forward," said Cox.

"There have been several occasions where word got out that we were kind of eyeing a property that needed some attention, then I'll drive by and it'll be torn down. People are taking care of business because people know that this council and this administration is not playing around with condemned properties."

Even in the short amount of time they've been in office, Mayor Cox states that he is proud of the work being done by his administration to get minden moving forward.

"I think the Council and myself are not passive. This group right here, we want to do something with the opportunity the good lord gave us. We want to move the needle forward while we have the time to do it. I'm proud of where we're at," said Cox.

while also overseeing the organization's programs. "We have new record-

ing artists that we're trying to get out and people to hear and get to know. We've been going for about a year and a half; we're basically a brand new organization. and we're really trying to get out there and do stuff in the community," said Ashley.

Along with helping local artists, the organization also works to aid in crime prevention by offering an outlet to the community's youth to participate in musical activities. This anti-crime program runs under the motto, "Put down the gun, and pick up the fun."

"Our organization also works with crime prevention, we use our artists to try to convince the youth that 'hey there's a better option.' We do tutoring where they come in and we teach them stage art, sound production and that kind of stuff," said Ashley.

The organization is also partnered with a local record label by the name of NC Records. This label is currently run by Cesan Calloway, who offers record deals under his label to the members of the Star Maker Independent Artists Association. By being partnered with this record label, musicians can release their music under a professional label.

There are currently three artists under the organization who actively perform live and release music. "We have three performing artists right now who are Cesan Calloway, RT Muleman Taylor, and DJ Wildman Tim. They've all got stuff coming out and stuff they're working on" said Ashley.

Cesan Calloway is a Minden local and has been actively releasing music since the 2000s. "I've been singing all my life, and I've got an album out right now and a lot of EPs and some new projects coming out soon," said Calloway.

Calloway has been a part of the Star Makers for about seven months and offers record label opportunities to the organization's members. "I'm with NC Record Label so the organization brings all the artists and all the producers to the record label under one umbrella. Right now under the label it's myself and three other artists that I'm focusing on," said Calloway.

"You know we are all different artists and, as an organization, I feel like we're going to do a lot of different things. I mean Muleman is traveling all over, and we all come together with different music and also other ideas and we bring it all together as one thing," said Calloway.

"Muleman" Rodney Taylor and DJ Wildman Tim are both musicians who got their start in music early in their childhoods. Both artists belong to the soul genre of music, and Tim is also a DJ.

"I've been singing since I was seven in the church choir, and I started DJing when I was 14," said Tim.

"I started singing at the age of 11. I've been doing it all my life. The organization group is just getting started, but singing soul, I've been doing that for about five years," said Taylor.

Although their journey isn't over yet, these three musicians plan to keep on striving to meet their goals and broaden their audiences.

disabled. I don't know where I'd be without it, to be honest with you."

Ware is a big experimenter when it comes to art. He doesn't stick with just one medium, and he likes to combine mediums in ways that most people wouldn't think to do.

"I like just creating stuff. I want to do sculpture. I want to do pottery. I like doing things with resin. I like painting. Anything that's creative and gives me an outlet, that's what I gravitate toward," Ware said.

His works in resin are particularly eyecatching. When asked how he thought to use resin as an art medium, Ware said. "My first experience with resin came when I was working with my dad on the riverfront in Shreveport. We redid all of the bars on the Shreveport side of the riverfront. In that process, we did a place called Banana Joes, and we poured probably 30 gallons of epoxy on that job. It was a bar top that we had to stain with this water-based acrylic ink. And I got to using that stuff, and I thought, 'man, that stuff would be gorgeous over artwork.' It's something that I decided to incorporate with my alcohol inks. I did some testing to make sure that it would actually hold up and was not going to lift the ink off the paper but, once I had one that was done, that's kinda what I've gravitated toward. A lot of my work has been with epoxy here lately."

Ware loves to mix media and does not feel constrained to work only in classical mediums.

"I do all kinds of stuff," said Ware. "I'm big into flowers and bugs. I love bees and butterflies, that's a big thing in a lot of my art. And I like to get out in my yard and take pictures of the flowers, especially when I find a bug that I can capture in the art. Then I'll take it and digitally manipulate it and then I'll print it off on either canvas or a heavy paper. And then I resin over the top of it. I do all types of mediums. I don't like to keep myself in a box; I like to just create." Ben Ware has shown his work previously at City Art Works, Big Sun Studios in Shreveport, and Critical Mass, and he has work on display currently at Dr. Thomas' in Minden and at the Agora Borealis in Shreveport. His work is bright, beautiful, and something to behold, and it will be on display at City Art Works through August.

one with a roll of nickels in a sock may have the intent and opportunity to cause harm, but he could easily be evaded, so the ability is not present. Intent does not need to be spoken but can be shown through actions. For example, a large man who attacks a small woman and begins to viciously beat her would be considered to have the intent to do great bodily harm even without saying a word. A person who calls and tells you that he's coming to blow up your house may have the intent and ability to harm you but lacks the opportunity to harm you at the time the threat was made. You could easily leave your home and call the police.

The use of lethal force is not legally justifiable to protect property, so if you find someone trying to burn down your house, and no one is in the house, you cannot legally justify shooting them.

"Before you press the trigger, before you pull that knife, before you bludgeon somebody with a fire extinguisher, before you use lethal force on anyone, the only thing you really need to think about is this: whose life am I about to save? If there is no answer readily available for that question, lethal force is not justified," said Barnette.



This case is very important because it underscores the great constitutional principle not only of free speech

but of freedom of conscience.

It's why Thomas Jefferson in 1777 "drafted a bill to establish religious liberty on the basis of the natural, inalienable right to freedom of conscience." (Nat. Constitution Ctr).

It is, no doubt, why Jefferson expressed his view that "no provision in our constitution ought to be dearer to man, than that which protects the rights of conscience against the enterprises of the civil authority." (Ltr. to Richard Douglas, 2-4-1809). It's also, no doubt, the motivation for Jefferson's declaration to Benjamin Rush that "I have sworn upon the altar of god eternal hostility against every form of tyranny over the mind of man."

The Supreme Court itself, in an earlier case involving compelled speech-West VA. Board of Educ. v. Barnette-eloquently reaffirmed this principle holding that state authorities had "transcended constitutional limitations on their powers" when their dictates "invaded the sphere of intellect and spirit which is the purpose of the First Amendment ... "

That is what the state law of Colorado was attempting to do here, and its action cannot be reconciled with our Constitution.

DWF schedules drawdown of Lake Bistineau

LDWF RELEASE

The Louisiana Department of Wildlife and Fisheries has scheduled drawdowns of Lake Bistineau in Webster, Bossier, and Bienville parishes to reduce the expansion of giant salvinia.

The drawdown will also benefit fisheries production by improving aquatic habitat and reducing the amount of organic matter on the lake bottom.

LDWF has requested the

tion and Development open the water control structure on July 31.

Once the water control structure is open, the lake should dewater at a rate of 4 to 6 inches per day until it reaches a potential maximum drawdown level of 8 feet below pool stage.

This dewater rate could be impacted, however, by local rainfall in the surrounding watershed. Aquatic habitat conditions will be

Department of Transporta- monitored during the drawdown and a gate closure date will be determined and announced at a later date.

> During the drawdown, an estimated 10,000 acres of water will remain in the lake. Boaters can still access the lake during the drawdown from the following public boat launches: Port of Bistineau Launch, Bossier Public Launch, Grice's, and Bayou Dorcheat Public Launch. Boaters are advised to use caution during the

low water period, as boat bicide applications will conlanes will not provide normal clearance of underwater obstructions.

The drawdown is a necessary component of LDWF's integrated management plan to control overabundant aquatic vegetation growth and to improve the Lake Bistineau sport fishery.

An annual cycle of high and low water fluctuation can provide beneficial effects similar to a natural overflow lake system. Hertinue during the drawdown period.

The LDWF has also scheduled a drawdown of Lake Clairborne in Claiborne Parish at the request of the Claiborne Parish Watershed District

LDWF has requested the Department of Transportation and Development to open the water control structure on September 18 for shoreline maintenance and erosion control.

Once the water control structure is open, the lake should dewater at a rate of 4 to 6 inches per day until it reaches a target level of 7 feet below pool stage. The drawdown gates will be closed on January 31, 2024, to allow the lake to refill.

Tips for summertime fishing


The weather has started to heat up here in the middle of July and for the bass fisherman, he knows that some of the day's most exciting and often best action occurs at the break of day. There is something about being on the water this time of year while all is quiet with a growing glow in the east as he casts a topwater lure next to the trunk of a cypress or willow.

When the twitch of the lure results in an explosive strike, it just about doesn't get any better than this. Once the day brightens, the early morning action usually slows and the average bass angler heads home for the air conditioning once old Sol peaks over the cypresses.

For anglers who want to extend their bass fishing experience longer, the search is on for one lure to keep the bites coming, even after daytime temperatures The Wobblehead rise. meets all the characteristics of just such a lure.

This rather non-descript device features a slender curved slab of metal with a single hook onto which is attached a plain straight tail six inch plastic worm. Incidentally, there is no lure easier to retrieve than a Wobblehead; you simply cast it out and bring it back in a rather boring straight retrieve. However, there is nothing boring when a big bass gulps down the bait.

The curved metal body of the Wobblehead gives the lure its name; it wobbles side to side and gives the plastic worm tail an enticing swimming motion which resembles a favorite food for a foraging bass, a small swimming snake. Remember the last time you saw a snake swimming across the water? That's the exact image you get when

you reel in a Wobblehead. These lures are especially effective when fished next to moss beds, where bass lurk out of the glare of the scorching sun waiting for something good to eat to pass by. A small snake slowly wagging overhead is often too much to pass up.

Cast out a Wobblehead in the heat this summer next to a patch of weeds and hang on. The results could leave you feeling "cool"

Bream fishermen can still do their thing with these fighters even in the heat of summer. Both bluegills and chinquapins can be caught even though the spawn is over and they have moved from their shallow spawning beds.

One of the most productive bream fishing forays I ever experienced was one sweltering day several years ago when Eddie Halbrook took me to Grand Bayou lake near Coushatta where we caught at least 50 big chinquapins fishing cold worms on the bottom on an 8 foot deep flat.

If you're a crappie fishermen, here's something you may want to try to improve your summertime catch of tasty slabs.

If you want the best service from your waiter at a favorite restaurant. let it be known that you're a generous "tipper". You're more than likely to find him eager and willing to be at your service. Keep this truth in mind the next time you head for the lake after summertime crappie. If you're a good "tipper", the crappie just might be much more cooperative.

explained Tipping

means that you add something to your crappie jig to make it more enticing. Some anglers regularly tip their jigs with small shiners while others prefer commercial pea-sized niblets, grass shrimp or wax worms.

One of the best times to go for crappie during the heat of summer is to say indoors during the hottest part of the day and head for the lake at night.A bucket of shiners dangled beneath the lights around a pier or off the side of the boat will attract shiners or shad which attracts the crappie. It can be a bunch of fun and you won't even need sunscreen.

Whether it's bass, bream or crappie, you can still get your string stretched even in the middle of summer.

Bream are on starting to slow down off the beds on hitting worms and crickets. Catfish continue to be caught fishing cold worms and night crawlers off the banks. For latest information, call Anderson Sport Center at 368-9669 or Honey Hole Tackle Shop at 323-8707.

LAKE CLAIBORNE Night fishing has been best for crappie fishing shiners under the lights around the piers and boat houses. The Majestic Big Bass Tournament is scheduled for July 21-22. Bass fishing has been best fishing around the docks and grass lines with swim baits and soft plastics or spinners. Some stripers are beginning to show up in the coves and hitting shad imitation lures. Bream are fair. Some nice catfish have been caught on noodles baited with live bream. For latest information, call Kel's Cove at 927-2264 or Terzia Tackle at 278-4498.

CANEY LAKE – Bass fishing has been best at night with Carolina rigs and deep diving rank baits along with soft plastics picking up some nice sized fish. Wobble-heads are taking some fish around the grass during the days Crappie are fair the days. Crappie are fair around the deep brush on shiners or jigs. The bream bite is slowing as the spawn is about over and they've moving from the shallow spawning areas. No report on catfish.
