The August Minden City Council meeting was a relatively brief affair where the mayor and council

handled city business such as the appointment of a new member to the Minden Planning

Commis-



sion, moving forward with the Minden Strategic Economic Development plan, as well as recognizing the Minden Dixie Darlings All Stars softball team for their incredible performance at the World Series

Braley Raborn was selected and voted unanimously by the council to be the new appointment to the Minden Planning Commission, replacing Sarah Haynes. "Haynes has served for quite some time. Her term expired in July 2023, and it's been recommended that Bralev Raborn be her replacement for a five year term," said Mayor Nick Cox.

The council also voted to grant the mayor the authority to move forward with an agreement

CRIME Heflin woman arrested for second degree murder following shooting **STAFF REPORT**

On August 2, authorities from the Webster Parish Sheriff's Office were alerted to an incident of homicide that unfolded in the quiet community of Heflin. At approximately 12:30 AM, law enforcement received notification of a shooting, prompting an immediate response to the scene in the 6000 block of LA Hwy 531.

Initial investigations by the authorities revealed that the incident arose from a domestic situation which had escalated, ultimately leading to the untimely death of 45-yearold Tyronne Winzer.

During the course of the inquiry, two witnesses came forward, providing information that implicated a suspect in the crime. The witnesses identified the alleged shooter as Chandricka Shehee, 23. Law enforcement apprehended Shehee for her suspected involvement in the homicide, and transported her to the sheriff's department for questioning.

After Shehee was informed of her rights and affirmed her understand-

WPSB School board votes to restore salary freeze steps

A major decision was made during the August 7 meeting of the Webster Parish School Board. Those teachers who have been behind on salary step increases since salaries were unfrozen in 2017 will now be getting those raises starting on their October

paychecks. Finance Director Crevonne O d o m wanted to

ing passing this item as it will cost the district an additional \$250,000 (approximately) per year. "I cannot recommend this as the director of business and finance," said Odom.

Almost all the board members were in favor of it however, with some showing visible emotion

on the subject. "I say this bill has been owed to teachers for a long time, and it's past due," stated Board Member Jonathan Guthrie.

In the end, 10 members of the board voted to pass the measure with Margaret Edens absent and Linda Kinsey voting against.

After that, there were several pieces of good news announced.

Personnel Director Robin Tucker reported to the board that all open positions have been filled. so the school year will begin on August 10 with a full complement of teachers and support staff.

Test scores from last year have come in and look very positive. Of eleven schools (grades 3-11), seven showed an increase in mastery percentages, and of the six testing areas in high school, five showed improvement. There will be more details after administrators have

With the start of the 2023-24 school year just around the corner, the Webster Parish school district welcomed its newest members with open arms. Last week, the district organized New Teacher Breakfasts as a part of their orientation program for the incoming educators, providing them with a warm and encouraging welcome.

Amidst the chatter of excited conversations and the aroma of freshly brewed coffee, the new teachers indulged in a breakfast specially prepared for them. Ready to embark on their educational journey in Webster Parish, the teachers were then introduced to the intricacies of their new roles.

The orientation covered a range of essential topics, including familiarizing the teachers with the software programs they will be using to record grades, attendance, and other administrative tasks. Additionally, the educators were exposed to differentiated instructional strategies, empowering them to cater to the

These officers learned about how prevalent human trafficking has become (almost to the level of drug smuggling), how to spot drug smuggling and weapon smuggling, and gained an awareness of cash being sent both ways across the border. "We have a lot of wrecks here in Minden," said Mc-Iver. "And it's discouraging when people don't have insurance when you're mandated to have insurance. We've got people driving around with no insurance, no driver's license, things like that. Law-abiding citizens are suffering for this. So if people don't have proof of insurance, we're going to take their license plate and tow their vehicle." The Minden Police Department strives to be one of the best-trained organizations in Louisiana. They are already getting a good reputation and are starting to attract officers who are currently working with other departments. With the support of the citizens of Minden, they will continue their efforts to become the best police department in the state.

between Minden and Atlas Community Studios for the Minden Strategic Economic Development Plan.

'We had a company write us a grant application to get the City of Minden a strategic plan that would lay out our future, take information from our community and guide where we want us to be, and get us a plan in writing so we know how we want to move forward as a community," said Cox. "The value of this grant is \$135,000. It's totally funded through the grant, and it won't cost the City of Minden anything. It'll give us guidelines for how we can grow, it identifies the different grants we can get, how we can pursue them, the deadlines we can pursue them by, so I think it's going to be a great tool for our growth and how we want to move forward as a city." One agenda item that led to some further discussion was that of entering into a professional services agreement and task order between the city and Manchac Consulting Group, Inc. Essentially the city would pay the company to seek and acquire grants for the City of Minden. "We've been talking to a company for a few months about pursuing some grants for us. This is an engineering company that has had pretty good luck getting grants. After talking to them, we set up a two-year agreement. The agreement is capped at \$50,000, and it's not to exceed \$50,000 over two years. We added a termination upon clause," convenience said Cox. "I just want everyone to know that in no way will they be running our public works or anything like that. The purpose of this agreement is for them to pursue grants on behalf of the City of Minden. Our attorney has thoroughly reviewed it a number of times and said we're in good shape

with this contract." When it was time for discussion, Councilman Michael Roy of District D voiced his concerns of working with Manchac in particular.

When we were presented with this in a workshop, we were presented with the idea of sidewalk grants from Manchac. Not quite sure how Manchac came to play at the City of Minden, but it was presented as such," said Roy.

In response Roy stated, "And I appreciate that, Andy, but we will have spent \$50,000 that possibly we could've got nothing out of. I just don't think that it's prudent that we take the

The Minden Police Department is gearing up for a lot of training starting in August. The department has begun its first ever inhouse in-service training. It's going to take a couple of months because there is so much to do.

Officers have been training over this course of this year to become instructors in a variety of areas including use of less-lethal force (beanbag shotguns), defensive tactics, first aid / CPR, and Intoxilyzer use. This month they will begin training the rest of the department in what they have learned, increasing the knowledge and abilities of the entire department.

Firearms training will now be held twice annually instead of once. "We're going to be doing more scenario-based training with simulation rounds, simulation guns," said Police Chief Jared McIver. "I want us to be very welltrained. You respond how you trained, you react how you trained. We're going to give the officers the very best training they can get so they can react to situations in the safest, most effective way."

The Special Response Team (SRT) has been training in different schools around the par-

ent schools in case they are called out to handle any dangerous situations. They have also been training on a smaller scale using abandoned buildings around town.

The department is fully staffed right now, which is unusual across Louisiana. "With being fully staffed, we can actually be proactive now," said McIver. "We can now do more of the things that need to be done to keep the city safer."

Being fully staffed is allowing the department to do some things they've never done before.

"We've started a criminal patrol team," said McIver. "They're going out and gathering intelligence, working problem areas, working alongside narcotics and the criminal investigation division."

They are also looking far away and ahead to try to avoid serious issues.

"We sent two guys to the [Mexican] border about a month ago. They've come back with a ton of intelligence and things that we can start utilizing here because whatever is happening at the border is happening all over the United States right now. They [the border enforcement] are just on the front lines. With this information, maybe we can head

"Since then, looking at this contract, it shows that we're not going to do just sidewalks, we're going to entertain all infrastructure projects. I'm not opposed to grant writing ... but in doing my research, because we only met one time as a council on this, it's come to light that Manchac is not a very reputable company, in my opinion. I have some personal relatives that have worked under Manchac and have been asked to do things that are not ethical. And I just don't think the City of Minden should put themselves in that situation doing business and such."

Roy then went on to recommend that they should table the motion and look at other companies that provide similar services. In response, Councilman Andy Pendergrass of District E voiced his confidence in Manchac and the contract that they would be entering into.

"I think it's good to have multiple opinions on things. I appreciate Councilman Roy being candid about this. In my discussions with Manchac and about Manchac, the gentlemen that we have servicing the City of Minden, things of that nature have been brought up. We've had multiple references cite that these gentlemen are top quality, and they've had a track record of success with what we're pursuing. I think the mayor and our attorneys have done a good job of looking over our contract and making sure that we have a termination clause," said Pendfirst company that we've looked at. Because I've talked to other contractors that do the same thing."

"I think that, as a whole, we sit down and we do this. I think we're a little bit ahead of the ballgame by jumping up with the first company that we find."

Ultimately, the motion still ended up passing, with four in favor and one opposed, the one being Councilman Roy.

Councilman Pendergrass went on to mention that there would be a drive-by parade taking place on Wednesday, August 9, where people can drive by to show their support for the Minden Dixie Darlings and their victory.

The Minden City Council meetings take place on the first Monday of each month at the Minden Civic Center starting at 6 PM. The meetings are open to the public, and for those who wish to view it live or after the fact, the meetings are streamed live to the City of Minden's Facebook page and YouTube Channel titled City of Minden - Feels Like Home.

Ted started first grade at Benton in 1942 and graduated from Benton High School in 1954. He played basketball and baseball in high school and had the honor of playing first string forward in the 1952-1954 basketball seasons. Bossier parish had only six high schools at that time, and Benton defeated all five other schools twice each year in the parish league, and won both parish tournaments. The parish tournament All Star team was awarded on good sportsmanship, with Ted receiving this honor in 1954. Benton's winning 1952-1954 basketball team record remained unbroken for many years. Ted graduated from Centenary College in Shreveport. While at Centenary, he played forward on Centenary's Junior Varsity basketball team. He was Grand Scribe of Kappa Sigma fraternity, Sophomore Favorite, and President of the Junior Class.

Dr. Hughes was a 1961 graduate of Baylor Dental College in Dallas, TX. He served as Captain in the United States Air Force Dental Corp as the only dentist on two radar sites at Sweetwater and Ozona, TX. After his honorable discharge in 1963, he opened his private dental practice in Nacogdoches, TX.

In 1980, Dr. Hughes joined the Veterans Administration Dental Service, and practiced in three different V.A. Hospitals, North Chicago, IL, Temple, TX, and Shreveport, I.A. In 1998, he completed his thirty-seven year dental career as Chief of the Dental Service at Overton Brooks V.A. Medical Center in Shreveport, I.A.

Dr. Hughes as a life member of the Texas Dental Association, life member of the American Dental Association, Fellow of the Academy of General Dentistry, and life member of the Nacogdoches, TX Rotary Club. He was licensed to practice dentistry in both Texas and Louisiana.

Latest indictment of Trump is election interference, attacking our Democracy

They are targeting him. There's just no other way to view it. They want him convicted on anything that will put him in prison and make it difficult for him to campaign for president—a race in which he is the clear frontrunner for the nomination, as well as ahead, or tied, in polling against Biden. (Note: Trump could still run even if "convicted" and in jail).

To accomplish this, they are charging him with actions that I believe are constitutionally protected activities.

Let's review the allegations: conspiracy to defraud the United States; conspiracy to obstruct an official proceeding; obstruction of and attempt to obstruct an official proceeding; and conspiracy against rights.

Let's analyze this:

First, Trump had the right-as every American does-to speak publicly about the election and even to claim that there had been fraud during the election and that he had won. Second, it would have to be proven beyond a reasonable doubt-a heavy legal burden-that Trump "knowingly" did the things he's accused of.

Well, what that means is that if Trump truly believed he won the election (which he has stated many times he does believe!) then he couldn't be found guilty

for "knowingly" attempting to defraud the public. He would only meet that element of the crime if he knew he lost and then did the things he's accused of.

For that reason, these charges "don't meet the standard" necessary to form an attack on a leading presidential candidate, stated retired Harvard Law Profes-

sor Alan Dershowitz. "These charges

don't meet the standard that ought to applicable when the attorney general of the United States authorizes

(National Report, 8-2-23). "That's a 'banana republic,' and the case has to be the strongest possible case when you go after the president's chief rival, who is tied with the president in recent polls at 44%." The indictment also has no "smoking guns," but instead depends completely on Trump's state of mind, Dershowitz added.

Dershowitz also warned that the indictment may violate Americans' rights to vote for the candidate of their choice. "You have a constitutional right to vote for or against him, and that shouldn't be denied by prosecutors or by [Trump's] political opponents." (Newsmax, 8-2-2023),

The Wall Street Journal (WSJ) has stated: "we've argued that an indictment of a former president should be based on serious charges with enough evidence to convince most Americans that it is justly brought," (8-2-23).

We don't have that here.

Nevertheless, a weak case matters not because polling indicates Trump can't possibly get a fair trial in either New York or D.C., anyway. This is not about justice. This is not a prosecution, it's a political persecution. This is about the current regime weaponizing our own government against its chief political opponent. They hate him but likely can't beat him, so they've engaged in the tactics of a dictator to try to remove him from the

This is a dangerous place for America to be.

Let's consider the utterly of the Trump indictments:

On March 17th, Hunter Biden admitted the laptop was his and on March 18th Trump was informed that New York City DA Alvin Bragg was indicting him on Stormy Daniels payoff-campaign finance violations. On June 8th, an FBI document claims Ukraine paid Joe Biden a \$5 million bribe and the next day Biden's DOJ indicted Trump on the Mar-a-Lago documents. Then, on July 31st, Hunter Biden's former business partner testified that Joe Biden was on the phone at least 20 times during Hunter's business deals, although Joe Biden has lied for years that he "never spoke to his son about his son's business dealings." The next day, Trump was indicted on these Jan. 6th charges.

A final thought: sometimes actions have unintended consequences and by charging Pres. Trump with these alleged crimes it will allow Trump's attorneys to litigate the 2020 election-with subpoena power and under oath-for the whole world to see. The outcome could well vindicate Trump's election fraud claims.

In fact, if President Trump had not spoken out about the election and the integrity of our voting system, he would have been derelict in his duty as President to see that the laws "be faithfully executed."

We must all continue to speak out against this clear election interference and blatant attack on our democracy.

Wall St. Journal: The future of school choice

Many states have recently created or expanded schoolchoice programs, but are parents taking up the opportunity? It's early days, but data from several states should encourage lawmakers that robust offerings are in demand.

Indiana this year reported an increase of some 20% in its voucher program. More than 53,000 students participated in 2022-23, compared with 44,376 the previous school year, according to the state education department. Thirteen more private schools were included, bringing the total to 343. All of this was before the state made vouchers nearly universal in May by raising the income cap and removing other restrictions.

Florida also made its K-12 scholarships universal this year by removing income limits. Step Up for Students, a nonprofit administering organization, recently said it had awarded 268,221 income-based scholarships, up from 183,925 at the same time a year ago. The group said it also had granted 74,711 special-needs scholarships, an increase of some 15,000.

Arizona beat Florida by a year in making its education savings accounts, or ESAs, universal. The state says it approved 47,667 new student applications in 2023, compared with 5,103 before the expansion. Nearly 700 private schools receive ESA funds.

West Virginia's ESA program, open to any student already in public school, is entering its second year. The program has received 6,323 applications for the coming school term, up from roughly 3,600 last year, per the state Treasurer.

Iowa's new ESA program received 29,025 applications during a month-long window, according to Gov. Kim Reynolds's office. In Arkansas nearly 5,000 students and more than 80 schools have applied or begun applying to

another new ESA system, the state Education Department says. Applications opened in late June and continue through July. The Iowa and Arkansas programs aren't universal in the first year, but they're likely to grow as they phase in broader eligibility.

None of this should prompt states to rest on their laurels. A recent Manhattan Institute report points out that getting ESAs through the political thicket is only the first step. Many parents are unaware of the offerings in their states, and a law does little good if it isn't implemented well. "We fear a program in which 100,000 families want to participate," the authors write,

"but cannot log in to the payment platform, or cannot track their expenditures, or cannot promptly pay the educational providers helping their children."

Some states might also find that the demand exceeds the supply of seats in private schools. But in time states that are generous with ESAs are encouraging a variety of options to expand or open, whether faith-based, classical, Montessori or something new, and with families choosing what works best for them. That's what a future of school choice looks like.

Area teams look to rebound from tough 2023 seasons

Fall camps for area and state college teams are now in full swing.

Louisiana Tech hit the field July 28 with the Bulldogs' opener against FIU scheduled for Aug. 26 at 8 p.m. at Joe Aillet Stadium. The rest of the teams

began practice last week.

Last season was a tough one for teams along I-20 and an hour south in Natchitoches

Louisiana Tech went 3-9 in Sonny Cumbie's first season. Grambling State went 3-8 in Hue Cleveland's first campaign.

ULM went 4-8 in Terry Bowden's second season. Northwestern State went 4-7 in Brad Laird's fifth season.

Of course, the big question is what will this season bring?

As usual, optimism reigns this time of year. But all four realistically have a chance to be better.

Tech was close to a .500 or above club last season. The Bulldogs lost back-to-back Confidence USA games in overtime and double overtime. Two other losses were by 10 points or less.

The quarterback position is a question mark. It looks like Boise State transfer Hank Bachmeier is the top contender.

If he develops, the Bulldogs could be CUSA title contenders. Tech has one of the most dynamic offensive players in the conference in receiver/ return specialist Smoke Harris.

The defense gave up a lot of points and will have to improve.

Like many coaches, GSU's Cleveland hit the transfer portal hard. The Tigers need to improve their offensive production to have any chance of competing in the SWAC after averaging only 22.6 points per game in 2022.

Alabama State quarterback Myles Crawley is the likely starter at quarterback.

The Tigers open the season Sept. 2 at 2 against Hampton in Harrison, N.J.

ULM will also have a new starter at quarterback, Jiya Wright. He was out most of last year after suffering a rib injury in the opener against Texas.

The QB job was left wide open when 2022 starter Chandler Rodgers entered the transfer portal.

ULM is Wright's fourth college. How he handles the position will go a long way toward determining the Warhawks' fate. The good news is 2022 leading receiver Tyrone Hill is back.

ULM hosts Army Sept. 2 at 2 in its opener.

While the Demons had a good run in the Southland Conference last season, going 4-2, Northwestern State is another team that will be looking for improvement on both sides of the ball.

Idaho State transfer Tyler Vander Waal is the top contender to be the starting quarterback. The Demons have 27 new players not counting incoming freshmen. There are also five new assistant coaches.

The influx of new players at all schools through the transfer portal makes things very hard to predict.

NSU travels to Lafayette to face Louisiana Sept. 2 at 6:30 in its opener.

Hopefully, all four of the area teams will figure out the winning formula.

As long as I've been a hunter, I have hunted on areas that have special names. The "Cocklebur" stand? It's located in the middle of a patch of – you guessed it – cockleburs.
