ST. JUDE AUCTION

Minden unites for St. Jude: \$2.5M raised as community races, cooks, and donates!

The Minden St. Jude auction saw another record breaking year with the event raising a whopping \$2,538,444 for the Children's Research Hospital. This feat was only attainable through the efforts of volunteers who worked throughout the weekend to make

the auction function, the sponsors who helped the event, whether through funding, raffle items, or auction items, and most importantly the generous viewers who chose to help fight the fight against children's cancer all while taking home some great items at the same time.

Despite the adverse weather conditions, the Minden Run for St. Jude

demonstrated remarkable community support, amassing an impressive total of \$100,230, underscoring the collective commitment towards advancing the cause of pediatric healthcare and research at St. Jude's Research Center.

The event, aimed at supporting the St. Jude's Research Center, commenced with the Kids

Fun Run, where young athletes from the region showcased their spirit. A. Ramsey of Minden clinched the top spot, followed by B. Marks of Haughton in second place and E. Harmon, also from Minden, securing third place.

Following the youthful energy, the 10K race unfolded, witnessing Keith Pitman of Minden seiz-

ing the victory, trailed by Anna Lake Watts, also of Minden, in second place, and Kenichi Pass from New Boston, Texas, securing third.

The momentum continued with the commencement of the 5K race, where Nathan Vogel of Campti led the pack, followed by Graham Gordy of Shreveport in second place and John Hiltom

Ferguson III, also hailing from Shreveport, in third.

Another big event for the weekend was the Minden St. Jude Chili Cook-off which raised a total of \$16,245 to go towards the Auction.

In the main competition, the judges selected Big Jon's Big Eats with

Webster Parish man wanted for attempted murder in Minden shooting

Authorities in Webster Parish are actively seeking a suspect wanted for attempted second-degree murder following a shooting incident in Minden last week.

The Minden Police De-

partment responded to reports of a shooting in the 600 block of Martin Luther King Drive, where they found a man suffering from multiple gunshot wounds. The victim was subsequently transported to Ochsner LSU Health for treatment. Further investigation revealed a second

victim who had been shot in the leg but initially did not seek medical treatment.

During the course of the investigation, authorities identified 28-year-old Jaryon Stephens as the alleged perpetrator of the shooting. A warrant has been issued for Stephens

on the charge of attempted second-degree murder.

Collaborative efforts between the Minden Police Department, the City Marshal's Office, and the Webster Parish Sheriff's Office are underway to apprehend Stephens, utilizing all available re-

sources.

Minden Police Chief McIver expressed confidence in the efforts, stating, "I feel confident we'll be catching him soon," while urging the public to come forward with any information regarding Stephens' whereabouts. "We encourage the public

to contact us if they see him or know his whereabouts. We will make sure they stay anonymous."

Louisiana State Representative McMahan outlines legislative priorities for upcoming sessions

In an exclusive interview with the Minden Press-Herald, State Representative Dr. Wayne McMahan shed light on the imminent legislative agenda set to unfold in Baton Rouge. Anticipating a three-week special session closely followed by the regular session, McMahan delineated key topics earmarked for deliberation.

Crime, touted as a paramount concern, tops the legislative docket. "We have a high crime rate across our state and, if you don't have a safe state, it's hard to keep your kids here when they graduate from college," stated McMahan. Governor Landry's past tenure as attorney general augurs well for having a deep understanding of the problems of crime in Louisiana. "I think he understands the issues that we're dealing with in this state."

McMahan anticipates that lowering the age of criminal responsibility back to 17 years will be one of the topics discussed. In 2016, the law was changed and, at

that point, 17-year-olds started being treated as juveniles in the criminal court system. Within the juvenile system, more crimes — especially violent crimes — are committed by 17-year-olds than any other age. This legal change has caused the juvenile system to be overwhelmed, without enough spaces to hold these young people. It has also become an additional problem that this age group causes the most problems within the system as well. "Down at Ware [Youth Center], one of the big issues that they've had is that the 17-year-olds are disrupting the facilities and making it hard for them to take care of the 13- to 16-year-olds," said McMahan.

Among the many topics likely to be part of these sessions, Representative McMahan hopes to include the management of Louisiana's natural resources, addressing the problem of students reading below grade level, ways to increase availability of healthcare in rural communities, and funding infrastructure repairs and enhancements, especially bridges in rural

areas.

Representative McMahan hopes that, as the Louisiana Legislature addresses the many issues they will be handed, they will take a long-term proactive approach rather than just reacting to individual problems. "I look back over the last 40 to 50 years, and I think our state has been reactionary. We react to the issues as they come up, and we very seldom have a long-range goal of how to get our state in a better position."

As the legislative landscape beckons, Representative McMahan exudes optimism, viewing the upcoming term as an opportunity for transformative change. "I'm excited about the next four years. The more I think about it, the more opportunities we have to make our state better."

Minden Police Association donates to injured Sheriff's Deputy Sgt. Aaron Barnes

Webster Parish Sheriff's Deputy Sgt. Aaron Barnes, who was seriously injured in an accident January 30 while directing traffic north of Dixie Inn, is the recipient of a donation from an organization of fellow law enforcement officers.

Sheriff Jason Parker was handed a check Thursday for \$1,000 from the Minden Police Association (MPA) to help Barnes and his family with expenses incurred since a vehicle struck the deputy, sending him to a Shreveport hospital with numerous severe injuries.

"I know this check says Minden Police Association, but this is a fellow officer who might need a little help," said Minden Police Dept. Lt. Joel Kendrick, MPA president. "We're happy to be able to do this for him and his family, and we wish him a very speedy recovery."

Barnes, whose injuries included a broken tailbone, broken nose, fractured ankle, severe lacerations to his forehead and lower body and road rash, underwent successful surgery in the days following the accident. His recovery has been

progressing well, officials said, and he has been released from the hospital.

"We talk to him just about every day and he tells us he's feeling better each day," Sheriff Parker said. "He's at home and is doing some walking, but he has to take it easy. It's a blessing that he's doing well, considering what happened."

Barnes was standing beside his vehicle just outside the northbound lane on U.S. Hwy. 371 north of Dixie Inn, directing traffic when he was struck by a northbound Toyota SUV around 7 p.m. Louisiana State Police investigators are still working the incident. Witnesses said the truck did not appear to reduce speed before striking Barnes.

Parker said the MPA donation is "...a very generous gesture by our fellow law enforcement officers. We appreciate it very much and I know Aaron will be grateful for what they've done. It means a lot to all of us."

Parker said the Sheriff's Office is also planning a fundraiser to benefit Barnes early next month. Plans have not been finalized, but the Sheriff said a food favorite will be on the menu.

John F. Kennedy

John F. Kennedy of Brookline, Massachusetts. Services were held at Cathedral of St. Matthew the Apostle, 1795 Rhode Island Avenue NW, Washington DC on November 29, 1963 at 11:00 a.m. Interment was at Arlington Memorial Cemetery.

Richard Belzer

Richard Belzer, the longtime stand-up comedian who became one of TV's most indelible detectives as John Munch in "Homicide: Life on the Street" and "Law & Order: SVU," has died. He was 78. Belzer died Sunday at his home in Beaulieu-sur-Mer, in

southern France. There was no known cause of death, but Belzer had been dealing with circulatory and respiratory issues. The actor Henry Winkler, Belzer's cousin, tweeted, "Rest in peace Richard. The comedy world is a poorer place without him. For the past 20 years, they lived mostly in France."

Marilyn Monroe

Marilyn Monroe was born Norma Jean Mortenson on June 1, 1926, in Los Angeles, California. She died on August 5, 1966, at the age of 36. She made only 30 films in her lifetime, but her legendary status was remain with film history forever. In 1942, at the age of 16, Norma Jean married 21-year-old aircraft plant worker James Dougherty. The marriage lasted four years, and they had two sons. In 1946, she began to model swimsuits. Her parts in the movie followed. In 1951, Marilyn had a fairly stable role in "Love Story." In 1952, she made "Monkey Business."

Abraham Lincoln

Abraham Lincoln was born February 12, 1809, in Hardin County, Kentucky. He was the son of Thomas Lincoln and Nancy Lincoln. Abraham grew up with his brother Thomas Lincoln, Jr., and his sister Sarah Lincoln. Lincoln worked as a boatman, his early years on a family farm in southern Indiana. Lincoln eventually became a lawyer in Illinois. He was elected to the Illinois legislature in 1834. They had four sons together. Robert Todd Lincoln, Tad Lincoln, William Wallace Lincoln, and Edward Lincoln. Robert Todd Lincoln was a very loving father and husband. He always thought of his family before himself. In 1860, Abraham was elected president of the United States. During his presidency, Lincoln is best known for abolishing slavery. As he was in a play on April 15, 1865, at the end of the Civil War, Lincoln was shot and died by an assassin. Abraham Lincoln will always be remembered - gone but never forgotten.

LNG Export Ban Continues Biden Attack on U.S. and Louisiana Energy Industry

I have recounted before the numerous ways—fearful of the Climate Change Religionists and the Green New Deal lunatics—that the Biden Administration has undermined and damaged the U.S. oil and gas industry, including in Louisiana.

During the 3 plus years of his Administration, Pres. Biden has shuttered and halted pipelines and closed off millions of acres in the U.S. to drilling. The Department of the Interior cancelled oil and gas lease sales for over one million acres in Alaska's Cook Inlet and also canceled two Gulf of Mexico leases, while generally making the leasing and permitting process significantly more difficult.

The fundamental question remains—knowing as we do that energy security is national security—why would our government ever choose to weaken domestic energy and, therefore, make our country more vulnerable to and dependent upon bad actors, including those who hate us and seek to harm us such as Venezuela, Iran, Russia, and China?

To the contrary, recall that in Pres. Trump's last month in office, Jan. 2021, America was producing more oil than it was consuming for the first time in 50 years and was exporting energy to the EU. The Trump Administration had made America energy independent, meaning we not only were providing

for our own national energy needs but, in fact, had become a net exporter of energy to other nations, thereby making most of Western Europe far less dependent upon Russia for their energy. But here we go again.

The Biden Administration has engaged in a permit freeze for new liquified natural gas (LNG) export projects by essentially rewriting the rules. As noted by the Wall Street Journal "the Energy Department is required by law to approve permits to export LNG to countries with which the U.S. doesn't

have freetradements if they are in the 'public interest.' The department has never rejected a permit. But now the Administration plans to do so by redefining 'public interest' to include the potential impact on the climate." (WSJ, 2-5-24).

And, although the Biden Administration is downplaying the number of permits and projects that would be affected, the truth is that "the Administration is deliberately creating uncertainty about permit approvals and extensions to chill investment and discourage foreign governments from signing long-term contracts. Why

risk investing in or signing a purchase agreement with a Gulf Coast project that may later be killed? Smarter to link up with the Qataris." (WSJ, 2-5-24).

This permit freeze directly harms the U.S. economy given that "a single LNG export project will produce about \$600 billion in revenue over its lifespan and create thousands of jobs, including in steel manufacturing and fracking—no government subsidies required." (WSJ, 2-5-24).

Here in Louisiana, our Department of Economic Development (LED) proudly notes that "Louisiana boasts three of the nation's seven LNG export terminals, with more facilities planned. Louisiana also possesses nearly 50,000 miles of integrated pipelines that crisscross every major highway, railroad, and navigable waterway in the state. Louisiana also holds 8% of the nation's natural gas reserves." (LED website).

LED also estimates that the economic impact of LNG in Louisiana is 18,000 jobs, \$4.4 billion contributed to statewide economic impact, and \$178 million in state tax revenue.

This action by the Biden Administration is reckless and shortsighted. When America's allies think the U.S. cannot be relied upon for their natural gas needs, it forces them to negotiate with America's enemies. I

also note that while the Climate Religionists are celebrating this "victory" from the Biden Administration, China is estimated to have built or is building 305 coal-fired power plants. Those CO2 emissions are immeasurable, and nothing will stop it.

We are not going to be able to be free of fossil fuels for decades if not generations. Renewable energy sources can't come anywhere near meeting America's or the world's energy needs right now. The folly and danger of this is that the Biden Administration is allowing America to be economically and strategically hamstrung when the rest of the world won't cooperate with ending fossil fuels, but our friends and allies will know they can't rely upon us.

Also, beyond the climate insanity, a secondary motive of Biden's LNG ban is rumored to be to punish Texas and Governor Gregg Abbott for standing up to the Biden Administration effort to cut down the razor wire that Abbott has placed on much of Texas' border to stop the illegal alien invasion.

Headgear of bucks quite a story

Here’s hoping your deer season was as successful as you hoped it would be. If you have been sitting down to meals of chicken-fried backstrap steaks or a tasty roast or found your breakfast of eggs tasting especially good with rounds or links of venison sausage on the side, you have for sure been successful. If you’re anxiously waiting for a call from the taxidermist telling you the mount of your trophy is ready for pick-up and hanging on the wall, pat yourself on the back; it’s been a good year for you. You may be having withdrawal symptoms now that season is over and you really wish you get to spend just one more frosty morning in a deer stand. You’re not alone in this. Scores of hunters feel the same way. What can deer hunters do as a form of recovery to help you get over your addiction to chasing deer? Here’s a suggestion – head for your woods and begin looking for shed antlers of the big buck you hunted all season but never showed up. Now that antlers are beginning to drop, the next several weeks offer the opportunity to locate sheds before the mice and squirrels begin gnawing on them. Here’s what happens in the world of the deer. Buck deer drop their antlers in late winter or early spring. Soon after losing their headgear, they start growing a new set of antlers they’ll have until this time next year. This new set begins as fuzzy knobs grow-

ing on the pedicles which are located on the buck’s head between his eyes and ears. The newly formed antlers are soft and subject to damage and for this reason, bucks are shy and reclusive; they’re protective of this new growth. A couple of months before shedding antlers, bucks use them to hook and thrash bushes, brush and small saplings and to fight other bucks to establish dominance. Bushes and bucks are in no danger of being gored and thrashed in spring and summer because he is protecting his newly forming soft antlers. Velvet is described as “vascular skin that supplies oxygen and nutrients to the growing bone.” This amazing material causes the antler it covers to grow at an amazing rate. In fact, deer antlers grow faster than any

other mammal bone. This fast rate of growth actually is a handicap to a buck because of the incredible nutritional demand on deer to re-grow antlers annually. Once the antlers achieve their full potential for the year, usually by mid-September in our part of the world, the velvet has served its purpose and as it dries and is rubbed off on bushes by the buck, the antler bone actually dies and here’s something I read that gave me pause. What deer hunters see when that big buck comes slipping by the stand is an animal sporting a head full of dead bone. Where should you look for the best chance to find shed antlers? If you planted a food plot prior to deer season, searching the plot or trails leading to the plot can often result in a bit of good luck when you find tines

sticking up out of the grass. Another good place to look is where a trail crosses a low fence or stream small enough for the buck to jump across. Antlers can sometimes be jarred loose when the buck lands on the other side of the fence or stream. So for folks puzzled about deer antlers, maybe this bit of information will answer your questions. There is a measure of excitement to hold in your hands the head gear of a big buck that will whet your appetite for what he’ll look like once hunting seasons roll around again this coming fall. The entire process of bucks growing velvet covered delicate antlers to them becoming hardened and eventually being shed just to do it all again every year is one of nature’s most amazing and fascinating feats.

LAKE CLAIRBORNE – The lake has been down but is rising and is around the five foot low level. Crappie are still deep with best

fishing just out from the dam on shiners or jigs. Bass are fair with secondary points producing some fish with soft plastics and jigs picking up some. For latest information, call Kel’s Cove at 927-2264 or Terzia Tackle at 278-4498.

CANEY LAKE – Some really nice bass to 11 pounds are being reported fishing the deep holes with the Hover rigs or Damiki rigs. Some yellow bass are being caught on jigging spoons. Crappie have been best around the deeper tops on shiners or jigs and they have moved to deep water out from the dam. For information contact Caney Lake Landing at 259-6649, Hooks Marina at 249-2347, Terzia Tackle at 278-4498 or the Honey Hole Tackle Shop at 323-8707.

LAKE POVERTY POINT – Crappie fishing has improved in deeper water around the trees on shiners and jigs. Catfishing is fair to good. No report on bass. For latest reports, call Poverty Point Marina at 318/878-0101.

LAKE YUCATAN – After being so low for weeks, the river is rising pretty fast and few anglers are going out to try it until the water level settles down more. For information, call Surplus City Landing at 318/467-2259.

As of February 6, 2024, the Webster Parish Police Jury has amended

Webster Parish Building Code Ordinance#982 to ensure the safety and protection of all citizens. The changes are:

- Section 5 PERMIT EXEMPTIONS

Electrical: A permit shall not be required for minor repair work, including the replacement of lamps, the repairing flush, and snap switches, replacing fuses, changing lamp sockets and receptacles, taping bare joints, and repairing drop cords or the connection of approved portable electrical equipment to approved permanently installed receptacles.

- Section 5 PERMITS

Application for permit All new construction and additions/renovations permits will require the plumbing, electrical, and mechanical contractors to purchase a separate permit for the proposed work. Each trade permit will cost \$50.00 per job/location. The applicant shall first file an application for a permit with the Webster Parish Building Department by the person, or his designee, proposing to perform the work. Such application shall describe the work to be performed; the premises on or in which such work will be performed; the electrical, plumbing, or mechanical contractor who will perform the work; and such

additional information as may be required by The Webster Parish Building Department. When issued, the permit shall not be transferable from one electrical contractor to another, and if the owner of the premises desires to have another electrical contractor perform the work, a new permit application shall be filed as if the original permit for the work had never been issued.

- Section 12 VIOLATIONS

Penalties: Any person who violates a provision of the code or fails to comply with any of the requirements thereof will be penalized \$300 first offense, \$700.00 second offense, and \$1,200.00 third offense. After the third offense, the violator will be restricted from obtaining a permit in Webster Parish for one year.

AN ORDINANCE TO DECLARE GREEN STREET A ONE-WAY STREET BETWEEN WEST UNION STREET AND PINE STREET

BE IT ORDAINED AND ENACTED by the Council of the City of Minden, Louisiana, in regular session convened on the date hereinafter stated:

I.

For each additional violation of the same provision of this ordinance within one year, the fine shall be increased by TWENTY-FIVE AND NO/100 (\$25.00) DOLLARS, not to exceed a total of TWO HUNDRED FIFTY AND NO/100 (\$250.00) DOLLARS.


