Police stop leads to arrest and multiple charges

A routine patrol on Miller Street turned eventful for Officer O'Connor on March 16, 2024, when he observed a gray Kia failing to signal 100 feet prior to a stop sign at the intersection of Miller and Bayou. The vehicle turned left onto Bayou and then attempted to turn right onto

Goodwill, activating the right turn signal during the turn.

Upon initiating a traffic stop, Officer O'Connor approached the driver and requested the driver's license, proof of insurance, and registration. The driver, identified as Nicholas Jones, 35, stated he did not have his driver's license and claimed the vehicle was not his.

Jones provided his name and date of birth but was unable to produce a license. When asked about the presence of weapons or illegal drugs in the vehicle, Jones denied having any.

Officers Sparks and Thompson arrived on the scene, and Officer O'Connor requested dispatch to check for active warrants on Jones

through Minden, Webster, Bossier, and Shreveport. He also requested information on Jones's driver's license status. During the interaction,

Officer Sparks spoke with Jones, who then voluntarily surrendered a small amount of natural marijuana. Subsequently, Officer Sparks and Officer Thompson conducted a search of the vehicle and

found a silver handgun under the driver's seat. As Officer Sparks stood up, Jones fled from the scene into the parking lot of an adjacent storage building.

After a brief pursuit, officers apprehended Jones and took him into custody. Jones was charged with possession of a schedule I substance (natural marijuana) under 14 grams, possession of a schedule

II substance (methamphetamine), possession of drug paraphernalia, possession of a firearm by a convicted felon, possession of a firearm in the presence of a controlled dangerous substance, resisting an officer, driving with a suspended driver's license, no turn signal, expired inspection sticker, and being a fugitive from Bossier Parish.

WPSB School Board approves land exchange and teacher pay stipend distribution AMBER MCDOWN

The Webster Parish School Board convened a special called meeting on March 18,

discussing a proposed land exchange with the City of Minden and the



distribu-**KITCHENS** tion of the Louisiana Department of Education (LDOE) differentiated teacher pay stipend. All board members were present. Paul Kitchens of Kitchens Law Firm presented details of the proposed land exchange, involving Griffith Stadium and a city water plant building on Constable Street. The exchange would see the City of Minden transferring ownership of Griffith Stadium to the school district in exchange for the property on Constable Street. Both properties now encompass 3.84 acres. Kitchens stated. "The concept is that there would be no money paid by either side because of the exact equivalency of the acreage." The board voted unanimously to adopt a resolution authorizing Superintendent Rowland to finalize the exchange of deeds. Notably, the parking lot of Griffith Stadium will not be part of the exchange, but the board intends to formalize arrangements for its continued use for baseball games. Additionally, the board approved an invoice for field dirt for the batting cage at Lakeside Jr/Sr High School. Jonathan Guthrie of District 4 expressed gratitude to Glen Warren, CW&W Contractors, and Monday's Oilfield for their donations of several loads of dirt for

Webster Parish drug investigation leads to arrest of Minden man

A lengthy investigation by the Webster Parish Sheriff's Office narcotics division into illegal drug activities culminated Thursday morning with the arrest of a Minden man on multiple distribution charges.

Derian Dequan Reed, 42, residing in the 1100 block of Tillman Drive, was apprehended after attempting to flee from officers executing a search warrant at his residence. Reed was subdued by the Minden Police Department's K9 officer Braum during his escape attempt.

Sheriff Jason Parker stated that Capt. Bobby Igo III and Sergeants Shawn Jenkins and Josh McCormick had been investigating Reed's alleged involvement in illegal

drug distribution for an rifle under the bed, and extended period. Deputies, with the assistance of MPD's Special Response Team, served the warrant around 11 AM.

"Our unit had been investigating this individual for quite some time, and we had built a solid case to obtain a warrant," Parker said. "We contacted MPD, and Chief [Jared] McIver didn't hesitate to provide us with any support we needed. We worked very well together to apprehend this person."

During the search of the residence, officers reportedly discovered a variety of drugs, approximately \$11,000 in cash, which Parker said is consistent with drug sales, and three firearms.

"Along with the narcotics, we found a .40 caliber pistol on the nightstand in his bedroom, an AR-type another handgun on a coffee table." Parker said. "This person is dangerous."

Reed is facing multiple charges, including possession of methamphetamine (176 grams) with intent to distribute, possession of cocaine (27.8 grams) with intent to distribute, possession of marijuana (135.3 grams) with intent to distribute, possession of synthetic marijuana (100 grams) with intent to distribute, possession of ecstasy (146.2 grams) with intent to distribute, possession of fentanyl (15 grams) with intent to distribute, possession of a firearm by a convicted felon, possession of a firearm in the presence of a controlled dangerous substance, an outstanding warrant for distribution of metham-



phetamine, and resisting an officer.

"It's always good to see the hard work of investi-

gators pay off with an arrest like this one," Parker said. "Thanks to the cooperation of MPD, this arrest was successful. none of our officers or deputies were injured. And, this guy is out of business."

Dixie Inn council meeting highlights fiber optic installation and traffic enforcement

The Village of Dixie Inn convened for its regular council meeting on March 12 at the Village Hall located at 60 Shell Street in Dixie Inn. The meeting addressed key developments, including the installation of fiber optic lines by AT&T in the area.

Alderman Lance Milligan expressed gratitude for the long-awaited internet service upgrade, stating, "I'm grateful that we're finally getting the internet that we have very much deserved for a long time. Thank goodness for

the GUMBO grant, the legislation, and everybody that made it happen." Milligan, one of the first residents to sign up for the new fiber optic service, praised it as "the best thing on the market, hands down."

While fiber optic lines are not yet accessible to all residents in Dixie Inn, Mike Griffith from the Webster Parish Police Jury assured, "We're going to have a map from the jury that will let everybody know who's got it and who doesn't. We'll make contact with those people who don't. We just want to make sure that nobody gets overlooked. We want to make sure everybody has the same opportunity." Current AT&T customers are expected to qualify for lower rates than non-AT&T customers.

In a related development, AT&T installed a new cellular tower on Homer Road in Minden last spring, paving the way for future fiber optic services in Minden.

The council also passed Ordinance No. 132, enabling the enforcement of certain traffic violations by automated means. Dixie Inn police officers using Light Detection and Ranging (LiDAR), either handheld or trailer

mounted, can now use photographic evidence to impose civil penalties on drivers who disregard speed limits and stop signs. Speeding fines will range from \$100 to \$150, with the vehicle owner responsible for the civil-violation penalties (fines). However, if the owner was not the driver, the owner must provide a signed affidavit identifying the person who was in possession of the vehicle at the time of the violation.

A current bill (SB21) in the legislature that would prohibit automated speed-enforcement devices is not expected to pass. Notably, a police officer stopping a vehicle and issuing a citation falls under a criminal penalty, while the discussed automated system that mails evidence to the owner pertains to a civil penalty. In light of Webster Par-

ish Deputy Sheriff Sgt. Aaron Barnes's serious injuries after being struck by a vehicle on January 30, the Dixie Inn Police Department emphasized the enforcement of LRS 32.125. This law mandates that all drivers yield rightof-way to emergency vehicles by pulling over to the right side of the road and stopping until the emergency vehicle has passed. If the emergency vehicle is parked on the side of the road, other drivers must make a lane change into a nonadjacent lane if possible. If a lane change is not possible, the driver must slow to a reasonably safe speed.

The Village of Dixie Inn holds its council meetings on the second Tuesday of each month, with the next meeting scheduled for April 9 at 5 PM. The public is welcome to attend.

Noise complaint escalates to arrest in Webster Parish

A noise complaint at a large party in an unincorporated area of Webster Parish escalated into a confrontation that led to the arrest of a resident on charges including multiple counts of aggravated assault with a firearm.

Webster Parish Sheriff Jason Parker said Steven Charles Toms, 47, was arrested early Thursday and taken to Bayou Dorcheat Correctional Center after deputies charged Toms with violation of the parish's noise ordinance and five counts of aggravated assault with a firearm.

The incident began with complaints about loud music from an outdoor

party. Deputies arrived to find a large crowd and hazardous parking. Toms, the party host, had not obtained a permit for the event, which was advertised as "It's Up," featuring a DJ and a notice to "BYOE" (Bring Your Own Everything), with admission fees being charged. Parish ordinance requires permits for gatherings of 250 or more, with appropriate security.

Despite the flyer mentioning "Security Strictly Enforced," no security was present when deputies arrived. When deputies requested the music be turned off, Toms became aggressive, demanding they leave his property.

"Our Parker stated, deputies did not pull their weapons in response be-

cause of the large crowd, including many juveniles, present in the immediate vicinity. We did an amazing job of maintaining order and de-escalating what had the potential to be a dangerous or even deadly situation."

After shutting down the party, deputies later obtained an arrest warrant for Toms, following a postincident review and discussions with the District Attorney's office. A search warrant executed at Toms' residence led to the recovery of the 9MM handgun involved in the incident.

Parker commended his deputies, saying, "No one was hurt, and that's always the goal in a situation like this. Our guys resolved a situation that could have gotten out of hand."

the project.

Regarding the distribution of the LDOE's differentiated teacher pay stipend, totaling \$144,340, the board considered four options mandated by the LDOE. These options include: Option 1 for Teachers in Critical Shortage per BESE, Option 2 for Highly Effective Teachers based on fiscal year 2022-2023 evaluations and assessments, Option 3 for teachers working in schools with an economically disadvantaged rate of 85% or more, and Option 4 for teachers in leadership positions. Up to 303 teachers in Webster Parish may be eligible.

After consulting with the Teacher Advisory teachers could receive the stipend. They also opted for multiple payments, meaning teachers qualifying for more than one option would receive the stipend for each area they qualify for. The exact number of eligible teachers is yet to be determined, but it is estimated that each teacher could receive around \$470 per qualified option. For instance, a teacher qualifying for both Option 1 and Option 3 would receive a stipend of \$940. Susan Addington of District 12 was the sole dissenting vote against this distribution method.

The next regular meeting of the Webster Parish School Board is scheduled for April 1 at 6 PM

Former President Trump Correct to Keep Focus on NATO Freeloaders

President Trump is one of members spent \$262 billion the most creative leaders we may ever see and the manner in which he brings attention to issues—whether in a statesmanlike way or with his inimitable bombast—he nevertheless is always successful in doing so.

Recall that while president, in 2018, Trump called out other world leaders who are part of the NATO Alliance and browbeat and shamed them into upping their contributions to the Alliance to the required 2% of each nation's gross domestic product (GDP). As noted by The Heritage Foundation in 2018 regarding Trump, " ... he has said Germany is a "captive" to Russia due to its oil and gas deals, and that he expects NATO countries to "immediately" increase defense spending to relieve some of the unfair burden on the U.S. After all, how many times have Europeans broken the promise to increase defense spending? The reality is, most NATO allies are free riders on American defense. And in spite of that, some NATO countries (like Germany) harbor deep anti-American attitudes, not just anti-Trump attitudes." (K. Holmes, The Heritage Foundation, July 12, 2018).

That was a fair assessment in 2018 and it is why people still trust Trump in 2024. And the Trump approach worked.

"In 2016, non-U.S. NATO

on defense; in 2020, they will spend \$313 billion. Regardless of whether this increase resulted from changing threat perceptions, or Trump's laser-like focus on inadequate defense spending, ... the results speak for themselves. The \$50 billion increase is equivalent to the entire defense budget of France." (D. Kochis, The Heritage Foundation, Nov 3, 2020).

Well, Trump has recently made a similar statement and the Washington Post is, unsurprisingly, outraged.

While in Conway, South Carolina, Trump stated to an

exuberant and receptive audience that he

had

whatever the hell they want" to NATO member countries who are not spending the required amount on their own defense. Trump stated that one of the presidents of a big country stood up and said, "well, sir, if we don't pay and we're attacked by Russia, will you protect us?" Trump said he responded "You didn't pay. You're delinguent. No, I would not protect you. In fact, I would encourage them to do whatever the hell they want." (M. Levine, Washington Post, Feb. 10, 2024). The Post correctly noted that "Trump has long been a fierce critic of U.S. participation in the alliance, frequently hammering European countries on their share of defense spending, and appeared to be referring to indirect funding as part of participation in the alliance."

And that is the only reason there has ever been any movement by these NATO nations toward paying anywhere close to what they owe for their own defense.

NATO remains critical to American national security interests, but we can no longer be expected to bear the lion share of the burden as we have for decades. That is why The Heritage Foundation contends that "to sustain the alliance, America's NATO allies must be prepared to step up to the plate, and fully participate in burden sharing with the U.S. (N. Gardiner, Feb 7, 2024).

That is also why, The Heritage Foundation urges, "this cannot be a two-tier alliance, where the United States carries the overwhelming military load for the defense of the free world. Last year, only 11 NATO members spent the 2 percent of GDP on defense (Estonia, Finland, Greece, Hungary, Latvia, Lithuania, Poland, Romania, the Slovak Republic, the United Kingdom, and the United States) agreed to almost a decade ago-and almost two years after Putin invaded Ukraine. This is unacceptable. It leaves the alliance dangerously vulnerable when it should be projecting strength and resolve." (Id.)

There is a balance that must be achieved here and the only national or world leader who has made any progress in correcting this inequity is Trump.

America is the world's only true superpower, but it cannot carry the weight of defense of the free world on its own. Trump's statements are necessary "tough love" threats directed to our freeloading allies, and when he was President, these statements were effective in dramatically increasing defense spending among our European allies.

But, Trump's essential point is that all NATO must pay their fair share for their own defense, a defense that is now provided primarily by the U.S. and hardworking taxpayers in Louisiana and throughout America.

Sometimes it takes years for us to let go of our pain and use it to help other people.

Jeff did that.

He was "calm in the newsroom storm."

It must be hard not being able to simply listen to your own muse in your quiet moments of inspiration.

I have always said that I really wouldn't want to work in a newsroom. It must be a nightmare to have to meet so many



Wilson named head coach at North Webster

Christopher Wilson has been named head football coach at North DeSoto.

Wilson helped North DeSoto achieve unprecedented success the last two seasons as an assistant coach in charge of running backs and the offensive line.

The Griffins reached the non-select Division II state championship game in 2022 and the semifinals this past season.

Before going to North DeSoto, Wilson spent two years as head coach at Plain Dealing.

Wilson replaced John Ware, who resigned after 12 seasons. He is now the head coach at Lakeside.

"I knew it was an opportunity where I could be successful in a place I felt was a match made in heaven," Wilson said of the North Webster job. "I wanted to be at a place where I could effect some change and I think they were looking for somebody like me with the transition.

"So I felt it was an op-

portunity for me to come in and, again, continue to grow and be the best version of myself and to serve the community and serve those kids."

North DeSoto went 12-2 in 2022. The Griffins fell to Lutcher 28-25 in the nonselect championship game. Last season, North DeSoto went 11-2 and lost to eventual champion Opelousas 28-20 in the semifinals.

Wilson said he gained valuable experience working under Head Coach Dennis Dunn, who led Evangel Christian to multiple state titles before becoming the head coach at Louisiana College (now Louisiana Christian). Dunn became the North DeSoto head coach in 2019.

"Really just organiza-

tion and really getting a gauge on loving people and communicating," Wilson said. "Coach Dunn was masterful how he dealt with people and how he led the boys and led his staff.

"So I was really blessed to have the opportunity to kind of sit back and to watch and see how somebody has the prestige of Coach Dunn leads a program. I gained so much valuable experience just being able to watch. Having the success we've had in the past two years I know that what we were doing works."

At Plain Dealing, Wilson's record was 5-14. But he faced the challenge of playing in one of the state's toughest districts while usually having less than 20 players available.

He helped rally the community around the team.

He said that experience has been invaluable in his journey to where he is now.

"I think what I learned at North DeSoto validated my experience at Plain Dealing," he said. "I knew we were on the right track. We were doing things the right way. The community

was engaged.

"The kids, albeit just a handful, they were engaged and they loved the program and loved what we were doing and what we were building. And so being at North DeSoto validated that experience. I knew I was on the right track as a leader. These two years have me that experience as an assistant. I think it's setting me up to be really, really good for the Springhill and North Webster community.'

Before going to Plain Dealing, Wilson was the offensive line coach and baseball coach at Mansfield for two seasons. He also was an assistant coach at Booker T. Washington and Fair Park.

Wilson will be taking over a North Webster team coming off a turnaround season. The Purple Knights went 7-5 and reached the second round of the nonselect Division III playoffs after going 2-8 in 2022.

Wilson said will remain at North DeSoto through the end of the school year. But he plans to take the Knights through 10 days of spring practice.

Pine trees yielding dreaded gold dust

This past Sunday I saw it for the first time. At first, I didn't know where that dust was coming from that I found on the windshield when I crawled behind the wheel preparing to head to church. Then I noticed the light golden color of the tiny flecks of dust. It hit me.

Pollen. Pine pollen.

Glancing at the ends of the branches of the hundreds of loblolly pines in my yard, I saw the swollen buds, locked and loaded to dump their load of aggravating yellow dust with no concern as to where their loads would land.

Pine pollen is produced by male pine cones, just trying out their masculinity I suppose. Some people are allergic to pine pollen, the same people are also likely to have allergic reactions to grass pollen. The culprit for most who experience bouts of hay fever in spring comes from pollen produced and released by oaks, hickories, rag weed and other such plants.

My wife enjoys opening the windows during spring to take advantage of nice comforting breezes. However, once the first bit of pollen is seen, she is not happy because this means she has to wait until pollen season ends in a few weeks to be able to open windows. By then, it's starting to warm up too much to enjoy the pleasant springtime breezes.

It can be used for the topical treatment of eczema, psoriasis, seborrheic dermatitis and other dry, itchy, flaky or inflamed skin conditions.


These research sources are suggesting that maybe we should give pine pollen more love because of all its benefits instead of treating it like a bad case of the flu.

GARDENING WITH DR. JOE WHITE

arch is typically the last month for a killing frost or perhaps even a freeze, but weather this year has been everything but typical. So go ahead and start a garden and hope for a more normal spring. There's lots to do in spring gardens and possibly I will mention some of the things you may consider.

ORNAMENTALS

This is a good time to set out strong transplants of cool season annuals. Why not try some of the Louisiana Super Plants? There are several good species from which to choose. While it may not be the best time to plant some of these. it's worth a try. However, I would suggest that you should also include species that previously have done well for you. Prepare hanging baskets

for later planting in vertical garden space. Later, place those that need full sun where they will get it and do likewise for those that need semi-shade of deep shade. Finish planting trees and shrubs that you didn't get to earlier to give them a better chance to become established before the stress of summer.

VEGETABLES

Plant Silver Queen or other "regular" varieties of sweet corn about the middle of the month and thereafter at two-week intervals until mid-April. Then the soil should be warm enough to plant some of the newer supersweet cultivars. Always plant three rows together for suitable pollination and ears full of kernals. Several other vegetables can be planted



this month, but delay planting the more cold-sensitive until the latter part of the month. Direct-seeded species often come up too thick and need to be thinned early to reduce competition. This practice usually results in faster growth and increased yields. When possible, use LSU recommended varieties for greater garden success, but don't necessarily limit your planting to only these. Make use of mulches to reduce weed problems and provide a more even supply of moisture to your plants.

FRUITS

Fertilize blackberries, the sooner the better. Spray blooming pear trees with either a copper-based chemical or an antibiotic to help control fire blight...a serious bacterial disease. Control weeds under mature fruit trees with appropriate herbicides rather than by disturbing the soil. When strawberries are producing, frequent light applications of a soluble fertilizer should increase yields.

LAWNS Mow winter species of lawn grass relatively short to reduce the competition to permanent turf grasses that are starting to grow. Remove leaves and other debris from lawn surface and add to compost pile. Treat lawn with pre-emergence herbicide now (if not already done) to kill sprouting summer annual weeds. Also treat lawn with post-emergence herbicides to kill existing weeds. Increase inventory of appropriate fertilizers for applying in mid-

April. A 15-5-10 analysis is usually a good choice for lawns. Several fire ant killers are effective, but are slow to do the job. So, the earlier you can apply them, the better off you will be.

GENERAL

Check out and repair or replace irrigation equipment in lawns, flower beds, vegetable gardens and landscape areas. Also inspect orchards and vineyards for the same reason.
