City Council charts course for \$4.1M allocation from American Rescue Plan Act

The Mayor and City Council met on Monday evening to hold a workshop where they discussed their plans for allocating the funding from The American Rescue Plan Act for the city of Minden. As a result of the act, the city is given \$4,100,000 to put towards making improvements in the community, including projects like replacing water lines, improving community facilities such as the REC Center and community house, and enhancing the animal shelter, among others.

Mayor Nick Cox created a working budget that provided rough estimates of how much the ARPA money would be used for each project. He made it clear that these estimates were ballpark figures and were subject to change as more solid estimates became available.

"I gave a lot of thought

Dallas man arrested on drug and weapons charges on Pearl Street

A Dallas man was arrested on Pearl Street in Minden on March 23, following a routine traffic stop that escalated into a significant drug and weapons bust. De'Audrick Gill, 23, was taken into custody after officers discovered a cache of illegal substances and firearms in his possession.

The incident began when an officer patrolling the area of East Union Street near Main Street observed a black Chrysler 200 failing to properly change lanes after turning left onto Main Street. The officer initiated a traffic stop and, as he approached the vehicle, the passenger was seen attempting to reach for something. A subsequent search of the vehicle revealed a small plastic bag of marijuana in the passenger's possession.

Gill, the driver, was instructed to exit the vehicle and was found to be in possession of more drugs. Gill claimed all responsibility for the contents of the vehicle. He admitted to having additional marijuana, Xanax, Promethazine, and two firearms under his driver's seat. A search of the vehicle uncovered a significant

Ribbon-cutting ceremonies were held in Dixie Inn and Minden on the morning of March 22 to mark the collaboration between

the state of Louisiana and AT&T on a plan to bring a state-of-the-art fiber network to homes, businesses, and farms in parts of thirteen Louisiana parishes. The \$22 million project is contingent upon a final

contract between the state of Louisiana and AT&T, with the telecom giant boasting extensive experience deploying fiber-optics across Louisiana.

Two women arrested on outstanding warrants after traffic stop

Two women were arrested on March 21 following a traffic stop in Minden when an officer observed a black Chevy Tahoe with an obscured dealer tag.

According to the police report, the officer noticed an overwhelming odor of natural marijuana emitting from the vehicle and observed four unrestrained children in the backseat. The driver, identified as Jaleshia Sims, 27, claimed the smell was due to her smoking earlier in the day and denied the presence of any illegal narcotics or weapons in the vehicle.

Seeds Women’s Center director advocates for pregnancy center funding bill

In a heartfelt testimony last week at the Louisiana State Capitol, Amber Bradford, executive director of Seeds Women’s Center, shared her personal journey of how a pregnancy clinic changed her life 17 years ago when she was pregnant with her daughter. Bradford, now leading Seeds Women’s Center, spoke passionately about the impact of such centers and advo-

cated for the passing of SB 278, a bill proposing state funding for pregnancy centers, adoption centers, and maternity homes. Bradford highlighted the success stories from states like Texas, Kansas, Nebraska, and Oklahoma, where similar bills have helped these centers thrive and serve more individuals in need. She emphasized the importance of providing a safe and non-judgmental space for women facing difficult decisions, much

like the one she found at a pregnancy clinic years ago. “My journey as a director at Seeds I can relate, understand, and share my story of how I made it and so can the women who are scared, upset, and not sure where to turn, have a safe, non-judgmental place as I did to be a part of like Seeds,” Bradford said. Bradford’s testimony, along with that of another client from Life Choices, a Monroe-based pregnan-

cy center, resonated with legislators, leading to the unanimous amendment of the bill by the House of Representatives Appropriations Committee and the Senate Health and Welfare Committee. “This bill does not affect our ability to share God’s love by asking to pray with our clients and patients, sharing baby items that are donated to our center through our learn to earn programs, or hindering us from partnering with any faith-based programs,”

Bradford clarified. Currently, Seeds Women’s Center and 32 other pregnancy centers in Louisiana rely solely on donations. Bradford expressed her gratitude for the community’s support and urged continued backing for Seeds Women’s Center. If passed, SB 278 would enable these centers to expand their services, including educating women on prenatal and postnatal care, providing alternatives to abortion, and offering

mom and dad classes. “This was an amazing experience, and I am so humbled to be a part of it to help not only pregnancy centers but help be the change for Moms, Dads, and children,” Bradford concluded. The bill now moves to Finance or to the Senate floor for a 2/3 vote. If it proceeds to Finance, Bradford will be invited back to share further insights with legislators about the crucial need for the bill’s passage.

Webster Parish Sheriff’s Office unveils new firing range

The Webster Parish Police Jury approved the allocation of a portion of the old penal farm for the development of a firing range for the Webster Parish Sheriff’s Office (WPSO) last year. Sheriff Jason Parker envisioned the facility benefiting local law enforcement, area officers, and the local community.

Officers from the Minden Police Department recently utilized the range on Penal Farm Road for firearm qualification, obviating the need for journeys to ranges beyond the parish. “This is what Sheriff Parker wanted, a facility that can be used by law enforcement officers to conduct their firearm proficiency training or to simply put in the practice they need,” stated Capt.

Joel Thomas, WPSO firearms instructor. “We will make the range available for departments in the parish, plus any from surrounding parishes.” While the range remains in its nascent stages, Thomas affirmed the area’s suitability and security for weapons training. Planned enhancements encompass a dedicated training building onsite, with designated instructors and range safety of-

ficers poised for assignment upon the facility’s formal inauguration. Training offerings will encompass low-light and nocturnal firearm drills, decision-making exercises, and leveraging cover and concealment for tactical advantage. Additionally, instruction in less-lethal munitions employment will be available. Beyond serving law enforcement personnel, the

range will extend its accessibility to the public, functioning as an arena for education and training. The department aims to establish scheduled windows during which the public can access the range under the supervision of a WPSO firearms instructor. Moreover, initiatives are underway to furnish firearms safety and self-defense courses, with considerations being given to the provision of

hunter safety instruction for youth. “Sheriff Parker believes well-informed, professionally trained citizens are an asset,” articulated Thomas. “We will be hosting firearm safety training to the public, and we’ll open the range for them at various times throughout the year.”

Minden Police Department goes cashless for public transactions

The Minden Police Department (MPD) is transitioning to a cashless system for all general public transactions, such as reports and bonds. According to MPD Lieutenant Kendrick, this move is aimed at administrative compliance with state audits and other requirements. “This is for admin-

istrative purposes just to keep things compliant with state audits and things like that,” said Lt. Kendrick. In a statement issued last week, the MPD stated that the shift to a cashless system aligns with their vision of modernizing financial processes, enhancing efficiency, and fostering greater transparency and accountability. The department aims

to streamline administrative tasks, reduce security risks, and better serve the community by greatly reducing cash transactions. Once the transition is complete, the MPD plans to make an additional public announcement regarding the cashless system. The department will accept only credit cards, money orders, or cashier’s checks for these transactions.

Key benefits of the transition include streamlined operations, enhanced security, improved record-keeping, transparency, accountability, and cost savings. Electronic payment methods will expedite various transactions, reduce wait times, and improve overall service delivery. Digital transactions offer heightened security features, minimize risks associated with cash

handling, and generate detailed, easily traceable records. This facilitates accurate financial reporting and compliance with regulatory audit requirements. “We understand that this transition may require some adjustments, but we believe it will ultimately lead to a more efficient, secure, and inclusive service for all residents of Minden,” the department

stated. “We remain committed to serving and protecting our community to the best of our abilities, and we believe that this move towards a cashless system will contribute to achieving that goal. We thank you for your continued support and cooperation.”

to the things that y’all wanted. The things that we, it seems like, as a group, wanted to see accomplished,” said Mayor Cox. “We have one shot, probably in the history of the city, to put some money towards getting us a step ahead. Never before in the history of the city of Minden have we had a windfall like this, so we could do something good with it.”

The listed items that the ARPA money is planned to be used for include the public works building, the animal shelter, the REC Department, audio and video equipment for the Civic Center, remodeling the community house, maintenance of the Shreve Water Main, airport hangars for the Minden Airport, and city cleanup and condemnations.

While going down the listed items to the Council, the Mayor gave general explanations of what the money would be used for. Regarding the funding for the REC Center, Mayor Cox was particular that he wanted the money to go towards improving the experience of the kids and citizens who utilize those facilities. “I want it spent on stuff that makes the kids have a better recreation experience,” said Cox.

One of the more practical items was the maintenance for the Shreve Water Main. The Mayor gave a concise explanation of the importance of this water line, stating, “If it goes down, we are done for. That is the most practical thing on the list. That is the line that connects the water pumping to the water tower.”

Another interesting item was investing in

building ten new hangars at the Minden Airport. These hangars would then be rented out to aircraft owners and generate revenue for the city. “I know that the airport is a tricky subject, but if you just look at this from a business standpoint, if we spend this money at an airport, it’s the one place on this list where we actually make it back,” said Mayor Cox. The hangars themselves would generate \$30,000 a year, on top of the profit from gas that the renters would also be purchasing.

In order for the city to oversee the use of the ARPA funds in some departments, special committees were made with members appointed by the Mayor. These include the Recreation and Civic Affairs Committee with Chairman Andy Pendegrass and Vice Chair Buddy Myles, the Animal

Shelter Committee with Chairman Michael Roy and Vice Chair Charlie Thomas, and the Property Standards Committee with Chairman Buddy Myles and Vice Chair Latasha Mitchell.

“It’s a big number, but if y’all agree to do that, I want the way the money is spent to be approved by the Chairman of these committees,” said Cox.

Near the end of the meeting, the Mayor reiterated about the working ARPA budget, “I just tried to look at all the things that y’all talk about a lot. And like I said, this is our shot to sprinkle some money through the city and hopefully it pays off in dividends.” As a result of the workshop, it seems that motions to move forward with this budget will be voted on during the May Minden City Council Meeting.

gation, it was discovered that Sims had an outstanding fugitive warrant through the Bossier Sheriff’s Office. A passenger in the vehicle, Akeilah Malone, provided a false name initially but was

later identified and found to have multiple active bench warrants and an arrest warrant through the Minden Police Department.

A probable cause search of the vehicle was conducted, resulting in

the discovery of 0.8 grams of methamphetamine under one of the children in the backseat.

Sims was charged with possession of a schedule II substance (methamphetamine), possession of a controlled dangerous

substance in the presence of a child under 17 years, and failure to restrain a child. Both Sims and Malone were arrested, advised of their rights per Miranda, and transported to the Minden Police Department for booking.

quantity of marijuana individually packaged for distribution, two bottles of Promethazine with Codeine, two bottles of Xanax, a scale, a Taurus G3 9mm, and a Smith and Wesson SD9 9mm.

Gill was charged with possession of schedule I (marijuana) with intent to distribute, possession of schedule II (Xanax)

with intent to distribute, possession of schedule V (Promethazine) with intent to distribute, illegal possession of a firearm near a controlled dangerous substance, possession of drug paraphernalia, improper lane change, and two bench warrants.

All evidence was collected and turned into the property room. Gill was taken into custody without incident.

Louisiana ‘Strikes a Blow’ for Free Speech
Government-Coerced Private Censorship Now Before U.S. Supreme Court

The case is *Murthy v. Missouri*, a suit brought in federal court in Monroe, Louisiana by a number of states, including Louisiana. The basis of the suit involves states and individuals whose Covid posts were censored who then sued federal government officials for violating their free speech rights. Lower courts had ruled in favor of these plaintiffs, finding that certain government officials had pressured social media platforms to censor and suppress their posts.

The legal question is one regarding freedom of speech and how these enormous social media sites choose to “moderate”—in fact, censor—the content of speech and whether, either by their own doing or as a result of pressure from the federal government, or both, these tech giants are suppressing certain speech—which is virtually always conservative speech.

These “communications” reflect active coordination between Facebook and U.S. government officials, including high-ranking White House officials. In one example, after Pres. Biden claimed that social media sites and “Covid misinformation” were resulting in “killing people,” a staffer at Meta (a Facebook spinoff) sent an email to U.S. Surgeon General Vivek Murthy, which stated “it’s not great to be accused of killing people” but Meta was committed to finding “a way to de-escalate and work together collaboratively.”

Other such “communications” (i.e., threats) include former White House director of digital strategy Rob Flaherty and Covid adviser Andy Slavitt who “flagged posts for removal to social media employees and berated them if they didn’t follow orders.” (Wall Street Journal, 3-18-24). Flaherty further stated that he “also blamed Facebook for the Jan 6, 2021 riot and said it would be blamed for Covid deaths if it didn’t increase censorship.”

Wow. WSJ further noted that “officials reinforced these private lashings with public threats” including those of former White House press secretary Jen Psaki who stated that plat-

forms could face “legal consequences” if they didn’t censor vaccine misinformation. In keeping with the Psaki threats, more than one Biden official strongly suggested the possibility of antitrust litigation brought against the platforms by the Department of Justice as well as removing Section 230 liability protections.

This incestuous relationship between the federal government and Facebook/Big Tech creates a toxic coordination

between government and huge social media sites to suppress critical information the public needs to make well-informed decisions. That’s irrefutable censorship of free speech.

The Biden Administration claims these threats are simply “jawboning”—government speech intended to persuade and inform that is protected by the 1st Amendment. That’s laughable. The U.S. 5th Circuit didn’t buy it concluding that Biden officials “weren’t merely out to persuade” but had instead “crossed the line by using threats of legal action.” (WSJ, Id).

The greatest virtue of free speech is that all kinds of ideas are thrust into the rough and tumble of the “marketplace of ideas” where the best idea prevails and leads the nation to wise policy results on challenging national issues. That obviously cannot occur if certain speech is censored and suppressed.

Well, after arguments before the Supreme Court and the questions of several Justices, I am concerned. Several justices reflected in their questions a view of free speech antithetical to that expressed by the Founding Fathers and reflected in the Constitution—that the 1st Amendment is a limit on the Government’s power to ‘abridge’ or censor free speech.

This unconstitutional view was articulated most clearly by Justice Jackson in her questioning but the so-called conserva-

tive Justices, including Kavanaugh and Roberts, also seemed to be leaning in the direction of supporting government censorship of free speech. Justice Jackson expressed concern that ‘the First Amendment will hamstring the government in significant ways in the most important time periods.’ She seems to have forgotten in her Constitutional Law class that “hamstringing” the federal government—beginning with that of the government of King George III—is exactly the reason why freedom of speech is the first Amendment in the Bill of Rights.

One of our most important constitutional principles is that the government cannot force private parties to do what the government is prohibited from doing on its own. Congress could not directly pass a law suppressing speech by American citizens about Covid. The law would be struck down immediately as a violation of the 1st Amendment. Well, neither can the government force Facebook and the other huge social media platforms to suppress speech. I hope the Supreme Court powerfully reaffirms that principle in this case.

I sense that Wayne and Linda knew how much we needed them because it was a known fact that we were the poorest family in town who had just moved in from the country in 1955 to the top of the rocky hill because daddy knew that mother couldn’t handle the horse-drawn wagon if we stayed in the country after he soon would die.

Life began to unfold.

Wayne was the minister who was placed in our path to preach the word and to minister to those within his reach.

We were within his path.

He visited my dad often during the last days of his life before he died on March 19, 1958 at home. He was the one who preached our dad’s funeral.

They were there for us.

Linda gave birth to their firstborn son, David, in the

year they were in our town. (I cherish the memory of knowing that mother sold them my out-grown baby bed which was used by both of their sons.)

The couple lived in a brownstone second story apartment near our school. My sister and I visited them almost daily as we walked by their house on our way home.

They never seemed to grow tired of us and always fixed us something to eat.

We loved them. His kind of preaching pricked a ten year old child’s heart. His sermons made me sit up and know the reality of it all. I would later become a Christian at fourteen as a result of those memories!

And then in September 1958 Wayne is called to leave our small church and to move to Florida.

The reality of their move became surreal when Brother

Earnest came to visit us on the last Sunday night after church on September 21, 1958 to celebrate my sister’s thirteenth birthday.

He must have spent a couple of hours but it was never long enough.

I will always believe he was praying for our safety knowing what a vulnerable state our family was in considering that my mother had suffered a brain trauma as a young child and never fully matured thus resulting in us later going to an orphanage.

We didn’t see them again but received letters from Florida.

We continued to walk by their apartment after school just hoping they might still be there. We never stopped looking for their blue and white 1950 Chevrolet.

Surely they would return.

I lost track of their whereabouts.

The first time I spoke to them was in 1981, just four years before Wayne died of a massive heart attack at the age of fifty-two.

But I have gotten to visit with Linda a couple of times in Tulsa, Oklahoma, where he preached. Her younger son,

Steve, still lives around Tulsa and David lives in Collierville, Tennessee. I asked her if she remembered me and her response was “I could never forget you.”

Their love was stamped in my heart.

I’ve gone online and researched Wayne’s work as a minister and it still reverberates today.

Don Bassett, the minister who gave his eulogy said “Wayne was always looking for something to do for someone in need!” And so it is with ministers and Christians who make a difference and who have a calling.

It isn’t the money paid or the lack thereof but the caring in the heart that makes them go the distance.

Love is a quality that cannot be bought or sold.

I sense that Wayne never tried to shift his responsibility to someone on a committee but did more than he had to do just because he cared.

Have we lost our mission today?

Kansas City trades former Minden star to Titans

Sneed reportedly gets 4-year, \$76M deal

Former Minden High star L’Jarius Sneed has been traded from Kansas City to Tennessee, according to media reports last week.

Sneed, a cornerback, played the first four seasons of his career with the Chiefs.

He played in three Super Bowls and helped the Chiefs win back-to-back titles the last two seasons.

According to the reports, the Chiefs will receive a 2024 third-round draft pick and a swap of 2027 seventh-round picks.

According to ESPN’s Adam Schefter, who was the first to report the news, the trade had been in the works for days and it will be a formality after Sneed passes his physical.

Sneed will sign a new contract and become one of the highest paid cornerbacks in NFL history, Schefter reported in a post

Former North Webster and LSU standout Devin White signed a one-year, \$7.6 million deal with the Philadelphia Eagles earlier this month.

OUTDOORS

It’s bird watching time

This is a special time of year, for many reasons. For the outdoorsman and woman, fishing is on the verge of getting white-hot and it’s about time to start chasing gobblers

There is one thing that more and more outdoor enthusiasts have taken an interest in over the past few years. Seed and feed stores will bear this out. Bird watching has grown into a sport that is attracting not only the Jane Hathaway types but good ole boys and girls as well. Birdseed, feeders and bird books are hot items today.

This is the time of year when a plethora of species make the unbelievable trek from South and Central America to move into our woods, some to nest and some to make brief stops on their way north. The best way to know just which wild bird species are paying you a visit is to get yourself prepared to view them. Here are a few essentials to make this sport more enjoyable.

BIRD FEEDERS—These come in a variety of shapes and styles. You can buy them, or you can make them yourself. My personal favorite is one I once constructed that was squirrel-proof. I nailed a 3-foot square of plywood on top of a length of old power pole that extends some five feet above the ground. Before securing the plywood, I slipped a length of sheet metal pipe, something like a stovepipe, over the pole, making it difficult for squirrels and raccoons to climb.

BIRDSEED — I use two types; a black oil sunflower and wild bird mix. Others use thistle for finches or suet for woodpeckers and nuthatches. Be sure you replenish the supply regularly,

especially after a rain since birdseed will spoil if left wet and unattended too long.

WATER — Birds, like humans, need water. A birdbath located somewhere in the yard will attract birds that come to water and bathe. A pump in the bath that circulates water will often attract warblers and other species that are not seed-eaters.

BINOCULARS — Leave a good pair of binoculars near your easy chair or wherever you can sit and watch what goes on around your feeder. Good viewing glasses makes bird identification so much simpler.

BIRD BOOKS— I have several and these are invaluable in helping me determine which species I’m viewing. I also keep a log of new sightings to help me build a list of birds I’ve identified.

Another type of bird will be here any day now, but you won’t find it feeding on sunflower seeds. It’s hum-

mingbird time and they’re easy to attract. All you need to do is hang a couple of hummingbird feeders outside your window for a colorful aerial display.

Here are some facts about these tiny creatures you might find interesting.

- Hummingbirds wings beat about 55 times per second in normal flight, and up to 200 beats per second during courtship and territorial displays.

- Top speed for the hummingbird is about 60 miles per hour.

- During migration, hummingbirds may travel 500 miles non-stop across the Gulf of Mexico.

- Their nests are no bigger than a half dollar and their eggs the size of an English pea.

FEEDER TIPS

- Make your own hummingbird food by mixing one part granulated white sugar to four parts water;

never substitute honey for sugar.

- Hang feeders in the open but shaded areas, especially under eaves next to hanging flower baskets.

- Clean your feeders every two to three days so the liquid does not ferment. Feeders should be cleaned with vinegar or bleach (not soap) and then rinsed with scalding water.

- Don’t worry about when to take your feeders down. Hummingbirds know when to leave. Late season feeding of northern migrants often occurs after your resident birds have already gone. They won’t stay behind and freeze.

- While hummingbirds need nectar for energy, they also rely on insect protein for body and feather growth. When insect levels fall, the birds begin to leave.

Bird watching...it’s inexpensive, it’s rewarding and it’s fun. And I’m glad that even good ole boys can enjoy it.

– Crappie are starting to move to the back of the creeks where spawning is starting to take place. Bass are moving shallow with some good fish

caught on spinners, soft plastics and jigs. Best catches are being made early and late in the day. Stripers are beginning to show up in open water around Kel’s Cove. No report on catfish. For latest information, call Kel’s Cove at 927-2264 or Terzia Tackle at 278-4498.

CANEY LAKE

– Bass are being caught on soft plastics and jigs as they are beginning to move from deeper water to mouth of the creeks. Rat-L-Traps ripped through the grass are picking up some bass with soft plastics, square bills and topwater lures are also working. Crappie are starting to move to the back of the creeks and are beginning to spawn and hit shiners or jigs. For information contact Caney Lake Landing at 259-6649, Hooks Marina at 249-2347, Terzia Tackle at 278-4498 or the Honey Hole Tackle Shop at 323-8707.

LAKE POVERTY POINT

– Crappie fishing has been good as they’re starting to move to shallow spawning areas with some still holding in deeper water. Shiners and jigs are working best. Catfishing is good. No report on bass. For latest reports, call Poverty Point Marina at 318/878-0101.

LAKE YUCATAN

– The water is on a slight rise. Lots of nice catfish and buffalo are being caught in nets. The crappie haven’t started biting just yet; water still too cold. For information, call Surplus City Landing at 318/467-2259.

ORDINANCE NO. 132

AN ORDINANCE OF THE VILLAGE OF DIXIE INN TO PROVIDE FOR THE ENFORCEMENT OF CERTAIN TRAFFIC VIOLATIONS BY AUTOMATED MEANS AND PROVIDE FOR CIVIL PENALTIES FOR THOSE CERTAIN TRAFFIC VIOLATIONS ENFORCED

BY AUTOMATED MEANS, AND OTHERWISE PROVIDING WITH RESPECT THERETO.

WHEREAS, data collected on behalf of the Village of Dixie Inn Police Department indicates a high incidence of drivers disregarding speeding laws on the streets of the Village of Dixie Inn; and

WHEREAS, the Village of Dixie Inn Council finds controlling speed on the streets of the Village of Dixie Inn through a program utilizing photographic evidence and enforcement through the imposition of civil penalties will help promote and protect the health, safety and welfare of the children and all citizens of the Village of Dixie Inn.

BE IT ORDAINED by the Village of Dixie Inn Council of the Village of Dixie Inn, Louisiana, in due regular and legal session convened, that Ordinance 132 is to read as follows:

*** CHAPTER 1-TRAFFIC AND VEHICLES

ARTICLE I-TRAFFIC REGULATIONS ON PRIVATE STREETS

*** SECT. I - Speed Limits on Private Streets

(a) In accordance with R.S. 32:41(E), the owner of any private street or streets within the corporate limits of the village may apply to the village to have speed limits established on said streets. Such speed limits may be established by the adoption of an ordinance by the Village Council if it deems such speed limits appropriate.

(b) In the event speed limits are established by ordinance on said streets, it shall be unlawful for any person to drive or operate a motor vehicle in excess of the limits set by the ordinance.

(c) In the event the Village Council adopts an ordinance to establish stop signs or speed limits on a private street, the owner shall remove all private stop signs and speed limit signs on that street.

ARTICLE 2-ELECTRONIC TRAFFIC ENFORCEMENT

SECT. II - Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Administrative Adjudication Hearing shall mean an administrative hearing of violations conducted by the Mayor's designee.

Chief shall mean the Village of Dixie Inn Chief of Police or his designee.

Total Civil Violation Amount shall mean the original fine amount plus any applicable late fees for failure to pay original fine amount within 30 calendar days from the date of receipt of civil notice of violation.

Department shall mean the Village of Dixie Inn Police Department, or an authorized representative as determined by the Chief.

Hearing Officer/Adjudicator shall mean the licensed attorney designated by the Mayor and Board of Aldermen of the Village of Dixie Inn who meets the qualifications contained within this section.

Mayor shall mean the Mayor of the Village of Dixie Inn.

Owner shall mean the owner of a vehicle as shown on the vehicle registration records of the Louisiana Office of Public Safety, Office of Motor Vehicles, or the analogous office or agency of another state or county.

Photographic Vehicle Speed Enforcement System or system shall mean a system consisting of an electronic process which is capable of producing one or more recorded images depicting the license plate attached to the rear of a vehicle being operated at a speed in excess of the speed limit. The speed measurement component of the system shall be properly calibrated on a regular basis as determined by the Chief and the records of such calibration shall be maintained with the Village of Dixie Inn Police Department.

Recorded image means an image recorded by the system depicting the rear of a vehicle which is automatically recorded

on a photograph or digital image, which also depicts the recorded speed, date, location, and time of the recorded image.

System location means the roadway location toward which a photographic vehicle speed enforcement system is directed and in operation or a segment of roadway on which a vehicle speed enforcement system is in operation.

Speed limit shall mean the established regulatory speed limit on the subject roadway.

Violation shall mean the notice of civil violation for speeding for this Chapter.

Sec. III - Imposition of Civil Violation Penalty for Violations Enforced by a Photographic Speed Enforcement System.

a. The Village of Dixie Inn Council finds and determines a vehicle traveling over the speed limit for the vehicle's direction of travel damages the public by endangering vehicle operators, passengers and pedestrians alike, by increasing the number of serious traffic crashes, and causing public safety agencies to respond at the expense of the taxpayers thereby decreasing the efficiency of traffic control and traffic flow efforts.

b. Except as provided in subsection (c) below, the owner of a vehicle is responsible for a civil violation penalty as shown in the following tables if the vehicle is traveling at a speed in miles per hour (mph) greater than the speed limit as shown when captured by the system in accordance with the vehicle's recorded speed and the corresponding speed limit of the roadway where the notice of civil violation was issued.

9 MPH to 10 MPH
11 MPH to 20 MPH
21 MPH to 30 MPH
31 MPH to 100+ MPH

c. Any photographic vehicle speed enforcement system which is hand-held, mounted in or on a trailer or in a fixed position shall be deployed at the discretion of the Chief of Police, who shall deploy such systems in his discretion within the Village of Dixie Inn. For each speed enforcement system which is hand-held, mounted in or on a trailer or is otherwise considered mobile, portable or easily transported to a different system location, the Department or its designee shall clearly and conspicuously mark on the outside of the apparatus that contains the speed enforcement system that the system is the property or under the control of the Village of Dixie Inn Police Department.

Sec. IV - Late Payments.

An owner who fails to pay a civil violation penalty beyond 30 calendar days from the date of mailing the civil notice of violation, inclusive of weekends and legal holidays, shall be subject to a late payment penalty of \$30.00 (e.g., original fine amount + 30 = total civil violation amount including late payment penalty). A notice of civil violation under this article is presumed to have been received on the tenth calendar day, inclusive of weekends and legal holidays, after the date the notice of civil violation is mailed.

Sec. V - Enforcement; procedures.

a. The Department is responsible for the enforcement and administration of this ordinance, or the Department may enforce and administer this ordinance in part or in whole, through one or more contractors selected in accordance with applicable law. The actions which can be used to enforce the payment of this civil penalty and related fees include but are not limited to: referring the debt to collection agencies; and/or initiating actions through a court of competent jurisdiction, or any other lawful means, all in accordance with applicable authority, laws, and procedure.

b. In order to impose a civil violation issued under this article shall contain the following:

- (1) A description of the violation alleged
- (2) The date, time, and location of the violation;
- (3) A copy of the recorded image of the vehicle involved in the violation;
- (4) The amount of civil violation penalty to be imposed for the violation;
- (5) The date by which the civil violation penalty must be paid;
- (6) A statement indicating the person named in the notice of civil violation may pay the civil violation penalty in lieu of appearing at an administrative adjudication hearing;
- (7) Information informing the person named in the notice of civil violation:

(a) Of the right to contest the imposition of the civil violation penalty in an administrative adjudication hearing;

(b) Of the manner and time in which to contest the imposition of the civil violation penalty;

(c) Failure to pay the civil violation penalty or to contest liability within thirty (30) calendar days from the date of receipt of the civil notice of violation, inclusive of weekends and legal holidays, is a waiver of the right to appeal.

(8) A statement that a recorded image is evidence in a proceeding for the imposition of a civil violation penalty; and

(9) A statement indicating failure to pay the civil violation penalty within the time allowed shall result in the imposition of an additional late penalty for each such violation.

d. A notice of civil violation under this article is presumed to have been received on the tenth calendar day, inclusive of weekends and legal holidays, after the date the notice of civil violation is mailed.

Sec. VI - Administrative Adjudication Hearing

a. A person who receives a notice of civil violation may contest the imposition of the civil violation penalty by providing all of the following within thirty (30) calendar days, inclusive of weekends and holidays, after the notice of mailing of the notice of civil violation:

(1) A request in writing for an administrative adjudication of the notice of civil violation; and

(2) Posting of a cash bond of \$50.00. No request for administrative adjudication shall be processed until due proof has been furnished indicating the amount of the cash bond that has been paid.

b. Upon receipt of a request and cash bond within the prescribed time period within this paragraph, the office shall notify the person requesting such hearing of the date, time and/or manner of the administrative adjudication hearing. If after the adjudication hearing, the person is found not liable by the adjudication officer, the cash bond of \$50.00 will be refunded to that person. If that person is found liable, he or she may ask that the cash bond of \$50.00 be used towards the payment of the civil violation.

c. A person is found liable after an administrative adjudication hearing or who requests an administrative adjudication hearing and thereafter fails to appear at the time and place of the hearing shall forfeit their cash bond amount.

d. Administrative adjudications of violations shall be conducted by the hearing officer designated by the mayor. In conducting administrative adjudications of violations, the hearing officer shall have the following functions, powers, and duties:

(1) To administer oaths, to accept admissions to, and to hear and determine contests of violations herein.

(2) To require the attendance of persons to give testimony at hearings, and to require the production of data and information, to the extent permitted by law.

(3) To adjudicate violations for which a notice of civil violation has been issued herein.

(4) To compile and maintain accurate records relating to notice of civil violations, violations and/or dispositions of violations and notice of civil violations.

(5) Upon request of the Department or a person charged with a violation, or his attorney, to prepare or

provide transcripts or audio records of hearings conducted by the hearing officer or to furnish such transcripts or audio records to the requesting person a reasonable cost.

(6) To designate an individual or individuals with the responsibility to answer, within a reasonable period of time, relevant and reasonable inquiries made a person charged with a violation, or his attorney, concerning the violation.

(7) The functions and duties in (4), (5), and (6) identified herein may be performed by representatives of the Department, as directed by the hearing officer.

(8) To prescribe regulations for the presentation and the conduct of hearings which need not necessarily be in strict conformity with the usual rules of evidence and technical rules of procedure, however, the fundamental principles governing a fair and impartial hearing or trial and due process of law must be reasonably and substantially adhered to.

e. Except as provided in subsection (i), failure to pay a civil violation penalty or to contest liability beyond 30 calendar days from the date of mailing of the notice of civil violation, inclusive of weekends and legal holidays, constitutes a waiver of the right to contest under subsection (a.).

f. The civil violation penalty shall not be assessed if after a hearing, the hearing officer enters a finding of no liability.

g. In an administrative adjudication hearing, the issues must be proved at the hearing by a preponderance of the evidence. The reliability of the system used to produce the recorded image of the violation may be attested to in an administrative adjudication hearing by affidavit of a law enforcement officer or a representative of the Department, or by actual testimony by either of them. An affidavit of a sworn law enforcement officer or representative of the Department, or actual testimony by either of them, that alleges a civil violation occurred based on an inspection of the pertinent recorded image is admissible in a proceeding under this article and is prima facie evidence of those facts contained in the affidavit or testified to. Testimony by any person shall be taken under oath or by affirmation, except to the extent such testimony is allowed by affidavit as provided above. The person charged with the ordinance violation may present any relevant evidence and testimony at such hearing.

h. Adjudication by mail.

(1) In cases where a person charged with a violation shows good cause for not attending a hearing, either personally or through a representative, the hearing officer may permit the matter to be adjudicated by mail which adjudication shall be made within 60 days of the date of the citation. Letters, memoranda, affidavits, photographs, or other documentary materials shall be admissible as evidence for the purposes of adjudications by mail. The hearing officer may exclude any material which is not relevant to the adjudication of the alleged violation. Failure of the person charged to proceed with an adjudication by mail after requesting an receiving permission to adjudicate by mail shall constitute an admission by the person charged of liability of the violation and shall subject the person who requested the adjudication by mail to the appropriate fines and costs assessed by the adjudication bureau.

(2) If a hearing examiner determines that an adjudication cannot proceed by mail, the adjudication bureau shall advise the person charged by first class mail that he must appear to answer the charge at a hearing.

i. It shall be an affirmative defense to the imposition of civil liability under this article, to be proven by a preponderance of the evidence, that:

(1) The operator of the vehicle was acting in compliance with the lawful order direction of a law enforcement or public safety officer;

(2) The operator of the vehicle violated the speed limit so as to move out of the way or an immediately approaching authorized emergency vehicle;

(3) The vehicle was being operated in accordance with La. R.S. 32:24, and the operator was acting in compliance with La. R.S. 32:24;

(4) The vehicle was being operated in accordance with La. R.S. 32:300.3 – Funeral

Processions; however, the operators are not exempt if they fail to comply with division 2, vehicle speed.

(5) The vehicle was being operated by a commissioned law enforcement officer performing authorized/assigned tasks;

(6) The vehicle was being operated during a bona fide medical emergency which is documented with adequate and sufficient evidence from a medical care facility, as determined by the Department;

(7) At the time of the violation, the vehicle was in the care, custody, or control of another person:

(a) As set forth in the owner's signed affidavit, identifying the name and correct mailing address of the person or entity who had the care, custody and control of the vehicle at the time of the violation.

(b) As set forth in the owner's signed affidavit stating that at the time of the violation the motor vehicle or the license plates of the motor vehicle involved were stolen or were in the care, custody, and control of some person who did not have the owner's permission to use the motor vehicle, or that the motor vehicle or license plate of the motor vehicle was stolen before the violation occurred and was not under the control or possession of the owner at the time of the violation. In order to demonstrate that the motor vehicle or license plate was stolen before the violation occurred and was not under the control or possession of the vehicle owner at the time of the violation, the vehicle owner must submit proof that a police report, incident report/general offense report about the stolen motor vehicle or license plate was filed prior to the violation or within 48 hours after the violation occurred.

(c) As set forth in a document, or "Transfer of Liability", signed and dated by the person, or a representative of the entity, who had the care, custody, and control of the vehicle at the time of the violation, indicating his/her responsibility for the violation and listing his/her name and mailing address. Responsibility for the violation shall in such a case be transferred to the person identified in the "Transfer of Liability".

(d) The tender of a statement of "Transfer of Liability" shall be for the sole purpose of identifying the person who is assuming responsibility for the violation identified in the notice of civil violation, but all defenses that may be asserted by the person alleged to be responsible are reserved and are not waived by the tender of such document.

(e) As set forth in a lease, rental contract, or other agreement, listing the name and mailing address of the person or entity who had the care, custody, or control of the leased or rented vehicle at the time of the violation. Responsibility for the violation shall in such case be transferred to the lessee.

j. Notwithstanding anything in this article to the contrary, a person who fails to pay the amount of a civil violation penalty or to contest liability is entitled to an administrative adjudication hearing on the violation if:

(1) The person files an affidavit with the office stating the date on which the person received the notice of civil violation mailed to the person; and

(2) The person files a request for an administrative hearing within 30 days from the date of receipt of the notice of civil violation, as stated in the affidavit.

k. The decision of the hearing officer shall be the final decision in the hearing.

Sec. VII - Appointment of Hearing Officer

a. Administrative adjudication proceedings under this article shall be conducted before a hearing officer who has been licensed to practice law in Louisiana for at least two years.

b. There shall be no one hearing officer appointed for the adjudication of proceedings under this article who shall serve in accordance with a schedule determined by the village attorney.

c. There shall be one hearing officer appointed by the mayor subject to approval and confirmation of the village council who shall serve at the pleasure of the mayor.

d. Hearing officers shall be sworn before the city attorney or his/her designee to uphold the Constitution, the laws and constitution of the State of Louisiana, and the Charter and ordinances of the Village of Dixie Inn, and

to abide by the provisions of the Louisiana Code of Governmental Ethics.

Sec. VIII - Orders of the Hearing Officer

a. The hearing officer at administrative adjudication hearings under this article shall issue an order stating:

(1) Whether the person charged with the violation is responsible for the violation; and

(2) The amount of any civil violation penalty, late penalty, and administrative adjudication costs assessed against the person.

b. The orders issued under subsection (a) may be filed with the Department. The Department shall maintain the hearing officer's orders/determinations.

Sec. IX - Effect of Liability; exclusion of civil remedy.

a. The imposition of civil violation penalty under this article shall not be considered a criminal conviction.

b. A civil violation penalty may not be imposed under this article upon the owner of a vehicle if the operator of the vehicle was arrested or was issued a speeding citation and notice to appear by a law enforcement or public safety officer as a violation of any of the provisions of Subpart A, Part IV, Chapter 1 of Title 32 of the Louisiana Revised Statutes if such violation was captured by the system.

c. Upon receipt of all documents supplied to the contractor, the hearing officer may enforce collection of all unpaid fines, fees, penalties, late payment penalties and administrative adjudication fees in a court of competent jurisdiction for vehicles registered through a filing with the Louisiana Office of Revenue and the Federal Offset Program.

d. The Chief or contractor, as applicable, shall supply to the hearing officer, or outside counsel bringing suit, all materials and/or testimony necessary to support enforcement.

e. Defendants in enforcement suits authorized by this section, have until rendition of final judgment, the option of settlement by payment of all outstanding fines, fees, penalties, late payment penalties, and administrative adjudication fees, as well as court costs and filing fees incurred (whether prepaid or otherwise) in enforcement. No defendant in such suit shall be required to pay attorney's fees in connection with such settlement.

f. Any money judgment obtained in a suit to enforce fines levied for violation of this division shall be recorded in the mortgage records of Webster Parish, and/or any other parish, as a judicial mortgage against the property of the defendant.

Sec. X - Collection Fees and Costs

In the event a fine or penalty is assessed pursuant to any provision of this Code, a default in the payment of a fine, penalty or any installment of a fine or penalty may be collected by any means authorized for the collection of monetary judgments. The Department may retain attorneys and private collection agents for the purpose of collecting any default in payment of any fine or penalty imposed by the Code, or any installment of a fine or penalty. The Department shall add a 35% cost of collections to any outstanding balance that requires the Department to retain the services of a collection agency. This 35% cost includes any default in a fine, penalty or any installment of a fine or penalty that was previously referred to an attorney or private agency and the payment of which remains outstanding.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that this ordinance shall become effective in accordance with the provisions of the Village of Dixie Inn.

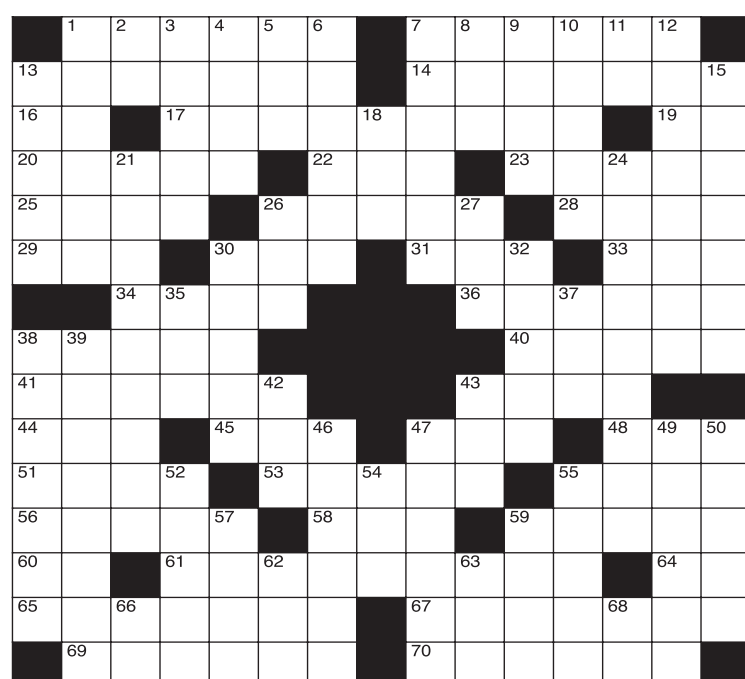

GARDENING WITH DR. JOE WHITE

HERBICIDES OFTEN BEST WAY TO CONTROL WEEDS

Long time gardeners are accustomed to using a hoe to get rid of weeds and that still works on certain types of weeds, but there's a better way which is effective on all weeds...and that is the use of an appropriate herbicide. In spite of a bad reputation stigma, many people (both farmers and suburbanites) now use various agricultural chemicals to control not only weeds, but also harmful insects and a wide array of diseases. Regardless of what product is used, it is of paramount importance that label instructions are followed and that applications are made in such a way as to not harm the environment.

This month and most of next month is the best time to use herbicides on lawns. It's probably a little late to use a pre-emergence herbicide to control warm season weeds such as crab grass and some grass species can be damaged if herbicides are applied during hot weather. So be careful about what you use and when you use it.

Precise calibration is more critical when using herbicides rather than other agricultural chemicals. And to prevent doing damage to your "good" crops (including lawns), tag one sprayer for use by herbicides only. Using less of a herbicide then instructions call for usually results in failure to kill the intended weeds while using more than recommended not only kills the intrusive weeds, but also other plants...as well as wasting time, effort and money.

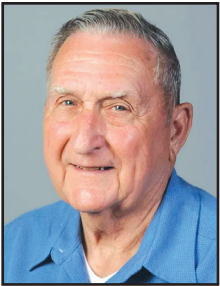
With the beginning of April, we are truly entering our long growing season and our lawn grasses are



awakening. This situation means that we should be extra cautious and make sure we have bought the right herbicide for our particular species of grass. For example, some products that we can use on Bermuda grass and Zoysia grass may not be used on St. Augustine and Centipede grasses without causing damage. Thus, it's important to check the label before making the purchase. The labels will tell you which grasses will tolerate the herbicide in that container. And do be aware that sometimes more than one application will be needed to eradicate a certain stubborn weed. Spot treatment may become necessary if earlier applications of a post-emergence herbicide failed to do the job. For this purpose, it may require that you use a herbicide that contains glyphosate or other strong systemic herbicide.

The good thing about using these strong herbicides (although many are relatively slow acting) is that they remain in the soil only briefly before they break down.

Using herbicides correctly will almost always give the results you want as all parts of the target plants will be killed while eliminating weeds mechanically with a hoe or lawn mower typically leaves live parts of the weed plants and these have the ability to grow into brand new plants.
