Minden woman arrested for flight and escape after traffic stop

Lashonda Thornton, 44, was arrested on March 25 following a traffic stop that escalated into a flight and escape situation in Minden. The incident occurred when an officer attempted to stop Thornton's vehicle for a traffic violation.

According to the police report, Thornton's vehicle was observed turning through a parking lot to avoid a red light at the intersection of E. Union Street and Sheppard Street. When the vehicle came to a stop on Martin Luther King Drive, Thornton immediately exited the vehicle. The officer requested her driver's license, insurance, and vehicle registration, but Thornton refused to provide the documents, insisting on knowing the reason for the stop first.

Despite the officer's explanation that he would disclose the reason after receiving the documents, Thornton continued to argue and refused to cooperate. A second officer arrived to assist in detaining Thornton, but she attempted to flee on foot. After a brief struggle, officers were able to subdue Thornton and place her in

Grant equips Webster **Parish SROs** with body cameras

In a move toward bolstering transparency and accountability within the Webster Parish public school system, School Resource Officers (SROs) have been equipped with new body cameras. The spearheaded initiative, by the Parish Emergency Management Advisory Committee, culminated in the acquisition of 15 Axon Body 2 cameras, funded through grants totaling over \$11,000.00.

"This puts all the SROs on the same page with body cameras, which helps the school board as well," remarked Chief Jared McIver of the Minden Police Department, underscoring the importance of uniformity in equipping officers.

Minden library hosts WIOA youth services event

The Minden branch of Webster Parish Libraries hosted an event focused on youth services under the Workforce Innovation and Opportunity Act (WIOA) on March 26. The WIOA, enacted in 2014, aims to provide a comprehensive youth employment program for eligible individuals aged 14-24 who encounter barriers to education, training, and employment.

Representatives from the Coordinating & Development Corporation (CDC) were present at the library to register interested individuals in their job training program tailored for youth in the 14 to 24 age bracket.

The WIOA Youth Program offers a range of services to help young adults develop the skills necessary to succeed in the future workforce. Some of the services available to participants include GED/high school equivalency completion, postsecondary education and training, paid and unpaid work experience, comprehensive guidance and training, leadership development activities, occupational skills training, financial literacy education, resume assistance, vocational training programs, and career counseling.

One key service provided by the CDC is an onthe-job training program.

This program not only offers young adults employment opportunities but also provides participating employers with various benefits, including up to 50% reimbursement of trainees' hourly wages, customized training, access to a pool of new vetted young talent, assistance with short-term projects, and positive public relations for businesses, as well as savings on recruiting, screening, and training costs.

Employers who enter into a new hire on-thejob training agreement can hire new workers for skilled positions and train them with the aim of offering permanent employment upon successful completion of training.



Homer police chief arrested on drug and weapons charges

Homer Police Department (HPD) Sergeant Arnold Stephenson, 50, was arrested on March 25 for possession of schedule I narcotics with intent to distribute and illegal carrying of weapons, as part of an ongoing investigation by the Louisiana State Police Bureau of

Investigations/Bossier City Field Office (LSP BOI BCFO). Stephenson was booked into Claiborne Parish Detention Center.

The investigation, which remains active, was initiated following a complaint of excessive use of force by HPD. In December 2022, HPD Chief Elvan "Van" McDaniel was arrested for aggravated battery and malfeasance

in office. Investigators found that Chief McDaniel had used excessive force by deploying a taser multiple times on a noncombative subject who was handcuffed and lying on the ground.

As the investigation continues, additional charges and arrests are possible. HPD will be unable to answer calls for service, with the Clai-

borne Parish Sheriff's Office handling all calls in the area, assisted by Troop G.

Louisiana State Police will lead the investigation, and additional information will be provided as it becomes available. Anonymous tips can be submitted through the Louisiana State Police online reporting system at http://la-safe.org/.

Sibley man arrested for drug possession and firearms offenses

James Limosnero, 29, of Sibley, was arrested in the early hours of March 29 on Sheppard Street by Minden police.

According to the police report, an officer observed a black Dodge Ram operating with a faulty left taillight and driving left of center. The officer initiated a traffic stop, and upon approaching the vehicle,

noticed Limosnero's pupils were constricted.

Limosnero, when questioned about his activities, stated he was "just trying to program my TV, and I'm out stopping the web hackers," exhibiting sporadic speech and an inability to maintain eye contact.

Following a frisk, the officer found a black 9mm Ruger in Limosnero's waistband. Standardized field sobriety tests were conducted, which Limosnero consented to. However, he displayed signs of impairment during the tests, including swaying, inability to focus, and balance issues.

Limosnero was subsequently arrested and a search of his vehicle yielded two round green pills, later identified as methamphetamines. Although Limosnero provided a breath sample registering .000% B.A.C.,

a drug recognition expert was not available at the time of arrest. A methamphetamine field test kit confirmed the nature of the pills.

Limosnero was charged with possession of Schedule 2 substances, possession of a firearm with controlled dangerous substances, reckless operation, and failure to have working tail lights.

A Minden man was arrested on domestic abuse charges after an incident on March 26. Officers were dispatched to the 300 block of Pennsylva-

nia in reference to an active disturbance. They made contact with Zarvia Moore, 35, and Cherrelle Moore.

Cherrelle Moore stated that Zarvia ripped her shirt off as soon as she opened the door when someone knocked. Minor lacerations were observed across the upper portion of her chest. Her 8-year-old daughter and 6-year-old niece were in the adjacent living room when the events happened.

Zarvia was taken into

custody without incident and transported to the Minden Police Department for booking. He was charged with domestic abuse with child endangerment.

These students, Abrianna Gardner, Allison Lorenz, Cailey Nail, Callie Lewis, and Gabrielle Cooper, are part of a new course at North Webster High School, which offers a dual enrollment course taught through ULM. As a result of their success, these students have been approved to attend the Educators Rising 2024 National Conference and Competition in Washington, DC, along with their chaperones.

Furthermore, the board approved field trips for North Webster Lower Elementary School 2nd grade students to Logoly State Park in Magnolia, Arkansas, and for Webster Jr High School honor students to visit the Dallas World Aquarium and view the total eclipse in Dallas, Texas. Both trips will be funded using Title I funds.

The board also adopted an LSBA Resolution op-

posing Education Savings Accounts, including House Bill 745, which creates the LA GATOR Scholarship Program. The resolution urges the Webster Parish legislative delegation to vote NO on any bill proposing an Education Savings Account, citing concerns that diverting public dollars to private schools disadvantages public education. "Educational savings accounts, as the term is being thrown about, is not true or indicative of what's going on," said Jonathan Guthrie, board ber for District 4. "These things that are being called educational savings accounts are nothing

but super-charged vouchers. I believe it will create more problems than it solves."

Additionally, the board

approved several expenditures for maintenance and upgrades using maintenance funds.

Personnel Director Robin Tucker announced plans to attend the Greater Minden Chamber Job Fair & Career Expo on April 3 to recruit for positions such as custodians, food service workers, and bus drivers.

The board's next meeting is scheduled for Thursday, May 2, at 6 PM at the school board office, and the public is welcome to attend.

During the arrest, Thornton resisted and attempted to escape The officer custody. warned her that a taser would be used if she did not comply. After continued resistance, the officer deployed the taser, allowing them to secure Thornton in Thornton handcuffs. was then able to pull her hands out of the cuffs, prompting officers to struggle once again to get the handcuffs on Thornton. Thornton continued to resist as the officers placed her in the patrol vehicle.

Thornton was charged with failure to use the required position and method of turning at intersections, flight from an officer, and simple escape. She was transported to the Minden Police Department without further incident.

Authorities remind the public to comply with law enforcement instructions during traffic stops to ensure safety for all parties involved.

He noted that cameras that SROs from the police department were already issued will return to the department to be used as replacements, indicating a seamless transition towards enhanced surveillance capabilities.

U.S. Betrays Ally Israel at United Nations

After President Biden's failure last week to veto a U.N. resolution calling for a cease-fire in Gaza, Israeli Prime Minister Benjamin Netanyahu cancelled visit by an Israeli delegation scheduled to meet with Biden in D.C. to discuss the planned invasion of the Hamas-infested city of Rafah in Gaza. Biden's cowardly decision to abstain from voting allowed the resolution, backed by China, Russia, Iran, North Korea, and many other dangerous enemies of both the U.S. and Israel, to pass.

In response to Biden's cowardice, Prime Minister Netanyahu said that this is "a clear departure from the consistent U.S. position" in the Security Council since the beginning of the war. This withdrawal damages both the war effort and the effort to release the hostages because it "gives Hamas that international pressure will force Israel to accept a cease-fire without the release of our hostages." (Wall Street Journal, 03-26-

As described by the Wall Street Journal, this past week "the U.S. withheld its veto and abstained as the U.N. Security Council passed a resolution that demanded a cease-fire in Gaza but didn't make the cease-fire contingent on Hamas releasing its 134 hostages. That condition, on which the U.S. had

previously insisted, has been of the U.S. population, acdropped." (WSJ, 3-26-24). In fact, the Biden Administration position has weakened so much that "Mr. Biden's initial support for destroying Hamas has faded, such that Vice President Kamala Harris now refuses to rule out 'consequences' should Israel invade Hamas's last stronghold of Rafah."

This feckless move by Biden is not surprising because, since Hamas's Oct. 7

massacre some 1,400 raelis, we've seen President Biden equivocate about, treat from, origihis ronal

bust support of Israel. This change is in no small part due to pressure from the Lunatic Left of the national Democratic Party that screams for Israel, whom it vilifies as an "occupier," to agree to a ceasefire and end the war while Hamas still controls Gaza. It would be perilous for Israel to do so.

Let's have some context:

We note that international calls for the annihilation of Israel, and generalized hatred of Jews, have increased exponentially. Polling in the U.S. reflects that while Jews

cording to FBI data, reported antisemitic hate crime incidents accounted for 9.6 percent of all hate crimes. (Anti-Defamation League ((ADL)) 10-16-2023 citing FBI statistics).

Let's also recall that in his State of the Union address Pres. Biden promised the families of U.S. hostages held by Hamas that "we will not rest until we bring their loved ones home." Well, that pledge has now been weakened at the United Nations.

Fly fishing fun, frustrating

If you hunt or fish you'll find there are some activities that are more highly revered than others, at least they are by zealots of the sport. Take quail hunting, for example. While quail in our part of the country have basically gone the way of the Studebaker, there are those who still keep a brace of pointers and seek out those widely scattered pockets of cover that may hold a covey or two. Why? Because quail hunting is so special to them; they just can't entertain thoughts that quail

numbers continue to shrink. Then there are the fly fishermen. The average angler heads for the lake or the creek bank armed with rods and reels, or a cane pole and bucket of worms. While some rod and reelers and cane polers have perfected their craft to a fine edge, the average fisherman just wants to catch supper, and the gear he selects is what he feels will allow him to do that most effectively.

Ah, but the fly fisherman is a far different creature. He's probably more of a any other sportsman. He tones of tippets and Royal Coachmen and such. He ties his own flies; builds his own rods. It's as if the process of preparing to fly fish is an end in itself.

I once tried fly fishing, but I soon learned that I lack something in the "purist" category. I purchased my outfit years ago at the local discount store for \$29.95. No, that was not the price of the fly line; that was the package price for rod, reel, line, leader and a box of flies. I took my purchase to a local pond where I'd located a bed of bluegills in the shallows. I managed to catch a few fish but I spent an inordinate amount of time getting my popping bug untangled from the myrtle bush behind me. I also noticed a lack of dexterity when it came to making "the cast". I almost threw out my shoulder trying to emulate the fly fishers I'd watched on TV. While they made it look so easy, I spent most of my fishing time tripping over line wrapped around my ankles and getting a half-hitch

several years ago, I spent some time with Dick Leir, owner of Dakota Angler and Outfitter and as he drove me alongside the sparklingclear streams in the Black Hills, he talked about his favorite sport, fly fishing.

"Fly fishing can be frustrating, but once you get over the initial aggravation, it is a calming sport," Leir explained. "There is an evolution that takes place in the life of a fly fisher. At first, his goal is to catch 'a' fish. Once he accomplishes this, he wants to catch a 'lot' of fish. Then he progresses to wanting to catch a 'big' fish; then a 'lot of big' fish. He arrives as a genuine fly fisher when his consuming desire is to catch 'that' fish.

"Fly fishing is unique in that it is one of the few doit-yourself sports. Anglers get a lot of satisfaction from painstakingly building their own rods and becoming adept at tying their own flies. To catch 'that' fish on a rod you have built with a fly you have tied offers the utmost satisfaction," said Leir.

While on a turkey hunt- fishermen don't go to a catching fish to eat.

> "The object is not to catch 'supper'. Wild trout are much too valuable for that. A legendary fly fisherman, the late Lee Wulfe once said, 'a trout is too valuable a commodity to catch only

> While wild trout are the number one quarry of most fly fishers, practically any species of fish can be caught on a flyrod. We don't have trout in Louisiana, but there are other fish that can provide great sport for the flyrodder. Bedded bluegills, like I attempted to catch, bass and crappie are all amenable to being caught on fly tackle.

As advanced age has caught up with me, I have laid aside my fly rod and casting rod and settle for a seat in a comfortable chair on the bank of a pond with bedded bluegills swirling the water just off shore. Skewering on a cricket and lobbing it into the mass of bream, I'm as happy as a fly fisherman wading a clear mountain stream for trout.

Living the Christian life is like a continuous progression of breaking ground, sowing seed, applying fertilizer and water, cultivating and getting ready for the anticipated harvest. Can't Jesus could. He often used this analogy in his teaching. The Great Commission (Matt 28:18-20) directs us to "go, make disciples...plant the seed, cultivate and fertilize them...and the Spirit will bring about the harvest." In times of extreme struggle, man tends to look for someone to blame. We make great efforts to search out the negatives of our situation. Well, I'm here to


