Minden man arrested for drug possession and resisting arrest **STAFF REPORT**

Joseph Fullwood, 42, of the 700 block of Yale Street in Minden was arrested on multiple charges, including drug possession and resisting arrest, after an incident at a local Circle K. A Minden police officer on patrol observed Fullwood entering the store wearing work gloves and sunglasses. Upon exiting, Fullwood began dancing and yelling, prompting suspicion of an altered mental state possibly due to drug usage Fullwood proceeded to walk with the flow of traffic in violation of state statute, with the officer activating emergency lights and ordering him to stop. Despite verbal commands and attempts to stop him, Fullwood continued walking, dropping items including a baggie later found to contain 79 grams of methamphetamine. The officer pursued Fullwood, who attempted to flee. When the officer started to exit his vehicle, Fullwood collided with the officer's vehicle door and fell. Once Fullwood was identified, the officer recognized Fullwood as a person who Parole and Probation had recently been searching for. Fullwood was taken into custody without further incident. Besides the drug possession charge, he faces charges of possession of drug paraphernalia (including a metal spoon commonly associated with intravenous methamphetamine use), obstruction of justice, resisting an officer, and an existing warrant.

Even in his last act, he was looking out for others."

Minden neighbors arrested on drug charges

Minden neighbors Stephen Garland, 53, and Elizabeth Coker, 31, both residing in the 300 block of Garland Drive, were arrested on drug-related charges on April 11, following a routine patrol by Minden police officers in the area of Sheppard Street.

Sergeant Cayer initiated a traffic stop after observing a white GMC

operating on Envov Sheppard Street without a license plate. Upon making contact with the driver, identified as Elizabeth Coker, Cayer discovered that Coker was waiting for the title to come in for the vehicle. There was another passenger in the front seat and Stephen Garland, the rear passenger, also in the vehicle.

Upon checking all subjects for warrants, Sergeant Cayer instructed Officer Brown to have Coker step to the front of the patrol unit. Coker, initially hesitant, was asked to place her purse on the hood of the unit for a safety check. Inside the purse, suspected methamphetamine in a plastic wrap and a glass pipe with suspected methamphetamine residue were discovered. Coker was then taken into custody without incident.

Subsequently, Officer Brown had Garland step out of the vehicle, during which a glass pipe with suspected methamphetamine residue was discovered in plain sight on the seat where Garland had been sitting. Garland was also taken into custody without incident. A search of the vehicle revealed a backpack containing a small plastic container with suspected methamphetamine and various prescription pills.

Coker and Garland were transported to the Minden City Police Department. Coker was of a schedule II (meth), charged with possession of a schedule II (meth), possession of drug paraphernalia, and possession of legend drugs. The vehicle was towed for

Both suspects were transferred to the Bayou Dorcheat Correctional Center.

Minden woman arrested for shoplifting and forgery

A Minden woman, Sara Mireles, 25, was arrested on April 10 after allegedly shoplifting at Save-a-Lot. According to police reports, officers responded to a call from the store manager, who suspected Mireles of stealing items as well as trying to pay with a fraudulent check on April 8.

Upon arrival, officers found Mireles with a backpack containing \$10.34 worth of stolen goods and six loose Gabapentin pills. Mireles admitted to signing a check she attempted to use, claiming she got it from her grandmother in a Texas nursing home. However, the check was later found to be from an old closed account belonging to someone else, who denied knowing Mireles or authorizing the check.

Mireles was charged with theft and possession of a legend drug, both misdemeanors, for the April 10 incident. Additionally, she faces felony charges for forgery and bank fraud related to the April 8 incident. The owner of the check signed charges against Mireles for forgery.

Mireles, who also goes

by the alias Sara Marley, was taken into custody and transported to the Minden Police Department. The check and Gabapentin pills were secured as evidence.

On April 13, Dorcheat-Bistineau Chapter DAR and Claiborne Chapter DAR toured the restored Moreland House in Homer. The family home has been restored by Sara Mc-Daniel of Simply Southern Cottage, and Dr. John Moreland whose family has resided in the home since 1854. The renovation began two years ago, and is now almost complete. Moreland House has undergone many changes since it was originally built. It began as a dogtrot, a type of house with a long open hallway down the center and rooms on each side. This type of design circulates cool air through a house during the summertime. Later, the hallway was closed and a small front porch with a central dormer was added. The long front porch and additional dormers were added in the 1930s. During the recent renovation, a large beautiful sun porch was added to the back of the house to give additional space to the kitchen and dining room. The house is being furnished with items from the late 1800s as well as items original to the house. Sara McDan-

iel gave DAR members a guided tour of the house, and John Moreland gave a PowerPoint presentation about the history of the Moreland family who traveled from Georgia to Louisiana in the early 1850s. Several members of Dorcheat-Bistineau and Claiborne chapters are descendants of this Moreland family. More information about Moreland House and the Moreland family history can be found on the Simply Southern Cottage blog. Hostesses for this month's meeting were: Cindy Madden, Judy Reese, and Sue Kinsey, descendants of Joseph Benson Moreland and Mary Amanda Phillips.

She will talk to us about Gerstner's Field, a World War I pilot training field near Lake Charles. Maggie is a descendant of Revolutionary War patriot Robert Corey who was born in 1752 in Belfast, Ireland. Robert moved to Ninety-Six District in South Carolina, where he served as a Private in Col. Thomas Sumpter's Brigade. Thomas Sumpter was living a life of retirement until the British burned down his home. He immediately organized the local militiamen into an army. In the summer of 1780, Sumter's Brigade was the only organized opposition to the British in South Carolina.

Any woman age 18 years or older who can prove lineal, bloodline descent from an ancestor who aided in achieving American independence from Great Britain during the Revolutionary War (1775-1783) is eligible to join DAR. Police arrest Minden man on drug charges

Darien Mitchell, 48, was arrested on April 8 by Minden police on drug charges after a warrant was served at his home in the 400 block of Plateau Street.

During the search, officers discovered 34

grams of natural marijuana (schedule I), 12 grams of crack cocaine (schedule II), 66 ecstasy pills (schedule I), and 87 doxepin hydrochloride pills (legend drug), all individually packaged for sale. Additionally, \$100 in small bills and a digital scale commonly used in the practice of selling illegal narcotics were found in a locked room shared by Mitchell and Jessica Hunter, with Mitchell providing the key.

Both Mitchell and Hunter were questioned after being read their Miranda rights. Mitchell claimed possession of the crack and ecstasy. Subsequent testing confirmed the substances' identities. Mitchell was arrested and booked for possession with intent to distribute natural marijuana (schedule I), ecstasy (schedule I), crack cocaine (schedule II), and doxepin hvdrochloride (legend drug), as well as possession of drug paraphernalia.



Legally Perverse, Idiotic Issue of Squatters' 'Rights' Deserves Attention

The Biden chickens are coming home to roost. Crime committed by American squatters is bad enough but due to the Biden Border Invasion we are experiencing both an illegal alien and domestic crime problem with squatting due to disarming and defunding the police, no bail and other Democrat and Biden issues. It's difficult to believe there

is actually a need to give attention to an issue, property rights, that is so well-settled as a matter of law and American history. However, the problem has been occurring across the country for several years and is now doing so with even greater frequency.

"I found out that there is a law that says that if a house is not inhabited, we can seize it." (WSJ, March 27, 2024). Well, because of the Biden Border Invasion, "he's not wrong about his home-invasion scam. Squatters are moving into people's homes uninvited, and once in they can be almost impossible to

dislodge."

It's occurring across the country. ... in New York last week: When Adele Andaloro tried to rid the

ALEXANDER house she inherited from her parents of squatters by changing the locks, the cops led her away in handcuffs. The squatters could still make themselves at home." (WSJ, id.). WSJ further notes "in Georgia, Paul Callins found squatters had moved into his home and changed the locks while he was away caring for his sick wife. In Texas, Houston schoolteacher Amberlyn Prather and her fam-

ily used a fake lease to occupy a Houston home. In California, Flash Shelton retook his mother's house by moving in when the squatters were out-and

then claimed squatter's rights himself. Two squatters were arrested Friday in connection with the murder of Nadia Vitel after she confronted them in her late mother's Manhattan apartment this month."

Still further, Danielle Cruz, a Chicago homeowner, "states she is struggling to remove a squatter from her property because local police cannot remove the woman due to state laws. Cruz was hoping to sell the three-bedroom property, calling police when she discovered the squatter inside. When he (contractor) walked in to check out the roof, he realized there was a young woman who moved in all of her belongings, and she took over the home" Cruz stated. They could not remove her, the police said, because they couldn't prove that she was trespassing even though all of the locks on the home had been broken and changed." (Fox News, June 9, 2022).

The real problem is that in many parts of the country squatters are granted some form of ownership rights after 30 days. The police can't know for certain or immediately what the situation really is and if an individual claims to be a "tenant," a homeowner must undertake an eviction proceeding to have them removed from the home which may take weeks or

months.

Florida Governor Ron De-Santis said, "no more" and was one of the first in the country to sign a bill effectively ending squatters' rights in his state. "You are not going to be able to commandeer somebody's private property and expect to get away with it," DeSantis stated. (NBC 15 News, March 29, 2024).

As our Founding Father John Adams said, "property is surely a right of mankind as real as liberty itself"... because property rights afford Americans the ability to be free and autonomous and to enjoy 'life, liberty and the pursuit of happiness,' and to prosper in a just society governed by the rule of law.

Passing along something special

Dennis "Skinny" Hallmark passed something along to me that was special. So special in fact that what I learned on that visit to Alabama with him in 1992 ignited a passion I had never felt before or since. He guided me on my first turkey hunt and when I drew a bead on a gobbler and he dropped, I was hooked just as solidly as if I had mainlined a narcotic.

For the next 20-something years, hunting wild turkeys in spring was my passion and not only did I finally learn how to do it on my own, I have had special opportunities to pass along my love for the sport to several other rookies like I was that day in Alabama.

Sarah Hebert was the first. On opening day of turkey season for youth several years later, I was asked to do for Sarah what Skinny had done for me. In other words, I was her guide for a hunt on what was then the Jackson-Bienville wildlife management area. I was privileged to call in a gobbler for this young teenager and saw in her eyes the same fire I experienced when my Alabama gobbler bit the dust.

Still later after having several successful turkey seasons under my belt, my Ruston friend, Jody Backus, asked if I would accompany him to his property to see if I could guide him to success with gobblers that inhabited his land. He was successful in downing a big gobbler.

Each episode differs in the way it plays out. When I called the gobbler in for young Sarah Hebert, it same right off the roost to the decoy we had set out. The hunt ended quickly because soon after daylight, she was packing out her first longbeard. In Backus'

case, the weather was chilly and nasty and we were on the verge of giving up when at the last minute, a big longbeard decided to make Jody's day.

On two other occasions, I shared my know-how with a couple of other hunters who took what they had experienced when I guided them to call in and take gobblers on their own. I wasn't there when Carla Johnson and Ross Downer got their gobblers but their success was almost as gratifying as if I had been there.

Louisiana's turkey season opened this past Saturday and I found out about another situation in which one hunter guided another hunter, a novice, to take their first longbeard.

My nephew, Dan Dupree, lives on Clear Lake in Natchitoches Parish with his wife, Debbie and two offspring, daughter Rachel who will graduate from college this summer as a nurse and high school senior, Johnathan, who has been successful in killing a gobbler or two.

"I had located some turkeys on our hunting lease and had gone out and scouted to sort of get them located. When opening day came, I had planned to take my dad and guide him but he wasn't able to go," said Johnathan. "Rachel asked me if I would take her so rather than going out to chase gobblers on my own, I agreed."

Rachel had been successful on her deer stand having taken a nice 9 point buck this past deer season but had never tried turkey hunting. They got to the woods early and as it began to get daylight, the gobblers began waking up and long story short, Johnathon used his turkey calls to entice a big longbeard to Rachel's gun. She dropped the 21 pound bird with a 10 ¹/₂ inch beard at 30 yards with one shot from her 20 gauge Remington.


Her reaction? "I'm hooked; I think Johnathon has created something in me that I'm going to love" she said.

That's the way it is, one hunter helping another experience the thrill of something that means so much to the guide and ultimately to the novice hunter. In my case, my helping Sarah and Jody and Ross and Carla to getting their first gobblers was right up there in soul satisfaction equal to the day Skinny watched me jump up and down with excitement over my first.

That's the magic turkey hunting induces.
