
to put on a performance that will make Minden proud.



## **Tourism unveils** development plans for Miller Quarters Park at public forum

The Webster Parish Convention & Visitors Commission held two public forums on July 18 to present development plans for Miller Quarters Park and gather feedback from the community. Representatives from Parish Line Architects and CARBO Landscape Architecture provided a detailed slideshow illustrating the proposed areas and features of the project.

The projected costs for the park range from \$7

million to \$10 million, with plans to build the park in stages. Notably, Miller Quarters is owned and will be developed by the Commission, using funds from occupancy taxes collected from visitors. "This is a Tourism project. The funds that we used to purchase this project were funds that had been saved based on the revenue that occupancy taxes provide for our community," said Tourism Executive Director Serena Gray. "Occupancy taxes are taxes paid by visitors. It's visitors See, QUARTERS, Page 3

## Chief Judge John Michael Guidry announces his candidacy for the Louisiana Supreme Court

Chief Judge John Michael Guidry, a Democrat, announces his candidacy for election to the District 2 Seat on the Louisiana Supreme Court.

Chief Judge Guidry has served as an appellate court judge on the Louisiana First Circuit Court of Appeal for 26 years. On January 1, 2023, he made history when he became the 15th Chief Judge of the Louisiana First Circuit Court of Appeal and the first African American to hold that position in the more than 100-year history of the court.

Prior to his election to the appellate court, Chief Judge Guidry served as a member of the Louisiana House of Representatives and the Louisiana State Senate. Chief Judge Guidry is also a former commissioner on the Greater Baton Rouge Port Commission and the Greater Baton Rouge Metropolitan Airport Commission. He currently serves as an adjunct professor at the Southern University Law Center and formerly served

as an adjunct professor with the Nelson Mandela School of Public Policy on the Baton Rouge Campus of Southern University.

Chief Judge Guidry is a member of the Council of Chief Judges of the State Courts of Appeal (where he serves as Secretary/Treasurer and Chairman of the Finance Committee), the American and National Bar Associations, the Louisiana Judicial Council of the National Bar Association (where he sits on the Executive Committee), and the American Judges Association. He formerly served as the representative to the Louisiana Judicial Council for the Louisiana Conference of Court of Appeal Judges and was appointed twice by the Louisiana Supreme Court, on the recommendation of its Chief Justice, to serve on the governing body of the Louisiana Judicial College. He is also a member of the Louisiana Domestic Violence Judicial Curriculum Advisory Committee and a member of the Baton Rouge Bar Association Pro Bono Committee.

Chief Judge Guidry obtained his juris doctorate degree, graduating cum laude, from the Southern University Law Center in 1987. He is also a graduate of LSU, where he obtained a bachelor's degree in political science in 1983.

Chief Judge Guidry, 62, is married to the former Carol Fowler of Maringouin, Louisiana, with whom he has a son, John Morgan, and a daughter, Kennedy Michelle. He is

also an ordained deacon and the former Sunday School Superinten-



dent at Fairview Baptist Church in Baton Rouge.

## Gene Reynolds speaks on Wildlife and **Fisheries changes at Minden Lions Club**

Gene Reynolds, vicechair of the Louisiana Wildlife and Fisheries Commission, addressed the Minden Lions Club on July 18, discuss-

ing recent departmental changes. Reynolds, a Dubberly resident and former Louisiana House of Repre-

she's doing a really good job," he said.

Significant policy changes include adjusting the fishing distance for pogies, or menhaden, to half a mile from the coast for most of the state

and one mile in certain areas. This aligns Louisiana's regulations with other states. Additionally, new data showed declinour numbers are down." This change is part of a 25-year plan to recover the redfish population.

Other updates include a ban on flounder fishing from October 15 through November 30 during their major migration, moving the start of turkey season from the fourth Saturday in March to the first Saturday in April to accommodate nesting season, and a limited bear hunting season requested by the legislature. The bear season will allow hunting in a few parishes with only ten permits issued statewide through a lottery system. Regarding the Lake Bistineau drawdown, gates will be opened on July 29 and closed on November 15. Reynolds emphasized the importance of projecting and releasing these dates for property owner planning. The Minden Lions Club hosts engaging speakers every Thursday at noon at the American Legion Memorial Hall, located at 119 W. Pine Street in down-


Reynolds outlined the structure and responsibilities of the seven-member Commission, which includes industry representatives and at-large members. The Commission, which sets departmental policies, can be overruled by the legislature or governor.

Madison Sheahan, the new Department of Wildlife and Fisheries secretary, was praised by Reynolds for her intelligence and energy. "Very smart, very energetic, and I think

Redfish limits have also been revised to four per person, with a ban on keeping bull reds due to the harm caused by prolonged fights. Reynolds explained, "When you catch them, you fight them for about 45 minutes. After that, not many of them make it. That's your brood stock, those big females like that, and town Minden.

# **From NLTCC to Willis Knighton: Dustin Davis's inspiring journey**

Dustin Davis, a proud alumnus of Northwest Louisiana Technical Community College (NLTCC), has shown incredible resilience and determination in his journey from a career-ending injury to a successful position in Information Technology. Currently serving as a Computer Support Technician I at Willis Knighton North, Dustin has received two prestigious Gold Star awards for his outstanding performance within his first 6 months on the job.

In 2018, Dustin faced a life-changing injury at work that ended his career. With a background that included the United States Marine Corps, construction, oilfield work, and the steel industry, he had to rethink his future. "Once it was obvious that my body could no longer handle manual labor, I made a decision to get an education," Dustin recalls. This decision led him to NLTCC.

Despite undergoing three major surgeries and 14 months of rehabilitation, during which he spent 6 months learning to walk again, he enrolled in Information Technology at NLTCC. "I signed up for two classes-Operating Systems and

Work Readiness-and aced both with an A,' he shares. Encouraged by this success, he took on more courses, gaining hands-on experience through part-time IT jobs while still a student.

The skills and knowledge Dustin acquired at NLTCC were instrumental in his career advancement. He graduated with Academic Honors, a 4.0 GPA, and several IT certifications, all of which opened doors to new opportunities. "I landed a part-time IT gig and then a 90-day contract IT job with TEKsystems," he says. Though TEKsystems had a massive layoff, Dustin persevered and eventually found his current position.

In August 2023, Dustin applied for a position at Willis Knighton North. After multiple interviews and consistent followups, he finally secured the job at the beginning of 2024. His dedication and hard work were soon recognized with two Gold Star awards within a week. "I was awarded two Gold Stars in one week-mind you, some people have been there for 10-20 years and haven't even gotten one," he proudly notes.

Dustin's achievements have also brought him unique recognition. Despite his initial reluctance,



he accepted an invitation to have his photo featured on a billboard, becoming the first employee in Information Technology at Willis Knighton North to reach this level of recognition.

Reflecting on his journey, Dustin offers valuable advice to current students and recent graduates. "Find out exactly what interests you the most and pursue an entry-level position that caters to it. Be the difference, ask questions, and ignore the negativity," he advises. He also emphasizes the importance of continuous learning and preparation for certifications, urging students to remain driven and never get comfortable or complacent. "Stay hungry and never forget where you come from. I went from being a broken man who literally could not walk and was full of self-doubt to flourishing among my peers against all odds, and despite lacking support. Now, I am making history and being recognized across two cities by one of the most respected hospital systems."

who come into Webster Parish and stay at our hotels, motels, camp sites, and our short-term rentals. Those taxes are collected to help Tourism establish a marketing plan that encourages increased visitation to our community."

Beyond occupancy tax revenue, the Commission is exploring additional funding options, including grants and sponsorships. "For this to be a reality, it's going to take a joint effort between private funding and grants," said Com-mission Chairman Ty Pendergrass.

The project aims to be inclusive and community-driven, with plans to post architectural designs and feedback forms on the Tourism website. "We want to hear what you want to see. We want to be creative. We want to be inclusive. We want this to be a beautiful asset to our community," Gray added. Mayor Nick Cox emphasized that the project does not use city funds. "This is not the city's money or the city's project. This is Tourism, and any money they raise really has no reflection on the city's budget. That being said, this is good for the city in my opinion. My point is that elected officials, the press, and political commentators have driven the rage-filled rhetoric that Trump would "kill democracy" and "unleash death squads." Remember, Biden himself previously denounced Trump and his "MAGA" supporters as "enemies of the people." In fact, just this week Biden told a group of supporters on a phone call that he now needed to "put a bullseye" on Trump.

But now the Left tells us we need to "condemn political violence" in the U.S. That's rich!

We should thank God that we have been sent a warrior to save our nation, and Nov. 5 can't come soon enough for its safety and healing.





# An upclose look at nature in action

It's summer time; it's hot and outdoors activities are best confined to early and late in the day. It's proper to sit back under the cooling hum of the air conditioner and remember how special the outdoors can be and to be reminded of events of the past thatmade impressions of me.

I remember once when visiting my hunting club in later summer, I experienced something that was news to me. I was privileged to see two wild turkeys take to the air from the back side of the goat weed patch, climb nearly a hundred feet high to sail over the tops of the pines at the edge of the field. Turkeys are not known as strong fliers and I had no idea they could fly that high with such ease.

The most fascinating thing I saw, though, was right here in my own back yard. Living in the country working from my home office, I'm often privy to nature doing what nature does. I'll hear a commotion outside the window and it'll be two hummingbirds undergoing a kamakazi attack on each other. Something scratches on the side of the house, I'll go out and a squirrel will scurry away. Looking across the pasture when I walk out for the morning paper, I'll frequently see a red-coated doe browsing along pasture's edge.

Recently, I saw something that at first baffled me. My interest was piqued when I noticed a mound of sand pushed up against the concrete slab of the back porch from under the ajuga plants growing there. I assumed it was the mole that has given us fits this summer. I was about to fetch the mole trap when a creature crawled out of a hole in the middle of the sand

pile and flew away.

It was the biggest wasp I'd ever seen. It looked like a hornet on steroids. Colored yellow and black somewhat like a yellow jacket or guinea wasp, the creature was a good two inches long. I was baffled and I'll admit, a bit shaken. What if a colony of super-sized hornets or yellow jackets had chosen this site for their home? I could forget about relaxing on the porch under the ceiling fan. I live too far from the emergency room to enjoy that privilege.

When I spotted a cicada lying in the sand next to the wasp's entry hole in the sand, a light bulb came on in my head. I had read an article sometime ago about cicada killer wasps that inhabit our area.

A trip to cyberspace revealed that the creature

which had troubled me was indeed a cicada killer. Photos accompanying the articles I read confirmed it. Here's what I learned from a University of Kentucky website about these interesting bugs.

"Also known as sand hornets, these wasps attract attention due to their large size, the burrows that they dig in home lawns, and their buzzing flights over the lawn. These insects occur in all states east of the Rocky Mountains and prefer to dig their burrows in sandy, bare, well drained soil exposed to full sunlight. The wasps feed on flower nectar while the immature or larval stage feeds primarily upon cicadas that are brought to the burrow by the adult.

"In spite of their large size, the wasps usually ig-

nore people but they can give a painful sting if bothered. Mating males are aggressive and more easily disturbed."

According to the article, the females search tree trunks and lower limbs for cicadas. The wasp stings its prey, turns the victim on its back, straddles it, and drags it or glides with it to the burrow. Each cell is furnished with at least one cicada (sometimes two or three) and a single egg before being sealed off. Two to 3 days later the egg hatches. Depending on the number of cicadas in its cell, the larva feeds for 4 to 10 days until only the cicada's outer shell remains.

And I thought a highflying wild turkey was going to be the highlight of my week!

LAKE CLAI-BORNE – Bass fishing is best at night fishing

soft plastics and dark spinners and crank baits. Some have been caught early mornings on topwater lures. Crappie have moved deep and are best around submerged brush on shiners and jigs. Better fishing has been late afternoons. Bream are fair around shallow bedding areas and hitting worms and crickets. No report on stripers or catfish. For latest information, call Kel's Cove at 927-2264 or Terzia Tackle at 278-4498.

CANEY LAKE -Bass fishing has been good at night on oversized plastic worms and deep diving crank baits with some big fish reportedly caught. During the day, deep diving crank baits and soft plastics fished on underwater humps is producing. Bream fishing is beginning to slow down as the weather and water temperatures are heating up. # SUMMER STEPS TO A STUNNING FALL GARDEN



Summer is the best time to just sit back and enjoy your garden. While you're at it, you can start thinking about fall gardening and planning bigger landscaping projects.

You still need to keep up with watering, occasional fertilizing and weed control (mostly mechanically because chemicals shouldn't be used in the heat of summer on turfgrass, although they can be used in flowerbeds). But it is best not to take on any extensive landscape updates in the next couple of months. Phew! You're off the hook.

But if you're itching to make improvements to your landscape, know that it's probably best to hold off until cooler days. In general, planting trees and shrubs during the heat of the summer is not recommended. This is not to say that if you do plant in the summertime your plant will definitely



Planting in containers is a fine idea any time of year, making it a great way to continue gardening year-round. You will need to water and fertilize container plants more frequently in the summertime. Plants cannot cool themselves in the absence of water and will wilt quickly, as plants transpire to cool themselves just like we sweat. As you water more frequently, you will also flush out more nutrients from the pots as they drain. Use a general-purpose liquid fertilizer every seven to 14 days to help plants along.

Tropical plants do well this time of year too. Right now, you can enjoy those flowering tropicals such as hibiscus, gingers, angel's trumpet, cannas, Turk's cap, mandevilla, bougainvillea, coral vine, allamanda, passionflower, giant bird of paradise, esperanza, firecracker plant and hummingbird bush. If you don't have some of these already, add them to your list and plant them in late September to enjoy next summer.

Existing turfgrass thrives in the summer, demanding frequent cuts with the lawnmower. Laying fresh sod in the summer, though, is a tough call. On one hand, the heat is very stressful on new turf with shallow root systems. However, roots will have more time to become established before they go dormant from November to February in Louisiana.

If you install a new lawn in the summertime, be sure it is watered thoroughly. Keep foot traffic off the sod for one week and water every day in the morning. With the heat, lots of water will be lost to evaporation, causing stress. Avoid watering at night, as the sod will remain wet, encouraging fungal diseases. St. Augustinegrass in particular is extremely susceptible to fungal diseases such as large patch and gray leaf spot. You can cut back on the watering after the first week and move to an every-other-day approach. By week three, you can water twice a week.

you can begin planning your fall garden. Now is the time to start ordering vegetable seeds. These will be our cool-season crops such as broccoli, Brussels sprouts, cauliflower, Chinese cabbage, cabbage, kale, lettuce, mustard greens and root crops such as carrots, beets and radishes. You can plant the transplants as early as mid-August, but our state vegetable specialist suggests waiting until mid-September.

In the meantime, you can still transplant tomatoes and bell peppers for a fall crop. And keep the eggplants and okra going. They should be really producing by now.


