# **Narcotics raid leads to multiple arrests** in Minden

In a coordinated effort, the Minden Police Department, along with the Marshal's Office, the Webster Parish Sheriff's Office, and the Bienville Sheriff's Office, conducted a narcotics raid on four homes in Minden and early on August 22. Warrants were served on two residences in the 500 block of Marshall Street, one in the 600 block of Constable Street, and one in the 100 block of Timothy Drive. The raid also targeted individuals with outstanding arrest warrants, including Justin Bailey and Demarcus Willis.

Constable Street Raid

At approximately 6:30 AM, officers executed a search warrant in the 600 block of Constable Street. In the rear of the property, an RV housed four occupants: Jeremy Clark, Darien Moore, Teri Nutt, and Melanie Lope. Inside the RV, officers discovered 0.543 grams of methamphetamine and 2.6 grams of synthetic marijuana on a small couch. Á cigarillo package containing an unbroken meth pipe was found next to the drugs.

The RV's occupants offered conflicting accounts regarding the ownership of the drugs. According to Lope and



Nutt, the methamphetamine belonged to Moore, while Clark claimed it belonged to Lope and Nutt. The small, confined space inside the RV placed all four individuals within arm's reach of the drugs, and it is believed that they were using the substances just before the raid.

Clark was found with a cut-off plastic straw in his pants pocket. All four were charged with possession of methamphetamine, possession of synthetic marijuana. and possession of drug paraphernalia. They were transported to the Minden Police Department, advised of their rights per Miranda, and



booked before being placed in holding cells awaiting transfer to Bayou Dorcheat Correctional Center (BDCC).

**Timothy Drive Arrest** At around 7:30 AM, officers proceeded to the 100 block of Timothy Drive to serve methamphetamine distribution warrants on Justin Bailey, 35. Bailey was locat-

#### Minden man arrested for violating protective order, facing multiple charges **STAFF REPORT** Minden Press-Herald

A Minden man was arrested after allegedly forcing his way into a residence in violation of a protective order, according to police reports. The incident occurred on August 20 at a home in the 100 block of Sterling Street.

Officers were dispatched to the residence following a 911 open-line call. Upon arrival, they made contact with the resident, who initially indicated that everything was fine. However, the resident, identified as a woman with an active protective order against her ex-boyfriend, later revealed that the man, Cedrick Carr, was still inside the house.

Additional officers arrived at the scene and, after being informed that Carr did not possess any firearms, they entered the residence. Carr, 33, was found in a back bedroom with two children. He was detained and advised of his rights.

# **Glenbrook coach highlights relationship-driven approach** at Lions Club meeting

Reagan Smith, head coach of the Glenbrook Apaches football team, spoke at the Lions Club meeting on August 22, emphasizing his relationship-focused coaching style. Smith, who has previously coached at West Monroe High School and Evangel High School, shared his commitment to being the type of coach he wished he had in school.

"I want to be someone who will take time to talk to every player, no matter their athletic abilities," Smith said. "I want to motivate through praise as often as I can. I want to

teach players fundamentals, skills, and strategies that they find intelligent."


Despite losing several first-string players to graduation last year, Smith expressed pride in the upcoming team. The Glenbrook Apaches have 40 varsity players and a total of 70 players across grades 7-12, including 16 returning seniors.

"This is the strongest team I've ever coached," Smith said. He added that his daily focus is on improvement, urging his players to identify and work on the three most pressing areas for growth.

Smith also discussed his emphasis on weight training, nutrition, and sleep to build stronger players. "The one thing that you can affect more dramatically in a football program than anything else is the level of strength in your team," he noted.

Smith believes in the power of motivation through understanding. "The why is motivation," he explained. "If I tell them why to make that block, they become a little more motivated. If I teach them how to make that block, they're a little more empowered. Then I have an empowered, motivated player."

Looking ahead to the upcoming football season, Smith is confident in his team's preparation, stating, "This year's Glen-

## Witness intimidated at Minden Medical Center, suspect charged

A Minden resident was charged with intimidating a witness following an incident at Minden Medical Center on August 14. The charges stemmed from a series of threats made toward a witness who had been involved in assisting at a local accident scene earlier that day.

According to a report filed by the Minden Police Department, the witness, who had arrived at the scene of a wreck at approximately 5:07 PM to render medical aid, observed a physical altercation between two parties, one of whom was identi-

After providing a written statement about the altercation, the witness later visited the emergency room at Minden Medical Center to check on the injured party.

While at the hospital, the witness encountered the same individual involved in the earlier altercation. The suspect, upon recognizing the witness, made several aggressive remarks questioning her presence at the hospital and her involvement at the accident scene. The situation escalated when the suspect demanded the witness's personal information, leading the witness to fear for her

fied as a 20-year-old male. safety.

> To ensure her safety, the witness requested assistance from hospital staff and was escorted out of the building. As she was being escorted, the suspect shouted a threatening remark at her. The incident was captured on body camera footage and corroborated by a written witness statement.

The suspect has been charged with intimidating a witness and is currently facing legal proceedings. The Minden Police Department is continuing its investigation into the matter.

All subjects are considered innocent until proven guilty in a court of law.

# Louisiana starts process to reorganize state's transportation agency

(The Center Square) — Louisiana lawmakers and Gov. Jeff Landry say the Louisiana Department of Transportation and Development is not completing transportation projects efficiently and a restructure could be in the offing.

Landry issued an executive order in May calling for a complete restructuring of the department and the Joint Committee on Transportation, Highways and Public Works met this week to discuss the possibility.

Louisiana hired an outside consulting firm to assist with the reorganization plan, Boston Consulting Group, which handles business strategies globally in many different markets for both the public and private sectors. The firm is involved 3,000 transportation and infrastructure projects, according to their website. The consulting firm met with the committee Monday to discuss their progress in improving efficiency and quality of work at the DOTD.

Mel Wolfgang, the senior partner with Boston Consulting, says so far they're still analyzing the current internal systems to see how they can be improved. Along with that, they are also comparing the Louisiana DOTD practices to other states.

This includes interviews with the staff and industry groups like construction along with the Legislature. The firm is analyzing data to create proper benchmarks that the department might not meet at present.

The group expects to present a roadmap to the DOTD based on those assessments by the end of September. The governor mandated in his executive order that the Secretary of DOTD to submit a feasibility report based on the recommendations from the consulting group.

Sen. Patrick McMath. R-Saint Tammany, felt that beyond project efficiency and productivity, the department could also reduce specialization among its employees.

"Employment flexibility based on performance is important," McMath said regarding the number of administrators in the department.

Sen. Gary Carter, D-Jefferson, felt employment flexibility will also help lawmakers correctly appropriate monies.

"We've taken many steps in the Legislature the last several years, I believe, to try to make certain the Department of Transportation and Development was spending its money on actual projects as opposed to administration," Carter said.

Lawmakers asked the group what they have done other states and its effectiveness. Although Wolfgang said they can't get into details due to confidentiality agreements, he said he believe there are some areas in need of improvement. the protective order, which prohibits Carr from being within 100 yards of her or her residence. The order was issued on August 16 and remains in effect until October 25.

According to the resident, Carr was waiting in the backyard when she arrived home with her children. As she attempted to secure the front door, Carr allegedly forced his way inside, pushed her, and took her phone when she tried to call 911. The resident managed to make a second call to emergency services, but Carr reportedly regained

#### Louisiana lawmakers receive update on state's federally-funded broadband program

(The Center Square) — Broadband expansion into rural areas of Louisiana is a major priority for the state House Commerce Committee.

During the committee's meeting on Monday, the Louisiana office of broadband development and connectivity, or Connect-LA, discussed Granting Unserved Municipalities Broadband Opportunities 1.0 and 2.0. Both are grant programs intended to improve internet connection for the underserved and unserved statewide.

Veneeth Iyengar, the executive director of ConnectLA, said Gumbo 1.0 was a federal grant of \$176 million. The office must spend those funds by December 2026 in order to receive the full amount.

The majority of the funds have already been dispersed for projects, with \$131 million appropriated. Last time the committee met in March, nearly 58% of those projects were in construction or complete. As of Monday's meeting, that number shot up to 88%.

Iyengar said a map on ConnectLA's website shows customers exactly where those projects are happening.

ConnectLA is now on the verge of a new grant program called GUMBO 2.0, which at full usage would be worth \$1.355 billion. Iyengar said in order to fully take advantage, the U.S. Department of Commerce requires the money be assigned to a service provider for broadband infrastructure by the end of the year.

As in any GUMBO 2.0, steps were taken to improve on the first grant program. For example, in GUMBO 1.0 ConnectLA allowed internet service providers define project areas or zones that lack high speed internet service. That led to some rural areas missing out on the grants.

In GUMBO 2.0, the of-

fice made its own map of project areas so they can ensure there are no "donut holes," as Iyengar called them.

He says they are still having conversations on how many project areas exist in the state, but so far they have found broadband-serviceable locations in every single parish, with around 141,000 total specific addresses. About 100,000 of those are households, 35,000 are businesses, and the rest are public service establishments like schools, fire stations, libraries and other government build-

Iyengar also specified

that in the event service providers don't bid on an area due to cost, his office has the authority to go and talk to companies and ask them what they need to encourage a bid on the area.

"Frankly, look there are project areas which might have just two locations, two addresses, where the cost of building fiber is gonna be \$60,000," Iyengar said. "And so in some of those cases, if there's not a taker, then we'll ensure that we find a solution for those folks."

A new map for GUMBO 2.0 showing what provider is serving each location should be up by mid November, and public comment on the matter will begin around the same time.

Legislators on the committee commended Iyengar and ConnectLA, saying their work has made Louisiana a leader in improving internet infrastructure.

"Louisiana is number one in the country when it comes to our broadband deployment. We're ahead of the other states," said Rep. Daryl Deshotel, R-St. Landry.

I have never been able to make sense of the details of the assassination attempt of President Donald Trump.



# Participation in high school sports tops 8 million for first time in 2023-24

INDIANAPOLIS — More than eight million participants competed in high school sports in the 2023-24 school year – an all-time record and the first time ever that total participation has exceeded the eight-million mark.

The NFHS High School Athletics Participation Survey indicated that 8,062,302 participants were involved in high school sports in 2023-24, which is up 210,469 from the previous year and tops the previous record of 7,980,886 set in 2017-18. The total includes 4,638,785 boys and 3,423,517 girls - both record highs - according to figures obtained from the 51 NFHS member state associations, which includes the District of Columbia.

The 2023-24 total marked the second consecutive increase after numbers tumbled during the pandemic. Since the initial survey after the pandemic, participation in high school sports has increased 444,248 in two years and represents a turnaround from the decline that started the year before the COVID-19 pandemic.

"We are thrilled to learn that participation in high school sports has exceeded eight million for the first time," said Dr. Karissa Niehoff, CEO of the NFHS.

"The comeback from the pause of school sports during the pandemic has been so gratifying and certainly indicates the staying power of education-based sports in our nation's schools. We salute coaches, athletic directors and other school administrators for making these experiences happen for stu-

dent-athletes."

compared to 20,875 the previous year – a 105 percent increase. And from the 15,716 participants in 2021-22, there has been an increase of 173 percent. There also was an increase in the number of girls competing on 11-player football teams from 3,654 to 4,094.

Including boys and girls competitors in 6-, 8-, 9- and 11-player football, and girls and boys participants in flag football, the overall football total for 2023-24 was 1,118,705 – an increase of 28,825 from 2022-23.

Another highlight is the sizeable jump in wrestling – boys and girls – for the second consecutive year. An additional 32,443 boys were involved in wrestling last year, jumping from 259,431 to 291,874. Since the 2021-22 season, there has been a gain of 60,000 in boys wrestling – an amazing 25 percent increase. And participation on girls teams has continued its historic rise as well with 64,257 participants last year – an increase of 102 percent from the 31,654 in 2021-22.

Outdoor track and field, volleyball and soccer all registered increases and remained the top three participatory sports for girls. Track and field increased four percent to 506,015, followed by volleyball at 479,125 and soccer at 383,895. Although the number of participants was down about 6,000, basketball (367,284) re-mained in the No. 4 spot followed by fast-pitch softball (345,451), tennis (195,766), cross country (192,989), competitive spirit (181,023 – up 20 percent), swimming and diving (138,174) and lacrosse (101,204).

Outdoor track and field. and soccer had significant gains on the boys side as well. After 11-player football and outdoor track and field (625,333), the rest of the boys top 10 includes basketball (536,668), baseball (471,701), soccer (467,483), wrestling (291,874), cross coun-(239,381), tennis trv (157,835), golf (155,174) and swimming and diving (116,799). The number of participants in Esports and Unified Sports also registered increases in 2023-24. A total of 27,051 students participated in Esports last year, which included 23,041 boys and 4,010 girls - an increase of 3,129 participants from the previous year. The survey indicated a total of 51,502 participants in the 15 Unified Sports, up from 42,010 in 2022-23.

New Grambling State Head Coach Mickey Joseph makes his debut Saturday when the Tigers visit Louisiana.

Louisiana Tech opens its third season under Head Coach Sonny Cumbie Saturday at home against Nicholls.

LSU faces USC in a battle of nationally-ranked teams Sunday at Allegiant Stadium in Las Vegas.

Louisiana Tech is coming off its second straight 3-9 season under Cumbie. Nicholls, a member of the Southland Conference, went 6-5 last season.

Tim Rebowe enters his 10th season as head coach at Nicholls. The Colonels have eight starters returning on offense and nine on

Grambling State is coming off a 5-7 season. Louisiana went 6-7 last season.

This is the first meeting between the teams since 2018 when the Ragin' Cajuns won 49-17.

Louisiana placed two players on the preseason All-Sun Belt first team — offensive lineman AJ Gillie and return specialist Zylan Perry. Defensive lineman Jordan Lawson made the second team.

Grambling State quarterback Myles Crawley is on several watch lists for FCS Offensive Player of the Year.

Northwestern State is coming off an o-6 season. It was canceled after six games in the wake of an off-campus shooting that took the life of junior safety Ronnie Caldwell.

Tulsa, a member of the American Athletic Conference, went 4-8 in 2023, Kevin Wilson's first season as head coach.

Tulsa running back Anthony Watkins was named to Athlon Sports preseason All-Conference first team. He rushed for 889 yards on 197 carries and scored four

LSU went 10-3 last season in Brian Kelly's second year as head coach. Garrett

touchdowns last season.

Nussmeier has replaced Heisman Trophy winner Jayden Daniels at quarterback.

The Tigers were ranked No. 12 in the preseason coaches' poll and No. 13 in the AP Top 25. USC was ranked No. 23 in both.

USC Head Coach Lincoln Riley announced last week that Miller Moss will be the starter at quarterback. He was 2022 Heisman winner Caleb Williams' backup for two seasons.

ULM is coming of a 2-10 season. The Warhawks will go into their opener with a 10-game losing streak.

Vincent announced las week that redshirt junior General Booty will be the starting quarterback.

Booty is the son of former Evangel Christian and LSU receiver Abram Booty and the nephew of former Evangel and LSU quarterback Josh Booty. His grandfather is former Woodlawn star quarterback Johnny Booty.

Jackson State went 7-4 last season in Head Coach T.C. Taylor's first season. Two of the biggest storylines are the increases in all forms of high school football – boys and girls – and the continued rise in both girls and boys wrestling.

Eleven-player football remained the most popular boys sport and registered an increase for the second consecutive year from 1,028,761 to 1,031,508. There also was an increase in 8-player football participation from 23,812 to 26,420.

The biggest gains in football, however, came on the girls side, particularly with the emerging sport of flag football. The number of participants in girls flag football more than doubled from 2022-23 to 2023-24. A total of 42,955 girls participated in flag football in 2023-24

# Setting fire to your woods works if done right

Let's say you have a 40-acre tract of forested property and you want your land to be more attractive to deer, turkeys and other wildlife. What can you do to make that happen?

Burn it. Say what? You've nurtured this tract for a long time so why would you want to set fire to it? On the surface, that doesn't sound like it makes any sense but when done properly and under the guidance of people who know what they're doing it's maybe the best tool at your disposal to convert a standing tract of timber into something that attracts wildlife.

Jesse Davis is President of the Piney Hills Prescribed Burn Association (PBA) and this organization stays busy helping property owners improve their habitat by utilizing a prescribed, or controlled, burn.

When done properly," said Davis, "prescribed fire is the cheapest and most effective way to improve your habitat. Removing undesirable brush and ground litter exposes grasses and forbs and seeds that would otherwise never sprout. A prescribed fire removes things that wildlife never eat."

When fire goes through a piece of property, how long does it take before wildlife can began using it?

"We've seen wild turkeys come to a fresh burn before the smoke even clears. They start finding things like acorns that be-

come exposed when the brush and duff is removed, Davis added.

When a fire goes through such areas, he noted that lots of native seeds and grasses that have laid dormant begin sprouting once sunlight begins to penetrate the forest floor. When desirable things begin to replace those that wildlife won't eat, deer and turkeys are quickly attracted to the area.

When is a good time to run a controlled fire through a piece of property?

"Almost anytime is a good time but especially after a timber thinning or any time like after a storm causes damages that ground becomes exposed to sunlight," Davis said.

What are some precautions that must be taken into account before planning a prescribed burn?

"The first thing that must be done is to have adequate fire breaks that will stop fire from going where you don't want it to go. Wind direction and velocity is also important. It is also important to consider neighboring property and which direction smoke will travel. You especially don't want to send smoke over neighbors, especially those with health problems," Davis added.

Other than deer and turkeys, do other species of wildlife benefit from a prescribed burn?

"There are no wild creatures that won't benefit from a prescribed burn. Birds and squirrels benefit as often, den trees are left for nesting as well as having foods they prefer begin growing," said Davis.

Are you interested in learning more about prescribed burning on your property and if it might benefit you? There is a meeting scheduled for September 12 at 6:00 at the Lincoln Parish

Sheriff's Office where anyone interested in this method of property management is invited to attend.

"We invite anyone who has an interest in what prescribed burning is all about," Davis said, "and we want more people to realize just what a controlled fire can do to enhance what you already have.'



sistent oven heat, changes in barometric pressure, or even faults in your ingredients. The situations in our lives can be viewed similarly. We as humans often go



# **CONSIDER USING** ORNAMENTAL **GRASSES IN YOUR** LANDSCAPE

some people the word "grass" L means a pretty lawn that ties together the plants in a landscape and makes the home the focal point of it all. To others it reminds them of a highly manicured green on which they play golf. But there are other types of grasses that serve another purpose which is to add some different textures to a landscape. These grasses also are attractive in their own right plus they introduce different colors, different forms and most will move in the wind thus providing a new element to the landscape. Some even have flowers.

Not too many of the ornamental grasses are evergreen and most are actually perennials which reveal their beauty during the growing season. But being a perennial you don't have to plant them but one time. And they give a different color as they move into the winter months. Some people don't like the tans and browns of their winter foliage and cut them back. And most have to be cut back in the break between winter and summer. When doing this, make the cuts above any emerging fo-liage to save the spring and summer beauty.

Most of the ornamental grasses require little attention and usually will survive in harsh environments with little watering. However, they may perform somewhat better if they receive an occasional rain or



some supplemental water is provided. Large and dense species are good screening plants that can block undesirable views. Depending on what you need you can get ornamental grasses that range in size from less than a foot to up to 15 feet. Some species have addi-tional qualities to offer such as fountain-like or rounded forms and eye-catching colors. But the most unique quality of many is their motion in the wind. Few other plants can duplicate this quality.

Still another feather that most gardeners and homeowners like about ornamental grasses is their ease of maintenance. They 're relatively disease free nor do most insects like them

while a few will adapt to somewhat heavier shade.

When planting ornamental grasses in existing beds, little improvement to the soil is needed. Planting is also easy. Just plant at the same level your clump of grass was growing in its container and water heavily. They can also be planted in the heat of summer... successfully.

Since most ornamental grasses do not form runners like Bermuda grass, but rather develop clumps they do not become a problem invader. The clumps just continue to get larger and when too big can be divided.



which translates into less spraying for pest control. Once established, little fertilization is needed. Another feather that most homeowners like is that they tend to be very adaptive. Thus, it's usually no problem to find one that is tolerant of full or part sun. Some can even handle a little shade
