Webster The Parish Police Jury Office of Homeland Security and Emergency Preparedness is organizing a Disaster Preparedness Event on September 6 at the Community Activities Center Building, 301 W. Church Street in Springhill, from 9:00 AM to 11:00 AM.

The event will provide the public with an opportunity to learn how to prepare for various types of emergencies. Representatives from several agencies, including the

Emergency Preparedness, the Governor's Office of Homeland Security and **Emergency Preparedness** (GOHSEP), the Louisiana Attorney General's Office, National Weather Service Shreveport, Pafford EMS, Springhill Fire Department, Springhill Medical Center, Springhill Police Department, Webster Parish Sheriff's Office. and Webster Parish 9-1-1, will be present to offer guidance and answer questions.

Topics to be covered include disaster preparedness for floods and tor-

safety and the importance of smoke detectors, key information for dialing 9-1-1, and how to properly mark residences or businesses to assist emergency responders.

A 27-year-old woman was arrested on August 9 after a disturbance involving a baseball bat led to charges of criminal trespass. Officers were dispatched at approximately 9 AM to the area of W R Reeder and Crichton Hill following reports of gunshots.

Upon arrival, officers made contact with one group at a residence on Crichton Hill, who informed them that another group had moved down the street. Officers proceeded to the 600 block of

encountered three people.

The individuals reported that T Neshia Malone had approached their residence attempting to instigate a fight with one of them. Malone allegedly threatened the teenager by striking a stop sign at the intersection of Crichton Hill and Morrow Street with a black and blue baseball bat. Witnesses stated that Malone entered their yard, stood in their driveway, and assumed a fighting stance. According to a resident, Malone had previously been trespassed from the property by a Minden police officer.

The teen declined to press charges for the simple assault.

Officers then contacted Malone at a residence on Crichton Hill. She admitted to going to the Morrow Street address with a baseball bat but denied swinging it at anyone. Malone also confirmed on body camera footage that she had been trespassed from the residence.

Malone was arrested for criminal trespass and transported her to the Minden Police Department for booking.

A Minden man was charged with domestic abuse with strangulation and false imprisonment following a violent altercation with his girlfriend in the early hours of August 30.

He was inducted into the Ohio Civil Rights Hall of Fame and the Dayton Historical Wright Brothers' Walk of Fame. Also known as "Mr. Dayton Civil Rights," he has been honored by many local, regional, and state organizations for his servitude and leadership. Mr. Gooding is an active life member of Omega Psi Phi Fraternity, Inc. He has even worked on the U.S. Supreme Courts' Commission on Racial Equality; and he still drives himself around Dayton, Ohio! Mr. Gooding's life has been one of local and national service. As Mr. Gooding so eloquently stated, "I did not fight to get honors, recognition or awards, I fought because there was a need!" Minden woman arrested on aggravated assault and weapons charges

A Minden woman was arrested Friday on charges of aggravated assault with a firearm and illegal use of a weapon following a domestic dispute.

Chameteria Jones, 40, turned herself in to the Minden City Police Department after an active 911 call reported her involvement in an altercation in the 100 block of N. Talton Street. Dispatch had earlier advised officers that Jones had fired a gun into the air during the incident.

According to the victim, the argument escalated when Jones brandished a knife and threatened to cause bodily harm. The situation intensified when Jones armed herself with a firearm, made additional threats, and fired a shot into the air. The victim reported to both dispatch and responding officers that he feared for his life.

Upon Jones' arrival at the police department, a gunshot residue test was conducted on her hands, which came back positive. Investigators at the scene recovered a 9mm shell casing and a knife, which was found in Jones' vehicle.

Post-Miranda, Jones admitted to engaging in a verbal argument with the victim, which escalated to her arming herself with a knife and then a firearm. Jones claimed she acted in self-defense. The dispute reportedly began over a grill.

Jones was subsequently charged with aggravated assault with a firearm and illegal use of a weapon, both felony offenses.

Prevents 'The Tyranny of the Majority



being given to the presidential election itself, it is easy to overlook another critical factor that will be determined in the election: the filibuster. Let's refresh our recollection. What is the filibuster and how is it utilized in the U.S. Senate?

The U.S. Senate website defines the filibuster and its close companion-the invoking of "cloture" (i.e., to close)—in this way:"The Senate tradition of unlimited debate has allowed for the use of the filibuster, a loosely defined term for action designed to prolong debate and delay or prevent a vote on a bill, resolution, amendment, or other debatable question ... In 1975 the Senate decided that 60 members of the 100-member Senate must vote to invoke cloture and end a filibuster." As a result, once a filibuster is begun the individual engaged in the filibuster may continue until 60 senators vote to end the filibuster or the individual literally collapses on the Senate floor from exhaustion.Why is maintaining the 60-vote requirement to end a filibuster so important? Well, while the filibuster is not a literal part of the Constitution it is a longstanding and wellsettled tradition that directly reflects what the Framers intended for the Senate to

have. After all, the U.S. Senate, which was viewed by the Framers as existing to check the heated and overwrought passions of the U.S. House, was de-

prevail. In fact, the analogy is that the U.S. House, as the body closest to the people, serves as the hot "cup" of rash and emotional legislative action and the U.S. Senate was viewed as the "saucer" onto which it spilled and cooled. This is also why the term of office of a member of the U.S. House is two years and the smaller, and, theoretically, more rational and steadier Senate, is 6 years.So why are Democrats swearing to abolish the 60-vote requirement to end a filibuster if Kamala Harris becomes president and they hold their majority? Because they want to push through their Left-wing agenda with a bare majority vote. In fact, Democrats in the Senate won't even need a majority of 51 Senators to abol-

With so much attention be, and the role it was to ish the filibuster in a Harris presidency. They would only need 50 Senators plus a Democrat Vice President breaking the tie.What are some of the dangerous and radical steps Senate Democrats could then take in this scenario?Senate Majority Leader Chuck Schumer has made clear that eliminating the 60-vote filibuster in a Kamala Harris presidency is a certainty and what would follow is alarming: a strong push for a national abortion law, a federal election law (s) to protect "voting rights" that would take over most elections and make it much more difficult for states to conduct elections, including a blizzard of absentee ballots of the kind we saw during Covid, and the election fraud that would follow. Imagine the fundamental restructuring of the U.S. Supreme Court with "court packing" and other procedural changes that don't require a constitutional amendment that would turn the Court into a third legislative body rather than the impartial, independent arbiter of law the Framers intended. Imagine banning state rightto-work laws, to say nothing of massive new tax increases Schumand regulation. er has also made clear he doesn't have a problem with price controls for food-an historically. demonstrably

bad idea—or price controls for drugs, and massive funding of the irrational doomsday Climate Change scenario.With the 60-vote filibuster eliminated, the entire Socialist agenda becomes not just possible, but likely. It is simply unwise and reckless to allow huge and sweeping changes of policy to be based on a slim, partisan majority of Senators. If we are going to Medicare for All and are going to abolish private health insurance; or, if we are going to tax unrealized capital gains (a tax on money we haven't even pocketed yet)—then at least 10 Senators from the opposition party should be in support of it. I recall Thomas Jefferson's vital governmental principle that "great innovations should not be forced on slender majorities."With four more years of destructive economic, foreign, and social policy, the America we know and love would be unrecognizable-and unrecoverable. Doctor Seuss said, "never tease a weasel"

Dr. Seuss wrote "We should never tease a weasel, not even once or twice, because teasing isn't very nice!"

According to the American Society for the Positive Care of Children, 28 percent of students between the age of 12-18, report being bullied in school.

Bullying has been and probably always will be on the school yard and sometimes in the work place.

Having been bullied as a child, along with my sister, Myrtle Alice, was very painful. Even though we survived, being taunted as a child is an experience that some children can't take.

We were teased because we were shy and born to very poor older parents in the backwoods of Arkansas. We dressed in an old fashioned way.

We rode to town in a horsedrawn wagon.

I was called Bug Eyes because my parents couldn't afford to buy me a set of glasses so they had my mother's metal frames fitted to my face in the first grade. I was called Buck Teeth because I inherited a space between my teeth. They also called me Long

because we long wore socks, held up by garover ters, our longhandled underwear. The socks invariably slipped and fell ex-

unmentionables causing further

teasing. The list seemed endless and the bully would sometimes look me in the eye in class and whisper "Sea Hag" or "Witch" while the teacher continued unaware.

I believe my sister got the worst brunt of all because her first name was Myrtle, named for our maternal grandmother, who died at twenty-five years of age in 1908. She was nicknamed Myrtle The Turtle Who Lost Her Girdle. Being so humiliated she dropped out of school as soon as she turned sixteen.

Fortunately she later went back to school after we went into an orphanage. She graduated from Abilene Christian University with a degree in art. She is now known as Alice.

A few years ago two girls were arrested in Florida for teasing Rebecca Sedwick until she jumped to her death from a water tower. Not so long ago there was a tragic story in The Times about a young girl who committed suicide when she could no longer take bullying.

Bullying has risen to a new level perhaps because the bully can keep his eye on his victim

through social media and the cell phone.

Until thirty-five ears ago I thought I had recovered from being teased. That's when I went back to my grade school class reunion and was shocked at some of the unrehearsed words that came out of my mouth when meeting a few of those class mates.

I passed out a few of my published stories and was overwhelmed by a letter I received from an executive in my class. He wrote, "you may not understand this but here I am reading one of your articles as I drive to work. Tears are flowing down my cheeks and I am asking 'how could we have been so mean to her?"

It wasn't my imagination!

I also learned that even though they were considered rich. by my standards, their mother was an alcoholic.

I also found out that the worst

bully in our school is an alcoholic. After drinking at our supper he was so drunk he could hardly deliver his speech.

Maybe the bullies need empathy, while being punished. Also they may need to be put into therapy because there must be something amiss in a child's life if they delight in hurting other children and animals.

We never know what is going on behind closed doors.

Being a bully can lead to being an adult who abuses his or her children later on so this is a serious issue.

My sister and I survived. She turned to art and is an accomplished artist and architect. She physically built their two-story house. I turned to writing many years ago.

Becoming a Christian at fourteen sustained me!

Many children don't survive.

Ronnie Coker to be inducted into La. High School Sports Hall of Fame

Minden High alumnus Ronnie Coker, who led Parkway and Captain Shreve to baseball state championships as head coach, will be posthumously inducted into the Louisiana High School Sports Hall of Fame in April.

As a player, Coker helped Minden win backto-back Class 3A state championships in 1981 and 1982. He graduated in 1982.

Coker, who passed away at 58 after a lengthy battle with colon cancer in June of 2023, guided Parkway to the Class 4A state championship in 1998 and Captain Shreve to the 4A title in 2007.

Coker is one of nine members of the 2025 Class that will be inducted April 25 during the Hall of Fame Banquet and Induction Ceremony at the Crowne Plaza in Baton Rouge.

He was the head baseball coach at Parkway from 1991-99, compiling a record of 196-75. He spent one year as head coach at Byrd before moving to Captain Shreve, where he coached for five years.

His overall record starting with his first year at Parkway was 357-145-1

in 15 seasons. He spent the remainder of his career as athletic director at Airline before retiring in 2021.

Coker was inducted into the Louisiana Baseball Coaches Association Hall of Fame in 2019.

In 2021, the Parkway baseball stadium was named Ronnie Coker Field.

Joining Coker in the Class of 2025 Hall of Fame inductees are Michael Bayer (contributor), Melissa "Ashley" Aldredge Brooks (competitor), Tony Lee Cutright (competitor), Barbara Farris (competitor/coach), O.M. "Butch" Helveston (coach), Br. Martin Hernandez, S.C. (contributor) Jennifer Streiffer Mascaro (competitor) and Ruby Smith Qualls (coach).

The Hall of Fame Banquet and Induction Ceremony is set for April 25, 2025, at the Crowne Plaza in Baton Rouge.





Peter asked to walk on the water and he did until he saw the turmoil around him and began to sink. It wasn't for the wind and waves that Peter sank but it was him




that Jesus seeks to teach us is faith and a firm focus on him, his will, and his word that will not only help you live a Godly life but also maintain one. We often fo-

GARDENING WITH DR. JOE WHITE

GARDENERS HAVE MUCH TO DO IN SEPTEMBER

enerally speak-ing, we've had unfavorable weather for gardeners this year. Extremely hot weather plus an extended drought. The typical expected cool down in the fall usually motivates true gardeners to get busy in their flower beds and vegetable gardens first removing any left-over annual flowers, destroying any weeds and getting ready for the upcoming season.

In the lawn area any fallen leaves that are still there need to be raked up and taken to the compost pile. Also, it's a good time to eliminate unwanted developing tree seedlings and other unwanted plants. You can thank the birds for most of those.

This is a good time to give some thought about what needs to be done in the coming months. Are you planning to have a spring vegetable garden and if so, what crops are going to plant? Are you planning for a spring flower bed full of bulb flowers that you will be planting this fall?



an annual, so don't expect much from them their second year. Both tulips and hyacinths perform much better if given a pre-chill for a period of six weeks before planting.

September is an appropriate time to check out your landscape and make decisions as to removing old plants and adding some new ones. If you're pleased with your current landscape, there is no need to make any changes. However, if you decide some changes would improve the appearance of your landscape, plan to make those changes sometime between

transplanting day lilies, iris and other similar plants. Dig up and store caladiums as soon as their foliage turns brown. Chrysanthemums will do better if you continue to feed and water them regularly until some of the flower buds begin to show color.

While fewer gardeners grow strawberries in our area than only a few years ago, September is the best time to plant them. Properly mulched, they typically require no attention in the fall and winter and will begin bearing their delicious fruits next April.
