Minden **City Council** takes action on budget amendments, infrastructure grants, and fire safety ordinances

The Minden City Council's most recent meeting covered



broad range topics, including amendments to the city's budget, grants for infrastructure

improvement, and many ordinances put forth by Minden Fire Chief Brian Williams to help the fire department keep the city safer in the case of fire emergencies.

Some notable items included amendments to the city budget. The first one the council passed was just a matter of making sure the city's budget was within the regulated variance.

"City governments, and all governments, are required to stay within a 5% variance of the proposed budget that we passed at the beginning. Things

# **Webster Parish Schools** earn 'B' grade with historic performance growth

The Webster Parish School System celebrated a historic achievement as District and School Performance Scores were released on Wednesday,

November 20. Thirteen of the district's fourteen schools demonstrated measurable growth, while the remaining school maintained its perfor-

mance level. Notably, six schools advanced to the next letter grade, propelling the entire district to a "B" rating.

Webster Parish ranked third in overall improvement among Louisiana's 69 public school districts. Among districts with an "A" or "B" rating, Webster Parish achieved the highest overall improvement.

"These results are particularly meaningful given the challenges of recent years," said Superintendent Johnny Rowland Jr.

"Our employees, families, and students have shown incredible resilience and dedication."

During the 2020-21 school year, 1,700 of the district's 5,500 students participated in virtual learning due to the CO-

VID-19 pandemic, with many continuing into the following year. Strict adherence to Region 7 Department of Health guidelines also led

to frequent quarantines, impacting both students and staff. The district did not return to a sense of normalcy until the 2022-23 school year.

"This achievement is a true testament to the hard work and relentless pursuit of excellence by everyone in our school community," Rowland added.

The Webster Parish School Board extended its congratulations to all involved, commending the collective effort that made this success possible.

# Intoxicated man found outside garage, arrested by police

A Minden man was arrested on November 22 after police found him unconscious and intoxicated outside a local busi-

According to a report from the Minden Police

Department, an officer responded to a call from a concerned citizen about a man lying on the ground in front of Potter's Garage in the 600 block of East Union Street. Upon arrival, the officer discovered the man, later identified as Victor Batton, 31, un-

conscious but breathing.

The officer woke Batton, who appeared disoriented and exhibited slurred speech. After frisking him for weapons, the officer detained Batton in handcuffs due to his visibly intoxicated state. Batton initially gave an incoherent response when asked for his date of birth, further

indicating his impaired condition.

During the encounter, the officer found Batton leaning against the patrol vehicle for support, unable to stand on his own. A search of his belongings revealed two empty snack bags with synthetic marijuana residue on the

packaging. Batton denied consuming any intoxicating substances and refused medical attention.

For his safety and that of the public, Batton was taken into custody and transported to the Minden Police Department for booking. He was later charged with appearing in an intoxicated condition.

Unable to post bond, Batton was subsequently transported to Bayou Correctional Center.

All subjects are considered innocent until proven guilty in a court of law.

# **Spencer Creech earns Eagle Scout** rank

Spencer Creech of Troop 100 Bossier was presented with his Eagle Scout badge at his Court of Honor on November 10th. Only 7% of Scouts ever achieve Eagle rank. To obtain this rank, a Scout must earn at least 21 merit badges, demonstrate leadership by organizing and carrying out a significant community service project, and pass a council board of review.

Spencer's Eagle Project was "Duffle Bags for Homeless Veterans." He conducted a two-month supply drive by speaking with leaders of area churches, businesses, and organizations to request donations. He collected over \$2,500 worth of supplies. He and his troop used the supplies to make first aid kits and personal care kits to go into 30 duffle bags. The duffle bags were distributed by Every Warrior Network in Bossier, a nonprofit organization that assists veterans in times of need.

Spencer served his troop as a patrol leader, assistant patrol leader, quartermaster, librarian, and historian. He earned 36 merit badges: his favorites were Fishing, Swimming, Rifle, Shotgun, and the Animation badge he completed by making stop-motion videos. He completed a Photography badge by taking pictures of historic buildings in Gibsland and Mt. Lebanon to make a photo




journal called "A Walk through the Past." On a trip to Italy, he completed an Archaeology badge by taking pictures of archaeology in progress at Pompeii and making an information guide. He and his troop completed a Nuclear Science badge by taking a guided tour of the Willis-Knighton Proton Therapy Center.

Spencer joined Cub Scouts when he was six. He attended family camps where he earned patches for marksmanship with a BB gun and a bow and arrow. He worked with a Scout mentor to complete the optional Cub Scout Nova STEM Program and

earn the Dr. Luis Alvarez Supernova Medal and the Dr. Charles Towns Supernova Medal. The medals were awarded by Norwela Scout Council. No Cub Scout in Louisiana had ever earned these awards before. Spencer completed Arrow of Light when he was 10, and crossed over into the BSA program.

Spencer is an 11th grade homeschool student, and plans to attend Louisiana Tech. His parents are Donna Sutton and Steve Creech of Minden. His grandparents are Betty Sutton and the late Jerry Sutton of Gibsland, and Sharon McComas of Smithville, Missouri.

# Gibsland man arrested for DWI after disturbance

A Gibsland man was arrested on charges of driving while intoxicated following a disturbance at a local Walmart and a subsequent traffic stop on Fincher Road.

The incident began when Minden police received a report about a possible drunk driver who had caused a disturbance at Walmart before leaving the property. The vehicle, described as a red Jeep, was reported heading southbound on Homer Road. Officers located the vehicle and conducted a traffic stop on Fincher

The driver, identified as Robert Reed, 49, of Gibsland, displayed signs of impairment. According to the police report, officers detected a faint smell of alcohol and noted that Reed had bloodshot eyes and exhibited slow pupil reaction, raising concerns about possible drug use.

Reed reportedly became upset during the stop, stating he did not understand why Walmart employees had contacted law enforcement, claiming he was there to purchase whiskey for his fa-

After being read his rights, Reed agreed to perform standardized field sobriety tests (SFSTs). He displayed signs of impairment during the horizontal gaze nystagmus test and struggled with the walk-and-turn and oneleg-stand portions of the evaluation.

Reed was arrested and transported to the Minden Police Department, where he refused a chemical test on the Intoxilyzer 9000. Officers noted Reed's continued uncooperative behavior during processing.

This is not Reed's first DWI charge; records show a prior arrest for DWI first offense in 2011 in Shreveport. He has been charged with DWI.

Authorities remind the public of the importance of reporting suspected impaired drivers to ensure community safety.

# Biden pardons his son Hunter despite saying multiple times he wouldn't do so

(The Center Square) President Joe Biden announced late Sunday that he is pardoning his son, Hunter Biden, who has faced federal prosecution for gun and tax-related charges. The move comes after multiple statements by the president along the campaign trail saying he would not do so if his son is convicted.

Biden released a statement Sunday arguing that the charges were "instigated" by the president's political opponents in Con-

"Today, I signed a pardon

for my son Hunter." Biden said in a statement Sunday. "From the day I took office, I said I would not interfere with the Justice Department's decision-making, and I kept my word even as I have watched my son being selectively, and unfairly, prosecuted."

Hunter Biden's plea agreement with the Department of Justice fell apart at the last minute earlier this year as some lawmakers called it a sweetheart deal and special treatment for the president's son.

Biden argued that his

son, Hunter, was unfairly treated for political reasons, justifying the pardon. Biden had frequently dismissed media questions about his son and whether he would pardon him, outright saying earlier this year that he would not pardon his son if convicted.

"Without aggravating factors like use in a crime, multiple purchases, or buying a weapon as a straw purchaser, people are almost never brought to trial on felony charges solely for how they filled out a gun form," Biden said. "Those who were late paying their taxes because of serious addictions, but paid them back subsequently with interest and penalties, are typically given non-criminal resolutions. It is clear that Hunter was treated differently."

Lawmakers in Congress and IRS whistleblowers have argued the opposite, saying Hunter Biden was given preferential treatment by federal investigators because of his father.

The news comes after federal prosecutors telegraphed their intention to drop the charges against President-elect

Trump, complying with a I have followed a simple long-standing Department of Justice policy to not prosecute a sitting president.

House Oversight Committee Chair Rep. James Comer also alleges his investigation found that Hunter was part of the Biden family business, which raked in tens of millions of dollars from entities in countries like China and Ukraine using the "Biden brand."

So far, that investigation has not led to any federal charges.

"For my entire career

principle: just tell the American people the truth. They'll be fair-minded," Joe Biden said. "Here's the truth: I believe in the justice system, but as I have wrestled with this, I also believe raw politics has infected this process and it led to a miscarriage of justice - and once I made this decision this weekend, there was no sense in delaying it further. I hope Americans will understand why a father and a President would come to this decision."

have to be within those guidelines. At the end of the year, we have to close out that budget by making sure we're in that 5% variance," said Minden Mayor

Nick Cox. The next budget amendment had to do with properly spending the money the city had received from the American Rescue Plan Act before the deadline at the end of the year, making sure the city could actually keep all the money it was given and not having to return it to the federal government. "Several years ago the City of Minden was given over \$4 million from the federal government for the American Rescue fund, and we have until the end of this year to make sure that every cent of it is allocated to some-

thing," said Mayor Cox. "It cannot just be allocated through a budget, it has to be nearly spent. We don't have to have the check written, but it has to be nearly spent, meaning an invoice, solid quote, or bid awarded.

"Many months ago we passed a working ARPA budget and just slap ran out of time to spend it all, so we have appropriate expenditures that we already made, so we would like to amend the budget and go ahead and reimburse the city for those very appropriate expenses we've already spent money on and, therefore, not have to send the money back to the federal government."

Next, the council authorized the mayor to be given full authority to execute and submit all documents pertaining to the Delta Regional Authority for a grant that the city had received to replace one of its oldest water

lines. "Last month, we were notified that we had received \$509,000 in grant money from the Delta Regional Authority, with a city match of \$155,000. This is to replace a 100-year-old line that feeds from the water plant to the water tower on Main Street," said Mayor Cox.

After that, the council approved raises for certain city elected officials which will take effect in 2027. The elected officials include the mayor, police chief, ward marshal, and the city judge.

"We give city-wide raises to all the employees, generally speaking, for the cost of living and things like that," said Cox. "What happens is, ten years go by, and that pay for those elected officials just lags and lags, and we're in a time where inflation is hitting every-

body so terribly hard." A significant portion of the meeting was allotted to explaining and approving various ordinances that all pertained to various aspects of the fire department and fire safety rules. The first ordinance simply had to do with eliminating some references in ordinances to positions in the fire department that no longer existed.

'There were positions in the past that the city had in areas of the town when it came to the structure of the fire department that no longer exist, and are no longer needed," said Mayor Cox.

The second ordinance had to do with preventing the obstruction or tampering of fire hydrants. "We have rules for this already. We've added some language that would prevent people from obstructing a fire hydrant. The way this is set up is in line with the NFPA national standards," said Mayor Cox.

The last one was a ordinance but single added some new rules or changes to existing ones that either help the fire department respond to emergency situations or keep emergency situations from happening in the first place.

"On item one, private water sources, that is pertaining to the fire department being authorized in an emergency to use water from private ponds, swimming pools, lakes, etc. to save life and property without liability for damages," said Minden Fire Chief Brian Williams.

The next part of the ordinance had to do with access boxes that hold keys to the properties for commercial buildings and gated communities; they will have to install those to help the department gain access to buildings in the case of an

emergency. "Currently, the City of Minden has a key box of forty to fifty keys, and we have to try to find a key to a building when we get there. It's just not efficient for what we're doing, so this fixes that," said Chief Williams.

'The access box system is a key box on commercial buildings that has an automatic fire alarm system or an automatic fire suppression system, to have a master key for locations in the building for the fire department to have access to."

Williams went on to state that existing buildings will have six months to comply, property owners will bear the cost of installation, and new buildings commercial will have to have them installed when being con-

He also described the security measures that will be put in the place to ensure that only the proper individuals will have access to the boxes, and that they will only be used in the case of an emergency.

"There is a security

plan in place so only the fire chief or the city clerk can request a key to these boxes. These boxes are only keyed for the City of Minden, and these keys will be under lock and key on the fire apparatus, and every individual has to have a security pin. They are time and datestamped security procedures so no one can just get it off of the truck at any time," said Chief Williams.

The next part of the ordinance had to do with adding rules pertaining to outdoor burning. The City of Minden did not have one, so this put some rules in place that describe what can and cannot be burned.

"The City of Minden does not have an ordinance that prevents outdoor burning. What I've requested is just adding in the ordinance that we just follow the state law regarding controlling air pollution," said Chief Williams. "What it states is that the only thing you can burn inside the city of Minden is vegetative

The next rule was made to help the problem of the department responding to false alarms. The ordinance gives plenty of leeway for an accidental trigger of an automatic fire alarm, but if the issue persists, allow for some fees to be administered to help incentivize the faulty alarm owner to get it fixed.

"It costs the city every time we respond to these calls. That's the main issue, just trying to get these malfunctioning systems repaired," said Williams.

"In twelve months, the first three times we get there are free. If we respond a fourth time, there's a \$100 fee, fifth time there's a \$200 fee, the sixth time there's a \$300 fee."

Lastly, the ordinance goes into detail about the dates and times that people in the city can sell or discharge fireworks. Originally it only referenced the dates. It also clarified what fireworks sellers must display and what fire equipment they must have on-site. It includes a requirement that people obtain a permit from the City of Minden building official if they are looking to do a pyrotechnic display outside of the legal holidays that are stated in the ordinance.

The Minden City Council meeting takes place on the first Monday of each month, starting at 6 PM at the Minden Civic Center. The meetings are open to the public, and for those who wish to view the meeting live or after the fact, it is live-streamed on the City of Minden's Facebook page and You-Tube channel titled "City of Minden - Feels Like Home."

# Trump Will Address Global Challenges From a Position of Strength

What I've always found interesting is the long-held belief that "America's enemies always test a new president to see how far they can go." Well, I'm highly doubtful that will occur now. They won't be testing this one.

Our enemies no doubt already know that the "appeasement" policy of the Obama-Biden Administrations is resoundingly over.

Rather, our enemies know exactly what they will be getting from Trump II and America—a decisive Commander-in-Chief and a military structure with the capacity to bring overwhelming force against America's enemies. The result of this, ironically, will be to preserve peace. This was President Reagan's philosophy of "peace through strength."

New security measures will undoubtedly include Pres. Trump's vision of possessing the technology to knock down and destroy incoming intercontinental ballistic missiles. In fact, Musk believes we should move to entirely unmanned fighter aircraft. If we ever do so we would no longer need to be concerned about many things, including human fighter

pilots being killed or pilots losing consciousness and passing out when G forces overwhelm them.

To that end, I am greatly interested in seeing what reductions Musk and Vivek Ramaswamy conclude can be smartly and strategically made to address the enormous but corroded U.S. military-industrial complex.

This is an exciting time on multiple fronts. The difference is America is again led by a decisive, fearless man who has been tried and has emerged victorious, not only overcoming eight years of relentless bombs and legal attacks from the corrupt Deep State and their media coven, but also surviving two assassination attempts, including one in Butler, PA where he was actually struck by an assassin's bullet. # Baseball's triple play has nothing on fishing trifecta

Baseball's triple play, though rare, is a thing of beauty. Here's one way it can be accomplished. The batter hits a hard line drive in the hole to the shortstop who stabs it, steps on second to catch the runner off base; then flips it to first before that runner can get back. Presto; you've just witnessed one of baseball's most exciting plays.

You may not realize it but fishing can also feature a triple play. I know; because I once participated in one. My triple play took about four hours to complete but the results were just as exciting. Here's what happened..

Eddie Halbrook, fishing guide and good friend, called me and invited me to join him for a fishing trip on Grand Bayou Lake near Coushatta.

"Man, I'm catching bass; catching crappie and finishing it up with some of the prettiest chinquapins you ever saw," Halbrook announced. I cleared my calendar, the date was set and we were off to this pretty little 2,500 acre lake in Red River Parish.

After launching at the public ramp just prior to sunrise, Halbrook motored only a few hundred yards before switching on a gadget on the dash of his boat. It was a GPS that showed a slowly moving arrow (that was us) approaching a dot on the chart.

"The dot represents one of my brush piles; I marked it as a way point on my GPS which makes it easy to get back to. We'll be within three feet of the top when we get there," said Halbrook.

Once the arrow representing the boat and the dot representing the brush pile were aligned, Halbrook tossed out a marker, handed me a jig pole with a Stinger jig and Berkeley Crappie Nibble added with instructions to fish near the buoy. "You'll feel the brush down there," he added.

He was right. About the time I bumped brush, I felt a tap on the line, set the hook and was soon fighting a medium-sized black crappie. In short order, we caught several more before Halbrook announced we needed to move on to try our luck with bass. Before leaving the brush pile, Halbrook hooked and landed a 3 pound channel catfish

that hit his crappie jig. Next, we moved to a cove where the bass had been schooling earlier in the week. A steady breeze had the surface churned to the point that we saw very little surface schooling activity. Not to be outdone, Halbrook handed me a rod he had rigged, Carolinastyle, with a 6 inch watermelon finesse worm. Half an hour later, we counted four bass we had landed with one being just above the 17 inch slot; the others just below it. "Now," Halbrook said

as he started the engine, 'the fun is about to begin. Have you ever caught chinquapin bream in the middle of summer?" I hadn't and was anxious to give it

Again, Halbrook flipped on his GPS and we motored slowly up to another "dot" on the chart. "This is where the chinquapins are hanging out. They feed on freshwater mussels and there are lots of them here on this flat."

He was right. Less than a minute after tossing my hook, skewered with a cold worm into eight foot water, the float shuddered and slid beneath the surface. It was a fine chinquapin, fat as could be. By the time an hour had passed, we put about 35 big chinquapins in the box. Thus, our triple play was completed with a catfish added as an extra, and we did it all between sunrise and noon.

A baseball triple play is a fun thing to watch. However, I was as excited to participate in a fishing triple play as watching the short stop complete one in Yankee Stadium.

creates common ground and an avenue for communication with people you otherwise might not talk to. This raises the question of why can't our Christian walk provide the same experience? We are not instructed to only minister to


around but we are instructed to minister to all the world. Take, for instance the movies where we sit for 2 hours with
