# Springhill man arrested on home invasion, domestic abuse charges

A Springhill man was arrested early Thursday after allegedly breaking into a woman's home, assaulting her, and taking her vehicle without permission, according to law enforcement.

Webster Parish Sheriff's deputies responded to a call just after midnight on March 20 in the 100 block of Red Bud Lane. The complainant reported that Cartavious Webb, 26, entered her residence, pushed her down a hallway, and then loaded items into her vehicle. Webb allegedly returned inside, choked the woman while she was seated in the living room, and then left in her vehicle.

Deputies later located Webb at an address on Cobb Street with the woman's vehicle. A witness reported seeing Webb enter the residence and hearing a struggle as he and the woman moved down the hallway.

Webb was read his rights under Miranda and transported to BDCC for booking on charges of home invasion, domestic abuse battery, and unauthorized use of a motor vehicle.

All subjects are considered innocent until proven guilty in a court of law.

# Traffic stop leads to 150-pound marijuana bust in Webster Parish

A traffic stop on Interstate 20 early Tuesday led to the discovery of approximately 150 pounds of high-grade marijuana, according to the Webster Parish Sheriff's Office.

Deputies found the marijuana, with an estimated street value of \$225,000, inside a travel trailer during the stop. Authorities arrested Joseph Alva Harper of Sylvania, Georgia, and charged him with possession of Schedule I narcotics (marijuana) with intent to distribute and possession of controlled dangerous substances in the presence of a firearm.

Harper was booked into the Bayou Dorcheat Correctional Center. The investigation remains ongoing.

A Ruston woman was arrested March 15 after authorities say she was driving under the influence with her 7-year-old child in the vehicle and in possession of multiple narcotics.

According to Louisiana State Police, a trooper responded to a call for assistance from the Minden Police Department near the intersection of LA 159 and McArthur Drive at approximately 6:58 PM on March 15. An officer at the scene reported that the driver had been observed operating her vehicle on the sidewalk and nearly striking a pole.

The driver, identified as Morgan Teekell, 40, exhibited slow, slurred speech and droopy eyes, leading officers to believe she was under the influence of a substance other than alcohol. She performed poorly on standardized field sobriety tests and was taken into custody for DWI.

Authorities stated that Teekell's 7-year-old son told officers she had handed him a pill bottle before being stopped. Upon inspection, the bottle contained multiple controlled substances, including Schedule II, III, and IV narcotics.

Teekell has a prior DWI conviction from Bienville Parish in 2022. She was booked on charges of second-offense DWI with child endangerment, possession of Schedule II, III, and IV narcotics, illegal possession of a controlled dangerous substance in the presence of a minor, and careless operation.

#### **Emergency responders aid college team after I-20 crash**

Local emergency agencies and community organizations came together late Thursday night to assist a college team from Texas after a major accident on Interstate 20 in Minden.

According to the Webster Parish Office of Homeland Security and Emergency Preparedness, the crash occurred at approximately 11:30 PM on March 20. Within an hour and 15 minutes, multiple agencies coordinated efforts to transport more than 40 passengers from the interstate to safety.

The response included the City of Minden Police Department, City of Minden Fire Department, Advanced EMS, Webster Parish School Board, First Baptist Minden, St. Rest Baptist Church, and Andrew's Towing. The Webster Parish School Board assisted in transporting the team to First Baptist Minden, where the church opened its facility to accommodate the group. St. Rest Baptist Church later provided further assistance by taking the team to their final destination.

The coaching staff of the Texas-based team praised the coordination of the response, stating they had "never seen such coordination during an emergency like this."

A Texas Southern Uni-

versity alumnus also expressed gratitude, commenting on social media, "Thank you so much for taking care of our students & coaching staff! TSU owes Minden a debt of gratitude!"

The Webster Parish Office of Homeland Security and Emergency Preparedness publicly acknowledged the efforts of all involved, commending their service to visitors passing through the parish.

# **Ordering Terrorists Returned to Our Home Is Insane**

At the heart of our democratic form of government is the critical need for an impartial judiciary which directly springs from our Separation of Powers. An impartial judiciary is indispensable to the rule of law because, if we lose our case but believe we were granted a fair trial and "had our day in court," we are willing to live with the results. That core principle is being undermined by a federal judge in Washington, D.C.

U.S. District Judge James Boasberg last week blocked an order of President's Trump's that is expressly based upon Pres. Trump's authority as Commander in Chief and, specifically, on the Alien Enemies Act, to deport criminal illegals who are members of Tren de Aragua, a violent Venezuelan gang. (I note that Boasberg also played a key and controversial role in the Trump-Russia collusion saga as the leader of the Foreign Intelligence Surveillance Court.)


This is not even a close call. President Trump posted,

'Unlawful nationwide Injunctions by Radical Left Judges could very well lead to the destruction of our Country. If a President doesn't have the right to throw murderers, and other criminals, out of our Country because a Radical Left Lunatic Judge wants to assume the role of President,

then our Country is in very big trouble, and destined to fail."

Judge Boasberg is engaging in judicial activism by legislating from the benchmaking policy—in a manner that is unconstitutional and, therefore, illegitimate. What do I mean?

A president acts with the greatest authority when he acts as Commander in Chief. This is because the Framers of our Constitution recognized that



try would, of necessity, need to be quick and deci-ALEXANDER sive and

not driven by consensus in the U.S. Congress.

It is simply beyond debate that the Commander in Chief has broad—if not nearly complete-constitutional authority to protect and defend our nation and ensure our national security. And, as it pertains to the tens of thousands of criminal illegals in our country committing heinous acts of murder and rape, our country and national security are under attack.

We are dealing with a single federal judge who is blocking the authority and decision-making of a duly elected president who possesses an overwhelming political mandate to address for purposes of national security the very issue of illegal immigration. That's judicial arrogance and judicial abuse.

I won't even address here that, as the very embodiment of the Executive Branch, a president also has great authority within the Executive Branch to direct federal agencies, fire federal workers and to reexamine the spending of billions of federal dollars, but he does.

The role of the Legislative Branch is to "legislate," to make law in conjunction with a president either signing or vetoing a proposed bill. The role of the Judicial Branch is to strictly serve as the "referee" between the branches to see that they remain within the confines of their constitutional powers. As such, it is absolutely not the role of any federal court to make policy or serve as a super legislature, second guessing the political branches.

This rogue Judge is unilaterally employing a nationwide injunction blocking the deportation of foreign terrorists from our land. He doesn't have that authority.

The U.S. Supreme Court must address this quickly.

I note that in a rare public statement, Chief Justice John Roberts indicated that the way to address judicial decisions that a president disagrees with is not to resort to impeachment of that judge but instead to rely on the appellate review process. I disagree. What this judge is doing is a direct affront to the rule of law and our constitutional scheme. Other Leftist judges across the nation are doing the same thing. If he wants to head off impeachment of federal judges, Chief Justice Roberts and the Supreme Court should review and reverse this decision quickly.

Justice Roberts and Justice Amy Coney Barrett recently made a cowardly decision not to rebuke a similar ruling by another federal district judge who blocked Pres Trump's perfectly legal decision to review all federal grants and halt payments of those grants until the review was complete. Both iustices should remember that our federal government is one of co-equal branches which means that the Separation of Powers also applies to the Judicial Branch and these abuses, if not swiftly checked, will prompt greater calls for the impeachment of federal judges.

# A Call for Patience — and Perspective on DOGE

There's a buzz circulating around Washington, D.C., and whether you're keeping up with the headlines or not, it's likely to reach every corner of the country — including right here in Webster Parish. I'm referring to the recent DOGE initiative — that's the Department of Government Efficiency spearheaded by Elon Musk and supported by President Donald Trump. While the name may seem unconventional, the mission behind it is anything but a joke.

The goal of DOGE is to identify inefficiencies and waste within the federal government and take tangible steps to eliminate them. It's a monumental task. One that won't be completed overnight - and that's precisely why I believe patience and perspective are so important right now.

– but I do believe it will be worth it.

Let's be patient. Let's stay informed. And above all, let's keep doing what Minden and Webster Parish do best — supporting one another through whatever comes next.

# **OUTDOORS** Lightning strikes twice for Jordan on Honey Brake

(Louisiana's deer season has been over for several weeks and I have been privileged to write stories on the impressive bucks taken for LA Sportsman's magazine taken. Here's my story of the most impressive buck I covered that is likely to be a new state record for the typical category.)

When Tyler Jordan shot a huge buck on December 7, 2020, he made a prediction that fortunately didn't hold true.

"I may never shoot another 190 inch buck. I'm in the woods a lot and I have never seen a buck that size,' Tyler told me when I wrote the story for LA Sportsman about a huge buck he had taken, a buck that scored 190 4/8 inches of mass. The buck earned the name of "Stomper".

Jordan was hunting in Catahoula Parish on the 20,000 acre Honey Brake property when he took the buck. Fast forward four years when Jordan, now age 32 encountered a buck that has earned the name of Stomper, Jr. because of similar genetics as Stomper

The son of Bill Jordan, founder and CEO of Real Tree, Tyler works in the marketing department of the company. He lives in Columbus, GA.

'We became interested in Honey Brake in 2018

and would bring business guests down to duck hunt. We had no idea at first that the property was capable of producing quality deer but as we learned what the folks at Honey Brake were doing our interest was piqued,' said Jordan.

Putting out trail cameras this past September, plenty of quality bucks began showing up but it was not until November 1 that Stomper Jr. started showing up on cameras.

"We purchased a ground blind to set up on the food plot where we felt was the best chance to see the deer. One afternoon, two minutes after legal shooting hours had ended, Stomper Jr. showed up at 20 yards.

A camera man and I were in the blind and apparently the buck saw the camera light and he spooked and took off. We didn't see any more evidence of him for 2 1/2 weeks," Jordan recalled. It became an issue of looking for favorable weather when deer would more likely to be active.

"On December 2, I checked the weather forecast and it looked like things would be pretty decent and I felt that if deer would move at all, it might be then. We had the north wind we needed and on the morning of December 3, he showed up four minutes before legal shooting time," he said.

Setting up a ground

blind in the area where this photo was taken, Jordan got in the blind around 2:30 the afternoon of December 5.

"There was plenty of action as does and smaller bucks were displaying rutting activity and then at 5:10, I looked up and there stood Stomper Jr. I shoot a Franchi .308 and got on him. When I hit the trigger, he dropped on the spot," Jordan continued.

The rack the 250 pound buck carried was mind boggling. There were 14 points, evenly distributed on each side and the inside spread was 19 5/8 inches. Main beams were 26 1/2 inches each with bases measuring 5 2/8 and 5 1/8. The buck was determined to be 6 1/2 years old.

The tale of the tape measured a gross score of 203 inches with the net score being 192 3/8 inches.

The previous Louisiana state record for typical whitetail bucks is a record that has held since 1939 when Marshall McKay downed a massive buck in Madison Parish that measured 186 6/8 inches. After a drying time of 60 days, it is very likely that Tyler Jordan can lay claim to a new Louisiana state record for typical bucks.

Well Tyler, you won't ever be able to say what you told me in 2020 that you may never shoot another 190 inch deer. You just did.

Bream are beginning to respond to crickets and worms in shallow water. No report on catfish or stripers. For latest information, call Kel's Cove at 927-2264 or Terzia Tackle at 278-4498.

CANEY LAKE -Crappie fishing has improved in the back of the creeks as they prepare for the spawn. Shiners and jigs are bringing some in. Bass are moving to the shallows and soft plastics and crank baits are starting to pick up fish. Chinquapins are just now starting the bite cold worms. No report on catfish. For information contact Caney Lake Landing at 259-6649, Hooks Marina at 249-2347, Terzia Tackle at 278-4498 or the Honey Hole Tackle Shop at 323-8707.



AN ORDINANCE AMENDING ORDINANCES 90 AND 90-A PROVIDING FOR THE MAINTENANCE AND REPAIR OF FENCING ON BUSINESS PROPERTY, THE REPAIR OR REMOVAL OF UNINHABITED DWELL-INGS THAT ARE NOT LIVEABLE, AND WRECKED OR NON-WORKING VEHICLES, REMOVAL OF APPLIANCES, JUNK AND TRASH, AND THE TRIMMING, CUTTING, OR REMOVAL OF TREES, HEDGES, BUSHES, AND SHRUBBERY CONSTITUTING A NUISANCE IN THE MUNICIPALITY OF THE VILLAGE OF DIXIE INN, LOUISIANA

Be it ordained and enacted by the Mayor and Board of Aldermen for the Vilage of Dixie Inn, Louisiana, the governing authority thereof, in it's Regular Session convened on the 11th day of March 2025, as follows:

MAINTENANCE AND REPAIR OF FENCING ON BUSINESS PROP-ERTY, REPAIR OR REMOVAL OF UNINHABITABLE DWELLINGS THAT ARE NOT LIVEABLE AND WRECKED OR NON-WORKING VEHICLES, REMOVAL OF APPLIANCES, JUNK AND TRASH, AND TRIMMING, CUT-TING, OR REMOVAL OF TREES, HEDGES, BUSHES, AND SHRUBBERY CONSTITUTING A NUISANCE IN THE MUNICIPALITY OF THE VILLAGE OF DIVIDINAL OUISIANCE OF DIXIE INN, LOUISIANA

Section 1. Clearing and maintaining of premises; requirements

Business owners shall maintain and repair damaged fencing Business owners shall maintain and repair damaged fencing along their property, and the owner of any premises, as to vacant premises or premises occupied by the owner, shall repair or remove uninhabitable dwellings that are not livable, and the occupant thereof, in case of premises occupied by other than the owner thereof, shall repair or remove vehicles that are wrecked or non-working, remove appliances, junk, and trash, and remove, trim or cut all trees, hedges, bushes or shrubbery, of whatever kind or nature, growing or remaining upon the premises, or in the area between the sidewalk and the curb abutting the premises, when the said trees, hedges, bushes, shrubbery or part thereof is now, or may become dead, unsightly, dangerous or a public nuisance in the opinion of the Board of Aldermen of Dixie Inn, Louisiana.

#### Section 2. Notice to remove

In order to effectively carry out the intent of Section 1 above, the clerk shall send to the property owner as determined from the latest assessment rolls, or the occupant of the property failing to comply with the requirements of this ordinance, a written notice requiring the property owner to comply therewith within 15 days from the date of receipt thereof. The notice shall be posted by registered or certified mail, with return receipt requested.

#### Section 3. Judicial determination

If the owner or occupant of the premises so desires, he may, within the 15 day period after service of notice to abate the nuisance, re-quest of the clerk, either in person or in writing, and without the requirement of bond, that a date and time be set when he or she may appear before the municipal court for a trial to determine whether he or she is in violation of this ordinance, and whether or not the location and continued existence of the trees, hedges, bushes, shrubbery, wrecked or non-working vehicles, appliances, or trash on his or her property constitutes a public nuisance.

#### Section 4. Failure to remove

If there has been no compliance by the property owner or oc-cupant with the requirements of this ordinance within 15 days of a judgment of the court determining that he or she is in violation, the owner or occupant shall be deemed guilty of a misdemeanor, and on conviction thereof shall be punished by a fine of not more than \$150,00 or shall suffer imprisonment for not more than thirty (30) days, or shall suffer both fine an imprisonment, at the discretion of the court.




