The weekend kicked off Thursday with the Game Plan for Health event at David Raines Community Health Center. Nearly 100 people received wellness checks, sports physicals, and free food.

Friday's youth football camp at Minden High School drew a large crowd. Before the camp began, one of the coaches told attendees that Sneed had been called back to NFL training camp and wouldn't make it. Moments later, Sneed surprised the kids by ap-

pearing on the field, met by cheers from the young athletes. Throughout the camp, he encouraged them with the phrase, "Be great today!"

On Saturday, the Sneed Reach 1 Foundation hosted a car show and 3v3 basketball tournament at the Minden REC Center. While attendance was lighter than

earlier events, organizers said those who came enjoyed good food, music from a live DJ, and a fun, relaxed atmosphere.

"I want to start with the youth, that's my biggest drive. It's what I love," Sneed said. "These kids are such a blessing, just to see all these smiles, them calling my name 'Sneed.' That's what I do

it for, just to give these kids hope and let them know that they can do it as well. I'm a normal person, just like them."

Sneed, a Minden High School graduate, former Louisiana Tech Bulldog, and two-time Super Bowl champion, currently plays cornerback for the Tennessee Titans.

7 pounds of marijuana found during I-20 traffic stop

A Louisiana State Police traffic stop early Thursday morning led to the arrest of a Jonesboro man after authorities discovered approximately seven pounds of marijuana in his vehicle.

According to a report from Louisiana State Police, a trooper stopped Latrevious Williams, 35, on June 19 around 2:26 AM on Interstate 20 near mile marker 44. The stop was initiated due to Williams driving in the left-hand lane, following another vehicle too closely, and having only one functioning tail lamp.

After making contact with the driver, the troop-

er observed what were described as "numerous indicators of criminal activity." Williams then signed a Louisiana State Police consent-to-search form. A search of the vehicle followed, during which the trooper located a trash bag containing approximately seven pounds of marijuana on the back seat.

Williams was arrested and booked on multiple charges, including driving on the right side of the road exceptions, following too closely, driving under suspension, no required tail lamps, and possession with intent to distribute marijuana.

Juneteenth celebration draws crowd to MLK Drive in Minden

Music, community pride, and messages of hope filled the air along Martin Luther King Drive on Thursday evening as Minden residents gathered for a Juneteenth celebration. The event drew a crowd and featured a variety of food trucks, local vendors, musical performances, and presentations.

Under sunny skies, attendees browsed vendor booths offering everything from house plants to community resources, while the scent of festival foods drifted through the street.

Avionna Smallwood, the reigning Phi Delta Kappa Miss Juneteenth, delivered a heartfelt address to the crowd. "Juneteenth is a day to celebrate freedom just like celebrating your birthday ... it's a day to remember that everyone deserves to be treated with kindness and respect," she said.

Sponsor Amanda Thomas praised Smallwood's service and spirit. "Avionna has done a terrific job, and we are just so proud and thankful to have her," Thomas said.

Smallwood is scheduled to crown her successor at a ceremony on June 20 at 6 PM at Webster Junior High School.

Therah Newman and John Gill Jr. performed Hold On, drawing cheers and applause from the audience.

Mayor Nick Cox took the stage to deliver an official proclamation on behalf of the City of Minden. "Every year this gets bigger and better," Cox said. "I've enjoyed watching this event grow because it's very important."

He ended the proclamation, saying, "I encourage all citizens to join in the observance of this significant day through reflection, education, community engagement, honoring the legacy of those who fought for freedom and for justice."

Adding a creative voice to the program, Tatiana Mason, the first recipient of the Kevin Washington Memorial Scholarship, read her original poem Forever More, which ended with the line, "we are the reason hope will never die."

Minden woman arrested in child death case

A Minden woman has been arrested in connection with the death of a 2-year-old child earlier this year.

After the autopsy was completed, Keatavia Morris, 23, turned herself in at the Minden Police Department on June 18 and was arrested on a warrant for two counts of child desertion and one count of negligent homicide, ac-

cording to police. The charges stem from an incident that occurred on April 30 at a residence in the 1300 block of Young Street. As previously reported, the Minden Police Department responded to a call at approximately 10:45 AM regarding an unresponsive 2-year-old girl. The child was transported to the emergency room in a private vehicle, where efforts to revive her were unsuccessful. According to Minden

Police Chief Jared McIver, initial findings indicated that the 2-year-old and a 10-month-old child had been left unattended inside the home, strapped in car seats. Investigators believed the older child may have slipped into a slouched position in the car seat, potentially restricting her breathing.

Dr. Billy Jack Talton

Dr. Billy Jack Talton, Professor Emeritus at Louisiana Tech University and a world-renowned figure in powerlifting, died peacefully at his home in Dubach, Louisiana, on June 18, 2025, with his loving wife, Carolyn, by his side. He was 85.

Born to Oltavone and George Talton on March 16, 1940, in Minden, Louisiana, Billy Jack played football and graduated from Minden High School. During this period, he became interested in lifting weights to gain strength. In 1958, legendary coach Joe Aillet recruited Billy Jack to play football at Louisiana Tech University, where he excelled as an athlete and continued his passion for weight lifting.

Upon graduation, Bastrop High School hired Billy Jack to teach and coach where from 1962-1967. Here, he developed the idea of competitive powerlifting as a motivator to include not only football players but also other students who perhaps were underserved by other high school sports.

Following his tenure at Bastrop, Billy Jack continued coaching at Captain Shreve High School from 1967 to 1970. Between 1970 and 1972, he coached at Northwestern State University while pursuing a doctorate.

He went on to join the staff at Cedar Creek High School, where he coached and taught from 1972 to 1974.

Louisiana Tech brought Billy Jack back in 1974, where he became a faculty member in Health and Physical Education. Soon afterward, several students approached him about forming a university powerlifting team. The team competed in its first national collegiate championship in 1976 and, by 1987, won its first National Championship. With a team that evolved from the Dungeon Dogs to the Iron Dogs, Billy Jack would build Louisiana Tech into a national powerlifting powerhouse. At the same time, he led the team to 22 national championships until his retirement in 2001. In 2012, the fitness room in the Lambright Sports and Wellness Center was named the Billy Jack Talton Fitness Room in his honor.

Recognized as the "Father of Powerlifting," Billy Jack served in many areas within the sport, including National Meet Director, IPF International Official, Official for the Paralympic Games, International Official for the

Special Olympics, and a host of powerlifting administrative positions. A ten-time Collegiate Powerlifting Coach of the Year honoree, he was recognized as the founder of Louisiana High School Powerlifting, inducted into the Ark-La-Tex Sports Museum Hall of Fame, named an inaugural inductee into the USAPL Louisiana Hall of Fame, honored as the USA Powerlifting Federation 1st Annual Coach of the Year, and inducted into the US Powerlifting Hall of Fame.

A true pioneer beloved by the hundreds upon hundreds of students he mentored and coached through the years, Billy Jack remained in close contact with scores of athletes who soared to incredible heights under his tutelage. Always willing to regale groups, small and large, with stories from his legendary career, his signature intensity, dry wit, and robust laugh remained a gift to those around him. His life pushed limits with a legacy built upon profound strength, tenacity, grit, and the pursuit of excellence.

Billy Jack is survived by his wife of 62 years, Carolyn Flanagan Talton; daughter Tanya McGowan White (husband Ricky); son Billy Jack Talton, II (wife Vickie); granddaughter Evangelina Talton, grandson Sean McGowan (wife Katie); grandson Brian McGowan (wife Calyn); grandson Trey Talton; sisters Susan Byrd (husband Larry) and Sharon White (husband Jimmy); nephew John McLemore; nieces Jennifer Cox (husband Ronnie), Patricia Phillips, Carolyn Frances Crouch, Ann Crouch, and Kristen Fairchild; great-granddaughters Sammi McGowan; Juliette McGowan and Caroline McGowan; and the family of Vickie Talton - Bertha Leticia Mejia (mother), Carlos Rameriz, (brother), Vanessa Lopez (sister) and Isauro Vasquez (brother).

Visitation is scheduled for Friday, June 27, 2025, from 5 P.M. to 7 P.M. in the Temple Baptist Church Fellowship Hall located at 1515 S. Service Road W in Ruston, Louisiana. vehicle. The suspect was described as wearing a white T-shirt and light-colored pants.

Upon arrival, officers located a man matching the description who was seen loosening a light fixture. Officers gave loud verbal commands for the man to approach and remove his hands from his pockets. He complied and was detained for questioning.

The man identified himself as Andolini Ray. During the interview, dispatch provided officers with a still image from surveillance footage showing a man in a white T-shirt and white pants reaching for the door handle of a remote-started car.

Ray claimed he had been visiting a friend and was walking through the complex when he became involved in a verbal altercation with another man, whom he alleged had made racist remarks. He said the image showed him near the car because the other man was inside it at the time.

However, police confirmed through dispatch that the vehicle's owner was not inside the car during the reported in-

cident. Based on this and other evidence, Ray was placed under arrest for attempted theft of a motor vehicle.

As officers attempted to place him into a patrol unit, Ray reportedly refused to comply with commands and tensed up. Officers used minimal force to secure him in the vehicle.

A complainant later told police that her husband had remote-started his vehicle to prepare for work and, upon stepping outside, noticed his work boots were missing. He reportedly found them near Ray and observed him near the vehicle before contacting authorities.

All incidents were captured on surveillance footage, according to the report.

Ray was transported to the Minden Police Department and booked on charges of attempted theft of a motor vehicle, resisting an officer, and theft. He was later transferred to Bayou Dorcheat Correctional Center due to the felony nature of the charges.

Man arrested following early morning altercation with brother on Hinton Street

A Minden man was arrested in the early morning hours of June 13 after reportedly assaulting his brother during a dispute over missing tools.

Officers were dispatched at approximately 2:04 AM to a residence in the 900 block of Hinton Street in reference to a physical altercation between two brothers. The caller reported being attacked while asleep and was found by officers standing in the street with significant bleeding around his neck and upper chest area.

The man told police he had been asleep when his brother, Grant Neal, 38, suddenly entered his room and began striking him. He said Grant accused him of stealing tools, and although he was unsure what weapon may have been used, he believed it could have been a cane or a similar object. He told officers that Grant stays at the residence a few times a week and that several teenagers were also inside at the time.

Officers entered the residence due to safety concerns and located Grant, who exited the home holding miscellaneous objects. He was taken into custody without incident. After being advised of his

rights, Grant stated that he had come to retrieve tools and discovered some were missing from a toolbox mounted on his truck. He admitted to confronting his brother, and that the two began physically fighting, though he did not specify who initiated the altercation.

Inside the residence, officers observed blood droplets throughout several rooms. The brother's bedroom was described as disheveled, with numerous sharp objects such as knives, drill bits, and razor blades found in the area. Officers believe the brother's injury beneath his chin may have been caused during the struggle when he came into contact with one of these objects. It was not confirmed whether the injury was deliberately inflicted.

Grant was arrested and transported to the Minden Police Department, where he was booked on one count of simple battery. During transport, he requested medical attention, stating he had suffered a head injury and was experiencing medication withdrawal. Medics responded, but Grant declined treatment.

Minden police lieutenant on leave, facing disciplinary hearing over property damage charge

A Minden Police Department lieutenant is on administrative leave and facing both criminal and administrative proceedings following a charge of simple criminal damage to property.

Lt. Christopher Hammontree, a 16-year veteran of the department, was already on administrative leave for a separate reason when he was charged Wednesday and released on his own recognizance, according to Minden Police Chief Jared McIver. McIver confirmed that his department has completed a preliminary in-

ternal investigation. He said he has submitted a disciplinary recommendation to the Minden City Council, which has the authority to either uphold, overturn, or alter the recommendation.

"What they will do now is for them to decide when they convene," McIver said in a phone interview. "It'll be totally up to them."

He added that the department must hold its personnel to a high standard.

"We've got a standard that should be above that of the normal public," McIver said.

McIver declined to dis-



cuss further details about the charge or administrative leave status, stating that the matter remains in its early stages.

Hammontree is expected to appear before the Minden City Council for a disciplinary hearing, though a specific time for the session has not been

announced. McIver said it would be up to the mayor and council to determine the format of the hearing.

Mayor Nick Cox said a decision on disciplinary action will most likely be reached during the next city council meeting which will be held on Monday, July 7.

Trump is Correct to Assist Israel in the Elimination of Iran's Nuclear Threat

Presidential historians traditionally look for signal and defining moments in a presidential administration as a method by which to rank and place that president in history. President Trump has just had one.

What happened?

In a secret operation that can only be described as outstanding, President Trump ordered Operation Midnight Hammer in which the U.S. Central Command conducted precision strikes in the middle of the night against three Iranian nuclear facilities in Fordow, Natanz and Isfahan, in order to destroy or severely degrade Iran's nuclear program. Transporting these enormous "bunker buster" bombs that were dropped was a large B-2 bomber strike package.

By all accounts, the result has been that the U.S. has, indeed, either completely obliterated or severely degraded the Iranian nuclear program.

President Trump explained his decision stating that "for decades we have watched Iranian leaders and their supporters chant 'death to Israel' and 'death to America.' We have watched the Iranian government, funding its proxies such as Hezbollah, Hamas, and the Houthis, deploy terrorism across the world." Now, with the Israeli attack already well underway, the U.S. not only aided Israel, one of its closest allies in the

world, but also eliminated the same nuclear threat to our own country.

We should also recall that there is proof that Iran has tried to assassinate President Trump—that Israeli Prime Minister Benjamin Netanyahu has intelligence that Iran 'wants to kill' Trump and was behind both assassination attempts on him.

the U.S. in another foreign war. From what I've read, this only means that, in addition to the military equipment and intelligence with which we already provide Israel, we are assisting Israel with the use of these devastating bunker-buster bombs, reaching those deep places underground where Iranian scientists are working to enrich uranium with the goal of creating nuclear warheads. Israel doesn't possess a bomb with the capacity to reach that far down, and these Iranian nuclear facilities must be destroyed.

President Trump now stands as a colossus on the

world stage. However, while he has re-asserted American military and foreign policy dominance with this strike in Iran, he also remains open to a negotiated end to this conflict.

As we watch this Iranian conflict unfold, I can't help but recall the Afghanistan debacle under President Biden. The arbitrary and capricious U.S. withdrawal from Afghanistan stunned and angered many of our allies. Remember, our allies over the last 20 years had made enormous investments, blood and resources, in the stabilization and peaceful coexistence of that country to prevent the very thing from happening that did happen—Afghanistan transitioning back to being a terrorist haven which threatens the entire civilized world, as well as the mass exodus of fleeing Afghans seeking emergency naturalization and settlement in the countries of our allies.

As the Afghanistan debacle unfolded, with our government leaving billions of dollars of American military equipment behind to the Taliban, and as those huge American planes were taking off from that airport, loaded with people who were literally falling off of the airplanes as they took off, I remember thinking we are watching Afghanistan again devolve dangerously into a terrorist magnet ruled by the Taliban, and we are witness-

ing once again the timeless and immutable principle of history and nations that strength deters bad actors while weakness begets war.

I also recall that such an epic disaster in Afghanistan underscores the essential lesson of history that the only way to ensure peace is through strength. As President Reagan said, "we know only too well that war comes not when the forces of freedom are strong, but when they are weak. It is then that tyrants are tempted."

President Trump has seized this moment. In so doing he has not only left a powerfully positive and indelible mark on his presidency, but he has also likely redirected the course of the world. There is no force as great as that of unharnessed nuclear power and to allow a nuclear weapon to be developed and possessed by such a radical group of religious zealots as those that comprise the Iranian government—a weapon it would also, no doubt, share with other terrorist groups—is simply too grave a risk to the world.

Our prayers are with you, Mr. President. Please continue to decisively and permanently end this nuclear threat now.

Sneed started the first five games before suffering an injury while taking a helmet to the thigh in Week 6 against the Indianapolis Colts

According to media reports, the injury was first diagnosed as a bruise. But further tests showed it was a more serious quadriceps

strain.

Sneed was placed on injured reserve on Nov. 22 and didn't play again.

According to media reports, he underwent surgery that included a bone marrow aspirate injection.

During his talk with the media at his camp, Sneed said he's as healthy as he has been and that

he's ready to come out and show what he can do.

At Kansas City, Sneed was considered among the top lockdown corners in the league.

"He's coming back injury-wise," Titans Head Coach Brian Callahan told Jim Wyatt of titansonline.com in May. "So, the rehab process is ongoing. He's in a good spot, excited about where he's at."

Sneed was in high spirits at his camp, which attracted more than 300 participants. That's up from 250 last year and 100 in the first year, Sneed said.

He said he appreciates the responsibility he has as a role model.

"The kids look up to me," he said. "They want to play on a big stage like me. Just a blessing to come back and be a role model for these kids. Show them the way that it can be done."

Three Louisiana lakes in top 10 for best fisheries



Louisiana is known as the "Sportsman's Paradise" with good reason. Although we're not at the top for deer, turkey and duck hunting, we hold our own rather well. With our proximity to the Gulf and its great salt-water fishing along with top-notch lakes and rivers within the state, we often turn heads when it comes to fishing.

An organization, Fishmasters.com, recently did a yeoman's job in selecting the top 30 lakes in states across the country. These lakes were chosen after talking with local anglers and followers on social media. The list was compiled not just about popularity but about where people actually go to fish and what they catch.

Louisiana's top 30 lakes, as compiled by Fishmasters.com, cover lakes all over the state. What attracted my attention was how the organization shined the spotlight on lakes in north Louisiana. A few of note included Bussey Brake, a lake that has recently caught on fire for the number of lunker bass it is producing. It sits at number 16 and if the list were more recent, Bussey might be higher.

Black Lake in Natchitoches Parish was listed as number 12 and Bistineau at number 11. What especially caught my attention was the top ten lakes that included those in north Louisiana. Number 1 was no surprise, Toledo Bend with Caney Lake coming in at number 2 and D'Arbonne at number 3. What really pleased me was the lake sitting at number 7, Lake Claiborne.

When I lived in Homer during the late 1960s, the big news was that a new lake was being planned and drawn up for the hills of Claiborne Parish. State Senator, Danny Roy Moore, a civil engineer working with Representative John S. Garrett drew up plans for the lake and were able to secure funds to construct the 6500 acre lake.

The lake was completed and water coursed over the spillway for the first time on May 17, 1968.

Before the lake filled, I would drive out before work and enjoy some exciting early morning duck hunts on the potholes that would eventually be inundated by 30 feet of water.

Once the lake filled, Lake Claiborne became a school bass para-

dise and fishing for bass that churned the surface chasing shad became my go-to sport.

A lot has happened to Lake Claiborne over the past 57 years since it filled. The lake's popularity started waning somewhat with the construction of Caney Lake, which became known as the big bass capitol of Louisiana. The state record 15.97 pounder was caught by Greg Wiggins on Caney, a record that has stood for over twenty years. Catching a four or five pounder on Claiborne was about the high standard.

Over the past decade, Lake Claiborne has quietly and steadily been making a comeback and much of the success today has to do with the introduction of Tiger Bass, a hybrid cross

between native largemouth bass and Florida strain largemouth bass. Tiger bass are known for their faster growth rates compared to pure strains of largemouths. During a recent tournament held on the lake, the top eight fish averaged nearly 8 pounds each with the largest weighing in at over 11 pounds.

"Lake Claiborne doesn't try to impress," quoting Fishmasters.com. "It delivers, especially for those who know how to read the water and come ready to fish."

Area fishermen should be proud to know that four of our north Louisiana lakes are in the top ten for the state, Toledo Bend, Caney, D'Arbonne and rather surprisingly, Lake Claiborne.

BUSSEY BRAKE – Bass have been good with several fish weighing in double digits caught early mornings on topwaters and on soft plastics and spinners later. Crappie are on the flats and some big ones are biting on shiners or jigs. The bream are bedding around the edges of the brush. For latest information, contact the Honey Hole at 323-8707.

OUACHITA RIVER – High water but on a slow fall. Some bass caught in the cuts and in the back water on buzz baits and spinner baits. Crappie are fair; bream are biting in the backwaters. For latest information, contact the Honey Hole Tackle Shop at 323-8707.

LAKE D'ARBONNE – Water is high with lots of current. Gates are open. Bass fishing has been best up Corney Creek on crank baits and soft plastics. Crappie are suspended on the flats and taking jigs and shiners. Bream are bedding shallow and hitting worms and crickets and catfish are good fishing off the banks. For latest information, call Anderson Sport Center at 368-9669 or Honey Hole Tackle Shop at 323-8707.

LAKE CLAIBORNE – Crappie fishing has been fair to good on jigs and shiners. Bass are around the banks

and hitting topwaters early while later hitting hit jigs, spinners and soft plastics. Bream are on the beds and worms and crickets are working on them. Strippers are schooling and hitting shad imitations. For latest information, call Kel's Cove at 927-2264 or Terzia Tackle at 278-4498.

CANEY LAKE – Bass are best early morning around the grass on topwater lures. Later in the day, soft plastics and crank baits are taking some fish on secondary points. Some schooling activity is being noted with fish hitting shad imitations. Crappie are around the deep tops and jigs and shiners are taking some big ones. Bream both chinquapins and bluegills are on the beds and hitting crickets and worms. For information contact Caney Lake Landing at 259-6649, Hooks Marina at 249-2347, Terzia Tackle at 278-4498 or the Honey Hole Tackle Shop at 323-8707.

LAKE POVERTY POINT – Catfish are biting. No report on others. For information, contact the marina at 318/878-0101.

LAKE YUCATAN – The water is scheduled to crest this weekend but is still too high for access to landing. No fishing this week. For info call Surplus City Landing at 318/467-2259.

Living the Beatitudes Daily

In studying through Matthew's Gospel, I 'camped' in Chapters 5-7 - The Beatitudes - for a while. By reading them over and over, I thought the teachings would 'stick to me' and that would be enough. But the more I studied them, the more I realized Jesus wants us to incorporate them into our daily living as we follow Him. That sounds like work to me!

Oh, but the blessings that come from obeying the Master's teaching! Soon after Jesus' baptism and his victory over Satan in the wilderness, He began his public ministry. The 'hour' had struck, the call to action had come, and He must go forth on His crusade. (Barclay). He knew His mission and He was ready for the challenge. Matthew records how Jesus began calling His disciples together (3:18-22). His promise was to make them

"fishers of men and not just fishermen." Others began to follow to hear his teachings and witness the miracles that He did. Our first recorded teaching sessions are referred to as The Beatitudes. This was His message He wanted to pass on to the disciples, and they would pass on to others. This might be considered the 'ordination sermon' for the disciples. In this Sermon on the Mount we find the His core and foundational teachings He shared with the disciples. Matthew and Luke give us their 'take' of the Mount Sermon, with some variation. Both accounts are rich in tips for godly living and service for us today.

It is said by scholars, "Matthew collected Jesus' teachings into one whole pattern; Luke

took the pattern, broke it up and scattered the pieces all over his gospel." We know this was not just one sermon He preached, but a summary of the consistent teaching to His disciples. Today we might use the 'retreat' concept for a Master teacher to use to teach concepts and truths for His team to use in future assignments. Jesus chose the hillside.

When Jesus went up the hill to teach, His disciples followed Him. He sat down and began to teach. (Master teachers sat and their followers sat around them, eager to hear every word). As He looked around, He made eye contact with them and began to share Himself. Imagine Jesus saying: "This is very important and I don't want you to miss any

of it." When Jesus opened His mouth, it was more than idle talk. This expression was used to speak of a solemn, grave and dignified utterance. He was really opening His heart and fully pouring out His mind. These were the men He chose to be His right-hand team in His task of taking the Good News to the world. It has been referred to as 'nothing less than the concentrated memory of many hours of heart-to-heart communion between the disciples and their Master.' And then Jesus began teaching...

"Blessed are the poor in spirit; Blessed are those who mourn; Blessed are the meek; Blessed are they who hunger and thirst for righteousness; Blessed are the merciful; Blessed are the pure in heart; Blessed are the peacemakers; Blessed are those who are persecuted for righ-

teousness' sake; Blessed are those who are insulted and falsely accused. Rejoice and be glad when you are persecuted because of Me, for your reward will be great; You are blessed," Jesus said.

This passage is worthy of our dwelling at length to fully comprehend what the Master Teacher is conveying to His disciples. Our assignment is to incorporate these challenges into our daily lives, putting to test each one as we allow the Lord to direct our paths. . And then our lives will be truly 'salt and light' to share with a hopeless and sin-sick world. (Robert Schuler spoke of them as being "Be-happy-attitudes").


